## No preconditions imposed on opposition MPs for allocations, says Anwar

BANGI: Prime Minister Datuk Seri Anwar Ibrahim said no conditions were ever imposed requiring opposition MPs to support him in order to receive allocations.

"We have never imposed any such condition, he said at a media conference at the Madani Government Retreat 2025.

He said the retreat served as a platform to identify what needs to be improved

He added that Anwar, in his closing speech, emphasised the government's commitment to being open to views and criticism from all parties to

improve its service to the people and the country.

"This gives room for every ministry and agency to improve the (weaknesses) in the government and will certainly help the Madani government to function better." – Bernama

Anwar advised opposition MPs to hold discussions with Deputy Prime Minister Datuk Seri Fadillah Yusof on allocations.

involving human trafficking, online scams, cybercrime and drug-related activities, all of which pose significant challenges to neighbouring countries, including Malaysia."

He was speaking after presenting Ramadan contributions to mosques and *surau* in the Rembau parliamentary constituency yesterday.

## EPF dividend expected to be higher than in 2023

The performance for the third quarter of 2024 is expected to yield good returns for contributors, said Second Finance Minister Datuk Seri Amir Hamzah Azizan.

He said based on the strong performance, EPF contributors can expect better dividend distribution for 2024 as compared with the

previous year.

"If we look at its performance up to the third quarter of last year, it is encouraging. By the third quarter, EPF had already earned RM57.5 billion (investment income), which is better than the previous year.

"This performance will continue into the fourth quarter. The dividend will be encouraging but I cannot comment what it will be. Just wait for it. It will be better."

He was speaking after completing the Larian Asean: Trek Kewangan @MOF event organised by the Finance Ministry yesterday.

EPF declared a higher dividend of 5.5% for

2023 for conventional savings compared with 5.35% in 2022, with a total distribution of RM50.33 billion.

For syariah savings, it was 5.40% compared with 4.75% in 2022, with a total distribution of RM7.48 billion.

EPF is expected to announce the 2024 dividend rate in early March. Several economists and academics had previously predicted EPF's 2024 dividend to exceed 6%.

## **CCAM fundraiser raises** RM200,000, seeks RM1.8m

KUALA LUMPUR: The Children's Cancer Association Malaysia (CCAM) hosted a Gala Night Fundraising Dinner on Saturday at Berjaya Times Square Hotel, in conjunction with International Childhood Cancer Day on Feb 15

The event raised RM200,000, but CCAM founder Lavaniyah Ganapathy told *theSun* that RM1.8 million is needed to provide medical care for 14 children currently under

CCAM support for the next year.

Sponsored by Berjaya

Corporation Berhad (BCorp)

founder and adviser Tan Sri Vincent Tan, the event gathered 350 guests, including supporters, corporate sponsors and members of the ublic, to raise funds for Malaysian children battling cancer.

Among those present were 60 childhood cancer survivors and their families, many of whom have received assistance from CCAM.

Lavaniyah, who founded CCAM in 2022, was inspired by her own experience after her daughter Mahiyaa Bala, six, was diagnosed with leukaemia.

"Childhood cancer remains a

pressing concern in Malaysia, with about 77 out of every 100,000 children diagnosed. Since its establishment, CCAM has helped 72 children and are supporting 14 others in their fight against cancer.
"In 2023 alone, 220 children lost

the battle with cancer. This underscores the urgent need for awareness, early detection and financial support," she said.

She highlighted that the most common types of childhood cancer in Malaysia include leukaemia, brain and nervous system cancers and lymphoma.

While the fundraiser secured RM200,000, CCAM aims to raise RM1.8 million to cover medical care for the children it currently supports.

To sustain our efforts, we need at least RM5 million annually fund essential treatments, financial aid and resources for families with children battling

cancer." Lavaniyah said.

The funds will help cover medical expenses, hospital treatments and financial aid for families facing long-term care costs.

Beyond financial aid, CCAM also conducts awareness programmes, provides emotional and psychological support and ensures that no child or family faces cancer alone.

The organisation supports children from newborns to 18 years old, ensuring equal access to medical care.

Despite medical advancements,

Malaysia's childhood cancer survival rate remains at 55% to 65%, far below the 95% survival rate in many developed countries.

"This gap is alarming and must be addressed," Lavaniyah said, urging an update to Malaysia's national cancer registry as the latest statistics date back to 2017.

"It is shameful that we are still

relying on outdated data," she added.

Lavaniyah stressed on the importance of early intervention, adding that timely treatment improves survival rates.

"Unfortunately, in some cases, funds were secured too late. By the time treatment began, infections or organ damage occurred," she said. had

The rising cost of cancer treatment is expected to increase by 12.7% annually, making financial aid crucial to ensure timely access

She urged the public, corporate sponsors and caring individuals to support CCAM's mission so that no child in Malaysia is denied cancer treatment due to cancer treatment

"We need to act quickly to give these children the best chance of survival. I urge all Malaysians to join CCAM in this mission so we can bridge the gap and give them the fighting chance they deserve," she said.

## 'Urban Renewal Bill will not displace Malays or low-income groups'

PUTRAJAYA: Town and Country Planning (PlanMalaysia) director-general Datuk Dr Alias Rameli has denied claims that the Urban Renewal Bill (URB) will displace Malays and B40 income groups urban areas

He said the government upholds 10 key principles to ensure transparency and safeguard the rights of registered property owners in drafting the bill.

"Among the main principles of the Bill are securing property owners' consent, maintaining original residents,

protecting landowners' interests and ensuring fair maintenance cost adjustments.

"The Bill does not involve

amendments to other laws as claimed by the Kota Bharu MP, such as the Federal Constitution, the National Land Code and the Land Acquisition Act 1960" he said in a statement.

Opposition MPs have labelled the Bill a subtle tactic to displace Malays from urban areas by lowering the consent threshold for strata housing redevelopment.

Perikatan Nasional Chief Whip Datuk Seri Takiyuddin Hassan (PN-Kota Bharu) also claimed the bill was being rushed through Parliament.

Addressing these concerns, Alias said the Bill complements existing laws while introducing additional provisions to protect property owners' rights. He noted that a review of over 17

property development-related acts had been conducted to prevent legal overlaps and conflicts.

Alias also dismissed claims that the Department of Director-General of Lands and Mines had rejected the Bill. "In reality, the department, through

the Natural Resources and Environmental Sustainability Ministry, agreed in principle to the Bill's drafting during the Cabinet Meeting on Aug 14,

2024," he said. He added that urban renewal is crucial to addressing dilapidated and unsafe buildings, aligning with global

best practices in urban development.
"Leaving old buildings to deteriorate with inadequate facilities and poor infrastructure is not an option

for effective urban governance.

"Support from various stakeholders is necessary and a 'do-nothing' approach is not an option for the Madani government, which prioritises long-term well-being and quality of life," he said

Alias also criticised 31 Malay-Muslim NGO that recently submitted a memorandum opposing the Bill to PN, saving their actions could hinder a legislative process that benefits urban communities and property owners





## 'Be transparent to maintain credibility

Influencers must strike balance between personal voice and being upfront when promoting sponsored content: Academic

**PETALING JAYA:** The rapidly evolving landscape of influencer marketing needs to balance between authenticity and brand relationships, said Universiti Kebangsaan Malaysia Centre for Research in Media and Communication senior lecturer Dr Nurzihan

She said the success of influencers comes from positioning their credibility alongside professional relationships with brands.

"They are expected to provide recommendations that benefit and not harm their followers mentally and physically, but how

Transparency is important, especially when

influencers promote products they do not use themselves or favour. They should disclose this fact if they don't like a product, but cultural values such as *jaga hati* (maintaining harmony)

make such transparency challenging."

Nurzihan pointed to food reviewer Jason Chen as an example, noting that while his honest opinions have sometimes led to a backlash, they have also prompted certain businesses to improve their offerings based on his constructive criticism.

She said influencers must strike a balance between personal voice and brand messaging with the key being to be upfront about sponsored content while making it feel natural. While adding that inconsistent messaging can damage credibility, she said transparency in sponsored content is not only ethical but legally required.

"The Malaysian Communications and Multimedia Commission has guidelines on

advertising disclosure. "Using hashtags like #ad or #sponsored isn't

just good practice, it's a necessary compliance." Nurzihan warned that Malaysian audiences are highly sceptical and appreciate those who prioritise honesty when promoting content.

While honesty is crucial, influencers must carefully navigate Malaysia's relationship-focused business culture.

honesty and brutal honesty," she said, adding that instead of saying "I hate this product," an influencer could say "This product might work better for different skin types."

She advised following the 80/20 rule in

which sponsored content is kept to about 20% of the total posts, and the rest is organic,

on the total posts, and the rest is organic, genuine lifestyle content.

Universiti Teknologi Mara head of Communication and Knowledge Advancement and Communication and Media Studies Faculty senior lecturer Dr Wan Hartini Wan Zainodin emphasised the power influencers have in shaping their partnerships.
"Current audiences are smart and can sense

whether a promotion is genuine or otherwise. So to maintain trust, influencers must engage in open communication with brands about

expectations.

"Balanced reviews that highlight strengths and weaknesses can help sustain credibility while preserving relationships."

Wan Hartini added that legally, influencers must be upfront about paid partnerships, and that their followers would appreciate such

"Misleading content can backfire and risk an influencer's reputation and attract legal consequences. The credibility that's built over and strengthens an influencer's industry

She said while accepting paid promotions offers immediate financial gains, authenticity remains crucial for longevity since it becomes a personal brand, and influencers who share their product experiences foster deeper connections with their followers, which leads to stronger brand collaborations.

"Even though excessive criticism of a product could strain brand relationships, there product count stain inflant relationships, there is a constructive way to provide feedback. Delivering comments in a professional and solution-oriented manner helps brands grow while maintaining influencer credibility.

Wan Hartini said influencers should aim to

educate and inform rather than merely criticise. To ensure long-term success, influencers must

go beyond profit-driven content creation.

"Just as we want to buy products that offer value for money, so do social media followers. A focus on authenticity and audience trust will ultimately enhance an influencer's reputation and earning potential.

"At the same time, brands that prioritise influencer marketing over product quality risk eventual failure. A great product should speak for itself. Marketing should amplify its strengths, not cover up its flaws."

## Nine Sarawak bridges expected to be completed this year

**MUKAH:** A total of nine more bridge construction projects currently under way in Sarawak are expected to be completed this

Sarawak Deputy Premier Datuk Amar Douglas Uggah Embas said out of 16 projects involving a cost of RM5.9 billion, two projects have been successfully completed, namely the

Marudi Bridge and Muara Lassa Bridge. He added that three of them are scheduled to be completed in March, namely the Rajang Bridge, Bintulu-Jepak Bridge (Iconic Cable Bridge) and Lingga River Bridge

Other bridges expected to be completed

this year include the Sejingkat Bridge, Batang Lupar 1 Bridge, Saribas 1 Bridge, Kemena-Sebauh Bridge, Limbang River Bridge and Kemena River Bridge in Sebauh, Bintulu," he said at the inauguration ceremony of the Muara Lassa Bridge in Daro.

Sarawak Premier Tan Sri Abang Johari Abang Openg officiated at the event on Saturday.

Unggah also announced that five more bridges are expected to be completed by 2026, namely the Batang Lupar 2 Bridge, Saribas 2 Bridge, Krian Bridge, Paloh Bridge and Igan

"Meanwhile, the construction project of the

Rambungan Bridge in Kuching is expected to

be completed in 2027," he said. Uggah, who is also Sarawak infrastructure and port development minister, also said by 2027, the construction project of the 896km coastal road, costing RM5.42 billion, will also be

completed.

"The coastal road connecting Lundu-Sempadi to Miri and passing through the Matu/Daro area has reached an 80% completion stage," he added.

The Second Trunk Road has now reached

30% completion and is scheduled to be fully completed by 2028. – Bernama

## Vet Dept disinfects illegal pig waste site

**PORT DICKSON:** The Negeri Sembilan Veterinary Services Department conducted a disinfection operation at an illegal pig waste dumping site in Site A, Tanah Merah on Feb 13.

The department said in a statement the action was taken to prevent the spread of animal diseases caused by wild animals digging through waste from the site.

"An inspection conducted by the department

at 3pm found several pits used to bury pig waste, with some remains scattered by wild animals.

"We advised the village head to ask the landowner to fill the pits immediately to prevent possible spread of diseases caused by wild animals consuming or dragging the pig waste."

The department said although there are no laws on illegal pig waste disposal, sanitation measures and monitoring pig transport without permits will continue to be enforced. – Bernama

## Over 19,000 heads of household getting RM100 monthly aid

IPOH: A total of 19,012 heads of household have received the Kad Perak Sejahtera assistance so far, which is part of the state's efforts to help the low-income group. Menteri Besar Datuk Seri Saarani Mohamad

said the initiative, introduced in 2019, was to ensure that the B40, poor and hardcore poor groups could meet basic food needs.

"This card can be used at 291 registered panel shops and supermarkets, with a total value of RM1,200 per year or RM100 per month for each recipient.

"A total of 1,002 new applications have been

received this time and 915 applications have been approved, with the highest number received from Kinta District involving 430 applications," he said after launching the card handover ceremony at Bangunan Perak Darul

Ridzuan here on Saturday.

Saarani said Perak is targeting 20,000 Saarani said Perak recipients under the initiative.

"We are committed to ensuring that the programme continues to benefit those who are truly in need," he added. - Bernama

## State to spend RM6b on rural water supply projects

**MUKAH:** Sarawak is set to spend approximately RM6 billion by 2030 on rural water supply projects, said Premier Tan Sri Abang Johari

He said the water supply grid construction project would also include the building of water treatment plants and the replacement of old

"It has already begun. Under the people's tr has already begun. Under the peoples project, it is RM4 billion. This does not yet include the 13th Malaysia Plan, where we will add another RM600 million. To replace the old pipes to prevent them from bursting, we estimate the cost to be RM1.1 billion," he said after launching the Muara Lassa Bridge in Daro on Saturday.

The construction of the 2,430m long bridge spanning Lassa River, which connects Daro to Pulau Bruit, began on March 22, 2019, and was

completed on Jan 9, 2025.

It is a key component of Sarawak's coastal road project, valued at nearly RM600 million.

The project aims to improve land access for

rural residents, particularly for those who previously relied on ferry services to cross the Batang Lassa.

Abang Johari added that infrastructure development requires significant funding. Earlier, in his speech, he said the completion

of the Muara Lassa Bridge would serve as a catalyst for development in Daro.

Moreover, with the upcoming construction of the Batang Paloh Bridge, which will connect Pulau Bruit to Serdeng next year, the entire Rajang Valley will have road access, opening up various economic opportunities in the region.

He urged the youth in Daro to seize the opportunity to engage in new economic sectors and adopt digitalisation as a means to support

"Don't just rely on the local market. We need to think globally and use the internet to market our economic products abroad. This is how our income will increase," he said. - Bernama

## **Hidden dangers of gummy** candies for children

Soft, sticky confection can cause airway blockage, prevents oxygen from reaching lungs, brain: Specialist

PETALING IAVA: Paediatricians have warned that gummy candies can cause choking in young children due to their underdeveloped jaw muscles and smaller airways, which make it difficult for them to safely chew and swallow

Paediatrician and neonatologist Dr Masri Muhamed said a child's airway makes him more vulnerable to obstruction, and even a small piece of gummy candy can completely block airflow and cause choking.

"Additionally, since children are often active and may eat, talk, laugh or run with the candies in their mouths, it can cause aspiration when the confection accidentally enters the windpipe instead of the food pipe.

"If not treated quickly, it can result in severe airway blockage or aspiration pneumonia (a lung infection caused by inhaled food particles)," he said when commenting on a recent incident in which 10-year-old Mohamad Fahmi Hafiz died after choking on an eyeball-shaped gummy candy during a *Quran* and *Fardhu Ain* class in Butterworth, Penang. The victim was rushed to the intensive care unit of a hospital but fell into a coma and died on Friday. Following his death, the Health Ministry has banned the sale of gummy candies in stores and online platforms and said it will seize the candy and act against

Masri said gummy candies can easily cling to the throat due to their soft and sticky texture, making them harder to remove compared with hard candies, which can sometimes be coughed out. He warned that a complete airway blockage prevents oxygen from reaching the lungs and brain, causing brain damage within four minutes if not cleared immediately.

"Prolonged oxygen deprivation can also

"Prolonged oxygen deprivation can also result in cardiac arrest, further reducing the chances of survival. Even if the child is successfully resuscitated, complications such as aspiration pneumonia, airway injuries or long-term neurological damage can occur.

"This is why immediate action is crucial. Performing the Heimlich manoeuver (a first aid technique in a chaling congregory) or in a statement of the control of the control of the control of the change of the control of the con

technique in a choking emergency) or in severe cases, cardiopulmonary resuscitation can save a child's life. Parents and caregivers should know basic first aid to respond quickly in emergencies."

Consultant paediatrician and child disability activist Datuk Dr Amar Singh HSS said while young children under five years old are well known to be at risk of choking from food and small objects, such incidents among children of schooling age have been on the rise in recent

He said a choking child may become pale or "blue," be unable to speak, cry or cough, become drowsy and look panicked.

"It is hard for parents to control what their children buy outside school, so the community should work with the government to ban dangerous products like gummy candies and jellies in small, mouth-sized cups, which are already banned in some countries."

Amar suggested that teachers use online training guides and resources from local NGOs to learn how to help a choking child, including performing back blows and abdominal thrusts.

Universiti Kebangsaan Malaysia public health medicine specialist Prof Dr Sharifa Ezat Wan Puteh said the Guidelines on the Enforcement of the Ban on Food and Beverage Sales Outside School Gates (Second Edition 2021) has been in effect since 2012 and prohibit vendors from selling food and beverages within a 40-metre radius of the school perimeter.

"However, enforcement is almost nonexistent, which is why high risk foods like gummy candies and konjac jelly continue to be sold near schools.

"These items may cause choking and

maldigestion. They are also high in calories, artificial colouring and fruity scents that attract children. School security and staff should help enforce the ban."

Sharifa Ezat said Australia has banned foods linked to choking incidents, adding that Malaysia should follow suit with food labels that display nutritional content and warning of choking hazards for children.

## 'Prioritise safety, protection of children at mosques'

KUALA LUMPUR: The authorities and mosque management must take immediate proactive action to ensure the safety of worshippers, ,especially children, who often frequent places of worship to seek knowledge and engage in

religious practices.

Malaysian Islamic Youth Movement women affairs bureau vice-president Dr Fatin Nur Majdina Nordin said the attempt to molest a young girl at a Batang Kali mosque in Selangor on Friday had tarnished the sanctity of the mosque and posed a threat to the psychological well-being and safety

She said such incidents should not occur in

mosques, which are supposed to be places of

worship that guarantee peace and safety.

"The movement expresses concern and urges the community to be more attentive to the issue of child protection and safety, particularly with regard to the recent sexual harassment incident involving a young girl at a mosque.

"The incident highlights the importance of monitoring and ensuring safety of both inside and around mosque premises, especially during

On Friday, a closed-circuit television (CCTV) footage went viral, showing a man wearing a white skull cap sneaking into the women's prayer area and hugging a young girl from behind while

she was in suiood (prostration) and then fleeing

The man was arrested at his residence located approximately one kilometre from the mosque, at 10am the same day.

Selangor Social Welfare Department director Azmir Kassim confirmed that checks revealed the man held a disability card due to learning

Fatin Nur Majdina said the issue of disability in the incident must be carefully considered as it is a sensitive matter and requires thorough investigation and assessment. She added that offenders should be appropriately punished and the identity of the child protected. - Bernama

## **Businessman loses** RM4.2m in scam

SEREMBAN: A former businessman lost RM4.2 million after falling victim to a Macau scam syndicate that posed as police officers. Seremban police chief ACP Mohamad Hatta

Che Din said police received a report from the 62-year-old man, who informed them he was duped by the syndicate last Thursday.

He said the man claimed to have received several messages via WhatsApp from an unknown number, introducing himself as "Sergeant Michael" on Dec 21 last year and informing the victim he was involved in a money laundering case.

"The victim made an online transfer to a company account and then deposited two cheques into two different company accounts as instructed by Sergeant Michael.

"He also told the bank to transfer money from

his personal account to another account with all transactions claimed to be for investigation purposes," Bernama reported.

Mohamad Hatta said the man only realised he

had been deceived after the bank notified him before his bank account was blocked, adding that the case is being investigated under Section 420 of the Penal Code.

He also said from January to December last year the police opened 105 investigation papers related to phone scams (Macau scam) involving losses of RM1.89 million, compared with 84 investigation papers with losses of RM930,931.18 in 2023.

As a preventive measure, he advised the public to be cautious when receiving calls from individuals claiming to represent any agency and requesting payments for any purpose.

The public is also advised not to provide details such as account numbers and banking information to others to avoid being manipulated by scammers."

## Crash kills driver, injures passenger

KOTA BHARU: A man was killed and a woman was injured after the lorry they were travelling in skidded and plunged into a ravine at KM79 of the Kota Bharu-Gua Musang (Bukit Ah Kim) road in Kuala Krai.

Kuala Krai police chief Supt Mazlan Mamat said the 48-year-old lorry driver died on the spot in the 11.20am incident on Saturday.

The 39-year-old passenger was taken to Sultan Ismail Petra Hospital for treatment.

"Preliminary investigations found that the lorry, which was travelling from Kuala Lumpur to Kota Bharu, is believed to have veered off the road and fallen into the ravine," he said.

### Child care centre not authorised to operate

**PUTRAJAYA:** A kindergarten embroiled in allegations of abuse involving a six-year-old autistic child in Shah Alam was found to be operating without complying with regulations.
In a statement, the Social Welfare Department

said checks revealed that the premises was not

authorised to operate as a child care centre (taska).

"The department has issued a notice prohibiting the kindergarten from operating due to violations under the Child Care Centre Act. It has also instructed the operator to attend a meeting at the Selangor welfare office. The case has been referred to the district education office."

The notice was issued following an investigation into a complaint by the parents of an autistic child, who alleged that the child had been abused at the premises.

On Friday, Shah Alam district police chief ACP Mohd Iqbal Ibrahim said the report lodged by the victim's mother stated that her husband had found red marks on the child's back and below the right eye. The case is being investigated under Section 31(1)(a) of the Child Act 2001. – Bernama







## Straw buffalo attraction at carnival

## Exhibits on traditional *padi* farming also featured at Kedah annual event

YAN: Standing amid the crowd, "Awang Kundur", a life-size buffalo sculpture crafted entirely from straw, was the main attraction at the Kedah Straw Carnival 2025 in Kampung Teroi, Guar Chempedak near here.

Created by the Pengkalan Kundur B4 Area Farmers Organisation, it was not just a sight to behold but also a tribute to traditional farming, in which buffaloes once played a crucial role in ploughing padi fields before modern machinery took over.

"Buffaloes were a farmer's best friend in the past, used to till the fields before tractors and other equipment came into play. Today, you won't find working buffaloes in Kedah anymore, except in demonstrations," said the organisation's manager Amrin Hamdan.

"After brainstorming ideas, we decided to create this exhibit. It took us two weeks to complete, and we didn't stop there. We also built a traditional rice barn and a padi threshing area, both of which were essential elements of padi farming in the past." he told Bernama.

Made with three massive rolls of straw, each weighing between 250kg and 300kg, the exhibits were brought to life with a budget of less than RM2.000.

Crafting the straw was no small feat, with 20 workers dedicating their time and skills.

"We divided the team into three groups, but creating the buffalo required eight people alone as it had to look as close to the real thing as possible," Amrin said, adding that their efforts paid off as visitors flocked to the carnival, eager to snap photos with "Awang Kundur".

"The response was overwhelming. Beyond just admiring the artwork, people also learnt about the farming methods of the past. It was a great way to reconnect with our agricultural heritage."

Muda Agricultural Development Authority (Mada) chairman Datuk Dr Ismail Salleh said the three-day carnival, that started on Friday, was a much-anticipated annual celebration following the padi harvesting season in Mada areas.

"This year, 12 organisations participated, and those with straw baler machines transformed their harvest waste into stunning sculptures. I was truly impressed by their creativity," he said.

The competition saw the top winner walk away with RM3,000, while the second and third place winners won RM2,000 and RM1,000 respectively. Other participants received consolation prizes.

Ismail said the carnival highlights the potential of straw as an additional source of income for farmers, adding that in the past, farmers would simply burn it.

For visitor Salina Ramli, 48, who attended the carnival with her husband Mazdi Mohd Razali. 48. the

event was a must-see.

"We saw it being promoted on social media and decided to come and check it out. Seeing these straw sculptures up close was simply breathtaking. Kedah is known as the 'Rice Bowl of Malaysia', so events like this are a brilliant way to showcase our culture and attract more tourists to the state." she said

## Mushroom income boon for underprivileged

BUKIT MERTAJAM: An oyster mushroom cultivation project at Universiti Teknologi Mara (UiTM) is helping to increase the income of asnaf mualaf (underprivileged Muslim converts) and improving their standard of living.

The community project utilises modern farming techniques through the iMistroom 2.0 modular smart mushroom house system.
It was created by UiTM Penang

It was created by UiTM Penang Faculty of Mechanical Engineering senior lecturer Assoc Prof Dr Hamid Yusoff and his team, in collaboration with four other stakeholders. Hamid said the project, funded by Bank Rakyat with an allocation of RM364,800, started in September last year with 20 asnaf mualaf participants selected to cultivate oyster mushrooms at Surau Al-Huda in Taman Markisah, Permatang Tinggi.
"iMistroom operates on the 2T (Leave and Harvest) and 3M (Userfriendly, Easy and Modular) concepts.

"iMistroom operates on the 2T (Leave and Harvest) and 3M (User-friendly, Easy and Modular) concepts. The participants are from B40 and asnaf communities, so we support them with a community-friendly technology that is easy to manage.

"This collaboration will continue until the end of this month, but

ongoing support will be provided to help the *asnaf* expand their yield and start cultivating mushrooms at other locations," he told reporters after the launch of the project recently.

The ceremony was officiated by UiTM deputy vice-chancellor (Industry, Community and Alumni Network) Prof Dr Jamalunlaili Abdullah and attended by Malaysian Chinese Muslim Association Penang branch chairman Ben Ooi Chooi Beng.

Hamid said the project is a joint effort between UiTM Penang and UiTM Kedah, with the Penang campus providing technology expertise,

training, guidance and monitoring, while the Faculty of Business at the Kedah campus assists in marketing and product research. The cultivation is carried out in

The cultivation is carried out in phases and 20,000 mushroom blocks have been placed in 20 smart mushroom houses. Ten units are located at the *surau* and another 10 are managed by a company in Pokok Sena, Kepala Batas.

He said each block could produce four to five harvesting cycles within three months and the project has generated about RM20,000 in sales. In addition to fresh mushrooms, valueadded products such as fried mushrooms are sold at several locations, Bernama reported.

Ooi said the project has been very beneficial, especially in helping the asnaf mualaf to generate income and reduce their reliance on monthly aid.

"In terms of sales and revenue, there is clear growth, with participants earning at least RM200 on top of their existing income.

"We see great potential for the participants to improve their standard of living. In fact, three participants have started their own fried mushroom kiosks."

## Taiwan invasion board game players go nuclear

▶ Tabletop simulation uses maps based on real-life exercises

**TAIPEI:** To stop invading forces seizing Taiwan, board gamer Ruth Zhong chooses the nuclear option, dropping an atomic bomb on the capital Taipei to secure the island's freedom and her victory.

The Taiwanese board game 2045

is a zero-sum contest of military strategy and individual self-interest

strategy and movidual sear-interest that puts players on the frontlines of a simulated attack.

Their battlefield game tactics will determine the theoretical future of Taiwan, which in the real world faces the threat of invasion.
"The most interesting part of this

game is that you have to make

continuous decisions based on the evolving situation, and these choices can alter the entire history of Taiwan in an instant," said Zhong, 36, at Sunny Boardgame store where she

played 2045 with friends. "I saw (the nuclear bomb) as a necessary move to ensure the survival of the entire island."

Launched by Mizo Games last month, 2045 is set in the first 10 days of a theoretical invasion of Taiwan and before help from friendly forces has arrived.

Players represent different characters, including a person who has taken up arms, a collaborator and an arms dealer.

Mizo Games founder Chang Shao-lian said 2045 was different to its previous war games, which required players to cooperate to win.

'We decided to move away from romanticism and create a game rooted in realism," Chang said.

In the game, if (an invader)

captures a critical number of key cities on the island, Taiwan loses.
"Some players assume the game

caters only to independence players but in reality, anyone with a strategic vision for the Taiwan Strait conflict can find ways to win," Chang said.

Mizo Games raised more than NT\$4 million (RM539,794) through a crowdfunding site and went to great lengths to ensure 2045 was as close

to reality as possible.

The makers consulted experts on military personnel, national security and political analysts, and also created maps based on real-life

They also studied actual attacks to ensure the "directional logic" of fighter jets attacking Taiwan's tallest building, Taipei 101, which features on the box cover. "We repeatedly refined details,

how much damage should be shown, the intensity of the explosion, the light effects and even

the presence of aircraft in the background," said 2045 designer Lai Boyea.

While the 2045 creators hope conflict stays on the game board, Lai said Russia's invasion of Ukraine in February 2022 had made the threat of an attack seem more real.

"You imagine, if they were to attack, how would they do it?"

"Many of the game's cards depict these possibilities, from amphibious landings on Taiwan's beaches to aerial incursions over central and southern regions."

While 2045 cannot capture the brutality of an actual war, Zhong said

it showed the limits of people's willingness to assist others in a crisis.

"Its value lies in showing players that even in a game, or in real life, your allies won't necessarily help

you unconditionally," she said.
"Everything ultimately depends
on interests." – AFP



## Toddlers killed in old grenade blast

PHNOM PENH: Two Cambodian toddlers died when a rocket-propelled grenade, believed buried since the country's civil war, blew up near their homes.

The explosion happened on

Saturday in a remote village in northwestern Siem Reap province that was once a battle site for Cambodian government soldiers and Khmer Rouge fighters in the 1980s

The children who died were cousins – a boy and a girl who were both two years old.

"According to an investigation report, the two toddlers were playing on the ground, digging the soil and may have hit (the grenade) with an object that caused the explosion: said Heng Ratana, director general of the government's Cambodian Mine

He said one child was killed instantly while another died in

"There has been peace for more than 25 years, but the blood of Cambodian people continues to flow because of landmines and the remnants of war," Heng Ratana said.
The accident comes afte

The accident comes after Cambodia was forced to partially suspend demining operations for several weeks when Washington suddenly halted funding following President Donald Trump's order to

freeze foreign aid for 90 days. But on Friday, Cambodian officials said deminers were to resume clearing unexploded munitions, after the United States granted a waiver to keep funding the work in the country.

The Southeast Asian nation remains littered with discarded

ammunition and arms from decades of war starting in the 1960s.

After more than 30 years of civil war ended in 1998, Cambodia was left as one of the most heavily mined countries in the world.

mines Deaths from unexploded ordnance are

with around 20,000 fatalities since 1979, and twice that number wounded.

Last month, two Cambodian deminers were killed while trying to remove a decades-old anti-tank mine from a rice field and a villager died in a landmine blast on his farm.

More than 1,600sq km of contaminated land still needs to be cleared, which leaves about a million Cambodians affected by war remnants.

Cambodia had aimed to be mine free by 2025, but the government pushed the deadline back by five years because of funding challenges and new landmine fields.

#### **RESCUERS RACE TO** FREE EIGHT WORKERS

MUMBAI: Search teams in southern India were working yesterday to rescue eight workers believed to be trapped in an irrigation tunnel that collapsed during construction. The accident occurred on Saturday in the state of Telangana after a sudden inflow of Telangana after a sudden inflow of water and soil caused a part of the tunnel to cave in. Workers near a boring machine managed to escape but another eight engineers and labourers near the entrance were believed to be stuck inside. "This is an unfortunate incident, but we are committed to bringing them out safely," State Irrigation Minister safely," State Irrigation Minister N. Uttam Kumar Reddy told reporters. – Reuters

#### **TIMOR KEEN TO BUY RUSSIAN MEDICINES**

DILI: The Democratic Republic of Timor-Leste is interested in buying medicines from Russia, President Jose Ramos-Horta told RIA Novosti. "We can cooperate in the healthcare sector or in trade, even in small volumes. We would even in small volumes. We would be happy to buy from Russia," he said. According to the president, he is especially interested in buying pharmaceutical products and medical equipment from Russia. "I know about Russian medical technologies. Russian medicine – it is high class to the level of the best hospitals and doctors anywhere in the US and in Europe." – Bernama

### Thai, Cambodian police free 215 in scam centre raid

BANGKOK: Thai and Cambodian police raided a building in a border town and freed 215 foreigners, a senior Thai official said vesterday, in an expansion of a regional crackdown against cyber scam centres.

against cyber scam centres.

Hundreds of thousands of people
have been trafficked by criminal
gangs and forced to work in scam
centres and illegal online operations across Southeast Asia, according to

the United Nations.

A UN report in 2023 estimated that the fast-growing operations generate

the fast-growing operations generate billions of dollars annually. The raid yesterday targeted a three-storey building in the Cambodian border town of Poipet in Banteay Meanchey province.

The rescued foreigners included 109 Thais, 50 Pakistanis, 48 Indians, five Taiwanese and three Indonesians, said Thai government spokesman

Jirayu Houngsub.
"This is the largest number of Thais freed from a building suspected of cyber fraud for the two countries."

The raid was the result of a joint effort by Thailand and Cambodia to tackle scam centres, he said.

Scam centres have been operating for years. But they now face new scrutiny after the rescue of Chinese actor Wang Xing, who was lured to Thailand with the promise of a job, and then abducted and taken to a

scam centre in Myanmar.

Southeast Asian countries have stepped up efforts to tackle scam centres, with recent actions along the Thai-Myanmar border, Earlier this month, Thailand cut power, fuel and internet supply to areas linked to scam

## 'US govt staff must justify work or lose jobs'

#### Employees mandated to reveal accomplishments

WASHINGTON: All US federal employees must justify their work or lose their jobs, Elon Musk said on Saturday hours after the president pushed him to be "more aggressive"

in slashing government spending.

Musk has led the effort to fire swathes of the government workforce.

"All federal employees will shortly receive an email requesting to understand what they got done last week. Failure to respond will be taken as a resignation," Musk wrote.

According to a copy of the email provided to AFP, federal workers were asked to submit "approx 5 bullets of what you accomplished

The email came from the US Office of Personnel Management (OPM), with the subject line "What did you do last week?" The deadline to reply was 11.59pm Monday, although the message did not say failure to do so would lead to termination.

The OPM did not immediately reply to

AFP's request for comment on Saturday

The American Federation of Government Employees (AFGE), the largest federal employee union, vowed to challenge any unlawful terminations in a statement from national president Everett Kelley.

Kelley slammed Musk and the Trump administration, saying the move showed "their utter disdain for federal employees and the critical services they provide to the American people".

"It is cruel and disrespectful to hundreds of thousands of veterans who are wearing their second uniform in the civil service to be forced to justify their job duties to this out-ofhas never performed one single hour of honest public service in his life," he said. Several federal employees told AFP they

were advised by their agencies not to respond to the email and wait for further instruction, a Treasury Employees Union.

"I have so much work to do, I am not going

to neglect actual patient care for this drama said a physician at the Department of Veterans Affairs, who received the email.

Musk later appeared to downplay the requirements of the request, writing on X that the bar is "very low" and saying: "An email with some bullet points that make any sense at all is acceptable!"

Earlier on Saturday, Trump said on his Truth Social platform that Musk was "doing a great job, but I would like to see him get more

aggressive".

"Remember, we have a country to save."

Trump has put the tech entrepreneur in charge of the new Department of Government Efficiency (DOGE) advisory body, tasking him with slashing public spending and tackling waste and corruption. In the latest cuts announced on Friday, the US. Defence Department is to reduce its

US Defence Department is to reduce its civilian workforce by at least 5% starting next week.

Trump's administration has already begun firing many other federal workers who are on probationary status.

DOGE is a free-ranging entity run by Musk, although its cost-cutting spree has been met with pushback and mixed court rulings.

A judge on Thursday denied a union bid to temporarily halt the firing of thousands of

people.

Musk said this week he would work with Trump for as long as he "can be helpful", as the pair dismissed concerns over conflicts of interest due to the tycoon's government

'Elon is doing a great job," Trump told a meeting of conservative activists on Saturday, running through a list of "some of the flagrant scams" that had been uncovered.

"We love Elon, don't we? He's a character.

People said: 'What official position does he have?' I said: 'Patriot.'

Musk said DOGE was publicising its actions on its website and the transparency would hold him accountable. - AFP

### Australia PM promises healthcare boost

SYDNEY: Prime Minister Anthony Albanese promised yesterday a US\$5.4 billion (RM23.8 billion) boost to the national healthcare system in an overture to voters ahead of elections that must be held by May 17.

Surveys show the cost of living is at the top of voters' minds.

As his three-year term in office nears its end. Albanese has yet to announce the date of elections. But unofficial campaigning is already

"Just as every Australian wants the best healthcare for their family, our government wants the best healthcare for every Australian," the prime minister told a rally in the Tasmanian city of Launceston.

Albanese said his centre-left Labor government would invest an extra US\$5.4 billion in Medicare, which has provided universal healthcare since 1984.

It would result in patients not having to pay for 90% of visits to the doctor by 2030, the government said, as well as delivering extra money for training nurses and doctors.

Peter Dutton, leader of the conservative opposition, responded to the latest spending promise by saying his Liberal-National coalition would match the US\$5.4 billion Medicare investment if elected.

Support for the Labor Party is running almost neck-and-neck with the opposition coalition, according to a Newspoll survey. - AFP

#### **EIGHT-YEAR-OLD MIGRANT GIRL DROWNS OFF PANAMA**

PANAMA CITY: A boat carrying 19 South American migrants blocked from entering the United States sank off the coast of Panama as they returned to their home countries, leaving an eight-year-old Venezuelan girl dead. The boat went down on Friday night "due to strong waves caused by bad weather" in Caribbean waters off northeast Panama, the country's Senafront border service said. Aboard were migrants from Venezuela and Colombia, and two crew members. Aside from the girl who died, the members. Aside from the girl who died, the others were all rescued, Senafront said. The migrants were returning home to Mexico and Central American countries after giving up on trying to enter the United States. – AFP

#### TWO KILLED IN PENNSYLVANIA **HOSPITAL SHOOTING**

YORK: A man carrying a handgun and zip ties took hostages inside a Pennsylvania hospital on Saturday, fatally shooting a responding police officer and wounding five others before he was killed by police. The gunman, identified as 49-year-old Diogenes Archangel-Ortiz, entered UPMC Memorial hospital in York, Pennsylvania, on Saturday and went directly to the intensive care unit, where he took staff members hostage. A nurse and custodian were both shot and wounded, and a doctor was grazed. The suspect and police exchanged gunfire after he walked into the hallway holding a female staff member at gunpoint with her hands bound. - Reuters bound. - Reuters



## Trump to name FBI chief Patel as acting ATF head

WASHINGTON: President Donald Trump will name newly confirmed FBI director Kash Patel (pic) as the acting head of the Bureau of Alcohol, Tobacco, Firearms and Explosives, said a person familiar with the matter.

Patel, a Trump loyalist, will run the FBI, the nation's most prominent law enforcement

agency, at a time of growing upheaval while also leading the ATF, which enforces US gun laws.

Democrats and two moderate Republicans had forcefully opposed Patel's nomination, saying his past calls for retribution against Trump's critics made him unfit to lead the FBI, but this was not enough to overcome broad Republican support. Patel, who has received

support from the Gun

Owners of America lobby group for championing gun rights, would be expected to lead an overhaul of the

agency, shifting its focus away from regulating firearms.

During his presidential campaign, Trump accused the ATF of being heavy-handed with gun owners and revoking licences on frivolous

grounds.
On Thursday, Attorney-General Pam Bondi abruptly fired the ATF's long-time chief counsel, Pamela Hicks, and had security escort her out of the building without an explanation or a warning, according to a source familiar with the matter. Bondi later said in an interview with Fox News that she fired Hicks because "these people were targeting gun owners".

Bondi had ordered the ATF to shift its focus to helping the Department of Justice target illegal immigration and shift away from its role of regulating arms, tobacco and alcohol.

Patel would be one of several Trump administration officials to take

Secretary of State Marco Rubio is also serving as acting administrator of

States Agency for the United International Development, which Trump wants to dissolve and fold under State Department control.

### Pope Francis in critical condition but alert

VATICAN CITY: Pope Francis in condition critical battling double pneumonia, had a "tranquil" night, was alert and had rested after a respiratory crisis and blood transfusions, Vatican yesterday.



The pope was admitted to Rome's

Gemelli hospital on Feb 14 after experiencing difficulty breathing for several days and subsequently had pneumonia diagnosed in

The Vatican described his condition as critical for the first time on Saturday, reporting that the 88-year-old Francis had needed supplemental oxygen and blood transfusions that day after a "prolonged asthma-like respiratory crisis".

"The night was tranquil, the pope rested," the Vatican said in a one-sentence update yesterday morning without providing further information.

A Vatican official, who did not wish to be

named because he was not authorised to speak about the pope's condition, said that Francis was awake and alert yesterday. The pope was receiving oxygen as needed via a small tube under his nose, but was breathing unaided, the official added.

In a written message for his usual Sunday prayer in St Peter's Square, which the pope was unable to give for a second consecutive week, Francis said he was continuing "confidently" with his treatment in hospital. He thanked his doctors and people who have sent him messages of

Archbishop Rino Fisichella, a senior Vatican official, told participants at a Mass in St Peter's Basilica yesterday they should make their prayers for Francis "stronger and more intense"

Double pneumonia is a serious infection that can inflame and scar both lungs, making it difficult to breathe. – Reuters

### Sudan rebels, allies sign parallel govt charter

NAIROBI: Sudan's paramilitary Rapid Support Forces and its allies have agreed to set up a parallel government, sources said yesterday, despite warnings such a move could further fragment the war-ravaged country.

"It's done," a source close to the organisers of

the signing ceremony in Nairobi told AFP.

The signatories said the charter paves the way for a "government of peace and unity" in rebel-controlled areas of the northeast African

country.

The move comes nearly two years into a devastating war with the regular army that has uprooted more than 12 million people and caused what the United Nations calls the world's worst hunger and displacement crises.

The signing, delayed many times, took place

behind closed doors in the Kenyan capital.

Among those who agreed to it was a faction
of the Sudan People's Liberation MovementNorth, led by Abdelaziz al-Hilu, which controls parts of the southern Kordofan and Blue Nile

Abdel Rahim Daglo, deputy and brother of RSF commander Mohamed Hamdan Daglo, who

was notably absent, also signed.

The charter calls for "a secular, democratic, decentralised state based on freedom, equality, and justice, without bias towards any cultural, ethnic, religious, or regional identity".

It also outlines plans for a "new, unified, professional, national army" with a new military doctrine that "reflects the diversity and plurality characterising the Sudanese state".

The proposed government aims to end the war, ensure unhindered humanitarian aid and

integrate armed groups into a single force.

The signing follows a rift within Sudan's largest civilian coalition, Taqadum, over the formation of the new government. - AFP

## Gaza truce gravely endangered, says Hamas

#### Israel expands West Bank military offensive

TEL AVIV: Hamas vesterday said Israel has gravely endangered a five-week-old Gaza truce by delaying the release of Palestinian prisoners under the deal because of the manner it has freed Israeli hostages.

The first phase of the truce ends early in March and details of a planned subsequent phase have not been agreed.

With tensions again hanging over the deal,

which halted more than 15 months of war, Israel yesterday announced an expansion of military operations in the occupied West

The military said a tank division will be sent in to the West Bank city of Jenin, the first such deployment to the territory in 20 years.

Since the Gaza ceasefire's first phase began on Jan 19, Hamas has released 25 living Israeli hostages in ceremonies before crowds at locations in Gaza.

Armed masked fighters escort the captives onto stages adorned with slogans. The

hostages have spoken and waved in what Israeli Prime Minister Benjamin Netanyahu called "humiliating ceremonies".

The Red Cross has previously appealed to "all parties" for the swaps to be carried out in a "dignified and private" manner. In the seventh such transfer, Hamas

released six Israeli captives on Saturday but Israel put off the planned release of more than

600 Palestinian prisoners in exchange.
Senior Hamas official Bassem Naim said postponing the release exposes "the entire agreement to grave danger".

Naim said the mediators, "especially the Americans", must pressure Israel's government "to implement the agreement as it is and immediately release our prisoners."

Both sides have accused each other of

violations during the ceasefire but it has so far

Netanyahu's office said early yesterday that, "In light of Hamas' repeated violations – including the disgraceful ceremonies that dishonour our hostages and the cynical use of hostages for propaganda - it has been decided to delay the release of prisoners."

Israel's military offensive in Gaza has killed

more than 48,000, according to figures from

The war drew in groups around the region, including in Lebanon where Israel in November reached a separate ceasefire with Hezbollah

Alongside the Gaza war, which displaced almost the entire population of 2.4 million, violence has also soared in the West Bank.

Israel's military said yesterday "a tank division will operate in Jenin" as part of 'expanding" operations in the area, where the military began a major raid against gunmen just after the Gaza truce began.

The United Nations has said the military activities have led to "forced displacement" of 40,000 Palestinians from Jenin and other refugee camps.

Defence Minister Israel Katz said he has told troops "to prepare for a prolonged presence in the cleared camps for the coming year and to prevent the return of residents

and the resurgence of terrorism."

In the West Bank as well as in Gaza, families of Palestinian prisoners had waited with uncertainly into the night on Saturday, hoping for their release.

In the city of Khan Younis, Umm Diya al-Agha, 80, said she had received word her son was among those scheduled to be freed, after 33 years in prison. - AFP

## Tens of thousands mourn slain Hezbollah leader

**BEIRUT:** Tens of thousands of people gathered on the outskirts of Beirut yesterday to pay their respects to Hezbollah's slain leader Hassan Nasrallah, nearly five months after he was killed in an Israeli airstrike. The killing of Nasrallah, who led the group

through decades of conflict with Israel and oversaw its transformation into a military force with regional sway, was one of the opening salvos in an Israeli escalation that weakened Hezbollah.

Carrying pictures of Nasrallah and Hezbollah flags, supporters gathered early yesterday for a mass funeral for Nasrallah and other slain leaders of the group at a stadium in the Hezbollah-controlled southern suburbs of

The 55.000-seat Camille Chamoun Sports

City stadium was nearly full hours before the ceremony was set to start.

Iranian Foreign Minister Abbas Araqchi, an Iraqi delegation including politicians and militia commanders, and a delegation from Yemen's Houthis were expected to attend.

The mass funeral is aimed at showing strength after Hezbollah emerged battered from last year's war with Israel, which killed most of its leadership and thousands of fighters and wreaked destruction on south

impact on Hezbollah compounded by the ousting of its ally Bashar al-Assad in Syria, severing a key supply route.

"We may have lost a great deal as a man, but we have not lost the value of the resistance because the resistance is clinging on," said Hassan Nasreddine, a Lebanese man headed to the ceremony from the south.

The funeral was also being held for Hashem Safieddine, who led Hezbollah for a week after Nasrallah's death. He was killed in an Israeli strike before he had been publicly announced

After his death, Nasrallah was buried temporarily next to his son, Hadi, who died fighting for Hezbollah in 1997. His official funeral was delayed to allow time for the withdrawal of Israeli forces from south Lebanon under the terms of a US-backed ceasefire which ended last year's war.

Though Israel has largely withdrawn from the south, its troops continue to hold five hilltop positions in the area, and Israel carried out airstrikes yesterday. - Reuters

## Greening our solar panels

OLAR photovoltaic (PV) technology is transforming how we harness and utilise energy. It provides clean electricity for homes, businesses and entire communities, reduces carbon emissions and plays a crucial role in combatting climate change.

combatting climate change.

However, there is a lesser-known side to this green revolution: the environmental challenges posed by PV panels when they reach the end of their life cycle. These challenges encompass technological, environmental, economic and legal aspects.

We must ask ourselves a vital question: How can we ensure that the end of clean energy is as green as its beginning? When PV panels reach the end of

When PV panels reach the end of their lifespan, they do not simply vanish. Each panel contains materials such as silicon, aluminium and glass, and sometimes hazardous substances like lead and cadmium.

If old panels are disposed of improperly, these harmful materials can leach into the soil and water, contaminating the environment. This pollution can persist for years, impacting ecosystems and human health.

Europe has taken steps to address this issue, with strict laws requiring PV panel recycling. These laws establish clear responsibilities for manufacturers and provide guidelines for managing old panels.

However, in other major markets like the United States, China and Australia, recycling largely depends on voluntary efforts.

According to Peter Majewski from Future Industries Institute, University of South Australia, Australia, without legal mandates, manufacturers, users and governments often lack clarity about who should take responsibility. This uncertainty prevents the creation of effective recycling systems and limits the potential for economic growth in the recycling industry.

Recycling PV panels entails a significant technical challenge. Research indicates that materials such as silicon and metals can be extracted and reused but the process is expensive.

High costs discourage companies from investing in recycling technology

and establishing facilities.
Furthermore, in many regions, the limited quantity of old panels available for recycling makes it difficult to justify the investment.

According to the *Energy Policy* journal, another issue is the limited market demand for recycled materials, which reduces the financial incentive to recycle. Without proper economic support, the process remains costly with little immediate returns

which reduces the mancial incentive to recycle. Without proper economic support, the process remains costly with little immediate returns. According to a research, titled "Recycling of Solar PV Panels: Product Stewardship and Regulatory Approaches," without clear regulatory frameworks, recycling will remain underdeveloped in many areas.

Legal systems complicate matters further. Different countries have varying rules on how to handle old PV panels, making it difficult to manage panels that are traded or moved across borders.

For example, one country may require recycling while another may have no regulations at all. This inconsistency creates gaps in the global effort to handle PV waste responsibly.

effort to handle PV waste responsibly.

At the same time, the lack of clear producer responsibility means manufacturers often have no incentive to design panels that are easier to recycle, leading to missed opportunities for innovation in sustainable design.

To address these challenges, science

To address these challenges, science and law must work hand in hand. Governments can enact laws that hold manufacturers accountable for the full life cycle of their products while encouraging the design of panels that are easier to disassemble and recycle.

They can also offer financial incentives, such as tax breaks, low-interest loans or grants, to drive investment in recycling technology. Supporting pilot projects for recycling facilities can showcase scalable models for broader implementation.

"By integrating rigorous research with clear policies, we can ensure that solar energy remains sustainable from production to disposal. This effort is not only about protecting the planet, it is also about taking responsibility for the legacy we leave behind.



## Prioritise children's mental health

HE mental health of children is increasingly becoming a critical issue worldwide, and Malaysia is no exception.

A local daily recently highlighted this concern, and the information and discussion presented paints a morbid picture.

This issue is even more alarming considering that physical health concerns often dominate public discourse while the psychological wellbeing of children remains overlooked.

With growing concerns over depression, anxiety and behavioural disorders among young individuals, the call is loud but the action is rather tepid.

Globally, mental health disorders affect 10 to 20% of children and adolescents, according to the World Health Organisation (WHO). Yet, many cases go undiagnosed and untreated due to stigma, lack of awareness and insufficient mental health resources.

A study published in the journal *The Lancet* 

A study published in the journal *The Lancet* found that nearly half of all mental disorders begin before the age of 14, making early intervention crucial.

begin before the age of 14, making early intervention crucial.

Malaysia is facing a similar crisis. The National Health and Morbidity Survey (NHMS) 2019 reported that 424,000 children in the country suffer from mental health problems, accounting for approximately 8.1% of those aged between five and 15. These figures indicate that children's mental health requires urgent attention from parents, educators and policymakers.

Children experiencing mental health problems often face difficulties in academic performance, social interactions and overall development. Depression and anxiety can lead to a lack of motivation, low self-esteem and, in severe cases, suicidal thoughts.

severe cases, suicidal thoughts.
Alarmingly, the NHMS 2019 also revealed that 10% of Malaysian teenagers have considered suicide, and 7.9% have attempted it. This data highlights the devastating consequences of

ignoring mental health concerns in children.

Furthermore, children with untreated mental health disorders are more likely to develop substance abuse problems and engage in self-

harming behaviours as they grow

According to Unicef (United Nations Children's Fund) Malaysia, bullying and cyberbullying have also contributed significantly to declining mental health among Malaysian children, especially with the rise of social media.

One of the major challenges in addressing children's mental health is the stigma attached to seeking psychological help

seeking psychological help.
In many cultures, including Malaysia, mental health issues are often dismissed as mere misbehaviour or a phase that children will outgrow. This misconception prevents parents and guardians from seeking professional help for their children.

Additionally, Malaysia faces a shortage of child psychologists and psychiatrists. According to the Malaysian Psychiatric Association, the country has only about 500 registered psychiatrists, far below the WHO's recommendation of one psychiatrist per 10,000 people.

psychiatrist per 10,000 people.

This lack of resources makes it difficult for affected children to receive timely and adequate mental health care.

In this scenario, schools play a crucial role in the early detection of mental health problems in children. Teachers and school counsellors should be equipped with basic training in identifying signs of distress, such as social withdrawal, sudden academic decline and frequent mood swings.

Implementing mental health awareness programmes within school curricula can help reduce stigma and encourage

reduce stigma and encourage children to speak up about their struggles.

Family support is equally vital. Parents and caregivers must be more attentive to their children's emotional needs. Open conversations about feelings, stress and anxieties should be normalised at home to create a safe space for children to express themselves without fear of judgement.

Recognising the urgency of the issue, the government has taken steps to improve mental health services. The 12th Malaysia Plan (2021-2025) includes mental health as a priority, aiming to increase mental health literacy and expand access to psychological services in schools and community centres.

and community centres.
Initiatives like *Talian Kasih*15999, a mental health helpline, provide immediate counselling for children and teenagers in distress.

distress.

Non-governmental organisations, such as Befrienders
KL and Mental Illness Awareness

and Support Association (Miasa), also play a significant role in advocating for mental health awareness and providing support for affected children and their families.

While Malaysia has made progress in acknowledging mental health issues among children, more needs to be done.

Increasing the number of child psychologists, integrating mental health education into school

curricula and reducing the stigma surrounding mental health are essential steps towards ensuring better mental well-being for Malaysian children.

Where do counsellors fit in?

Counsellors play a vital role in addressing children's mental health by providing early intervention, emotional support and essential coping strategies.

As the first line of defence in schools and communities, they can help identify signs of anxiety, depression and behavioural issues, ensuring timely support before these challenges escalate.

They also serve as a bridge between children and specialised mental health professionals, referring severe cases for clinical treatment when necessary.

Beyond working with children, counsellors can educate parents and teachers on fostering a supportive environment and reducing stigma, making mental health care more accessible and accented in society.

unfortunately, Malaysia has around 11,000 registered counsellors under the Malaysian Board of Counsellors and it is still insufficient to meet the rising demand for mental health services.

The ideal ratio recommended by WHO is one counsellor per 1,000 students in schools, yet Malaysia falls short of this benchmark. Additionally, experts suggest that Malaysia needs at least 20,000 counsellors to effectively address the mental health needs of the population. Hence, while the race and battle rages on, we

Hence, while the race and battle rages on, we as individuals, in our respective roles can take the first step towards becoming better informed.

## **Boosting Malaysia's inbound tourism**



**TOURISM** is a term that can be vague when used broadly or misapplied to recreational activities that generate no income, such as visiting natural sites like beaches and jungles, or manmade areas with free public access, such as city streets and parks.

city streets and parks.

The United Nations World Tourism Organisation defines tourism as a social, cultural and economic phenomenon which entails the movement of people to countries or places outside their usual environment for personal or business/professional purposes.

The above definition is suitable for academics and tourism students, but for the vast majority in the tourism sector, it sounds like jargon and serves little practical purpose in the industry.

It is more meaningful to describe tourism as

It is more meaningful to describe tourism as a massive industry, with the main expenditures being shopping, accommodation, food and beverages, transport, entertainment and attractions.

Taking travel into account, the tourism business can be divided into outbound tours for travelling overseas, inbound tours for incoming tourists and domestic tours for travel within the country.

While outbound tour fares are primarily spent overseas, fees collected for inbound and domestic tour services remain within the country. Additionally, the services for inbound and domestic tours are largely the same, with the main difference being that inbound passengers typically pre-book their services before entering Malaysia.

Many assume that domestic tour packages are only for Malaysians but most are actually sold

to foreigners already in the country. These could be visiting tourists who prefer to purchase sightseeing tours upon arrival or foreigners living here, including students, expatriates and

their family members.
Few Malaysians travelling within the country purchase domestic tour packages as most have their own vehicles or use public transport. They can also book their flights and accommodations directly, without needing to pay for services provided by travel agencies.

The success of a nation can also be

determined by its inbound tourism, which not only brings in foreign exchange but also foreign investments. There is a strong correlation between inbound tourism and foreign investments, both at the national level and within its various regions or states.

Last year, Malaysia's inbound tourism nearly reached 2019 levels. The four years from 2020 to 2023 are not suitable for comparison as they were heavily impacted by Covid-19. However, 2024 will serve as the new benchmark for comparing performance in the years to come.

In 2024, we received 25,016,968 tourist arrivals, less than the 26,100,784 in 2019. However, the number of excursionist arrivals rocketed to 12,944,787 from 8,944,841 in 2019. Overall, we had 37,961,484 foreign visitors in 2024 compared with 35,045,625 in 2019.

Foreign tourists spent RM102.2 billion, or an average of RM4,086.60 per person while foreign excursionists spent only RM4.5 billion or an average of RM348 per person during their few hours in our country, including the large numbers of cruise ship passengers on shore excursions.

In terms of per capita expenditure, a foreign tourist is 11.7 times more valuable than a foreign excursionist. In other words, one million foreign tourists is equivalent to 11.7 million foreign excursionists. The tourism business is driven by numbers, and receipts are more important than arrivals.

However, the likelihood of their return for

future visits is the same. Therefore, we must treat all visitors with the same care and respect, including those staying at hostels and budget hotels, as they could return as successful executives or business people, bringing many family members and friends along with them.

Last year, the top six nationalities that made up the most number of visitors to Malaysia were from Singapore, Indonesia, China, Thailand, Brunei and India. Combined, they totalled 32,092,389, or 84.5% of all foreign arrivals.

Focusing on these six nationalities makes sense for those looking to make a significant impact in Malaysia's inbound tourism.

However, there is also potential for businesses to target niche markets they specialise in. Ultimately, success depends on understanding and acting on the relevant facts and figures.

## International reserves rise to US\$117.7 billion as at Feb 14: BNM

KUALA LUMPUR: Malaysia's international reserves rose to US\$117.7 billion (RM519.9 billion) as at Feb 14, 2025, from US\$116.4 billion on Jan 31, 2025, according to Bank Negara

Malaysia (BNM).

The central bank said the reserves position is sufficient to finance five months of imports of goods and services and is 0.9 times the total short-term external debt.

The main components of the reserves were foreign currency reserves (US\$105.2 billion), International Monetos; 50.2 billion), international wione-tary Fund reserves position (US\$1.2 billion), special drawing rights or SDR (US\$5.7 billion), gold (US\$3.3 billion) and other assets (US\$2.3 billion).

Total assets amounted to RM634.34
billion, comprising gold and foreign
exchange and other reserves, including
SDR (RM527.02 billion), Malaysian
government papers (RM12.95 billion),
deposits with financial institutions

The central bank said total capital and liabilities amounted to RM634.34 billion, comprising paid-up capital (RM100 million), reserves (RM196.07 billion), currency in circulation (RM176.33 billion), deposits by financial institutions (RM124.49 billion), institutions (RM124.49 billion federal government deposits (RM15.61 billion), other deposits (RM79.87 billion), Bank Negara papers (RM10.71 billion), allocation of CDP (PM26.19 billion) SDR (RM28.18 billion), and other liabilities (RM2.96 billion).

## Asteel unfazed by US tariff hikes on steel, aluminium

KUALA LUMPUR: Sarawak-based Asteel Group Bhd sees the United States' recent move to increase tariffs on imported steel and aluminium to 25% from 10% as an opportunity to expand regional trade within Asean and explore alternative markets

Group managing director Datuk Seri Victor Hii Lu Thian (*pic*) said since Asean governments are already implementing measures to manage cheap imports, the company believes Malaysia should

adopt similar strategies.

He said Asteel, which has partnered with Tokyo-based Marubeni-Itochu Steel Inc, is positioning itself to enhance regional collaborations and expand market

reach beyond traditional partners. "The imposition of a 25% tariff on imported steel and aluminium into the US will likely lead to trade diversion, increasing the influx of steel products into Malaysia. This could disrupt the balance in the domestic steel market, affecting export oppor-tunities and inten-

sifying competi-tion from redirected supplies, parti-cularly from China.

Recently, International Trade

Company sees it as an opportunity to step up regional trade within Asean and explore new markets, says managing director

South Korea, Japan, and Vietnam,"

He said the global shifts in trade flows due to these tariffs could result in price volatility and supply chain instability.

"Countries previously exporting

to the US may seek alternative markets, causing fluctuations in supply and demand. Asteel is closely monitoring these developments to mitigate risks and ensure a stable supply chain for our operations and customers," Hii said.

Reuters recently reported that US President Donald Trump ordered a 25% import tax on all steel and aluminium entering the US, ending previous exemptions for allies including Canada and the European Union and marking a major expansion of trade barriers.

Hii said that to mitigate negative effects and capitalise on opportunities, the government should reinforce anti-dumping legislation, expedite investigations and imple-ment protective measures against unfair trade practices.

"Decisive action is necessary to prevent lasting damage to Malaysia's steel industry, ensuring fair com-petition and sustainable growth. Asteel urges authorities to step up enforcement against illicit steel imports, as seen in recent seizures by the Customs Department."

and Industry Minister Tengku Datuk Seri Zafrul Tengku Abdul Aziz said Malaysia currently has a moratorium on establishing new steel and aluminium plants and expanding existing facilities due to

expanding existing facilities due to concerns about potential overcapacity in the country.

He said while recent developments in the US may raise questions, Malaysia is not a significant exporter of steel and aluminium to the US. "Our primary exports to the US are in the electrical and electronic scene." electrical and electronics sector, making the impact of any US actions on steel and aluminium exports negligible."
Asteel chief business develop-

ment and corporate affairs officer Fong Fui Yee said Malaysia's steel demand is expected to remain stable despite global economic uncertainties.

He said the rapid growth of data centres would be driven by key sectors, including infrastructure, construction and manufacturing. "Asteel anticipates continued "Asteel anticipates continued growth in these areas and is committed to supplying high-quality steel products to support national development initiatives." Fong noted that Asteel has been involved in significant projects, including the PMG13 millor Elminatives."

## Sports Toto reports improved revenue and pre-tax profit for Q2'25

PETALING JAYA: Sports Toto Bhd (SPToto) reported revenue of RM1.48 billion for the second quarter ended Dec 31, 2024 Q2'25), an increase of 8.3% compared to revenue of RM1.37 billion in the corresponding quarter of the previous year.

The group's pre-tax profit im-proved by 71.8% to RM82.64 million in the quarter under review, from RM48.12 million in the corresponding quarter last year

In the quarter ended Dec 31, 2024, subsidiary STM Lottery Sdn Bhd achieved revenue growth of 6.1% compared to the corresponding quarter of the previous year, primarily driven by improvement in average sales per draw and higher accumulated jackpot prizes in Lotto games, despite having only 41 draws in the quarter under review compared to 42 draws in Q2'24.

Pre-tax profit increased by 31.5%,

primarily attributed to a combination of higher sales and lower prize payout in the quarter under review.

Meanwhile, subsidiary HR Owen Plc's revenue increased by 9.4% in O2'25 compared to the corresponding quarter of last year. Sales growth was primarily driven by positive demand within the used car sector contributed by better sales volume and increased average selling price. The new marque,

Lotus, which is now represented by HR Owen, has also generated new sales. HR Owen reported a reduced pre-tax loss of RM7.8 million compared to a loss of RM15.8 million in the same quarter of last year. The narrower loss reflects revenue growth amid the

challenging economic environment in the United Kingdom.

For the six-month period ended

Dec 31, 2024, the group's revenue was

lower by 1.3% to RM2.92 billion, mainly attributed to lower sales recorded by STM Lottery and HR Owen. Despite the drop in revenue, the group reported a 9.5% increase in pre-tax profit to RM151 million for Q2'25 from RM137.9 million in Q2'24, mainly driven by improved results

from STM Lottery.

For the period under review, STM Lottery reported a slight decline in revenue of 1.9% mainly due to fewer draws conducted (81 draws versus 84 the in previous

corresponding period). Despite the drop in revenue, pre-tax profit increased by 10.5% mainly attributed to lower priźe payout.

HR Owen reported an increase in revenue of 2.4% compared to the previous year's corresponding period, with positive demand within the used car sector alongside a mix of sales volume and increased average selling price. The Lotus brand with its commencement of deliveries during the current reporting period also contributed to the increase in revenue. However, due to unfavourable foreign exchange, it reported a marginal drop

in revenue of 0.5% when converted into ringgit, being the reporting currency of the group.

HR Owen reported a higher pre-tax loss of RM19.3 million compared to a pre-tax loss of RM15.5 million in the previous year's corresponding period. previous year's corresponding period, attributed to higher operating

expenses incurred associated with the expenses inclumed associated wint the additional new marque, as well as weaker new car sales due to under-performance of certain existing brands represented. SPToto's board has declared a

second interim dividend of 2 sen per share, amounting to about RM26.7 million, for the financial year ending June 30, 2025. The dividend is payable on April 18. The total dividend distri-bution for the financial period ended Dec 31, 2024 is about RM53.7 million. Directors of SPToto remain

cautiously optimistic that the group's business will remain steadfast.

## Pay closer attention to compliance

proper compliance can be very expensive in the form of additional LP+ MATTERS taxes, penalties and surcharges. And in the event that any failure is prosecuted, the tax-payer or the represent-atives of the organisation

can be imprisoned.
In the case of corporates, the government is a de facto stakeholder who generally collects 24% of profits as taxes Surprisingly, many owners or boards companies abdicate responsibility rather than delegate under supervision to their management to internally prepare tax computations or outsource the work to their tax agents. Many directors may not know the details of the tax computations.

#### How is tax computed?

There is a general misconception that

taxable profits are derived from accounting profits. The basis of taxation is set out step-by-step in

the Income Tax Act, and calculating taxes follow specific rules. However, in practice, the accounting profits are used as a starting point, and adjust-ments are made to the accounting profits to arrive at the taxable profits which will be different from the

accounting profits

#### Where is the gap?

Since this is an annual requirement, there is a tendency for tax preparers especially in organisations where there is no change in the business to do a "copy and paste" from the previous year's tax computation, updating the numbers based on the current year financials. The person preparing the tax computation relies on the description in the ledgers or the management accounts, and very

often fails to check the underlying details of the income or expenditure to ensure the accuracy or correctness of the transactions. Without this understanding, the tax computation can go badly wrong because of misapplication of the income tax rules. The increased volume of tax

regulations, tax rules, guidelines, rulings and notices of change of practices circulated by the Inland Revenue Board makes the preparation of tax computations time consuming. Unless close attention is paid to all these changes and the provisions in the Income Tax Act together with the supporting secondary legislation, mistakes can be easily made.

If there is any special expenditure incurred or actions taken by the company, for example, assets held for sale where during that year, you are not entitled to any capital allowances although the assets are still being used by the company. There are many other provisions such as

nition of received versus receivable. meaning of incurred, transfer pricing, and many more issues which can come up in one year and may not arise in the next year that can "trip

up" the tax preparer.
Since most taxpayers do not provide underlying documents to the tax agents, a serious gap will arise between the taxpayer and the tax agent in the tax treatment in the event there is a disconnect between the underlying documents and the ledgers provided to the tax agents.

Tax agents usually handle large volumes of tax returns and time is of essence to them. Unless a tax agent spends time to probe the taxpayer, he may not be able to uncover any mistakes because the taxpayer may have misunderstood or accidentally misrepresented information to the tax agent.

## **principles has widened**The divergence here also requires

much attention because in preparing the tax computation, the accounting treatment of the transaction must be unwound and given the proper tax treatment

An example is treatment of longterm lease payments, long-term concession transactions, etc. If the preparer does not understand the accounting treatment, it will lead to an incorrect tax treatment.

#### What should you do?

What should you do?

Boards of directors and senior
management should spend time
monitoring the output of the tax
computation to check at least the reasonableness of the tax positions. It is also extremely important that all tax preparers must keep abreast with the changes in the tax laws.

## JF Technology puts up positive performance in second quarter

On a quarter-on-quarter basis, the group's revenue rose 15.2% to RM11.5 million in Q2'25 from RM10 million in the preceding three months. The double-digit improvement stemmed from higher sales from Malaysia and China. Revenue from Malaysia jumped 37% to RM3.5 million in the quarter under review from RM2.6 million in O1'25. Sales from China improved to RM5.6 million in Q2'25, an increase of 33.4% from RM4.2 million in the preceding quarter. In tandem with this, net profit in the

quarter under review jumped to RM1.3 million

quarter under review jumped to RM1.3 million from RM0.3 million in Q1'25. Cumulatively, the group reported first-half FY25 revenue of RM21.4 million and net profit of RM1.7 million versus RM21.6 million and RM4.3

## Malakoff turns around with RM268.69m FY24 net profit

Significant improvement in group's earnings attributable to improved contributions from power plants in Tanjung Bin, Johor

PETALING JAYA: Malakoff Corporation Bhd recorded revenue of RM8.97 billion for the financial year ended Dec 31, 2024 (FY24), a decrease of 1% from the previous financial year's RM9.07 billion following a smaller energy payment contribution from Tanjung Bin Power Sdn Bhd, which is largely due to the lower Applicable Coal Price (ACP) during the year under review.

The group reported profit after tax and minority interests (Patmi) of RM268.69 million for FY24 compared to loss after tax and minority interests (Latmi) of RM837.16 million

The significant improvement in the group's earnings was attributable to improved contributions from its power plants in Tanjung Bin, Johor. The assets which sit in its subsidiaries Tanjung Bin Power and Tanjung Bin Energy Sdn Bhd, benefitted from the lower ACP pursuant to the stabilisation of

global coal prices.

The group said in a statement that it was not impacted by any share of loss or

impairment loss from foreign associates during the year under review, compared to the preceding finan-cial year which saw a substantial share of

loss from its 40% foreign associate in Bahrain, Al-Hidd Independent Water and Power

For the fourth quarter ended Dec 31, 2024 (Q4'24), the group posted revenue of RM2.16 billion, a decrease of 4.4% or RM99.4 million from RM2.26 billion in the quarter ended Dec

This was primarily due to the lower energy payment recorded from Tanjung Bin Power given the fall in the ACP, although it was partially moderated by higher energy payment contributions from Segari Energy Ventures Sdn Bhd and Prai Power Sdn Bhd

This means Malakoff recorded Patmi of RM26 million in Q4'24, an increase of RM383.1 million or 107.3% from the RM357.1 million Latmi reported in Q4 FY'23. The increase in profit was mainly due to higher contributions from Tanjung Bin Power, the

absence of any share of loss and/or impairment loss of the group's investment in the Middle East and a reduction in the group's financial costs following the repayment of selected borrowings and term loans, which saw the Malakoff's gross and net gearings decline to 1.39 times (Q4'23: 1.59 times) and 1.00 times (Q4'23: 1.04 times),

respectively.

Managing director and group CEO Anwar
Syahrin Abdul Ajib (pic) highlighted Malakoff's continued progress in strengthening its power generation capabilities, expanding its renewable energy (RE) footprint and advancing environmental solutions.

He said the group's strong performance in the financial year under review reflected the success of its strategic initiatives in transitioning towards sustainable development.

"We are actively expanding our RE initiatives to support Malaysia's clean energy transition. As



## Asia mulls crypto policy shifts

### > Hong Kong and Singapore are front-runners as nations race to cash in on booming sector

**SINGAPORE:** Hong Kong and Singapore are the front-runners in a push by Asian governments to become cryptocurrency hubs as they look to capitalise on the global resurgence of the sector thanks to the support of US President Donald

Bitcoin recently hit a record of close to US\$110,000 while others have also rallied on the back of

Trump's pro-crypto promises. With forecasts that they could rise further, governments are keen to get a piece of the action.

Hong Kong regulators said last

Wednesday that the city needed to tap "global liquidity" and laid out plans including the possibility of offering riskier crypto products such as derivative trading and margin financing.

"The one word that we need to think about always is liquidity," Eric Yip, an executive director at the Securities and Futures Commission (SFC), said at an industry conference in the financial hub.

"How do you bring liquidity to this market, hence commercial value, hence ecosystem?"

The collapse of exchange FTX in 2022 took along with it around US\$8 billion from customers who used it to buy, sell and store cryptocurrencies.

The funds were later recovered,

but regulators around the world are anxious to avoid a repeat, and the sector has since moved away from its freewheeling, anti-establishment origins to embrace regulation.

Officials stress the need for investor protection while still hoping their rules will be business-friendly.

"There was a lot more scrutiny "There was a lot more scrutiny two or three years (ago), right after FTX ... (Regulators) want to make sure that they do the proper due diligence," said Hong Fang, president of another exchange, OKX.

Officials in Malaysia and Thailand are mulling crypto-related policy shifts, while Japan, South Korea and Cambodia have made incremental moves, according to

incremental moves, according to Bloomberg News.

But Hong Kong and Singapore, along with Middle East standout Dubai, cemented their front-runner status during a period when US regulators under Joe Biden's administration were sceptical toward crypto.
In an executive order last month,

In an executive order last monin, Trump – who has pledged to make the United States the "crypto capital of the planet" – said he will instead provide "regulatory clarity and certainty" to support blockchain and digital asset innovation.

Animoca Brands group president Evan Auyang said the anticipation surrounding a new US playbook is a

game changer and will influence regulators worldwide.

Singapore's Monetary Authority has ued "Major Payment Institution" licences in relation to digital payment tokens to 30 companies, including OKX, which it added last year.

The city-state has had a head start in regulating digital assets, including with efforts such as the 2022 Project Guardian that brought regulators

together with major global banks to explore asset tokenisation.

That project showed Singapore "engaged early on central banks, and the singapore in the singap regulatory bodies, international standards setting bodies", Leong Sing Chiong from the Monetary Authority of Singapore said in November.

Hong Kong, which uses a different approach, has granted "Virtual Asset Trading Platform"

licences to 10 companies.

The Chinese finance hub is "number two ... behind Singapore" when it comes to crypto regulation,

said Animoca's Auyang. While Hong Kong has fewer exchanges, they saw a spike last year in terms of value received, according to blockchain research platform Chainalysis.
In the first half of 2024, Hong Kong's

centralised exchanges collectively received US\$26.6 billion, almost triple the year before and almost double Singapore's US\$13.5 billion.

Hong Kong overhauled its legal framework for crypto exchanges in mid-2023, with the SFC put in charge of vetting and licensing.

China has banned crypto since

2021 and exchanges in the semi-autonomous enclave cannot serve mainland Chinese clients.

But Yat Siu, executive chairman of Animoca Brands, said pro-crypto policies have Beijing's "blessing" and that Hong Kong benefits from

being China's financial gateway.

Aside from exchanges, the SFC said last weej it will explore a range of regulations, including for custody services, staking and over-the-counter

"Hong Kong isn't sitting back and saying, 'Look at the US, we're just going to sort of kick back," Yat Siu said. "It actually spurs it more into

However, regulators have learned

that the devil is in the details.

Hong Kong regulatory lawyer Jonathan Crompton said: "Anybody who engages in (exchange licensing) is going to have to commit to a very serious governance regime. It's not for the faint-hearted."

for the faint-hearted."

Over the past two years, some companies have reportedly found it challenging to hire specialised compliance personnel. The SFC vetting team, too, is understaffed.

The regulator's website lists eight pending candidates, while 13 have withdrawn their applications.
"The SFC has been stuck between

a rock and a hard place," Crompton

## Indonesia seeks to replant 120,000ha of oil palm

JAKARTA: Indonesia has set a target to replant 120,000ha of smallholders oil palm plantations and up to 10,000ha of smallholders' cocoa plantations this year, the chief executive of the state plantation fund said.

The agency, which collects and manages the palm oil export levy to fund government palm oil programmes including smallholder replanting and biodiesel funding, earlier this year went through a reorganisation process following a decision to include management of cocoa and coconut programmes.

"For cocoa and coconut replanting, regulations are being prepared especially on agriculture minister regulation as the basis of rejuvenation in cocoa and coconut," state plantation fund CEO Eddy Abdurrachman said

Abdurrachman said.

The agriculture ministry estimated that 282,378 hectares, or more than 20% of Indonesia's cocoa plantation, were damaged and pressuring output.

This year, the government

targets to replant between 5,000ha and 10,000ha of cocoa and coconut plantations each. Indonesia provides 60 million rupiah (RM16,000) per hectare to

replant unproductive oil palm

plantation owned by smallholders.
The agency has not shared the amount that will be provided for

cocoa replanting.
In 2024, the agency funded oil palm replanting for 38,247ha, below the targeted 70,000ha due to land legality issues and high palm oil prices. – Reuters

## Seven & i picks Bain as preferred buyer

in asset sale

TOKYO: Japan's Seven & i Holdings, operator of the 7-Eleven convenience store chain, has picked Bain Capital as its preferred buyer for a stake of its non-core assets, local media reported on Saturday.

Bain has been competing against rival private equity firm KKR and local buyout firm Japan Industrial Partners in bidding since late last year for a major stake in York Holdings, an entity that the

retailer plans to spin off.
Bain is believed to have offered a valuation of more than ¥700 billion (RM20.8 billion) for York Holdings, the *Nikkei* newspaper and Jiji news agency reported.

Nikkei cited a person it did not name, while Jiji did not specify where it received the information.

The retailer has sought to separate non-core businesses that include its supermarket operations into York Holdings.

The unit will house 31 subsidiaries including the group's superstores business, baby goods store Akachan Honpo and the company that operates Denny's restaurants in Japan. – Reuters

## XPeng eyes doubling global presence by year's end

SHANGHAI: XPeng, one of China's leading electric vehicle makers, plans to double the number of countries in which the company operates by the end of this year, its CEO said on Saturday.

Founded in 2014, XPeng is one of the Chinese firms in the sector with the strongest international ambitions, focusing in particular on cutting-edge technologies and design. "We are going to accelerate from

the 30 countries and regions where we were present in 2024," XPeng founder and chief executive officer He Xiaopeng told a news conference in the southern Guangzhou city, overseeing a shipment of XPeng cars to Thailand.

"This year, we will increase to 60 and will have established more than 300 after-sales service points worldwide,"

XPeng which designs high-end cars, already has stores in several European countries, including France,

Germany, Sweden and Norway.

"Over the 10-year period from 2024 to 2033, we expect half of XPeng's sales to come from outside China," He said.

The ambitious plan comes despite the obstacles posed by the European Union, which has imposed extra omion, which has imposed extra import tariffs on China-made electric vehicles of up to 35.3% after concluding Beijing's state support was unfairly undercutting European automakers

XPeng is banking that its bespoke reatures – such as driving assistance, rapid recharging and modular interiors – would help it stand out from the crowd in the fiercely

## **Berkshire Hathaway** reports record profit, cash

Buffett urges govt to spend money wisely and take care of less fortunate

NEW YORK: Berkshire Hathaway on Saturday reported record annual profits and boosting its cash stake to US\$334.2 billion (RM1.5 trillion), as Warren Buffett used his annual shareholder letter to caution Washington to spend money wisely and take care of those who get the "short straws in life".

straws in life."

Buffett's admonition came as many investors worry US lawmakers won't rein in soaring fiscal deficits, and could make them worse by extending tax cuts backed by President Donald Trump.

The 94-year-old, the world's sixth-richest person and arguably its most famous investor, also colorable and the straining the solutions.

also acknowledged his advanced age, telling shareholders he uses a cane and will spend less time fielding their questions at Berkshire's

annual meeting on May 3.

He nonetheless assured shareholders they would be in good hands after he turns over the conglomerate's reins to vice-chairman Greg Abel, saying the 62-year-old Abel has "vividly shown his ability" to deploy capital.

"It won't be long" before Abel takes over, Buffett said.

Buffett's letter was accompanied by Berkshire's annual report, where it reported a third straight record annual operating profit,

rising 27% to US\$47.44 billion.

Quarterly operating profit rose 71% to US\$14.53 billion, also a record, and which analysts viewed as solid.

Net income for the full year totaled US\$89 billion, including gains from Berkshire's common stock investments such as Apple and American Express.

Berkshire's cash stake reflected high business valuations and nine straight quarters of selling more stocks than it bought. The selling included Apple, which remained its

largest stock investment.

"Often, nothing looks compelling; very infrequently we find ourselves knee-deep in opportunities," Buffett wrote.

This year is Buffett's 60th at the helm of

Berkshire, which he transformed from a failing textile firm into a US\$1.03 trillion conglomerate with dozens of businesses in insurance, railroad, energy, industrial, retail and other sectors.

"Berkshire's activities now impact all corners of our country. And we are not finished," Buffett said.

Buffett said Berkshire will continue preferring equities, primarily US stocks, over

cash, even as it resists paying a dividend to shareholders, which it has not done since 1967.

He said reinvesting in Berkshire is one reason the Omaha-based firm paid US\$26.8 billion of federal taxes last year, 5% of all payments by corporate America.

Buffett himself is worth US\$149.5 billion,

Forbes magazine said,

But he also sent a cautionary message to Washington, lamenting how capitalism "has its faults and abuses - in certain respects more egregious now than ever", with malfeasance by "scoundrels and promoters" in full force.

He urged lawmakers to help preserve a stable US dollar, saying "fiscal folly" can destroy the value of paper money and the country has at times "come close to the edge".

Buffett said long-term success of Berkshire and the American economy, which he called the "American miracle," has depended on people's ability to participate.

That, he said, is something Uncle Sam can

encourage, or take away.

"Take care of the many who, for no fault of their own, get the short straws in life. They deserve better," Buffett wrote, addressing the government.

"And never forget that we need you to maintain a stable currency and that result requires both wisdom and vigilance on your part," he added. - Reuters

## Argentina's Milei praises American plan for reciprocal tariffs

**WASHINGTON:** Argentine President Javier Milei met with Donald Trump on the sidelines of a gathering of US conservatives on Saturday, where he praised his American counterpart's reciprocal tariffs plans that have shocked trading partners.

Addressing the yearly Conservative Political Action Conference (CPAC) near Washington, the ultra-libertarian president often echoed Trump's positions as he attacked what he called "a political class with a God complex".

Trump, whom Milei sees as an ideological ally, has vowed to impose reciprocal tariffs beginning April 2 - applying the same fee levels to imports that other countries place on US products.
Milei said he wanted to make Argentina "the

first country in the world to join this reciprocity agreement that the Trump administration is asking for in trade matters".

Trump has also threatened to impose 25%

tariffs on steel and aluminum imports.

Argentina is one of the Latin American countries that would be most affected.

Milei doubled down on a series of Trump positions, approving the dismantling of aid agency USAID and – in words echoing a speech by Vice-President JD Vance – castigating European countries which he said had arrested people "for

expressing themselves on social networks".

Milei also defended his "dear friend" Elon

Musk, the billionaire businessman tasked by Trump with engineering stark budget cuts.

It was Milei who last Thursday presented Musk with a chainsaw, which the Tesla and

SpaceX boss proudly flaunted on the CPAC stage. Milei said his own government would "use a chainsaw" to hack through state programmes deemed "superfluous, redundant, unneces or directly harmful".

Under Milei, Argentine inflation has fallen but the poverty rate last year surpassed 50%, according to official data. – AFP

## **Trump orders** tighter curbs on China investments

WASHINGTON: US President Donald Trump has signed a memo calling for curbs on Chinese investments in strategic sectors such as technology and critical infrastructure, a move Beijing slammed on Saturday as "discriminatory".

The move, including an expanded role for a foreign investment review panel, comes at a time of growing trade tensions and strategic competition between the world's two biggest economies.

It is aimed at promoting foreign investment in the United States, while protecting US national security interests "particularly from threats posed by foreign adversaries" like China, the White House said.

The memo signed on Friday singles out

China for "increasingly exploiting United States capital to develop and modernise its military, intelligence, and other security apparatuses".

China's Commerce Ministry spokesperson on Saturday said the "US approach unduly broadens the concept of national security, and is discriminatory".

It will "seriously hurt the confidence of

Chinese enterprises willing to invest in the United States", the spokesperson said in a statement.

"China will closely follow the moves of the US and take necessary measures to safeguard its legitimate rights and interests," the spokesperson added

The memo called for the Committee on Foreign Investment in the United States (CFIUS) to be used to restrict Chinese investments in key US sectors such as technology, critical infrastructure, health care and energy.

CFIUS is a panel that weighs the national security implications of foreign investments in the Únited States.

"President Trump is keeping his promise to prevent foreign adversaries from taking advantage of the United States," the White House said. – AFP

### BMW to review timing of electric Mini production in UK

LONDON: BMW said on Saturday it is rethinking its timetable for manufacturing all-electric Mini cars in Britain, citing uncertainties facing the industry.

Mini announced in 2023 that it would invest £600 million (RM3.3 billion) in the UK to make its Mini brand all-electric by 2030 with production due to start in Oxford in 2026.

But BMW Group said on Saturday it was now rethinking that plan.

now rethinking that plan.
"Given the multiple uncertainties facing the automotive industry, the BMW Group is currently reviewing the timing for reintroducing battery-electric. Mini production in Oxford," it said in a statement.

Sales of electric vehicles have struggled to grow as much as expected.

The industry is also contending with US President Donald Trump's threat to impose a

25% tariff on all US auto imports.

Volkswagen's Audi has said it plans to expand its output in North America and Mercedes will also boost its US production.

In its statement, Mini said construction in Oxford was well underway "to make the plant future-ready" but it had told Britain's government of its decision to review the timeline.

"As part of this discussion, we agreed not to take the previously announced grant, but we remain in close dialogue about our future plans," the statement said. - Reuters

## Cautious trading expected on lack of fresh catalysts

**BURSA** Malaysia's main index is expected to trade within a range of 1,570-1,600 points this week due to a lack of fresh catalysts, an analyst said.

Rakuten Trade Sdn Bhd vice-president of equity research Thong Pak Leng said the online broker expects the market to maintain a cautious stance as funds continue to flow from emerging markets into Hong Kong and mainland China markets.

"That said, we believe foreign funds will return to the region in the near future, supported by stronger economic growth compared to the western bloc," he told Bernama.

Thong recommends that investors focus on large-cap sectors

such as banks, plantations, and telecommunications, while also considering domestic plays like construction and retail real estate

investment trusts for a defensive investment strategy.
"Should the benchmark index reclaim and maintain a position

above 1,590 for an extended period with strong volume, a move toward the next resistance level at 1,620 is likely," he added.

Meanwhile, Hong Leong Investment Bank (HLIB) said the FTSE Bursa Malaysia KLCI (FBM KLCI) is likely to remain in consolidation phase as long as it continues to close below the key 1,590 level.


It noted that investors will assess market developments, including local corporate earnings announcements this week,

global trade and geopolitical tensions, the US Federal Reserve's policy outlook, and potential stimulus policies from China.

For the trading week just ended, the FBM KLCI mostly declined, weighed by concerns over the US tariff policy set to take effect on April 2, raising fears about its impact on the global economy, inflation, supply chains, and investment plans.

On a Friday-to-Friday basis, the key index inched down 0.57 ofa-point to 1,591.03 compared with 1,591.60 a week earlier.

### Ibraco soars with 148% y-o-y profit growth in Q4'24

**KUCHING:** Ibraco Bhd, a property and construction developer in Sarawak, closed the financial year on a high note with a revenue of RM236.50 million for the fourth quarter ended Dec 31, 2024 (Q4'24), marking a significant 124% increase compared to RM105.42 million in the corresponding quarter of the previous year.

The impressive revenue growth was primarily fuelled by the continued momentum in the group's construction segment, which contributed RM130.33 million, or approximately 55% of total revenue in O4'24.

The segment's strong performance was largely driven by progressive revenue recognition from government construction contracts. Meanwhile, the Property segment also delivered solid contributions, reporting revenue of RM91.49 million in Q4'24, compared to RM69.68 million in the corresponding quarter last year, further supporting the group's overall financial performance.

Profit after tax for Q4'24 stood at RM22 million, reflecting a 148% increase compared to RM8.86 million in Q4'23

In addition to its strong financial results, the group is progressing well with two major projects in Sarawak – The NorthBank and Arden City.

"We are proud to deliver another solid quarter, demonstrating the resilience of our business strategy and the strong execution by our team," group managing director Datuk Chew Chiaw Han said.
"Our construction segment continues to be a key growth

driver, supported by a healthy order book. Looking ahead, we are optimistic about our prospects with upcoming property launches

The group declared an interim dividend of 2.0 sen per share for the financial year ended Dec 31, 2024.

### Ringgit set to reach RM4.36 to dollar on trade deal optimism

**THE** ringgit is expected to move towards its immediate support level of RM4.36 against the US dollar this week, driven by optimism surrounding a less aggressive tariff trade approach by Donald Trump's administration.

This follows the United States president's comments about a and the United States presidents comments about a potential new US-China trade deal, with markets anticipating a more targeted and gradual approach to high import tariffs. Trump also reportedly said that he expects Chinese President Xi Jinping to visit the US, although he did not provide a timeline for the trip. Russia and the United States on Tuesday agreed to start working toward a peace deal, with US Secretary of State Marco

Rubio saying the two sides agreed broadly to create a high-level team to support the Ukraine peace talks.

Bank Muamalat Malaysia Bhd chief economist Dr Mohd Afzanizam Abdul Rashid views the move positively.

"If this positive momentum continues, the ringgit is expected to move higher. However, several Federal Reserve (Fed) officials are scheduled to speak at public forums, and their views on interest rate direction and US monetary policy could influence financial markets, including foreign exchange markets:

The ringgit strengthened by 0.4% against the US dollar since last Friday, despite expectations that the Fed will keep interest rates steady in the near term. The ringgit appreciated to end the week at 4.4165/4200 from 4.4310/4385 the previous week.

The local currency weakened against the British pound to 5.5851/5895 from 5.5769/5863 and slipped versus the Japanese yen to 2.9346/9371 from 2.9048/9099 last week

However, it strengthened against vis-a-vis the euro to 4.6236/6273 from 4.6437/6515 previously. – Bernama

KOSSAN Rubber reported 4Q24 core net profit of RM23.6m, bringing its 2024 numbers to RM97.2m - accounting for 89% and of our and consensus' estimates. Its share price corrected 22% since our sector downgrade in January. Following the recent share price correction, we view its valuation as undemanding, trading at 0.4SD above mean. We believe Kossan deserves at least +1SD valuation given its relatively better margin profile and sizable exposure in the US, which should benefit from trade diversion opportunity.

Kossan's 2024 full-year results were below expectations, primarily due to unfavourable FX, offset by improved operating efficiencies. Revenue surged 2% QoQ to RM517.9m as its gloves and cleanroom division saw 7% and 8% growths, against a 33% QoQ decline from the technical rubber division. Assuming a blended ASP of US\$22/1000 pieces, we estimate a sales volume growth of 2% QoQ - implying plant utilisation rate of 80%.

PBT margin from the technical rubber division improved 6ppt

QoQ to 14.7%, mainly due to higher unrealised FX losses recognised in 3Q24. Its glove division saw PBT margin contracting

1.5ppt QoQ to 5.8%, as MYR strengthened against the USD.
Our sector downgrade at the start of 2025 had largely played out. Kossan is currently trading at 1.3x P/B, which is 0.4SD above its 2-year historical mean of 1.2x. However, we expect the 1Q25 results to likely be weaker QoQ on the back of a potential slowing down in sales volume due to the frontloading effect by US customers. We advise investors to look beyond the April/May period when the US channel inventory depletes, which should start to drive volume growth

UEM Sunrise's 4Q24 earnings beat estimates. Net profit surged, driven mainly by higher property sales and billings, and land disposals. Full-year sales of MYR1.418bn also surpassed management's RM1bn target. We believe the successful past launches and upcoming launches in Iskandar Malaysia will continue to drive earnings. Apart from being the best proxy for the multi-year growth story in Iskandar Malaysia, UEMS could be the Kuala Lumpur-Singapore high speed rail play if the Government reinstates the project.

The revenue and earnings growth was primarily driven by higher billings and property sales, as well as land disposals at both group and JV levels. In view of the better results, a 1.24 sen DPS was declared (FY23: 0.75 sen), representing a dividend payout ratio of 60% (vs 50% last year). Net gearing fell slightly to 0.40x, from 0.43x in the previous quarter.

4Q24 property sales totalled RM489.1m, compared with RM426m in 3Q24. UEMS' full-year property sales of RM1.418bn (FY23: RM2.138bn) significantly exceeded management's original target, largely attributed to the successful launches that mainly took place in Sep-Oct 2024. A total of RM904m worth of projects were launched in 2H24 alone (vs its initial plan of only RM800m for the year), and the projects in Iskandar Malaysia saw encouraging take-up. 

James Bond started life on the page, his name taken from the cover of a Jamaican bird-watching book because author Ian Fleming wanted something as mundane as

Fleming was able to draw from some rich real-life experiences, having served as a commander in the naval intelligence during World War II.

One of his key missions was Operation Goldeneye, aimed at operation Gotteneye, affect as abottaging ties between Spain and Germany, which later gave him the name for his Jamaican home and inspired the 1995 movie.

His first novel Casino Royale was

released in 1953 and was a huge hit. The escapades of a larger-than-life secret agent gave the British public a brief escape from the grim reality

## Online shopping giants bet on smart systems to curb clothes returns

FROM sizing advice via selfies to robot stock-takers, online shopping behemoths have increasingly turned to artificial intelligence (AI) in a bid to stem the flow of bad-for-business

clothes returns. Up to 30% of fashion items bought on the internet are sent back, according to a late 2024 study by consulting firm McKinsey and the Business of Fashion website – not least because 'clients are buying several sizes or styles and returning most of them".

That practice drags down profit margins. Each returned package costs between US\$21 (RM93) and US\$46 on average given the costs of transport, treatment and making the item fit for selling again, according to a separate McKinsey study.

"70% of returns are linked to a sizing issue," said Zoe Tournant, whose company Fringuant markets an Al-driven algorithm to fix that, charging clients between 5,000 (RM23,105) to 100,000 euros a year.

Armed with the customer's height. veight and a quick selfie taken on the phone, the French-based startup promises shoppers a better idea of what size would fit them best.

"With the selfie we detect their age, gender", to help "refine" the image of the customer's body fed into its AI model, trained for a year on thousands of photos, Tournant explained.

Within seconds that model is then matched up with the garment's dimensions provided by the brand to tell shoppers whether a jumper "falls perfectly on the shoulder" or if there are "doubts at the level of the hips" for

a pair of trousers.

Tournant said her firm has some
20 clients, including upmarket
womenswear label Maje, which she claimed has seen a dramatic drop in returns.

Similarly tempted by Al's promise, Zalando acquired Swiss start-up Fision in 2020, one of a raft of companies working in the size-

prediction niche.
Since July 2023 the German
heavyweight retailer has adopted its
own Al-driven sizing tool where
customers help avoid returns "by taking two photos of themselves with their phone while wearing tightfitting clothes", said Zalando.

Besides sizing, e-commerce firms are also counting on Al to help avoid returns caused by shipping errors and automate their stock counts.

At ID Logistics, which operates in 18 countries, the order pickers' trolleys are equipped with a smart camera to check that the colour or size of the product retrieved from the shelves matches the order.

The device immediately alerts the worker if they have picked up the wrong item.

In less than two years, this camera has "reduced by 90%" the number of incorrect parcels, explains Ludovic Lamaud, ID Logistics Director of

Development and Innovation.

Elsewhere in the warehouse, an independent robot "rammed with Al" likewise maps the premises to "update the stock according to what sees", processing "6,000 to 30,000 pallets a night".

"The right stock prevents preparation errors and therefore returns," said Lamaud. – AFP

## All about DeepSeek

### Breaking down key concerns about latest Al chatbot

EEPSEEK has quickly become one of the most talked-about artificial intelligence (AI) models, with its tustest releases, positioned as open-source rivals to OpenAl's frontier models. As excitement builds, so do concerns over security, privacy and regulatory scrutiny.

#### DeepSeek

DeepSeek refers to the large language model (LLM) produced by a Chinese company named DeepSeek, founded in 2023 by Liang Wenfeng. LLM is a machine-learning model that has been pre-trained on a large corpus of data, which enables it to respond to user inputs using natural, human-like responses.

#### Interest in DeepSeek LLM

In January 2025, DeepSeek published two new LLMs: DeepSeek V3 and DeepSeek R1. The interest surrounding these models is two-fold. First, they are open-source — meaning anyone can download and run these LLMs on anyone can download and run these LLMs on their local machines. Second, they were reportedly trained using less-powerful hardware, which was believed to be a breakthrough in this space as it revealed such models could be developed at a lower cost.

#### Differences between DeepSeek V3 and DeepSeek R1

DeepSeek V3 is an LLM that employs a technique called mixture-of-experts (MoE) that requires less compute power because it only loads the required "experts" to respond to a prompt. It also implements a new technique called multi-head latent attention (MLA), which significantly reduces the memory usage and performance during training and inference (the process of

generating a response from user input).
In addition to MoE and MLA, DeepSeek R1 implements a multitoken prediction architecture first introduced by Meta. Instead of just predicting the next word each time the model is executed, DeepSeek R1 predicts the

model is executed, DeepSeek In predicts the next two tokens in parallel.

DeepSeek R1 is an advanced LLM that utilises reasoning, which includes chain-of-thought (CoT), revealing to the end user how it responds to each prompt. According to DeepSeek, performance of its R1 model rivals OpenAI's o1 model.

## Minimum requirements to run DeepSeek model locally

DeepSeek R1 has 671 billion parameters and requires multiple expensive high-end GPUs to

run.

There are distilled versions of the model starting at 1.5 billion parameters, going all the way up to 70 billion parameters. These distilled models are able to run on consumergrade hardware. Here is the size on disk for each model:

Therefore, the lower the parameters, the less resources are required and the higher the parameters, the more resources are required.

The number of parameters also influences how the model will respond to prompts by the user. Most modern computers, including laptops that have 8GB to 16GB of RAM, are capable of running distilled LLMs with seven billion or eight billion parameters.

#### DeepSeek vs other LLMs

Benchmark testing conducted by DeepSeek showed its DeepSeek R1 model is on par with many of the existing models from OpenAI, Claude and Meta at the time of its release. Additionally, many of the companies in this space have not open-sourced their frontier LLMs, which gives DeepSeek a unique


Finally, its CoT approach is verbose, revealing more of the nuances involved in how LLMs respond to prompts compared with other reasoning models. The latest models from OpenAl (03) and Google (Gemini 2.0 Flash Thinking) reveal additional reasoning to the end user, though in a less verbose fashion.

#### Frontier model

A frontier model refers to the most advanced LLMs available that include complex reasoning and problem-solving capabilities. Currently, OpenAI's o1 and o3 models along

#### Onen source vs website

Deploying the open-source version of DeepSeek on a system is likely safer to use versus DeepSeek's website or mobile applications, since it does not require a connection to the internet to function.

However, there are genuine privacy and

security concerns about using DeepSeek, specifically through its website and mobile applications available on iOS and Android.

## Concerns surrounding using DeepSeek's

website and mobile applications
DeepSeek's data collection disclosure is
outlined in its privacy policy, which specifies
the types of data collected when using its website or mobile applications. It is important to note that data is stored on secure servers, although the retention terms are unclear. Since DeepSeek operates in China, its terms of

service are subjected to Chinese law, meaning consumer privacy protections, such as the European Union's General Data Protection Regultion and similar global regulations, do not apply. If you choose to download DeepSeek models and run them locally, you face a lower risk regarding data privacy.

**DeepSeek's ban** As of Feb 13, several countries have banned or As of Feb 13, several countries have banned or are investigating DeepSeek for a potential ban, including Italy, Taiwan, South Korea and Australia, as well as several states in the US have banned DeepSeek from government devices including Texas, New York, Virginia along with several entities of the US federal government, including the US Department of Defense, US Navy and the US Congress. This list is likely to continue to grow in the coming list is likely to continue to grow in the coming weeks and months.

## Research claims remote working causes 'Zoom fatigue'

SINCE the widespread adoption of remote working, online meetings have become part of the daily routine for many employees. While this practice facilitates remote collaboration, it also generates a growing feeling of fatigue, often referred to as "Zoom fatigue". A study published in the scientific journal *Plos One* highlighted a little-explored factor in this phenomenon: dissatisfaction with your appearance onscreen

Researchers at Michigan State University surveyed 2,448 American workers from a variety of professional sectors (technical, scientific and administrative), who often take part in virtual meetings in a professional context. They found people who are more dissatisfied with their physical appearance experience increased fatigue

during online meetings.

This discomfort leads them to make more frequent use of image management tools, such as filters, avatars or video editing options. However, these tricks do not just improve their appearance onscreen. They also alter their perception of the effectiveness of videoconferencing, and reduce

their willingness to use it on a long-term basis.

This study raised important questions about ergonomics and employee well-being in the digital environment. It revealed digital fatigue is not a matter of cognitive fatigue, but can be fuelled by psychological factors linked to self-image. Unlike

face-to-face encounters, online meetings give you a constant eye on your own reflection, which accentuates aesthetic concerns and amplifies mental fatigue. The authors of the study recommended new approaches to improve the experience of remote meetings.

"Our study highlights dissatisfaction with facial appearance contributes to Zoom fatigue, leading to reduced adoption of virtual meeting technologies," the researchers explained in a

Therefore, they suggested rethinking the functionalities of video conferencing platforms to better meet the socio-psychological needs of professionals. They also encouraged companies to consider the impact of these technologies on their employees' well-being, and to promote a more measured use of online meetings in their work organisation.

While the study has certain limitations — notably a panel made up solely of American workers and the impossibility of establishing a direct causal link — it paved the way for further research into the psychological challenges of online work. Companies, for their part, would be well advised not to underestimate this fatigue and to think about alternatives to make virtual meetings more comfortable and less draining. -ETX Studio

He is definitely not the scene-stealer in the film, but he delivers a grounded performance that suits his role well. His comedic timing, especially in the initial interactions especially in the initial interactions with Nithya's character, adds to the film's lighthearted tone. However, in some emotional sequences, his performance feels a little restrained, making certain key moments less impactful than they could have been. Vinay Rai is a refreshing presence in the film. His rule as a positive.

in the film. His role as a positive, mature character adds depth to the narrative. Vinay's role is written with dignity and warmth, making him a standout as a good friend and boyfriend.
Yogi Babu, as always, delivers on

the comic front. His impeccable timing and natural delivery ensure that the humour never feels forced. His interactions with both the leads add lightheartedness to the story, making the film more entertaining.

#### Strengths and weaknesses

The film starts off on a strong note, establishing its characters and premise in a fun, engaging manner. The first half is filled with witty dialogues, organic humour and fun storytelling, keeping the audience entertained. The modern approach to relationships and parenthood is refreshing, making the film relatable

to the younger generation.

However, the second half struggles to maintain the same momentum. While the emotional depth increases, some of the conflicts feel rushed. Certain moments that could have been explored with more nuance get resolved too quickly, making the climax slightly

without upsetting the US Congress, by having monsters in the unit instead. Following the attack on the fictional country of Pokolistan by the Amazonian sorceress Circe (Anya Chalotra), Waller puts a team together to protect the princess, consisting of the Bride of Frankenstein (Indira Varma), Doctor Phosphorus (Alan Tudyk), Nina Mazursky (Zoe Chao), G.I. Robot and Weasel (both voiced by Sean Gunn), Led by Rick Flag Sr. (Frank Grillo), "Task Force M" begrudgingly sets on their mission rife with problems, particularly when Eric Frankenstein (David Harbour) shows up to "save" his Bride.

**Bloody good precedent** A spiritual sequel to 2021's *The Suicide* Squad, Creature Commandos is the first official entry in the new DC Universe (DCU) created by James Gunn and Peter Safran, with the second entry being the new Superman later this year. The series is pretty much what anyone familiar with Gunn's films would expect, as Creature Commandos follows the template of "rag-tag group

together despite their differences that Gunn established with Guardians of the Galaxy over 10 years ago and re-established with The Suicide Squad. However, the core difference here

is the medium *Creature Commandos* is delivered in. Being an animated series, Gunn and showrunner Dean Lorey get a lot of room in pushing their content to the extreme, particularly the violence. This brings up a question on how the subsequent DCU titles will handle graphic violence or sexual themes. **Balancing light and dark**The series serving as a foundation to the DCU aside, *Creature Commandos* is still entertaining. Bearing a visual and comedic resemblance to the popular,

but niche animated series Archer, the

show fires on all cylinders at all times, whether its time for jokes, moments of seriousness or a combination of both.
Unlike his films, Gunn has more

room to expand on the characters he has. Waller is roped into Task Force M, with most of the episodes focusing flashbacks on each individual member of the team. G.I. Robot, an android created to kill Nazis during World War II, receives a sombre series of flashbacks, while characters such as the anthropomorphic, unintelligible

Weasel — who was brought back weaser — who was brought back from the 2021 film — and the Bride have dark backstories, particularly the latter with Gunn's not-so-subtle condemnation of "incel behaviour".

Overall, it is a tightrope display of balancing between the edginess of Zack Snyder's previous DC Cinematic Extended Universe and what made those early Marvel films fun. If Gunn keeps it up with the next DCU projects, maybe Warner Bros will finally find success in its DC Comics properties.



Faizal, one of the country's best strikers, said he plans to open a hockey academy in Pandamaran, Klang after Hari Raya Aidilfitri because he loves to teach children.

Faizal completed his second successful treble with THT after 2023 by defeating 2024 treble champions, Tenaga Nasional Berhad (TNB) 3-0 through a penalty shootout after the two teams were tied 1-1 in the final.

Faizal, his brother Fitri, and Syarman Mat Tee

managed to find the target to help THT emerge as champions.

THT previously won the Piala Sumbangsih (Charity Shield) title and maintained their unbeaten record in all nine matches to win the league.

THT head coach, Mohd Hafizi Baharom gave full credit to the players for the success of the treble and victory in the final.

"We didn't expect to win the treble by

maintaining an unbeaten record in all 12 matches.


