Initiatives to protect, ensure well-being of elderly citizens

Several measures introduced by Social Welfare Dept to provide financial assistance, social support and direct intervention for at-risk seniors

PETALING JAYA: The growing number of elderly and infirm Malaysians living alone, and in some cases dying unnoticed, has prompted the Social Welfare Department to intensify its efforts to safeguard such individuals and ensure they remain connected within the community.

Several recent cases highlight the severity of the issue, including the death of a 46-year-old woman living alone in Putrajaya on May 26 last year, reportedly due to a chronic illness.

In another tragic incident on July 12, an 85-year-old woman perished in a house fire in Kampung Bukit, Tumpat in Kelantan. Firefighters discovered her body in the bathroom, with burns on multiple parts of her body.

In another case, a 49-year-old man who was suffering from tuberculosis and diabetes was found lifeless in his home in Terengganu last year.

Recognising the devastating effects of isolation on mental and physical health, the department has introduced several initiatives to provide financial assistance, social support and direct intervention for at-risk seniors.

direct intervention for at-risk seniors. "The Social Welfare Department's primary goal is to help seniors age within their communities rather than in institutional care."

One of the government's key initiatives is the Welfare Aid for Senior Citizens Programme, which provides RM500 per month to low-income elderly individuals.

This support helps seniors cover basic needs and remain independent. In 2023, RM857 million was allocated, benefiting over 146,000 senior citizens.

Another initiative is the Bedridden Disabled Persons and Chronic Patient Care Assistance, which also provides RM500 per month to families caring for bedridden or chronically ill elderly relatives.

It said in 2023 alone, the scheme supported over 28,000 recipients, with a total allocation of RM165 million.

"For those who live alone or have no

immediate carers, the department's Home Help Services Programme will deploy volunteers to provide essential care and companionship.

"These volunteers assist with daily tasks such as meal preparation, personal hygiene care, companionship, recreational activities, housekeeping, laundry and medication reminders."

The department added that beyond financial and social support, the Domestic Violence Act 1994 has been strictly enforced to protect elderly individuals from abuse, neglect and mistreatment, while the National Policy for the Elderly promotes intergenerational engagement to strengthen family and community ties.

Additionally, under the Women, Family and Community Development Ministry, the department is also working to introduce a Senior Citizens Act, a law aimed at legally recognising and protecting the rights of abandoned or vulnerable seniors.

The Social Welfare Department has also set up activity centres for the elderly across the country, providing safe spaces where seniors can socialise, learn new skills and engage in community activities.

The department's Elderly Care Unit also provides transport services, ensuring seniors can attend medical appointments, social events and community programmes.

These initiatives aim to reduce isolation and eep seniors actively involved in society.

For seniors facing distress or emergencies, the department operates the Talian Kasih Helpline (15999 or WhatsApp 019-2615999) 24/7, all year round.

It is also working with welfare volunteer organisations through Home Help Services to ensure regular check-ins on vulnerable seniors.

With over 6,698 seniors currently receiving support through the Home Help Services, the department stresses that combating elderly isolation requires a united effort from families, communities and government agencies.

Woman reprimanded for allegedly insulting Prophet Muhammad

KUALA LUMPUR: The Islamic Development Department has reprimanded a woman, who is an author, over a social media post allegedly insulting Prophet Muhammad SAW.

The department said it had summoned the owner of the Facebook account "Ainon Mohd" over the post.

It added that officers from the Federal Territories Mufti Office and the Selangor State Mufti Department were also present at a meeting with the woman on Monday.

"The department urged her to remove the post. It advised her to be cautious when sharing content related to Islam and recommended that she should consult authorities to avoid disseminating inaccurate information.

"She agreed to take down the social media post, apologised and promised not to do it again, and gave an assurance that she would be more careful with her writing," the department said in a post on its Facebook page. It urged all parties to refrain from raising

It urged all parties to refrain from raising issues that could cause confusion or public anxiety, tarnish the dignity of Prophet Muhammad SAW as the messenger of Allah SWT, or disrupt harmony among Muslims in the country.

"(We) appreciate the efforts of those in the book publishing industry in engaging with the public through this medium, which also serves as a platform for *dakwah*. The department urges all parties to exercise caution and avoid arbitrarily attributing matters to Prophet Muhammad SAW, to uphold the sanctity of his name and his dignity as the messenger of Allah SWT." Meanwhile, Inspector-General of Police Tan Sri Razarudin Husain said police have received 13 reports nationwide against the author, who is also an entrepreneur.

He said police initially received a report lodged by a 34-year-old man at the Beranang police station in Kajang on Saturday. "The (person) has been identified as a 75-

"The (person) has been identified as a 75year-old woman. We have recorded a statement from the complainant to complete preliminary investigations, which were carried out under Section 298 of the Penal Code and Section 233 of the Communications and Multimedia Act 1998.

"Police will never compromise on any issue related to race, religion and royalty, and action in accordance with all existing legal provisions will be taken against those found to be causing disharmony and disturbing public peace." – Bernama

DPM extends condolences

He said the eight, who were killed in Gaza, were humanitarian heroes who "tirelessly dedicated themselves to helping our oppressed brothers and sisters".

Seeking imprisonment to escape loneliness

PETALING JAYA: In certain parts of the world, elderly people are reportedly committing crimes not out of necessity but in search of companionship and care within prison walls.

The growing trend, observed in countries such as Japan, South Korea, the United States and the United Kingdom, highlights the devastating effects of loneliness among old people.

In Japan, a tragic case involved an elderly woman who intentionally committed crimes to be imprisoned, hoping to find shelter and care after being abandoned.

The 81-year-old woman, only known as Akiyo, as reported by CNN, has been jailed twice for theft after first stealing food while she was in her 60s and later repeating it when survival on a pension became difficult. Could such a phenomenon occur in

Could such a phenomenon occur in Malaysia? While there are no reported cases of seniors deliberately seeking imprisonment in Malaysia, experts warn that social isolation and economic struggles among the elderly are growing concerns.

Universiti Teknologi Mara gerontologist Dr Nur Amalina Aziz said considering Malaysia is well-known as a multi-racial and multi-religious society, older persons might not resort to such drastic measures to escape loneliness.

"However, this issue can be related to the increasing number of admissions to old folk homes each year, due to lack of housing, income and children to care for them. "Among the primary factors contributing to

older people committing crimes are poverty and social isolation. For some, being sent to prison becomes the last option to escape dire conditions such as loneliness and emptiness, social stigma and poverty."

Nur Amalina said as elderly people are left alone over time, loneliness and social isolation could worsen their condition, leading to cognitive decline, severe depression and a reduced quality of life, ultimately increasing the risk of mortality.

She said according to the World Health Organisation, socially isolated older people face a 50% increase in risk of dementia, a 30% increase in risk of stroke and cardiovascular disease, and a 25% increase in risk of early death.

Nur Amalina said considering their mental and physical well-being are crucial, it is risky for older individuals to live on their own, especially if they suffer from chronic illnesses.

"My advice to those living alone or experiencing loneliness is to stay active, embrace the simple joys of life, spend time on activities that bring you peace and surround yourself with the people you cherish. Syndicate selling birth certificates for RM50,000

KUALA LUMPUR: A birth registration syndicate that forges documents to deceive the National Registration Department (NRD) into issuing legitimate birth certificates is believed to be selling the certificates for up to RM50,000 to parents with adopted or stateless children.

According to a source, the syndicate employs individuals to pose as relatives of a baby to submit forged documents on the baby's birth at NRD counters during the registration process.

"The forged documents, which are issued by legal practitioners and doctors, are instead prepared by the syndicate.

The source said the certificate sells for between RM10,000 and RM50,000.

Malaysian Anti-Corruption The Commission has frozen 11 bank accounts containing RM100,000 and seized 30 documents as part of an investigation.

On March 11, 16 individuals, aged between 20 and 80, were arrested in the Klang Valley and Johor under Klang Valley and Joh Ops Outlander and Ops Birth.

Among those detained were a civil servant, a medical practitioner with the title "Datuk Seri" and a legal practitioner.

They are suspected of committing offences from 2013 to 2018 and 2023 to 2025 involving bribery and the preparation and submission of false birth confirmation documents. – Bernama

Digital addiction among children raising concerns

PETALING JAYA: As digital devices become an integral part of daily life, the growing dependency of children on them has raised significant concerns.

Consultant paediatrician and child disability activist Datuk Dr Amar-Singh H.S.S. warned that digital addiction affects children's development, mental health and overall well-being. "Some signs of digital addiction in children include a decline in

academic performance, reduced concentration in class and decreased involvement with family members. "Children suffering from digital addiction may also display mood

instability, depression and low self-esteem. Many children even hide their excessive digital use from their parents." He said excessive screen time is

linked to delays in language

development, impaired social skills and physical health issues

"À major concern is language delay in young children as many parents and caregivers use devices as a convenient but inappropriate babysitter," he said, adding that it also limits outdoor activities and disrupts sleep. "While digital devices offer

learning opportunities, excessive use could be harmful. There is a clear dose-response relationship between screen time and issues such as loneliness, depression and hopelessness. "Many children are not only

addicted to (videos) but also to social media and electronic games, leading to prolonged use and social disengagement."

He recommended parents follow and enforce screen time guidelines with their children.

"For those below two years old, devices should be avoided entirely. For those aged two to five, screen time should be limited to one hour daily, ensuring content is high quality and interactive."

He emphasised the need for parental involvement, setting consistent limits for older children and fostering responsible digital habits.

"If parents want their children to spend less time on devices, they must regulate their own usage. The most important gift we can give our children is to listen to them.

Gobind takes helm at DAP, continuing family legacy

GEORGE TOWN: With decades of governance experience across various levels, Gobind Singh Deo has stepped into his new role as Democratic Action Party (DAP) national chairman.

His election marks a generational shift in the party's leadership and positions him as the torchbearer of his late father Karpal Singh's political legacy. Known as the "Tiger of Jelutong",

Karpal was a towering figure in Malaysian politics, advocating justice and parliamentary integrity. Gobind, the second son of five

siblings, now faces the challenge of leading the 59-year-old party within the ruling coalition as it prepares for

the 16th general election.

Universiti Sains Malaysia Political Sociology senior lecturer and political analyst Prof Datuk Dr Sivamurugan Pandian said Gobind is well equipped for the task, citing his clear ideological stance and administrative experience spanning party, state and federal levels

"Gobind and Karpal led DAP at different times but both emerged as leaders when change was needed.

"Karpal rose to prominence while the party was struggling to build support as an opposition force. Now that DAP is part of the government, Gobind must recalibrate the party's direction and engage members in a

way that aligns with political realities."

While Karpal was known for his uncompromising stance, often clashing with political opponents in Parliament, Gobind balances assertiveness with diplomacy, which is an approach that could prove crucial as he works alongside DAP secretary-general Anthony Loke to maintain party unity and relevance.

Gobind's victory in the Central Executive Committee elections was particularly significant.

Universiti Kebangsaan Malaysia Political Science senior lecturer Jamaie Hamil said Gobind's rise to chairmanship was expected.

"Gobind is no stranger to

leadership. His aura and influence, inherited from Karpal, undoubtedly played a role in convincing party delegates to elect him."

However, Jamaie cautioned against drawing direct comparisons between the two leaders as while both are known for their strong parliamentary presence, their approaches may differ. "Gobind has his father's firmness

but he operates in a different era. Unlike Karpal's combative style, Gobind has the opportunity to shape DAP's trajectory through . strategic engagement rather than confrontation.

DAP veteran Datuk Seri Phee Boon

Amar-Singh said with the rise of e-learning, it is a challenge to balance education and screen time.

'Parents and educators need to create structured schedules and encourage offline activities to maintain a healthy balance."

He said ultimately, the fight against digital addiction starts at home.

"Regulating electronic devices use is not enough. Parents must be actively involved in their children's play and daily activities."

A private kindergarten teacher who asked to be known only as S. Komathi said increased exposure to digital devices among young children may contribute to developmental delays, poor developmental delays, poor motor skills and even rising health concerns.

With over 20 years' experience, she has observed a sharp rise in speech and developmental issues among children.

"Previously, we would see only one child in two years with developmental delays. Now, it is around 10 out of every 100 children

in my kindergarten." She also noted an increase in cases of "lazy eye", a condition affecting vision.

"In the past, maybe one child in three years would have this problem. Now, I see around three cases in just one year."

Komathi said children's social skills have also deteriorated, with many becoming more withdrawn and struggling to show respect to teachers and parents. She added that children today

are quieter and less confident in

"Many do not know how to hold a pencil properly or even how to chew and swallow their food correctly," she said.

She cited excessive screen time as a major factor.

"Parents are busy on their phones, so they give phones to their children. Kids start believing 'the phone is my world'. I urge parents to set limits and reintroduce outdoor play.

"Parents need to change first. If they make an effort, their children will follow?

M'sia expands TVET efforts to meet workforce demand

Programme equips individuals with specialised knowledge and hands-on training for advanced career growth, says academic

PETALING JAYA: Malaysia is ramping up efforts to strengthen its technical and vocational education and training (TVET) sector to meet the growing demand for skilled workers and boost economic growth.

Once regarded as an inferior alternative to university education, TVET is now gaining recognition as a vital pathway to employment, with new government policies and industry collaborations.

Universiti Tun Hussein Onn Malaysia TVET programme head Assoc Prof Dr Marlina Mohamad said the country's initiatives to enhance TVET are showing promising results.

"TVET equips individuals with practical skills and specialised knowledge tailored to specific trades, industries or professions. It emphasises hands-on training and real-world competencies, preparing students to enter the workforce with the expertise needed for their chosen careers."

According to the National TVET Council, as of February last year, Malaysia had 1,398 TVET institutions nationwide. This included 673 public institutions under 12 ministries, 28 state government-run institutions and 697 private institutions .

Marlina said the government had introduced several initiatives to strengthen TVET, including the National TVET Policy 2030, launched in June 2024.

"The policy aims to unify TVET standards, enhance governance and promote TVET as a prestigious career pathway.

prestigious career pathway. "The Education Ministry has also announced that by 2027, basic TVET skills will be integrated into primary school curricula, ensuring pupils gain early exposure to technical education. The efforts have successfully elevated TVET's status, making it a key

contributor to Malaysia's skilled workforce and economic growth."

Despite recent advancements, Marlina said TVET still faces challenges in gaining recognition.

"Many Malaysians traditionally view university education as the ideal pathway to career success, leading to misconceptions that TVET is a secondary or less prestigious option," she said, adding that persistent beliefs about TVET careers offering fewer opportunities or lower salaries continue to hinder its accentance

its acceptance. However, she said public perception is beginning to change.

beginning to change. "TVET is not a 'dead-end' option but a stepping stone to greater career advancement. "Changing the perception requires collective

effort from the government, industry, schools and society," she added.

Marlina stressed that stronger industry collaboration is key to boosting TVET's reputation.

"When top companies hire TVET graduates with competitive salaries, it demonstrates the value of technical skills.

"Schools, career counsellors and parents need to be well-informed about the benefits of TVET. Providing students with hands-on exposure to technical fields from a young age and promoting TVET as an equal and respected option alongside academic routes can gradually shift outdated perceptions." Marlina said Malaysia's job market is

Marlina said Malaysia's job market is evolving, with a growing demand for skilled workers in fields such as engineering, digital technology and advanced manufacturing.

"TVET plays a crucial role in preparing students for high-demand industries by equipping them with practical skills and hands-on experience that employers seek." She cited Germany's highly skilled workforce

She cited Germany's highly skilled workforce as an example of how a robust vocational training system can drive economic growth.

"It's time to move past outdated perceptions. TVET is a first-choice education pathway that is just as valuable as traditional academic routes," she added.

In February, Deputy Prime Minister Datuk Seri Dr Ahmad Zahid Hamidi highlighted the high employability of TVET graduates.

He revealed that the national average employment rate for TVET graduates stood at 94.5%, with some institutions reporting rates as high as 98.7%.

"Many students secure jobs even before completing their studies. "TVET prioritises skill-based learning,

which directly translates into productivity. "Employers value competency, and this is why TVET graduates are in high demand,"

is why TVET graduates are in high demand," Zahid said.

Leftovers from bazaars donated to underprivileged

GEORGE TOWN: Ramadan bazaar traders in Penang have been donating unsold items to those in need to prevent food waste.

Local Government, Town and Country Planning Committee chairman Jason H'ng Mooi Lye said this was more meaningful than traders discarding the unsold food.

"Not only the traders, but the organisers of the bazaars are also very attentive to the matter and always ensure that food or drinks are not wasted at their stalls.

"If there are any leftovers, they will be donated to those in need, including at mosques, surau and other places."

He added that based on monitoring by the Penang Island City Council and Seberang Perai City Council, the cleanliness level at the bazaars was also found to be satisfactory.

H'ng said several other agencies, including the Penang Health Department, have also been monitoring the bazaars to ensure that traders comply with regulations and cleanliness standards. He added that both local authorities place

He added that both local authorities place significant emphasis on the issue of foreign nationals trading at the bazaars, as the matter has been clearly outlined in the offer letters to traders.

"Throughout this fasting month, there are 100 bazaars with 4,574 traders selling various food and beverage. So far, we have taken action against two stalls operated by foreign traders."

Meanwhile, Penang Domestic Trade and Cost of Living Ministry director S. Jegan said overall inspections at bazaars in the state over the past two weeks found that traders are displaying prices clearly and reasonably.

"We have only received three complaints from all of Penang. One is a case under the Price Control and Anti-Profiteering Act 2011, while the other two are still being investigated." – Bernama

Crocodile populations to be monitored after sightings at beach

KOTA KINABALU: The Kota Kinabalu City Hall has intensified monitoring of crocodile populations in Sungai Darau near the city hall depot workshop and other hotspot areas.

Mayor Datuk Seri Dr Sabin Samitah, who heads the Crocodile Threat Management Committee, said the city hall had also received reports of crocodile sighting in the sea near the Tanjung Lipat beach that was shared on social media.

"The monitoring is conducted in collaboration with various agencies, including the police, Sabah Fire and Rescue Department, Sabah Civil Defence Force and the Wildlife Department.

"The committee has also taken proactive steps, including conducting a study to estimate the crocodile population in areas under the city hall purview, installing warning signs in high-risk locations, and setting up closed-circuit television (CCTV) cameras in hotspot areas." Those with information on crocodile

Those with information on crocodile sightings around Kota Kinabalu City are urged to report them immediately to the Sabah Wildlife Department hotline at 089-561 527.

Meanwhile, on its Facebook page, the Sabah Civil Defence Force said it was monitoring the Tanjung Aru Beach area with the Wildlife Department following the sighting of a 1.5m-long crocodile. – Bernama

School leavers unaware of technical education option

PETALING JAYA: Many school leavers are still unclear about the prospects of technical and vocational education and training (TVET) and perceive it as a second-choice pathway compared with university education.

Despite it being promoted as a viable route to skilled careers, students say they receive minimal exposure to TVET, leading to misconceptions about its value and career potential. Nur Hayfaa Qistina, 17, from Subang Jaya, shared her perspective: "I understand that TVET provides hands-on skills in areas like mechanics and electrical work. I first heard about it from my teachers but they didn't explain much

teachers, but they didn't explain much. "Career talks and fairs at school primarily focused on university pathways such as medicine, engineering, and business, leaving TVET largely unmentioned. "It seemed like TVET was only suggested for students who weren't academically strong."

This lack of information led Nur Hayfaa to believe that TVET was meant for those who did not intend to pursue higher education.

"People assume university leads to better jobs and higher salaries, but some don't even know what kind of career prospects TVET offers."

Nur Iman Safia , 17, from Shah Alam, said she is familiar with TVET but does not see it as the right path for her, as she plans to pursue accounting.

However, she acknowledged TVET's benefits. "I think it is a great option for students who enjoy working with their hands and want to enter the workforce quickly.

"I've heard of success stories from seniors who found good jobs after TVET education, so I believe it is valuable," she said.

Nur Iman also disagreed with the notion that TVET is only for students who

struggle academically.

"I know smart students who simply prefer hands-on learning over theory.

"Unfortunately, many people still assume TVET is for those who can't do well in school. But, it's not true – it's just a different way of learning," she said.

In January, Deputy Prime Minister Datuk Seri Dr Ahmad Zahid Hamidi announced that students without SPM qualifications could enroll in TVET programmes. He said over 10,000 students did not sit for the SPM in 2023 and the previous year, adding that the initiative aims to provide these students with a second chance to pursue such courses.

"We hope to establish a collaborative effort between the National TVET Council and the Education Ministry to identify these students," he said, adding that the government was streamlining tehcnical institutions to offer more options and better opportunities for students.

Ismail Sabri called to MACC again to provide statement

Former PM summoned to commission HQ for fifth time after failing to attend session yesterday

PUTRAJAYA: The recording of former prime minister Datuk Seri Ismail Sabri Yaakob's statement at the Malaysian Anti-Corruption Commission (MACC) headquarters over allegations of corruption and money laundering will be held today.

According to MACC sources, Ismail Sabri was unable to attend yesterday's statement recording session. Media representatives had begun

Media representatives had begun gathering outside the MACC headquarters as early as 9am yesterday to follow developments as Ismail Sabri was expected to provide his statement for a fifth time. The MACC investigation into Ismail Sabri began on Dec 11, 2024, when he was ordered to declare his assets.

He officially submitted his declaration on Feb 10 and subsequently appeared at

the MACC headquarters to give provide a statement on Feb 19. Since then, he has been summoned

several times to assist in the ongoing investigation. Over the past week, he was present for

five hours on March 13, almost six hours the next day and seven hours on Monday. The investigation focuses on the

expenditure and acquisition of funds for the promotion and publicity of the Keluarga Malaysia programme during Ismail Sabri's tenure as prime minister from August 2021 to November 2022.

On Monday, MACC chief commissioner Tan Sri Azam Baki was reported to have said several new files had been opened in relation to the investigation. This followed new information received, with many more matters to be presented to Ismail Sabri.

Azam also said the investigation is being conducted in relation to corruption, abuse of power and money laundering.

According to him, the investigation is not only based on the original file related to the Keluarga Malaysia issue but also on new information and MACC intelligence, Bernama reported.

The case is being investigated under the MACC Act 2009 and the Prevention of Money Laundering, Prevention of Terrorism Financing and Proceeds of Unlawful Activities Act 2001.

On March 3, Azam was reported to have said Ismail Sabri is a suspect in the investigation into the corruption and money laundering case.

This followed the discovery of about RM170 million in cash in various currencies and 16kg of gold bars in a safe house during an MACC raid.

M'sian rescued from Myanmar scam centre arrested

KUALA LUMPUR: One of the 25 Malaysians rescued from a job scam syndicate in Myanmar on March 12 was arrested after police investigations revealed he had played a role in recruiting locals.

Bukit Aman Criminal Investigation Department (Intelligence/Operations) deputy director Datuk Fadil Marsus said the 20-year-old man was detained after police conducted screening and interrogation of all the victims who were brought back by bus from Tak Province, Thailand.

"We keep rescuing them but not all of them are victims. Out of the 25, only six individuals are genuine victims.

"These victims will be given an interim protection order and during the investigation period, we will ensure their safety. Meanwhile, the others are not genuine victims. So, it is likely they are recruiters, facilitators or scam workers who have been to the location, before asking to be rescued," he told a press conference at Bukit Aman on Monday.

He said the man would be remanded for seven days for further investigations and police have opened five investigation papers under Section 12 of the Anti-Trafficking in Persons and Anti-Smuggling of Migrants (Atipsom) Act 2007, involving contingents from Kuala Lumpur and Johor.

The other rescued Malaysians are still under investigation, while genuine victims have been granted an interim protection order for 21 days.

On March 12, 25 Malaysians who were victims of a job scam syndicate were repatriated via Mae Sot, Tak province in northern Thailand after being handed over by Myanmar authorities to the Malaysian embassy through Thai authorities. Meanwhile, 489 police reports have been received from Jan 1, 2021 to March 13, involving 637 individuals – 517 men and 120 women – aged between 22 and 39, who fell victim to overseas job scams, including in Myanmar, Cambodia and Laos.

Of the total, 504 individuals were rescued, while 133 remain stranded abroad.

"Investigations found that 83% of the victims had an educational background up to the Malaysian Certificate of Education level, and the primary medium through which job offers were received was social media platforms such as Facebook, Telegram and WeChat, followed by invitations from friends or family.

"A study by police also found that not all individuals rescued from human trafficking syndicates meet the definition of victims under the Atipsom Act," he said. – Bernama

MAHB tightens wildlife smuggling checks

KUALA LUMPUR: Malaysia Airports Holdings Bhd (MAHB) has reaffirmed its commitment to addressing wildlife smuggling at the KL International Airport (KLIA) through tighter security measures and closer cooperation with enforcement agencies.

As the operator of KLIA, MAHB said its aviation security team remains focused on preventing illegal activities that could threaten passenger safety and air transport.

"While our baggage handling system is designed to prioritise critical security concerns, MAHB remains committed to combatting wildlife smuggling through close collaboration with all relevant authorities," it said in a statement.

MAHB has also contributed resources to boost detection capabilities.

In June 2024, it donated two Belgian Malinois K9 detection dogs to the Wildlife and National Parks Department, trained to detect the presence of endangered species listed under the Convention on International Trade in Endangered Species of Wild Fauna and Flora, including elephant ivory, rhinoceros horn, pangolin scales, snakes and turtles.

Recent seizures include five endangered Asian Koel birds worth RM65,000 at klia2 and 4,386 endangered pig-nosed turtles concealed in seven suitcases bound for Hanoi. – Bernama

RM14.5 million worth of e-waste seized

KUCHING: The Sarawak General Operations Force brigade seized over RM14.5 million worth of electronic waste in three raids across the city during Op Hazard Sarawak on Monday.

Its commander SAC Che Ghazali Che Awang said the raids, conducted between 10am and 4pm, were carried out in collaboration with the Sarawak Department of Environment and local authorities.

He added that nine individuals, including a local woman and a foreign man aged between 26 and 55, were arrested in connection with the case.

"Further inspections uncovered 525.45 tonnes of unprocessed e-waste components valued at RM14,695,500, along with three heavy vehicles worth RM2.4 million, five machines and various types of equipment worth RM3 million and other items worth RM1.5 million," he said in a statement yesterday.

All confiscated items have been handed to the department and authorities for further investigation under the Environmental Quality Act 1974, Environmental Quality (Scheduled Waste) Regulations 2005 and the Padawan Municipal Council by-laws. – Bernama

Father, son die in fiery trailer crash

IPOH: A man and his son were burned to death after the sand-laden trailer they were travelling in crashed into the rear of a trailer carrying cotton bales and burst into flames at Km331.8 of the North-South Expressway (northbound) yesterday.

Perak Fire and Rescue Department assistant director of operations Sabarodzi Nor Ahmad said the operations centre received an emergency call about the accident at 7.46am.

He said a team of officers and personnel from the Bidor Fire and Rescue station was despatched to the scene and arrived at 7.57am.

"The operations commander reported that the incident involved a sand-laden trailer, which crashed into the rear of a cotton-loaded trailer.

"The male driver of the sand-laden trailer, believed to be in his 40s, was found trapped inside the burnt-out vehicle.

"Another victim, the driver's son, in his 20s, was also found burned to death, and the bodies were removed by the rescue team," he said. – Bernama

Indonesia to assess scam centre returnees

Suspected perpetrators face legal action

JAKARTA: Indonesia will question hundreds of its citizens arriving in the capital yesterday after they were rescued from online scam compounds in Myanmar, the largest batch of arrivals in the country following a multinational crackdown on the operation.

Myanmar's Myawaddy scam centres are part of a Southeast Asia network involving criminal gangs trafficking hundreds of thousands of people to help generate illicit revenues running into billions of dollars a year, according to the United Nations.

About 200 Indonesians arrived at Jakarta's airport yesterday from Myawaddy via Thailand and another 200 will land later, Security Minister Budi Gunawan told a news conference.

The Indonesian government cooperated with the Thai government and the Chinese government to rescue and repatriate 554 Indonesians," he said.

Around 154 more are expected to arrive today, Budi said.

They were among 7,000 people from different nationalities freed from scam centres in Myawaddy following a multinational crackdown to dismantle the illegal compounds. "We will conduct an assessment to find out

which ones are victims or perpetrators. "We want the Southeast Asia region free of online scams," he said.

The 554 people, consisting of 105 women and 449 men, will be taken to a dormitory usually reserved for pilgrims returning from Mecca where they will be questioned by police, he said.

Those cleared would be allowed to return home but those suspected of being willing participants in financial crimes would face legal action in Indonesia.

Footage showed the arriving Indonesians wearing red masks and bandanas and being



welcomed by authorities, including Foreign Minister Sugiono.

Some of them cried and hugged the officials. Budi said some of them were beaten and given electric shocks before being rescued.

Others were also threatened that their body parts would be surgically removed if they failed to meet targets set by the cartel, he said. "Be careful when you make friends on social

media. I am the victim of social media," a survivor with the initials DN told reporters.

Earlier this month, another group of 84 Indonesians returned home from Myanmar while 70 others remain in the country. Some of them were being detained and a few have refused to go home, Budi said.

Aside from Indonesia, China and India have also repatriated their citizens from Myawaddy but thousands still remain in the area including those from African nations.

Authorities in Myanmar, under pressure from ally China, have cracked down on the scam compounds.

Between 2020 and September last year, Jakarta repatriated more than 4,700 Indonesians entangled in online scam operations from countries including Cambodia, Myanmar, Laos and Vietnam, according to

Foreign Ministry data. The United Nations estimates that as many as 120,000 people may be working in Myanmar scam centres against their will. - Reuters/AFP

Court refuses to stop arrest of fugitive police chief

COLOMBO: A Sri Lankan court refused on Monday to quash an arrest warrant for the island nation's fugitive police chief who is wanted over an officer's death in a botched raid.

Inspector-General Deshabandu Tennakoon has been in hiding since the arrest warrant was issued last month and police have made a public appeal to help find him.

He stands accused of authorising an ill-fated drug bust in 2023, allegedly against internal regulations, that sparked a gun battle between competing police units.

Despite Tennakoon being in hiding, he still managed to file a writ urging the arrest warrant be cancelled, which the Court of Appeal refused to grant in Monday's ruling.

Police said on Sunday they had deployed six special units to track down Tennakoon but were only able to trace his wife and son, who claimed they were unaware of his whereabouts.

Failure to find the police chief has "undermined public confidence in the police force", spokesman Buddhika Manatunga told reporters.

A foreign travel ban has been imposed on Tennakoon in case he tries to flee the island. The state prosecutor told another court

hearing last week that evidence had emerged of Tennakoon operating a paramilitary hit squad to carry out illegal activities.

Á magistrate ordered Tennakoon's arrest in February following allegations he authorised an illegal raid in the southern coastal resort town of Weligama.

Local police, unaware of the undercover operation, confronted the unit, sparking a gun battle in which one officer was killed and another critically wounded. No drugs were found.

Tennakoon was appointed police chief in November 2023, but the move was challenged in the Supreme Court, which suspended him last July pending the outcome of a separate court case

The next hearing in that case is due in May. He was given the top job despite the country's highest court ruling in another case that he had tortured a suspect in custody by

rubbing menthol balm on his genitals. The Supreme Court had ordered Tennakoon

to pay half a million rupees (RM7,111) to the victim in compensation, but the government at the time ignored judicial orders to take disciplinary action against him. - AFP

Three senior cops shot dead in gambling raid

JAKARTA: Three police officers were shot dead during a raid on an illegal gambling site in Way Kanan district, Lampung province, on the southern tip of Sumatra.

The officers were shot by a gunman on Monday while they were at the site in Karang Manik village, Negara Batin sub-district. They were identified as Negara Batin Police

Chief Inspector Lusiyanto, Chief Brigadier Petrus Aprivanto and Brigadier Two Ghalib Surva Ganta from the Way Kanan Police Criminal Investigation Unit. Police

spokesperson Lampung Commissioner Yuni Iswandari said a 17-member team from Way Kanan Police, which included officers from Negara Batin Police, had been dispatched following reports of illegal gambling activity.

"At the scene, they came under fire. Three officers were killed in the line of duty," she said, adding that the bodies were taken to Lampung Police Hospital for post-mortem.

Senior officers from Lampung Police arrived at the scene as authorities ramped up efforts to investigate and apprehend those responsible, Yuni said.

Indonesia has strict gambling laws, with Article 303 of the Criminal Code imposing severe penalties on those involved in organising or taking part in such activities. - Bernama

Taiwan probes duo over 'unification' comments

TAIPEI: Two Chinese influencers living in Taiwan are under investigation over their comments "advocating unification" with China, a Taipei immigration official said yesterday, days after the agency ordered a third Chinese influencer to leave the island.

The National Immigration Agency (NIA) was investigating two influencers identified as En-gi and Xiao-wei over their "statements advocating unification", a NIA official said.

The two women posted videos on Douyin, the Chinese version of TikTok. Over the weekend, NIA ordered another

influencer identified by her surname Liu to leave Taiwan after she allegedly called for "unification by force" in her videos.

"The NIA emphasises that, due to Liu's advocacy of unification by force, which has caused significant public concern and posed potential threats to national security and social stability, she must comply with the departure order within the given timeframe," the NIA said in a statement on Sunday. "Failure to do so will result in enforced

deportation in accordance with the law."

The NIA official said yesterday that Liu "must leave the country within 10 days, starting the day after the letter (departure order) is received".

"The letter has already been sent. I cannot confirm whether it has been received or not," the official said.

Liu, who claims to be from Hunan, shared a compilation of some of her videos with her more than 485,000 followers on Monday.

In one video, she said "Taiwan has always been China's territory, but now DPP is pushing Taiwan into the danger of war", referring to the ruling Democratic Progressive Party of President Lai Ching-te.

Liu said "according to Article 8 of the Anti-Secession Law ... the mainland no longer needs any other reason to use force against Taiwan!'

"I love the mainland and Taiwan. I support peaceful reunification because both sides of the Taiwan Strait are Chinese people. Chinese people should not fight Chinese people," she said. – AFP

South Korea tightens security for opposition leader

SEOUL: South Korean police stepped up security for the leader of the main opposition Democratic Party, after lawmakers had warned of a potential assassination plot targeting Lee Jae-myung.

In January last year, Lee was stabbed in the neck by a man who lunged at him with a knife after asking for his autograph.

The man was sentenced to 15 years in prison.

Tensions have been running high in South Korea since President Yoon Suk Yeol briefly imposed martial law last December triggering the country's worst political crisis in decades.

His martial law imposition and its fallout have widened deep social rifts between conservatives and liberals and put pressure on institutions.

Yoon faces a criminal trial on charges of insurrection, while the Constitutional Court is also expected to rule in coming days on whether to uphold his impeachment and permanently strip him of his powers

Police have been preparing for the risk of clashes, with both Yoon's supporters and his opponents due to hold large rallies when the court makes its decision. South Korea's acting President Choi Sang-

mok repeated yesterday a call for citizens to accept and respect the court's ruling. - Reuters

Stranded space station astronauts head home

Return caps end to nine-month mission

WASHINGTON: Nasa astronauts Butch Wilmore and Suni Williams departed the International Space Station early vesterday in a SpaceX capsule for a long-awaited trip back to Earth, nine months after their faulty Boeing Starliner craft upended what was to be a roughly week-long test mission.

Wilmore and Williams, two veteran astronauts and retired US Navy test pilots, strapped inside their Crew Dragon spacecraft along with two other astronauts and undocked from the orbiting laboratory at 1.05am ET (1.05pm in Kuala Lumpur), embarking on a 17-hour trip to Earth.

The four-person crew, formally part of Nasa's Crew-9 astronaut rotation mission, was scheduled for a splashdown off Florida's coast later at 5.57pm ET (1.57am today in Kuala Lumpur).

The astronaut pair had launched into space as Starliner's first crew in June for what was expected to be an eight-day test mission. But issues with Starliner's propulsion system led to cascading delays in their return home, culminating in a Nasa decision last year to have them take a SpaceX craft back this year as part of the agency's crew rotation schedule.

The mission has captured the attention of President Donald Trump, who upon taking office in January called for a quicker return of Wilmore and Williams and alleged that former president Joe Biden "abandoned" them on the ISS for political reasons. SpaceX CEO Elon Musk, a close adviser to

Trump, echoed his call for an earlier return. SpaceX's Crew Dragon is the United States' only orbital-class crew spacecraft, which Boeing had hoped its Starliner would compete with before the mission with Wilmore and Williams threw its development future into uncertainty.

The astronauts will be flown to quarters at the space agency's Johnson Space Center in Houston for several days of health checks before Nasa flight surgeons approve they can go home to their families.

Living in space for months can affect the human body, from muscle atrophy to possible vision impairment.

Upon splashing down, Wilmore and Williams will have logged 286 days in space – longer than the average six-month ISS mission length, but far short of US record holder Frank Rubio. His continuous 371 days in space ending in 2023 was the unexpected result of a coolant leak on a Russian spacecraft.

Williams, capping her third spaceflight, will have tallied 608 cumulative days in space, the second most for any US astronaut after Peggy Whitson's 675 days. Russian cosmonaut Oleg Kononenko set the world record last year at 878 cumulative days.

Swept up in Nasa's routine astronaut rotation schedule, Wilmore and Williams could not begin their return to Earth until their replacement crew arrived, to maintain adequate US staffing levels. - Reuters

Kiribati holds rights for deep-sea mining exploration across a 75,000 sq km swathe of the Pacific, in a region known as the Clarion Clipperton Zone.

Through state-backed subsidiary Marawa Research, Kiribati had been working with Canada-based The Metals Company to explore the mineral deposits.

But that agreement was terminated "mutually" at the end of last year, The Metals Company said.

A Kiribati fisheries official said the nation was now exploring opportunities with other foreign

partners. The Metals Company said Kiribati's mining rights were "less commercially favourable" than other projects with Pacific nations Nauru and Tonga. – AFP

US to execute four death row inmates this week WASHINGTON: A 46-year-old man convicted which involves pumping nitrogen gas into a

of rape and murder was scheduled to be put to death by nitrogen gas in the southern state of Louisiana yesterday, the first of four executions this week in the United States.

Jessie Hoffman, who was sentenced to death for the 1996 murder of Molly Elliott, a 28year-old advertising executive, will be the first person executed in Louisiana in 15 years.

A district court judge last week stayed Hoffman's execution on the grounds that the use of nitrogen gas may amount to cruel and unusual punishment, which is banned under the US Constitution.

But the stay was lifted by the US Fifth Circuit Court of Appeals.

Only one other US state, Alabama, has carried out executions by nitrogen hypoxia,

facemask, causing the prisoner to suffocate.

The vast majority of US executions since the Supreme Court reinstated the death penalty in 1976 have been performed using lethal injection.

Hoffman, a parking lot attendant, was convicted in 1998 of abducting Elliott in New Orleans as she went to retrieve her car and join

her husband for dinner. Hoffman's lawyers have appealed to the Supreme Court to halt the execution on the grounds that the nitrogen gas would "interfere with Jessie's ability to practise his Buddhist meditative breathing". "The Supreme Court has repeatedly held

that prisoners must be allowed to practise their religion as their lives are being taken by

execution," said Cecelia Kappel, one of Hoffman's attorneys.

"There are plenty of execution methods Louisiana could adopt that would not interfere with Jessie's ability to practise his meditative breathing, and only one, nitrogen gas, that makes it impossible for him to do so," she said.

Three other executions are scheduled in the United States this week. Aaron Gunches, 53, is to be executed by

lethal injection in Arizona today for the murder of Ted Price, his girlfriend's ex-husband.

Wendell Grissom, 56, is to be executed by lethal injection in Oklahoma tomorrow for shooting and killing Amber Matthews, 23, in 2005 during a home robbery.

Edward James, 63, is to be executed by lethal injection in Florida tomorrow. - AFP

WEST BANK ANNEXATION **RAMPED UP: UN**

GENEVA: Israel has expanded and consolidated settlements in the occupied West Bank as part of the steady integration of these territories into the State of Israel, in breach of international law, the UN human rights office said yesterday. A report to be presented to the UN Human Rights Council later this month comes amid growing fears of annexation and policy shifts under President Donald Trump and new settler outposts in areas of the West Bank seen as part of a future Palestinian state. "The transfer by Israel of parts of its own civilian population into the territory it occupies amounts to a war crime," UN High Commissioner Volker Turk said. – Reuters

EU: Russia, China hitting West with digital arsenals

BRUSSELS: The European Union yesterday said Russia and China were using "massive digital arsenals" to interfere in Western democracies, while their messaging on the war in Ukraine had become increasingly aligned.

"Foreign information manipulation and interference is a major security threat to the EU," foreign policy chief Kaja Kallas said in a report.

"We must not underestimate the power that this has over us."

In its latest annual report on the subject, Brussels said last year it tracked disinformation attacks against over 80 countries and more than 200 organisations.

The war in Ukraine remains a major target for Russia but events such as the Olympics in Paris and farmers' protests in Germany were also in the crosshairs.

"The aim is to destabilise our societies, damage our democracies, drive wedges between us and our partners and undermine the EU's global standing," Kallas said.

The report said Brussels has become better at joining up the dots to expose the campaigns by Moscow and Beijing to shape opinion in the EU. It said Russia uses a complex web of

"of state and non-state actors" from social media influencers to state media and official spokespeople to create and amplify its messages.

China, for its part, appears to be stepping up the use of "both private PR companies and influencers to create, amplify and launder content aligned with China's political interests worldwide".

The report stopped short of accusing Russia and China of actively colluding to spread disinformation, saying the "crosspollination between the two seems to remain largely opportunistic". - AFP

Airstrikes kill 326 in Gaza

Israeli military says campaign will expand

CAIRO: Israeli airstrikes pounded Gaza, killing 326 people, Palestinian health authorities said yesterday, collapsing a two-month ceasefire with Hamas as Israel vowed to use force to free its remaining hostages in the strip.

Minister Benjamin Prime Netanyahu said he had instructed the military to take "strong action" against Hamas in Gaza in response to the group's refusal to release hostages and rejection of ceasefire proposals. "Israel will, from now on, act

against Hamas with increasing military strength," his office said in a statement. Hamas accused Israel of

overturning the hard-fought ceasefire deal agreed in January, leaving the fate of 59 hostages still held in Gaza uncertain.

Strikes in Gaza were reported in

many locations. Health Ministry officials said many of the dead were children.

In hospitals strained by 15 months of bombardment, piles of bodies in white plastic sheets smeared with blood could be seen stacked up as casualties were brought in.

The Israeli military said it hit dozens of targets, and that the attacks would continue for as long as necessary and extend beyond airstrikes, raising the prospect that Israeli ground troops could

resume fighting. The UN Humanitarian Coordinator for the Occupied Palestinian Territory urged for the ceasefire in Gaza to be immediately reinstated.

"Waves of airstrikes occurred across the Gaza strip since the early hours of the morning ... This is unconscionable," Muhannad Hadi said in a statement.

Israeli media said Israel was opening shelters in commercial hub Tel Aviv to prepare for possible retaliation from Hamas or Yemen.

In Washington, a White House spokesperson said Israel had consulted the US administration before it carried out the strikes, which the military said targeted mid-level Hamas commanders and leadership officials as well as infrastructure belonging to

the group. "Hamas could have released hostages to extend the ceasefire but instead chose refusal and war," White House spokesperson Brian Hughes said.

In Gaza, residents said Israeli tanks shelled areas in Rafah in the southern Gaza Strip, forcing many families who had returned to their areas after the ceasefire began to leave their homes and head north to Khan Younis.

Negotiating teams from Israel and Hamas had been in Doha as mediators from Egypt and Qatar sought to bridge the gap between the two sides after the end of an initial phase in the ceasefire, which saw 33 Israeli hostages and five Thais returned by groups in Gaza in for exchange some 2,000

Palestinian prisoners. With the backing of the United States, Israel had been pressing for the return of the remaining 59 hostages still held in Gaza in exchange for a longer-term truce.

However Hamas had been insisting on moving to negotiations for a permanent end to the war and a full withdrawal of Israeli forces from Gaza, in accordance with the terms of the original ceasefire agreement.

'We demand that the mediators hold Netanyahu and the Zionist occupation fully responsible for violating and overturning the agreement," the group said.

Each side has accused the other of failing to respect the terms of the January agreement, and there were hiccups during the first phase. But until now, a full return to the fighting had been avoided.

Israel had blocked deliveries of aid from entering Gaza and had threatened on numerous occasions to resume fighting if Hamas did not agree to return the hostages it still holds. - Reuters

Houthis won't 'dial down' under pressure

DUBAI: Yemen's Houthis will not 'dial down" their action against Israeli shipping in the Red Sea in response to US military pressure or appeals from the group's allies such as Iran, the group's foreign minister said.

Jamal Amer spoke to Reuters late on Monday after the US launched a wave of strikes in areas of Yemen controlled by the Houthis, who said last week they were resuming attacks on Red Sea shipping to support Palestinians in Gaza.

Two senior Iranian officials said Iran had delivered a verbal message to the Houthi envoy in Tehran on Friday to cool tensions and that Iran's foreign minister asked Oman, which has mediated with the Houthis, to convey a similar message to the group when he visited Muscat on Sunday

Both officials asked not to be named.

Iran has not made any public comment about recent outreach to the Houthis over their renewed action. Tehran says the group takes decisions independently.

President Donald Trump said on Monday he would hold Iran responsible for any attacks carried

out by the Houthis. "There will be no talk of any dialling down of operations before ending the aid blockade in Gaza. Iran is not interfering in our decision but what is happening is that it mediates sometimes but it cannot dictate things," Amer said, in his first comments on the issue to a foreign news agency.

Speaking from Yemen's capital Sanaa, which has been hit by strikes, he said he had not been informed of any message Iran delivered to the Houthi envoy in Tehran.

There were messages from other powers to dial down, he said, but added: "Now we see that Yemen is at war with the US and that means that we have a right to defend ourselves with all possible means, so escalation is likely."

Iran has shown increasing concern it could be drawn deeper into conflict with the United States. Iran and Israel exchanged direct strikes for the first time last year as the Gaza war escalated.

Trump, who withdrew the US from a 2015 deal between Iran and six major powers that curbed its sensitive nuclear work in exchange for sanctions relief, has stepped up a "maximum pressure" campaign of sanctions on Iran since returning to office for a second term in January

"(The US) is threatening Iran and hitting Yemen. Now all scenarios are possible. We will do what they will do to us. If they are hitting us from (aircraft carrier USS Harry S.) Truman, we will retaliate by hitting Truman," the Houthi foreign minister said.

While Iran champions the Houthis, the group says it is aligned with Tehran without being a puppet.

Experts on Yemen, where the Houthis expanded control during years of civil war, say the group seems mainly motivated by domestic concerns and support base.

The Houthis said on March 12 they had resumed attacks on Israeli ships using routes that pass through the Red Sea after the group said Israel had not met a Houthi deadline for ending an aid blockade on Gaza. Reuters

France has emerged as a new force on the badminton circuit. producing men's singles and doubles players who have been performing impressively, either winning or reaching the later stages of several tournaments.

Taiwan, however, appears to be an even more formidable threat. Recently, they have been producing incredible talent in the men's singles and doubles, making them a serious contender and a dark horse in the upcoming Thomas Cup tournament.

Traffic pollution: A deadly killer of health

LOBAL carbon emissions from fossil fuels surged to a record high last year, with no sign that the world has reached a peak.

Burning fossil fuels resulted in CO_2 (carbon dioxide) releases hitting 40 billion tonnes last year, pushing atmospheric CO2 levels 52% higher than they were in pre-industrial times

Emissions growth overall has slowed, fortunately, thanks to the global adoption of solar panels and electric vehicles.

We saw in Part Two that Malaysia scored its first plus point with a radically new solar panel installation scheme that will make every roof dance in the sun, provided the details when released are truly groundbreaking. We concluded Part Two with -4 points.

Resurrection of EVs

In Part Three, we take a drive with the electric vehicle (EV). Has Malaysia stepped on the pedal or is the EV

going at a snail's pace? Let us place the EV in the context of its long history. The EV, in the form of milk delivery vans, was introduced

in the 1970s in Britain. This columnist,

as a visiting Commonwealth fellowship journalist, enjoyed the good fortune of being invited by a milkman to ride in his EV van as it made short trips in the city neighbourhoods. However, the low capabilities of the

EV, restricting its use neighbourhood trips and growing resistance from the oil industry towards any technological improvements to the EV, ensured that they almost suffered extinction until their miraculous resurrection in 2004 thanks to Elon
 Musk's Tesla.
 His Tesla was the

first production of an all-electric car to travel more than 320km per charge.

Japan's Mitsubishi entered the scene in 2009 and Nissan followed soon after. The global stock of EVs grew steadily in the 2010s, with European and Chinese carmakers joining in.

The first EVs sold in Malaysia were the Mitsubishi i-MiEV and the Nissan Leaf in 2013. This marked the beginning of the EV market in our country. However, EV adoption in Malaysia has been slow as protectionist measures are in place.

Hence, prices for many years were all above RM130,000, and the saying, "EVs are only meant for the rich", became household words. Tax exemptions introduced in Budget 2022 made no dent: if you own a petrol car less than five years old, would you dump it for an EV priced

above RM100,000? In 2023, the BYD Dolphin and Neta V entered the Malaysian market but their prices on the road with insurance still exceeded RM100,000. The Proton e.Mas 7, launched in December 2024, is priced at RM109,800.

In China, the BYD Seagull is priced at just US\$9,700 (RM43,141), making it possible for one out of every two cars sold in China to be an EV

EVs in Malaysia cost upwards of RM100,000, not because EVs are expensive by nature but the high price is due to restrictions set by the Investment, Trade and Industry Ministry that requires an imported EV to tag its price in our market above RM100,000. This restriction of course runs against climate action.

In Malaysia, EVs account for only 5.6% of the total car industry volume. For our snail-paced response to climate change, the EV earns Malaysia no points.

The government should incentivise the committees of all houses of worship to purchase one EV as a show of frontline leadership in climate action. If all religions

participate, it gets to be a commitment that brings religions

together. Two concerns deter most topearners income from buying. They are the battery are the battery range and charging infrastructure, and battery life and replacement cost.

The government could bypass these concerns by getting the oil industry to reward hybrid owners with incentives.

Hybrids priced below RM200,000 include Proton X90 Mild Hybrid, Honda e:HEV and Toyota Corolla Cross Hybrid. Our climate score

remains at -4 points.

Ecological crisis We shall now look at two related issues:

traffic congestion and air pollution. Remember that our holistic analysis sweeps in all three facets of the great ecological crisis. These facets are climate change, biodiversity loss and mass pollution.

Klang Valley residents have noticed that year after year, traffic is getting heavier. However, it is not the pro-car policies since the 1980s that resulted in Klang Valley's spreading congestion; it is the failure of transport authorities to prioritise bus services.

Car owners in many countries take the bus rather than drive to work daily. Research by three French transport associations last year found that 81% of Europeans living in five European capitals - Berlin, Madrid, Paris, Stockholm and Warsaw - use

public transport for day-to-day travel. For half of them, a bus stop or rapid transit station is just five minutes away.

In Malaysia, there is near-complete absence of first- and lastmile connectivity, meaning that the buses ply only profitable routes.

For saturation coverage, obviously more than half the routes will be unprofitable if only large buses are used. In Malaysia, there is no concept of bus transport as a must-have public service.

Ride-hailing service is costly if you were to use it daily for connectivity. Demand-responsive transit is also not practical as it requires you to book a ride.

Buses operate solely for profit because the government counts only the cost of bus operations; it does not factor in the cost of manpower hours lost in traffic jams, the cost of wasteful petrol burning and the

environmental damage. Petrol car exhaust contributes to carbon emissions primarily through the combustion of fuel in the engine. Petrol is a hydrocarbon that consists mainly of carbon and hydrogen. When it burns in the engine, hydrocarbon reacts with oxygen (O_2) from the air to produce CO_2 , the most significant greenhouse gas emitted by petrol cars that traps heat in the atmosphere contributing to global warming. If combustion is not complete due

to insufficient oxygen or inefficient engine performance, it also produces carbon monoxide (CO), a toxic gas that forms when there is not enough oxygen for complete combustion.

On average, burning one litre of petrol produces about 2.3kg of CO₂. How much petrol is burnt on chokefilled Klang Valley roads every working day when even the suburban lanes are now seeing bumper-to-bumper traffic? Each petrol car emits 4kg on average.

With three million petrol cars on

Klang Valley roads every working day, some 12 million kg of CO_2 is spewed out per year by all the Klang Valley petrol cars on working days.

Klang Valley also has approximately six million petrol motorcycles, mostly used for deliveries. Factoring in the heavy frequency of daily trips, their emissions equal that of the car population.

Even the British newsweekly The Economist has commented on Klang Valley's monstrous traffic jams. For preferring to keep a monster instead of developing excellent bus transportation, Malaysia loses one point. The score is now back to -5.

Impact of air pollution on health

There is another cost that the government ignores: the cost of air pollution on health. Roughly 24 million kg of CO_2 is breathed in by Klang Valley residents per year. This works out to 90,000kg per day, except Sundays, but inclusive of Saturday traffic at half the workingday volume. If you live in a highdensity traffic area, you are breathing

in 10kg of CO_2 a year. The byproduct CO reduces the oxygen-carrying capacity of blood. Petrol also emits nitrogen oxide and nitrogen dioxide, which cause respiratory issues and increase cancer risk, as well as benzene and volatile organic compounds linked to leukaemia and other cancers. Additionally, it releases polycyclic aromatic hydrocarbons associated with lung and skin cancer, sulfur dioxide that causes respiratory problems, and formaldehyde, which irritates the eyes, nose and throat while penetrating deep into the lungs.

Worst is the cancer-causing PM2.5 particle. PM means "particulate matter" and the number 2.5 refers to fine inhalable particles with diameters that are generally 2.5 micrometres and smaller

Harvard University researchers have discovered that not only does PM2.5 directly affect the foetus, leaving it vulnerable to asthma, but it also increases the risk of cerebral palsy which causes infant disability.

Prolonged exposure to heavy traffic pollution increases the likelihood of heart ailments and lung cancer.

The Health Ministry revealed last month that nearly 250,000 Malaysians have been diagnosed with cancer over the past seven years, with the number of deaths from the disease rising each year.

Lung cancer is among the five most common types of cancer affecting Malaysians, according to the ministry. Cancer is the third leading cause of premature deaths after pneumonia and heart failure.

The International Agency for Research on Cancer, part of the World Health Organisation, has classified outdoor air pollution as a Group One carcinogen, meaning there is strong evidence that it causes cancer in humans.

The simplest, most affordable way to provide first- and last-mile connectivity to the nearest rail transit station or to a nearby destination is for existing bus services to use vansized buses for local routes so that every household is within five or 10 minutes walking distance from a

bus stop. Additionally, buses should run at intervals of no more than 15 minutes during the daytime.

Due to the government's failure to address the threat to lives, Malaysia loses another point, bringing the core to -6.

In Part Four, we shall examine whether Malaysia's stand in the geopolitical field earns us a plus point.

Capital A reaches new heights in ESG scores

SEPANG: Capital A Bhd and its associate Asia Aviation Public Company Limited (AAV) reported new highs in their sustainability scores according to the latest ratings released by regional exchanges and international assessment bodies in December 2024.

assessment bodies in December 2024. At group level, Capital A's FTSE ESG ratings rose to 3.5 out of a maximum 5, up from 3.2 the previous year. The group also saw its S&P Global Corporate Sustainability Assessment (CSA) score surge to 47% from 40% for the previous two years, scoring above average in the airline category for the second year consecutively.

Meanwhile, AAV – which operates Thai AirAsia – received its first internationally benchmarked score of 3.7 as the Stock Exchange of Thailand (SET) commences its transition from ranking the ESG performance of its listed entities using its own ESG ratings scorecard to FTSE Russell by 2025. AAV's first FTSE ESG score reflected its stellar performance under SET's ESG Ratings of 83%, corresponding to the exchange's AA-level rating. All abovementioned ESG scores were assessed

based on the entities' 2023 performance.

Capital A chief sustainability officer Yap Mun Ching said: "Capital A continues to put emphasis on strengthening its sustainability strategy and delivering outcomes in response to regulatory developments, particularly in relation to the environmental performance of its aviation business. "The positive ESG results show that we are on the right track as we focus on increasing operational efficiency to lower our emissions and improving governance through the establishment of sustainability committees at all our listed entities.

"Key achievements in 2023 that helped to deliver this strong performance were the publication of Capital A's emissions reduction targets up to 2050, achieving AirAsia's lowest yet carbon intensity measures and recovering the group's On-Time Performance and Net Promoter Score.

Firms struggle to meet standards, says expert

KUALA LUMPUR: Malaysian firms face hurdles in meeting environmental, sustainable and governance (ESG) standards due to capability, capacity, and investment challenges, an expert said.

PwC Malaysia's sustainability and climate change leader Andrew Chan said capability is a significant factor because sustainability is still a relatively new field.

Evolving frameworks and standards under the ESG agenda require firms to adapt and develop the necessary expertise and resources.

"For instance, after addressing climate risks through existing frameworks such as the task force on climate-related financial disclosures and the International Financial Reporting Standards (IFRS) S2 climate-related disclosures, companies will also need to respond to naturerelated risks and upcoming frameworks like the IFRS S3 and S4.

"Additionally, many sustainability

professionals may not yet possess the skills required for detailed financial reporting, necessitating collaboration with financial reporting colleagues to meet requirement standards such as the National Sustainability Reporting Framework," he told Bernama.

Another challenge, according to Chan, is capacity, as evidenced by the intensified sustainability agenda over the past five years.

He highlighted LinkedIn's Global Green Skills Report 2024 which showed that the global demand for workers with green skills, or green talent, is outpacing supply. Between 2023 and 2024, demand for green

Between 2023 and 2024, demand for green talent rose by 11.6% while supply grew only by 5.6%.

"If the current trajectory continues, we will face a shortfall of nearly one-fifth (18.7%) of the green talent required by 2030, leaving us without half the green talent that employers will need. "While universities are responding to this demand, more efforts are needed to sustain the pipeline of talent for mid to senior roles."

Chan said investment is another barrier. Many organisations view sustainability primarily as a compliance-driven obligation rather than as strategic opportunities for value creation.

PwC Malaysia's Corporate Directors Survey 2024 showed only 21% of board directors perceive sustainability as an opportunity for value creation.

"This perception often results in relatively low budget allocations for sustainability initiatives.

"However, companies that are more mature in sustainability reporting invest in enterprise systems that integrate efforts across sustainability, finance and technology, allowing access to larger budgets and resources, enabling more comprehensive and effective sustainability data management and reporting," he said. While sustainability is on board agendas, companies may not be capturing its impact adequately as part of their bottom line, he said.

"Our corporate directors survey finds that only 14% understand how their climate commitments influence capital allocation decisions.

"Just 27% believe that climate change consideration is embedded into their value creation strategy.

A challenge they face aligning sustainability with business strategy is the lack of control and visibility over their companies' sustainability plans and data, he said.

"Many current ESG data systems lack the robustness and consistency needed for high-quality and timely analysis, often relying on manual or spreadsheet-based systems instead of integrated enterprise resource planning solutions," Chan said. – Bernama

Regulatory shifts reshaping fintech expansion: Kairous Capital

KUALA LUMPUR: Regulatory changes in key markets such as the United States and the European Union impact fintech expansion, particularly in cross-border pay-ments, crypto, and digital banking. Hence, domestic companies must stay compliant to retain market access, making regulatory adapta-bility a vital investment factor.

Kairous Capital managing partner Joseph Lee (pic) said the geopolitical landscape, including US-China fintech restrictions, affects the capital flow and tech partnerships in emerging markets such as Malaysia.

"Investors must gauge how fintech startups tackle regulations while seizing regional opportunities.

"At Kairous Capital, we assess their regulatory resilience and scalability across markets, leveraging our Southeast Asia-China network to help them navigate complexities, form key partnerships, and refine expansion strategies," he told SunBiz.

Lee said fintech is transforming payments with real-time settlements. Application Programming Interface integrations and digital wallets, making transactions faster and more secure.

Artificial intelligence-driven fraud detection, encryption, and tokenisation enhance security, making

digital payments safer than cash, he said, adding, however, that inte-grating these innovations with legacy systems is costly and complex.

"Fintech firms must also keep up with evolving regulations and cyber threats. From January to October 2024, Malaysia saw RM1.22 billion in cybercrime losses, prompting the government to review banking laws for stricter accountability. Banks and fintechs alike must invest in infrastructure and talent to balance innovation with security," Lee said.

Fintech plays a crucial role in expanding access to financial services by significantly lowering the barriers to entry, he noted.

One key aspect is the transformation of traditional banking through digital platforms.

Mobile banking apps, digital wallets, and online payments reduce costs and make it affordable for underserved populations to open and maintain accounts. This digital shift has allowed millions, especially in developing regions, to manage money and transact without needing physical branches.

Lee said another important role is fintech's innovative approach to redit scoring. By utilising alternative data – such

as utility payments, rental histories, behavioural metrics, or even social circles - fintech firms can assess the creditworthiness of individuals lacking formal credit histories.

This, he said, opens the door for micro-loans and other financial products to those previously ex-cluded by traditional lenders.

"For example, most digital wallets in Malaysia offer micro-financing products for their users. Given the small loan size and cost of delivering this service to a large user base, banks have historically been unable to do so. Together, these ad-vancements democratise financial services and drive economic empowerment and growth

by integrating more people into the formal financial ecosystem."

On fintech's role in healthcare payments, Lee said digital platforms enhance efficiency by automating billing, claim verification, and fraud detection. "A notable case we can examine is

fintech companies working on digital-enabled medical coverage and digital third-party administrators

"By integrating mobile wallet solutions and potentially blockchain-based claim processing in future, they can reduce billing turnaround times and slash administrative costs by more than 30%.

"However, there are chal-lenges like integrating these

solutions with legacy systems, ensuring robust cybersecurity to protect sensitive patient data and complying with evolving healthcare regulations.

Lee said fintech is also revolutionising sectors like manufacturing, agriculture, and supply chain logis-tics by unlocking new avenues for working capital and streamlining payments through data-driven digital platforms.

"Overall, we see these innovations lowering the transaction costs and accelerating fund disbursement, enabling a more agile, inclusive financing ecosystem that drives growth and competitiveness in traditionally capital-intensive sectors.

"We strongly believe investors should scrutinise how these firms deploy technology: cost-effective AI and automation should enable rapid scaling without excessive capital outlay.

"A successful fintech should balance tech investment with tangible outcomes, ensuring innovation leads to improved customer retention and sustainable income rather than higher tech spending.

"When these elements are in place, investments in inclusive fintech diversify portfolios and offer potential for long-term stable returns as they tap into expanding under-served markets," Lee said.

PETALING JAYA: Franchise International Malaysia 2025 (FIM 2025) is poised to become a key gateway for franchise expansion in the Asean region, providing a platform for local and international brands to explore new market opportunities.

Organised by the Malaysian Franchise Association (MFA) in collaboration with the Ministry of Entrepreneur and Cooperatives Development, this year's edition is expected to attract more than 150 franchise players and 30,000 visitors, reinforcing Malaysia's position as a regional franchise hub.

MFA chairman Datuk Radzali Hassan (*pic*) said, FIM 2025 will feature a range of high-impact programmes designed to facilitate business networking, knowledge sharing, and cross-border investment.

"Among the highlights are the Asean Franchise Convention (May 7-8), which will bring together industry experts to discuss franchise sustainability, digital transformation, and

profitability. The event will also see the adoption of key franchise-related declarations among Asean member countries, further strengthening regional collaboration," he told SunBiz.

Additionally, Radzali said the franchise business matching session (May 8) aims to connect

franchise brands with potential investors and partners from over 20 countries, helping busi-nesses expand beyond their domestic markets.

"Other major events include the franchise exhibition (May 8-10, featuring global fran-chise brands, and the certified franchise executive training programme (May 5-6), which will equip professionals with advanced franchise m a n a g e m e n t skills," he added. Beyond FIM

2025, Radzali said, MFA is a c t i v e l y facilitating the global exbrands through a series of franchise trade missions to high-potential markets.

Radzali emphasised the impor-tance of these initiatives in posi-tioning Malaysia as a global franchise leader.

"Malaysia has a well-established franchise ecosystem, supported by strong legal frameworks such as the Franchise Act 1998 and globally recognised certifications like our halal certification. Through FIM 2025 and our international trade missions, we aim to accelerate the global expansion of Malaysian franchise brands and strengthen cross-border collaborations," he said.

To ensure sustainable franchise growth, Radzali said, MFA is working closely with financial institutions government agencies to provide financing support for franchise entrepreneurs.

'Several institutions, including Perbadanan Nasional Bhd, SME Bank and Tekun Nasional, are

offering financing schemes tailored to franchise businesses. The Market Development Grant by Matrade further supports international franchise expansion efforts by pro-viding financial assistance for overseas market entry."

With the National Franchise Policy 2030 positioning franchising as a key driver of Malaysia's economic growth, Radzali said.

MFA's strategic focus remains on ex-panding market access, streng-thening financial accessibility, and fostering global partnerships.

"As MFA continues to strengthen collaborations with government agencies, trade associations, and private investors, FIM 2025 and the upcoming franchise trade missions are set to play a pivotal role in accelerating Malaysia's franchise industry growth both regionally and globally," he said. FIM 2025 will be held at the

Kuala Lumpur Convention Centre from May 8 to 10, providing a prime opportunity for franchise brands, investors, and industry stakeholders to engage, collaborate, and expand their businesses across borders.

In 2025, MFA will lead trade missions to key destinations in-cluding the Philippines, Taiwan, China, Indonesia, Saudi Arabia and Kazakhstan, connecting local franchisors with international investors and business partners." He said these trade missions provide Malay-

Malaysia Petroleum Resources Corporation (MPRC) senior vicepresident/operations head Mustafa Akbar Reza noted that the OGSE industry consolidation has been repositioned to focus on strategic partnerships.

"The idea is that there are many OGSE companies and each company is concentrated on one business. The term 'industry consolidation' did not fully capture the opportunities available for OGSE companies to build capacity and capability and was too restrictive in terms of what we want to achieve in the industry," he told Bernama in an interview ahead of the launch of the Mid-Term Review of the National OGSE Industry Blueprint 2021-2030 (OGSE Blueprint) report tomorrow.

Launched by the Ministry of Economy in April 2021, the OGSE Blueprint aims to develop a robust, resilient and globally competitive Malaysian OGSE sector.

In 2023, there were 3,392 OGSE companies under the Standardised Work and Equipment Categories licensed and registered by Petroliam Nasional Bhd.

Mustafa noted that strategic partnerships would help OGSE companies diversify and compete better, especially outside Malaysia, which can also help them diversify their customer base. He said the MPRC is committed to strategic partnerships forward and that the agency is looking for a series of programmes to enhance the competitiveness and resilience of

Mustafa said the MPRC also is planning to introduce another key component of strategic partnerships on March 20 that may include the signing of memorandums of understanding or formal agreements between one or two partners and pointed out that technology adoption was historically an area where OGSE companies lagged.

"We have just seen our effort to boost technology adoption pick up pace since last year," he said, adding that there would be an announcement of new developments under the OGSE Development Grant to support technology adoption.

Since the launch in 2021, RM20 million has been allocated through the OGSE development grant, benefitting 64 companies, with 22 companies successfully commercialised and generating a combined revenue of RM38.3 million

Mustafa noted that the OGSE development grant has not gotten enough representatives from Sabah and Sarawak and that the MPRC would work together with stakeholders in both states to address the issue.

Explaining the mid-term review report, Mustafa said the report was conducted by MPRC to evaluate progress and ensure the industry remains aligned with national priorities and successfully adapts to the evolving energy landscape. In general, Mustafa said the

In general, Mustafa said the majority of OGSE companies are small and medium enterprises, so the

impact of the OGSE Blueprint, especially concerning their most pressing "pain points", such as upskilling talent, technology adoption and access to finance, benefits the SMEs.

"The OGSE Blueprint is a longterm document, involving all the OGSE ecosystem stakeholders, as with any undertaking of this size, one challenge is ensuring everyone remains committed to working together until the finish line," he added.

Among key milestones achieved since the OGSE Blueprint launch were bridging the talent gap and addressing the industry's need for a one-stop source of information on support and services available for OGSE companies.

On talent development, Mustafa said around 600 individuals were trained under the coaching and mentorship programmes, enhancing OGSE industry knowledge and expertise, and more than 300 upskilled and certified in highly sought after technical disciplines.

He added that the launch of the i-OGSE portal in 2023, which provided information on areas including financing and export programmes has channelled grants, alternative financing and export assistance to more than 60 companies.

Mustafa said eight new or expansion projects have been approved by Mida, attracting multinational investments and 160 companies and recording a total of RM2 billion in potential export sales via Matrade-led business matching and global trade fairs.

Since 2021, Mustafa said some OGSE companies are gradually shifting to new adjacent sectors in the energy transition, with companies venturing into solar and other renewable energy.

"This marks a major milestone in the evolution of the OGSE sector, where we see companies pivoting to new businesses, in line with the oil and gas industry's shift towards providing lower emissions solutions," he added.

EVE Energy expansion to create over 1,000 jobs

KUALA LUMPUR: EVE Energy Co Ltd's phase 2 expansion will create over 1,000 jobs, underscoring its commitment to Malaysia's economic growth, the Malaysian Investment Development Authority (Mida) said.

IRB's e-Ansuran now accessible on MyTax portal

PUTRAJAYA: The online instalment application service for payment of tax balances or tax arrears via e-Ansuran has been accessible through the MyTax Portal since March 5.

The Inland Revenue Board (IRB), in a statement yesterday, said the initiative was introduced to make it easier for taxpayers to apply to pay in instalments their tax balances or tax arrears, allowing them to obtain automatic

approval without the need for supporting documents.

According to IRB, eligible taxpayers must meet the following criteria, the total application amount must exceed RM 300 and above and the Instalments can only range between two to six payments.

It said the application applies to income tax instalments only and does not include ongoing

instalment plans.

Taxpayers can access the e-Ansuran service by logging into the MyTax portal via the link https://mytax.hasil.gov.my/ and selecting the relevant role (Individual / Director / Representative Director).

However, cancellation of e-Ansuran applications can only be done at the IRB office. – Bernama

New dawn for third-party funding in Malaysia

LEGALLY SPEAKING

ThirdD-PARTY funding (TPF) is the funding by an external party of a litigant's costs for arbitration proceedings. Funding is typically provided by specialised funders or insurers, in return for a share of the settlement or damages, if the litigant is successful. The enactment of the Arbitration (Amendment) Act 2024 sees the introduction of a formal framework governing TPF in domestic and international arbitrations, where any services related to the arbitration are provided in Malaysia, even if the seat of arbitration is outside Malaysia.

The Arbitration (Amendment) Act introduces a structured framework for TPF agreements emphasising legitimacy, transparency, and regulation. The Act states, amongst others, that:

● TPF agreements may cover the "costs or expenses of the arbitration", which includes any costs or expenses incurred prior to the commencement of the arbitration or during the arbitral proceedings or the court proceedings relating to the arbitration.

• The common law rule against maintenance and champerty shall cease to apply to the TPF and such agreements shall not be treated as contrary to public policy; and

The Act sets out the disclosure requirements for such agreements which include requirements to disclose the existence of a TPF agreement and the identity of the funder to assess any potential conflicts of interests to facilitate transparency.

This shift signals the end of Malaysia's long-standing position on the torts of maintenance and champerty – both traceable to English common law and deemed contrary to public policy. Maintenance occurs when a third party, with no prior interests in the proceedings, maintains or aids a litigant to prosecute or defend an action. Champerty is a form of maintenance wherein an action is funded in exchange for a reward or portion of the proceeds of litigation.

These specialised funders, often financial firms or insurers, provide financial assistance on a contingency or success-based model and are invaluable to levelling the playing field in David versus Goliath scenarios where a litigant with little means comes up against a defendant with extensive resources and deep pockets. TPF may balance the scales, ensuring the financial backing of everyday

Goliaths do not outlast, overpower or pressure the Davids into submission. It holds larger corporations and well-funded entities accountable and discourages them from using financial dominance over entities or individuals with lesser means, for example, tech startups defending their patents from a dominant tech conglomerate; a subcontractors enforcing payment claims against a main contractor; and a minority shareholder challenging the unfair practices of the majority.

TPF agreements also allow litigants to mitigate financial risks by transferring the costs and risks to an external funder and reducing their own upfront expenditure and exposure to losses with minimal disruption to everyday workflow. Contextually, such agreements would allow a small business(es) involved in protracted legal proceedings to avoid dipping into its working capital or exhausting other financial reserves. Incidentally, this financial safety net may also result in parties being less inclined to settle and may encourage a more robust and drawn-out pursuit of claims.

TPF agreements are often bespoke, highly customisable and complex, with terms tailored to meet the litigant's specific needs. For example, rather than relying on a single funder, agreements may cater to multiple funders at varying stages of the proceedings, with the funders' returns and contributions aligned to their expertise and the case's requirements. This model however brings its own set of challenges as it requires careful coordination between the parties to prevent misalignment of expectations on the outcome, timelines, or strategies of the case. The involvement of multiple funders raises concerns about funders potentially influencing case strategy and prioritising profit over the best interests of the litigant. Without adequate safeguards, there is a risk that disputes may shift from being justicedriven to being investment-driven.

Whilst the introduction of TPF into arbitration proceedings marks a significant shift in the alternative dispute resolution scene in Malaysia, its newness brings both promise and uncertainty, expanding access to justice and providing a lifeline to smaller entities but at the potential cost of unfamiliar complexities. As parties navigate this evolving landscape, it is imperative to seek legal consultation to ensure fair and equitable resolution of disputes that remains justicedriven, not investment driven.

BEIJING: Dozens of foreign CEOs will visit Beijing this month for a flagship development conference where some are expected to meet President Xi Jinping, according to a draft agenda and three sources familiar with the matter.

The annual China Development Forum will take place on March 23-24 at the Diaoyutai State Guesthouse in the capital, two sources told Reuters.

Beijing is keen to attract foreign investment at a time of heightened geopolitical tensions, as policymakers try to boost domestic consumption to offset fresh US tariff pressure.

Those attending include the CEOs of FedEx, Siemens, automakers BMW and Mercedes-Benz, chip designer Qualcomm, AstraZeneca, Nestle, Saudi Aramco, Citadel, Rio Tinto, Estee Lauder, Standard Chartered and KPMG, according to a draft agenda seen by Reuters. The chairman of Deutsche Bank is also on the list.

A Mercedes-Benz spokesperson confirmed to Reuters that CEO and chairman Ola Kallenius would attend the forum. A spokesperson for pharmaceutical firm AstraZeneca declined to comment on whether the CEO was attending and meeting Xi. BMW's China chief Sean Green will also

BMW's China chief Sean Green will also attend, according to people familiar with the matter, adding CEO Oliver Zipse would make clear to the Chinese government that the German carmaker planned to continue to support the market. BMW declined to comment.

None of the other firms immediately responded to requests for comment.

Top executives of several major mining, engineering and healthcare firms will also take part, according to the draft agenda, which could be subject to last-minute changes, one of the sources said. Compared to previous years, a higher proportion of European CEOs are represented.

Xi is likely to meet a select group of foreign chief executives on March 28, which could include European and British CEOs, said one source, adding that the list of attendees and timings could be subject to last-minute changes. Reuters was not able to determine the list of overseas CEOs expected to meet Xi. US President Donald Trump imposed 20%

tariffs on Chinese exports this month, prompting China to retaliate with additional duties on American agriculture products. Foreign direct investment into China fell

Foreign direct investment into China fell 13.4% year-on-year in January, according to official data released last month.

"Any trip to China by American CEOs would be very low-key given the current heightened scrutiny on American investment in China from Washington," said the source, adding that fewer US CEOs would attend this year. However, some leading American chip firms such as Broadcom and Synopsys are sending their CEOs, according to a list of foreign delegates seen by Reuters. Micron said yesterday its CFO Mark Murphy has been invited to attend the forum this year.

American firms subject to current investigations or scrutiny by Chinese authorities including Google, Illumina, PVH and Walmart were also not on the draft agenda.

"I think it's still important for the Chinese to showcase their interest in foreign business people but it's hard to see how there is a real dialogue going on," Joerg Wuttke, partner at DGA Group and former president of the European Chamber of Commerce in China, told reporters in Shanghai on Monday.

"It would be nice if (Xi) has a new message of real openness and the question is would he do this. In the European business community we've coined this phrase 'promise fatigue." – Reuters

CK Hutchison faces increasing pressure over ports deal

HONG KONG: Hong Kong is opposed to "bullying tactics" by foreign governments, the city's leader said yesterday when asked about conglomerate CK Hutchison's port deal with US firm BlackRock amid reports that China is also scrutinising the sale.

CK Hutchison said this month it had agreed to sell most of its global US\$22.8 billion (RM101.3 billion) ports business, including assets near the strategically important Panama Canal, to a group led by BlackRock.

The deal has become highly politicised, with US President Donald Trump hailing the deal after previously calling for the Panama Canal to be removed from what he says is Chinese control.

Other American politicians have said CK Hutchison's operation of the ports represented a security risk to the US due to its reliance on the trade of goods through the canal.

"(The Hong Kong) government urges foreign governments to provide a fair and just environment for enterprises," Hong Kong leader John Lee told reporters at his weekly press conference.

"We oppose the abusive use of coercion or bullying tactics in international economic and trade relations."

Yesterday, Bloomberg News reported Chinese authorities have begun looking into CK Hutchison's ports transaction, directing multiple agencies to review the deal for potential security risks and antitrust violations.

Beijing's examination of the deal doesn't necessarily mean any action will be taken subsequently, the report added, as large deals often attract regulatory attention.



CK Hutchison did not immediately respond to a request for comment on the report. It has previously said the deal is "purely commercial in nature and wholly unrelated to recent political news reports concerning the Panama Ports".

It was not immediately clear what levers, if any, China could pull to block the deal, given the business that CK Hutchison is selling is outside China and Hong Kong, while the company itself is registered in the Cayman Islands.

Hong Kong leader Lee told reporters "any transaction must comply with legal and regulatory requirements", adding the city would handle it "in accordance with the law".

Shares of Hutchison fell as much as 4.9% yesterday, hitting their lowest since March 4. Founded and listed in Hong Kong, CK Hutchison, owned by billionaire Li Ka-shing, has said its business operations are independent from China.

A week after news of the ports deal, China's Hong Kong and Macau Affairs Office reposted two commentaries criticising CK Hutchison and saying the sale was a betrayal of China that neglected national interests.

While CK Hutchison agreed to negotiations with the BlackRock consortium on an exclusive basis for 145 days according to a statement, the deal has not yet been finalised.

As the controversy escalates, two sources told Reuters on Monday that CK Hutchison will not hold earnings conferences after it reports results tomorrow, a highly unusual move for the conglomerate. – Reuters

'Hedge fund Polymer Capital to debut pure Japan funds'

HONG KONG: Polymer Capital Management, a Hong Kong-headquartered hedge fund, is launching two Japan-focused funds this year to tap into the robust demand for the world's thirdlargest stock market, according to three people familiar with the matter.

The move will see the US\$4 billion (RM17.7 billion) multi-manager Asian hedge fund heavyweight joining a wave of fund launches in Japan.

One of Polymer's new funds will adopt an equity long/short strategy and allocate capital across a team of 30 portfolio managers, with an initial target size of US\$500 million.

This fund will largely replicate the current

Japanese book under its flagship Polymer Asia Fund, two of the sources, who are directly involved in the matter, said on condition of anonymity as the information is not public. The second fund is an equity fund that takes

only long positions, or so-called long-only fund, one of the sources said.

Tokyo-based investment veteran Daisuke Nakayama, who previously ran JPMorgan Asset Management's Japan fund, will lead the longonly product, the source said.

Nakayama's portfolio, since he joined Polymer in September 2023, has posted returns exceeding 20% over the Topix benchmark, the source added. A Polymer spokesperson declined to comment.

Polymer, founded by ex-Point72's Asia head Angus Wai in 2019 and backed by alternative investment giant PAG, has quickly grown into one of Asia's largest hedge fund platforms that uses various trading teams to invest across different asset classes. Its main market-neutral Polymer Asia Fund returned 11.6% in 2024.

Polymer started a China A-shares Equity Fund in April 2024, diversifying into a single country fund for the first time.

The firm now has six offices in Hong Kong, Shanghai, Singapore, Sydney, Taipei and Tokyo. – Reuters

EQUINIX ISSUES GREEN BONDS IN MAIDEN OFFERING IN SINGAPORE

SINGAPORE: US digital infrastructure company Equinix said yesterday that it has issued S\$500 million (RM1.66 billion) in green bonds in its inaugural offering in the Singaporean market. The Nasdaq-listed company said in a statement it intended to allocate an amount equal to the net proceeds from the green bonds to recently completed or future eligible green projects. Equinix issued S\$500 million in 3.50% senior notes due 2030 in the offering that closed on March 13, said the statement. The issuance is the first time a US company has accessed the Singapore dollar bond market in over five years. DBS Bank and Standard Chartered were joint global coordinators. They were also the joint lead managers and bookrunners with HSBC and OCBC, the statement showed. – Reuters

CHINA EV GIANT BYD SOARS AFTER SUPER FAST CHARGER LAUNCH

BEIJING: Shares in Chinese EV giant BYD surged to a record high yesterday after it unveiled new battery technology it says can charge a vehicle in the same time it takes to fill up a petrol car. The company said the battery and charging system, called "Super e-Platform", boasted peak speeds of 1,000kW, allowing cars to travel up to 470km after being plugged in for just five minutes. Hong Kong-listed shares in BYD jumped more than 6% to hit a fresh peak at one point yesterday morning before paring some of the gains. Shenzhen-based BYD introduced the Super e-Platform alongside two new EV models that will be the first to feature the system: the Han L sedan and the Tang L SUV. The Shenzhen-based company also unveiled plans to build more than 4,000 ultra-fast charging stations nationwide to support the new technology. – AFP

Other countries will hit back at US with high tariffs'

China's Global Times warns that Washington's measures will inflict significant harm on American economy

BEIJING: US tariffs will inflict significant harm on the US economy as other countries hit back with "high tariffs" on American goods, Chinese state media warned, leaving the door open for more measures by Beijing as another wave of levies looms.

Barely two months after returning to the White House, President Donald Trump has triggered trade conflicts with China, Canada, Mexico and the European Union. Trump is also threatening reciprocal tariffs on every country that taxes US imports, with those levies potentially kicking in on April 2.

^c China swiftly responded with countermeasures in February and March when two rounds of Trump tariffs took effect. And Beijing is widely expected to quickly react to the April tariffs should they come to pass.

"In response to US tariffs, its trading partners will not sit idly by," the nationalist Chinese tabloid *Global Times* wrote in an

editorial yesterday. "Retaliating with high tariffs on US exports could become an option for many countries."

Beijing has slapped retaliatory levies on US agriculture and food exports, placed export and investment curbs on 25 US firms, suspended soybean import licences of three US firms and halted imports of US logs.

China also launched probes into some

US fibre optic products. To help foreign companies based in China resist "external shocks", its commerce ministry will take a series of measures to help them expand sales in the country, according to Yuyuan Tantian, a social media account affiliated with state broadcaster CCTV, on Monday, citing people familiar with the matter. "Many countries are actively seeking to

diversify their economic partnerships and reduce their reliance on the US by forging new trade alliances," *Global Times* said.

In a separate development, the CEOs of two top Australian banks said in Sydney a

trade war sparked by Trump's tariffs may drive up global inflation, stoke market volatility and slow economic growth, but added Australia was insulated from the disruption.

The heads of No. 1 retail lender Commonwealth Bank of Australia and No. 1 business lender National Australia Bank told a conference the new US administration's protectionist policies would likely strain the global economy in the medium term with higher costs and lack of certainty.

But Australia's roughly US\$15 billion (RM66.7 billion) a year in exports to the US was small compared to its overall export trade, so the country was better placed than Canada, which sells 85% of its exports to the US, the financial leaders added.

"There's certainly risk to the downside, around slowing global growth," CBA CEO

Matt Comyn told the Australian Financial Review Business Summit, adding US tariffs would mean "inefficiencies in trade (and) therefore more inflation".

CBA had reported a "pronounced uptick" in mortgage applications since the Reserve Bank of Australia cut interest rates last month for the first time since November 2020 to 4.1%, Comyn's head of retail banking Angus Sullivan told the conference earlier.

NAB CEO Andrew Irvine said the rate cut had been an "exhale of breath" in the economy, but "tariff madness" under Trump may lower the chance of further cuts this year. Currently NAB expects two

25-basis point cuts in 2025. "We're not an island," Irvine told the conference. "If this tariff madness does happen, we could be at the end of (rate) reductions." – Reuters, AFP

Alaskan officials to seek investors in Asia for LNG project

TOKYO: Alaska's governor and state represen-tatives will visit Japan and three other Asian countries starting this week to court investors for a natural gas project that President Donald Trump says could pump trillions of dollars into the US, although Japanese energy firms remain sceptical.

Officials from the state-run Alaska Gasline Development Corporation (AGDC) and development partner Glenfarne Group will visit allied Asian countries "to update industry leaders on Alaska LNG's economic and strategic competitive advantages, and discuss oppor-tunities for participation", said AGDC spokesperson Tim Fitzpatrick.

The officials want to transport gas south from Alaska's remote north via a US\$44 billion 1,300km pipeline, to be shipped as liquefied

natural gas to Japan, South Korea and Taiwan. The trip, which Alaska Governor Mike Dunleavy will also be taking, runs from today to March 30 with visits to Taiwan, Thailand, South

Korea and Japan. "He's going to be going over there to hold high-level discussions with the leaders in all those countries and corporate executives to talk about the pipeline," said Jeff Turner, Dunleavy's spokesperson. "If we can get a pipeline project going, we can certainly be a steady supplier of LNG to the Pacific Rim."

Dunleavy said last week that exports could begin by 2030 and deliver about 3.5 billion cubic feet of gas per day.

Trump is pushing energy sales to Asian allies while threatening trade tariffs, reviving Alaska's stalled LNG ambitions. On Feb 7, he asked Japanese Prime Minister Shigeru Ishiba for support and on March 4 South Korea agreed to discuss the project.

South Korea's industry ministry said AGDC had asked for a meeting, but that nothing has been decided. Despite Trump's claim that Japan wants in, Japanese energy firms have yet to commit. – Reuters

EFS **INDONESIA TO RAISE PALM OIL EXPORT LEVY TO 4.5%-10% TO FUND BIODIESEL MANDATE**

JAKARTA: Indonesia will raise its palm oil export levy to between 4.5% and 10% of the crude palm oil reference price, up from 3% to 7.5%, to finance a mandated increase in the amount of the oil used in biodiesel, a plantation fund official said yesterday. Indonesia raised the mandatory amount of palm oil in its biodiesel mix to 40% this year from 35%. It is studying increasing it to 50% in 2026, as well as a 3% blend for jet fuel next year, as it seeks to curb fuel imports. Kabul Wijayanto, director at the Plantation Fund Agency, which is in charge of collecting and distributing the export levy, said authorities would impose the new rates three days after the regulation is issued. Wijayanto said the regulation was being processed by the law ministry. – Reuters

SNB SAYS WEAKNESSES IN BANKS' CAPITAL REGIME STILL NEED TO BE ADDRESSED

ZURICH: Weaknesses in the capital regime for the Swiss banking sector still need to be addressed after the 2023 collapse of Credit Suisse, the Swiss National Bank (SNB) said yesterday, backing government efforts to make the industry more robust. In its annual report, the Swiss central bank noted that it had in an assessment last June highlighted weaknesses in UBS's capital backing for its subsidiaries. "The SNB emphasised that the current capital position of the UBS parent bank is stronger than that of Credit Suisse before the crisis," it said. "Nevertheless, weaknesses in the current capital regime need to be addressed." UBS argues that it is already well capitalised in comparison to global rivals and that making it hold billions of additional dollars risks putting it at a disadvantage. Reuters

Air India CEO: Global aircraft shortage at least 4 years

NEW DELHI: Air India CEO Campbell Wilson said yesterday the global aircraft shortage hampering airline growth will persist for four to five years as supply snags hobble production at jetmakers Boeing and Airbus.

speaking at an event organised by travel news website Skift, Wilson said he sees pinch points in the supply of narrowbody jet engines, business and first class seats, and some elements of aircraft fuselages.

Air India is in the midst of an ambitious turnaround strategy two years after Tata Group took control of the airline, but its restructuring efforts have been complicated by jet delivery delays. These setbacks have forced the airline to operate older jets longer than planned, increasing maintenance costs and slowing its modernisation and expansion drive

When asked about how Air India plans to navigate delays, Wilson told reporters:[#]There is not a lot we can do. We are victims of circumstance, as is every other airline."

"If you are capacity constrained, you need to be a little bit more ruthless with respect to where you deploy aircraft to maximise the return," he added. "It means you can't expand to places you would otherwise like to expand."

The competition among airlines to lease aircraft and the different configurations available make leasing aircraft challenging, Wilson added.

In 2023, as a part of the multi-billion-dollar revamp, Air India ordered 470 jets from Airbus and Boeing, including 10 of the US planemaker's much-delayed 777X aircraft and 190 Boeing 737 MAX jets. Late last year, the

airline ordered 100 more Airbus aircraft.

When asked about delivery timelines for 7X, Wilson said, "Who knows?" His comment underlined uncertainty among

airlines who have ordered the jet that is considered a successor to Boeing's 777, one of the

most commercially successful long-haul airliners. Last month, Wilson told Reuters Air India was holding off on exercising its outstanding options to buy additional Boeing jets until the planemaker has cleared its backlog.

Boeing is recovering from a near two-month crippling worker strike last year. The planemaker cannot produce more than 38 737 MAX aircraft per month because of a cap set by the US Federal Aviation Administration.

Boeing did not immediately respond to a Reuters request for comment. - Reuters

Gold hits record high amid economic concerns

▶ Bullion surpasses US\$3,000 twice in one week as trade tensions, economic instability drive investor demand

BENGALURU: Gold prices scaled a record peak above the crucial US\$3,000-mark (RM13,326.90) yesterday for the second time in a week, as investors sought cover from economic concerns fuelled by US President Donald Trump's tariff policies.

Spot gold rose 0.2% to US\$3,006.88 an ounce as of 0525 GMT after hitting a record high of US\$3,016.92 per ounce earlier in the session.

Gold climbed above the US\$3,000/oz milestone for the first time on Friday.

US gold futures gained 0.4% to US\$3,017.20.

Gold is moving higher on account of a weaker dollar and continued tariff uncertainties... With gold at record highs there

is a lot of technical and chart based buying that kicks in since there is no resistance apparent on the charts," said Marex analyst Edward Meir.

The US dollar index wallowed near a fourmonth trough, making gold cheaper for overseas buyers.

Historically considered a hedge against geopolitical instability, gold has risen more than 14% year-to-date. Since Trump took office in January, gold has hit a record high 14 times as trade tensions boosted safe-haven demand.

Trump has floated plans for a series of US tariffs, from a flat 25% on steel and aluminium which came into effect in February to reciprocal and sectoral tariffs that he said will be imposed on April 2.

ANZ raised their up to 3-month gold price forecast to US\$3,100/oz and 6-month forecast to US\$3,200/oz, citing escalating geopolitical and trade tensions, easing monetary policy and strong central bank buying.

New economic projections from Federal Reserve officials this week will provide the most tangible evidence yet of the likely impact of Trump administration policies.

Forecasters have marked down their expectations for US growth this year, raised concerns about a potential recession, and expect increased inflation.

Israeli air strikes may also see tensions flare in the Middle East again and that could add to the litany of drivers pushing gold higher," Capital.com's financial market analyst Kyle Rodda said.

Spot silver firmed 0.1% to US\$33.85 an ounce, platinum added 0.2% to US\$1,002.50 and palladium rose 0.4% to US\$968.96. Reuters

FAA reinstating fired employees after court order: Union

WASHINGTON: The Federal Aviation Administration (FAA) is reinstating 132 employees who were fired on Feb 14 after a federal judge in Maryland ordered their return, a union said on Monday. The Professional Aviation Safety Specialists

union said the probationary employees who were fired as part of the Elon Musk-led Department of Government Efficiency federal government cuts will receive back pay and should return to duty status on March 20.

"This is a win for public safety and for a critical workforce dedicated to the FAA's mission," union President David Spero said.

Transportation Secretary Sean Duffy said last month that the FAA cut 352 probationary employees out of about 45,000 total, but said none were in "safety critical" positions.

The FAA did not immediately respond to a request for comment. The US Transportation Department cut hundreds of other probationary workers across other agencies.

The firings raised alarm after a series of plane crashes have sparked concern about US aviation safety

US District Judge James Bredar in Baltimore directed the administration to reinstate tens of thousands of federal workers, saying 18 agencies that fired probationary employees en masse violated regulations governing the process for laying off federal workers. The government had claimed it fired individual workers for performance reasons.

"There were no individualised assessments of

employees. They were all just fired," Bredar said. The union said those who were fired in February included technical operations, mission support services, air traffic services and flight standards service.

"Haphazardly eliminating positions and encouraging resignations creates a demoralising effect on the workforce," Spero said. "We are pleased that the expungement of these letters referencing the false performance claims allows these employees to continue their service to the American flying public without this unsubstantiated blemish on their work record." – Reuters

Audi to cut 7,500 administration, design jobs by 2029

BERLIN: Volkswagen's Audi will cut up to 7,500 jobs in Germany by 2029 in areas like administration and development, the premium carmaker said on Monday, the latest German auto industry player to reduce costs.

The planned measures, agreed on Monday by management and labour representatives, should save the carmaker €1 billion (RM4.9 billion) per year in the medium term, it said, adding it was investing a total of €8 billion in its German sites in the coming four years. The cuts at Audi bring layoffs currently

planned across the Volkswagen Group to just under 48,000: VW has unleashed a cost-cutting programme involving 35,000 job cuts, Porsche plans to cut 3,900 jobs, and software unit Cariad aims to slash around 1,600.

Audi has already cut around 9,500 production jobs since 2019, a move it said at the time should free up billions of euros to fund its shift to EVs and boost margins to 9-11%.

But the brand has fared poorly in recent years, with its operating margin crashing to 4.5% in the first nine months of 2024 from 7% in the same period of the previous year due to weak sales in its key markets and the cost of ceasing production at its struggling Brussels plant. A job security guarantee agreement at its

German sites was extended to the end of 2033, Audi said. – Reuters

Big pharma fears top drugs targeted in US-EU tariff feud

LONDON: Drugmakers are urging the Trump administration and European Union (EU) officials to exclude medical goods from expanding tariff wars, hoping to avert price spikes on top-selling medicines made in Europe from Novo Nordisk's Wegovy for weight loss to Merck's cancer immunotherapy Keytruda. In conversations with US officials, the

pharmaceutical industry argued that tariffs on the EU would increase drug costs and create access barriers for patients, endangering priorities outlined in President Donald Trump's health-related executive orders on drug pricing and increasing life expectancy of Americans, according to more than a half dozen pharma industry sources with direct knowledge of the discussions.

Some are signalling a willingness to expand manufacturing in the US, while pressing for tax breaks and regulatory changes that would make it easier to make that happen, according to three of the sources.

"We are firmly delivering the message to the Trump administration and to the European Union that patients will pay the price" for tariffs, said a

senior executive at a European drugmaker. Industry executives are also pressing their case with officials in Brussels, urging the EU hold off on retaliatory tariffs even if Trump includes medicines in a trade dispute, several of the sources said. Some raised the fact that lifesaving medicines were excluded from sanctions on Russia following its invasion of Ukraine.

Western countries "We have as interconnected supply chains in this sector. Interrupting these flows will hurt patient access to lifesaving medicines," said a senior executive at another large European drugmaker. "It's a loselose" situation.

Pharmaceutical products have long been spared from trade wars due to the potential harms. But Trump's move to increase tariffs on goods from China, including finished drugs and raw ingredients, as well as an initial round of tariffs between the US and EU on goods like steel and bourbon, has raised expectations that medicines will join the list.

The majority of medicinal supplies imported from China are of low monetary value. But the US depends on medicines partly produced in Europe that bring in hundreds of billions of dollars in revenue.

For example, Novo Nordisk partially makes some of the active pharmaceutical ingredient for obesity injection Wegovy in Denmark, while

mega-blockbuster Keytruda and Merck's AbbVie's wrinkle treatment Botox are made in Ireland.

Novo CEO Lars Fruergaard Jorgensen said this month that his company would experience short-term impacts from tariffs, but is moving to produce domestically more of its medicines sold in the US. The company last year announced a US\$4.1 billion (RM18 billion) investment to expand production in North Carolina.

Merck declined to comment for this story. AbbVie declined to comment on where individual medicines are manufactured but said it has a robust manufacturing network globally.

The US government, a major buyer of drugs for its massive Medicare and Medicaid health programs, may face higher prices to account for the cost of tariffs, said Simon Baker, head of global biopharma research at Redburn Atlantic.

Emily Field, head of European pharma equity research at Barclays, told Reuters that until very recently she thought tariffs on prescription drugs were not a serious threat. Now she is "getting asked about this nonstop by clients," she said.

Industry sources declined to say how the Trump administration has responded to its messages. The US president has previously announced tariffs on trade partners only to subsequently suspend or delay them or allow exceptions. One source said it was impossible to know which of several trade policy philosophies would prevail in the White House

Trump last week called out Ireland for luring pharmaceutical companies with tax breaks, contributing to a "massive deficit." White House officials did not immediately respond to a request for comment. The European Commission declined to comment.

The Covid-19 pandemic highlighted the dependency of the US and EU on China and India for raw ingredients to make critical drugs and hospital supplies, as governments competed for materials used in vaccines and protective gear.

Many large drugmakers have since sought to delink supply chains for the Western and Chinese markets. But the notion of separating production ties between Europe and the US was not seriously considered, several of the sources said.

Indianapolis-based Eli Lilly recently announced plans to spend at least US\$27 billion on four new manufacturing plants in the US, but many drugmakers would find it difficult to follow suit, several of the sources said.

Building a new production facility in the US can cost up to US\$2 billion and take 5-10 years before it is operational, including time and costs related to fulfilling regulatory requirements, according to industry trade group PhRMA.

A senior executive from one of the European drugmakers said creating a wholly US-based manufacturing process would mean diverting funds from researching future medicines, and amounts to "fixing something that is not broken." Reuters



Asian Film Awards in Hong Kong celebrates cinematic achievements in glitzy ceremony

HE 18th Asian Film Awards in Hong Kong early this week celebrated the region's cinematic achievements. This year's Asian Film Awards showcased 30 exceptional films from 25 countries or regions, competing for 16 awards.

The red carpet event saw a star-studded lineup, including Malaysian actress Lin Min

Chen, South Korean actor Jang Dong Gun, Taiwanese stars Eddie Peng and Wu Kang-ren. Hong Kong filmmaker and martial arts star Sammo Hung served as president of the jury that selected the winners.

The prestigious Lifetime Achievement Award was presented to *Perfect Days'* Yakusho Koji, recognising his four decades of profound contributions to cinema. Payal Kapadia's Indian co-production *All*

Payal Kapadia's Indian co-production *All We Imagine as Light* won best film, while the best actress honour was awarded to Shahana Goswami for her lead performance in *Santosh* directed by first-time filmmaker Sandhya Suri, who also won the best new director prize.

The best director prize went to Japan's Yoshida Daihachi for his atmospheric character study Teki Cometh.

MAZON Studios knows *Invincible* is one of its strongest media properties, yet certain decisions it made for the adult animated show's new season raise some eyebrows, particularly in the animation department. In *theSun*'s review of the second season, we

In *theSun*'s review of the second season, we pointed out despite a strong narrative, the season had a weak, downright comical moustache-twirling primary villain. However, as a whole, it was elevated by solid writing and great animation, be it during the fights or standard conversations. On the animation front, *Invincible*'s second

On the animation front, *Invincible*'s second season is almost the exact opposite – at least for the first six out of eight episodes.

Superhero morality tested

Once again weaving several plot threads at once, the new season gets down and dirty on the morality and ethics of superheroes, particularly for those who with powers that could easily decimate entire cities.

Mark Grayson/Invincible (Steven Yeun) continues to face the repercussions of his father Nolan/Omni-Man's (J.K. Simmons) actions in the first season. This time around, he is also burdened with setting a good example for his half-brother Oliver/Kid Omni-Man (Christian Convery).

A babbling baby in the second season, the young superhero has aged to around 10 years old in a matter of months due to his half-Tharaxan genetics. Further complicating matters is the emerging bloodlust within Oliver due to being half-Viltrumite. In the background, several other

In the background, several other developments take place, particularly Cecil Stedman's continued research into developing anti-Viltrumite weapons to protect Earth through morally dubious means, Allen the Alien (Seth Rogen) attempting to break Nolan out from a Viltrumite prison in space and Angstrom Levy's return.

As said before, there is a lot more going on in the story with the supporting characters. These plot threads – seemingly inane and sometimes pointless – all culminate and intersect with the final two big events in the season's last episodes.

Animation woes drag season down

The definitive and strongest connective tissue in this season is Mark's growth, along with the relationship between him, Oliver and their mother.

For the half-brothers, a large aspect of their relationship and growing familial bond, which grows throughout and bookends the season, is where do they, as heroes, draw the line when it comes to killing "bad guys" who deserve it and whether the act of taking another's life is warranted.

His development as a character and the Grayson brothers' growing relationship bloom in the final two episodes, which is also the high point of a strong season bogged down by poor animation.

Not so *Invincible*

Shaky animation weighs down season until epic finale

Possibly due to budget or time constraints, every shot, scene or action sequence from the first episode up to the sixth looks like it was done by an amateur animator – or animation team – on YouTube.

Scenes are often poorly shaded. Faces regularly lack dynamic expressions. There is a weird lack of depth in relation to the shadows cast. The worst by far is how any form of movement, particularly the flying or actionheavy ones, looks like still images that are poorly animated to give an illusion of motion.

To illustrate this, look at a picture with someone's face on your phone and use your fingers to crudely enlarge the image and move it around. This is what scenes in *Invincible*'s third season look like when they try to portray movement.

Explosive finale redemption

Amazon Studios may have brought its budgeting approach from *The Boys* over to *Invincible*, where a large chunk of a season is done on a shoe-string budget so money can splurged on the season finale. Because once the seventh episode kicks off, the animation quality roars back with a vengeance.

And what a finale it was. In the seventh episode, a war breaks out with alternate versions of Mark/Invincible appearing on Earth and battling its heroes, while the final episode once again highlights the pure carnage, devastation and catastrophe that follows any Viltrumite.

Lasting nearly 40 minutes, *I Thought You'd Never Shut Up* is an orchestra of mayhem, as one of the most infamous Viltrumites from Robert Kirkman's comics appears on Earth. Voiced by Jeffrey Dean Morgan with the actor's natural menacing swagger, Conquest arrives to see that Mark has failed to conquer Earth after the last Viltrumite, Anissa, came to deliver the order in the last season.

deliver the order in the last season. Nothing short of being a *The Walking Dead* reunion for Yeun and Morgan, their characters enter into a battle that is best summed up as a destructive spectacle, levelling entire cities and leaving at least several thousand civilians either dead or maimed for life.

For the entirety of the season, Conquest is never mentioned or shown coming to Earth. He is not a villain that the season builds up to. The Viltrumite simply appears out of nowhere and through the stellar animation, Morgan's voicework and writing, Conquest proves to be just that good of a villain that he requires no build-up or progression before the climactic fight.

Conquest also answers the question that Mark and Oliver asked each other – yes, some bad guys should certainly be killed if it means protecting even one person.

Invincible's third season is streaming on Prime Video.

Rory's St. Patrick's Day delight

the fairway at the par-4 18th, and the tournament was all McIlroy's once Spaun's third shot narrowly missed the green.

McIlroy finished up with a bogey and won the playoff at 1-over. "I feel like I'm a way more complete player than I

was a few years ago," McIlroy said on the Golf Channel broadcast. "Even in conditions like this.

"That little 9-iron into 17, the little 8-iron into the last there, I said to (caddie Harry Diamond) there, that little

shot will take us a long way. "I feel like I can play in all conditions and

anything that comes my way. Really happy that I was able to get it done today.

McIlroy, 35, picked up the 28th victory of his PGA Tour career and his second of the year, following the AT&T

Pebble Beach Pro-Am. His first Players Championship title came in 2019, and he is the eighth player to win the prestigious event multiple times. His 2019 victory also happened to

occur on St. Patrick's Day. "It's been a good luck charm for

me," McIlroy said. Spaun, 34, is stuck on just one victory

in 228 tournaments in his PGA Tour career. But he continued a stellar start to the season this week by notching his third top-three finish, following a T3 at the Sony Open and a T2 at the

Cognizant Classic. This is probably the best golf I've played maybe in

my career consistently," Spaun said. "I had a chance to win at Sony, had a pretty good chance to win at Cognizant, had a chance to win this week.

"But to go from where I was a year ago today or to start the week, yeah, I'm pretty proud of where I've been able to dig deep and kind of get some self-belief and get some confidence to play some good golf." Spaun and McIlroy both noted the windy conditions

at TPC Sawgrass, which had wreaked havoc on the golfers as early as Sunday. "It was just a tough morning to play golf in general,"

Spaun said. "It would probably be one of the harder days

that we'd have if it was this wind direction. "Yeah, committed to every shot I hit. The one on 17 was exactly what I was trying to do, just didn't work out. "A lot of positives from the week to take from and

proud to give myself a chance today, and maybe next time it'll go in my favour." Playing with a one-shot edge, McIlroy landed his tee

shot at the par-3 29 feet from the hole with a 9-iron before Spaun played his shot.

"I feel bad for JJ; he hit a really good shot on 17 and it just went straight through the wind," McIlroy said.

Tom Hoge mixed seven birdies with a lone bogey en route to a 66 to share third place at 10-under with Akshay Bhatia (70) and Lucas Glover (71). - Field Level Media



Prancing Horse reality bites Hamilton

Briton has to improve driver-engineer partnership to thrive at Ferrari

BY KIERAN JACKSON

HERE'S nothing like racing agony, the reality of a new dawn compared to the high-octane hullaballoo, to wipe out a two-month period of euphoric bliss.

Lewis Hamilton arrived in Melbourne visibly joyous ahead of the opening chapter of his Ferrari story. Three days on, F1's joint-most successful driver will now be under no illusions regarding the scale of the voyage ahead.

And it wasn't just Ferrari's late fumble - for both drivers, we should add, with Charles Leclerc also impacted – which will eat away at Hamilton on his flight to Shanghai for this weekend's Chinese GP.

While driving behind the safety car on lap four, when told to "stay in mode charge... charge button on", Hamilton's response was polite but firm. "Yeah, no problem. Just don't repeat everything, please."

Nine laps later, Hamilton responded, "Leave me to it, please" twice when instructed to use an overtake button on the steering wheel, as he frustratingly failed to pass the Williams of Alex Albon

By lap 25, the Briton's replies were sharper: 'Yes, please leave it, please leave it.'

Much of this should be expected. Even in Hamilton's title-winning pomp at Mercedes, former engineer Bono experienced his fair share of vexed Hamilton rebukes.

Yet with dark clouds circling in Melbourne in the final 10 laps on Sunday, what Hamilton cannot expect is to make a strategy call himself, unaware of the weather radar. And the inaccuracy of Ferrari's forecasts cost them dear. To his credit, Hamilton did not twist the knife

in when speaking to the media afterwards. "I

think Riccardo did a really good job," he said.

"Generally I'm not one who likes a load of comments during a race. If I need it I'll ask for it. But he did his best today and we'll go through

In defence of Ferrari's strategy department, these are split-second decisions being made with a whole range of moving parts. Yet Red Bull, Mercedes and McLaren timed their pit

stops accurately; Ferrari did not. Ferrari's floundering in the tactical department has long been used as a stick to beat the prancing horse.

A series of errors in 2022 ultimately cost Mattia Binotto his job as team principal and current boss Fred Vasseur has worked hard to improve the clarity and accuracy of decisions from the pit wall to the cockpit. But Melbourne showed they are far from

perfect. Perhaps of more concern to Hamilton will be Ferrari's lack of pace. For all the fanfare of his £50 million-a-year

(RM275m) move, Hamilton will now know the extent of the challenge ahead if he wants to compete for a world championship. - The Independent

Swiatek takes responsibility for 'unacceptable' action

IGA SWIATEK has responded to the criticism aimed in her direction after she was involved in a furious incident with a ball kid at Indian Wells.

It took place during her defeat to Mirra Andreeva, who went on to beat Aryna Sabalenka in the final.

Swiatek was visibly frustrated during the match and struggled to control her temper as it progressed.

At one point, she was thrown a ball by a ball kid and furiously smashed it into the ground, prompting jeers from the fans in attendance.

It landed in the stands but only narrowly missed the ball kid on its way over. The incident led to Swiatek being widely criticised on social media, with some fans branding her behaviour "unacceptable".

Swiatek issued a firm response yesterday, taking to *Instagram* with a lengthy statement as she reflected on what happened and the

"I expressed frustration in a way I'm not proud of," she wrote. "My intention was never to aim the ball at anyone but merely to release my frustration by bouncing it on the ground.

"I immediately apologised to the ball boy, we made eye contact and nodded to each other when I expressed regret that it happened

"I've seen many bounce players balls in frustration, and frankly, I didn't expect such harsh

jokingly I can say I lack experience in this and misjudged my aim in the

heat of the moment."

Swiatek went on to point the finger at those criticising her by accusing them of "creating theories" and insisting the standards she is judged against are unhealthy.

"When I'm highly focused and don't show many emotions on court, I'm called a robot, my attitude labelled as inhuman," she said.

'Now than I'm more expressive, showing feelings or struggling internally, I'm suddenly labelled immature or hysterical. That's not a healthy

Draper 'deserves' new career high

JACK DRAPER believes his hard work is paying off after thrashing Holger Rune to win the biggest title of his career at Indian Wells, a result that moved the 23-year-old up to a ranking of seventh in the world.

Draper won his maiden ATP Masters 1000 title in style by demolishing Rune 6-2, 6-2 in just 68 minutes on Sunday, backing up his victory over defending champion Carlos Alcaraz in the semifinals.

The Briton was rewarded with a place in the world's top 10 and Draper said he "deserves" to stand next to the game's best after a difficult couple of years dealing with injuries and physical issues

He told Sky Sports: "I feel like I deserve it in all honesty. The amount of adversity I've been through, the amount of sacrifices, the amount of time that all the people around me have put into and the hard work.

"It's an emotional feeling to know how much you've gone through and put in and to be here now and to say that I'm gonna be No 7 in the world tomorrow. Honestly it means... I can't tell you how much that means.

Draper's third career title was his biggest to date and follows a run to the US Open semifinals last season.

He also reached the fourth round of the Australian Open this year, but on both occasions suffered injury set-backs after playing best-of-five.

He recovered in time to play Indian Wells, one of the biggest tournaments in tennis outside the grand slams, and enjoyed an impressive run that included wins over Alcaraz, Taylor Fritz and Ben Shelton.

The 23-year-old saved his most complete performance until last, however, and served brilliantly during his first ATP Masters final.

Draper broke Rune early in both sets and did not face a break point on serve throughout the match.

South Korea coach slams Bayern over Kim injury

SOUTH KOREA coach Hong Myung-bo has accused Bayern Munich of not looking after Kim Min-jae properly after he withdrew the central defender from his squad for two World Cup qualifiers to receive treatment on an Achilles injury.

Kim was named in Hong's 28-man squad last Monday for the qualifiers against Oman and Jordan but withdrawn on Saturday for "treatment on his left Achilles tendonitis and rehab".

Hong told reporters at training in Goyang that the national team coaching staff had been aware for a while of "warning signs" that the injury might flare up.

"Unfortunately, Bayern Munich did not properly protect the player to prevent injury so we've ended up in a situation where we have to play these important matches without a key player," Hong said.

"Just because a match is important doesn't mean it's right to have Kim on the pitch. There have been warning signs since last year and we were fully aware of them.

"We couldn't keep Kim Min-jae around for these important games because it would run counter to our principles of protecting players. So we've made the decision to rest him.

Kim missed Bayern's 1-1 draw with Union Berlin in the Bundesliga at the weekend but has played 13 of the club's 16 matches since the German winter break ended.

FC Seoul centre half Kim Ju-sung, who has played only two previous internationals, will replace the Bayern player in the heart of the South Korea defence, Hong said.

"We had Kim Ju-sung with the national team last year and he has some experience with our system. That's why we chose him. He has been excellent so far in the K League," Hong added. -Reuters

Wood is enjoying the best season of his career, hitting 18 goals in the Premier League and rubbing shoulders in the scoring charts with Alexander Isak and Erling Haaland.

His exploits have helped propel Forest into third place in the table and if they stay there it would guarantee Champions League football.

Other New Zealanders playing in Europe include Marko Stamenic at Olympiacos in Greece, Tyler Bindon at Reading and Matt Garbett with Breda in the Netherlands.

The 2026 World Cup in the United States, Canada and Mexico has been expanded to 48 teams, ensuring a team from Oceania will

gain automatic qualification. To seal their place, New Zealand must first beat Fiji on Friday (2.10pm Malaysian time) in Wellington before a decisive qualifier against either New Caledonia or Tahiti on Monday.

WEST HAM forward Michail Antonio says he came close to dying in a horrific car crash that shattered his leg but is "100%" confident he will play football again.

The Jamaica international required surgery after crashing his Ferrari into a tree on Dec 7

"All I know is that I hit a tree," he told the BBC. "I don't know how I hit a tree, that the police came and when they found me in the car, I was in between the two seats."

The 34-year-old, who also had a serious car accident in 2019, said he broke his femur bone in four places but revealed his comeback is three months ahead of schedule.

"I'm a good three months ahead of where I should be," he said. "I've lifted 130kg on the leg and I'm trying to do other things and just focus on myself, so it's definitely a good place right now and mentally I'm in a good place too."

He added: "I'm 100% (certain) that I'll be back on the pitch. This is what I'm focused on." Antonio paid tribute to West Ham for their

support but explained how he had sought therapy and struggled when manager Julen Lopetegui was dismissed and replaced by Graham Potter in early January.

"If I try and rush myself back, go out there and try and show him what I can do when I'm not physically right, it puts me in a bad stead because won't be right and I won't be able to do the things that I want to do," he said.

Antonio, West Ham's all-time top scorer in the Premier League, admitted he was embarrassed after the crash, near London.

"Obviously I've almost died in the car crash. It just made me slightly embarrassed that it was that bad," he said.

"Physically I'm getting better but mentally trauma lasts a long time," he added. "So, there is always going be periods and

We tried to use the strategy we practised before but it did not work because we were also new to Herry's training programme," he told reporters after a training session yesterday.

Five more sports for Sukma 2026 to be finalised after Raya

SELANGOR is expected to finalise five additional sports that will be contested at the 2026 Malaysia Games (Sukma) after the Hari Raya Aidilfitri celebrations, said state Youth, Sports and Entrepreneurship Exco Mohd Najwan Halimi.

He said this was due to the results of a meeting held on Feb 26 which decided to give space to other states to propose suitable events for the biennial games.

"Through the Sukma Supreme Committee meeting on Feb 26, the decision still gives any state the opportunity to propose five additional events. Currently, no decision has been made but I expect that we will get a decision on the five events after Raya at the latest," he said on Monday.

Previously, Najwan was reported as saying that the list of sports events to be contested at Sukma 2026 would be fully finalised in August which also involve additional sports events, including pickleball that was proposed by Selangor, as the host.

Meanwhile, Najwan said the Sepang International Circuit (SIC) will be used as the main venue for the opening event and his party were still reviewing the suitable location for the closing event.

"The closing ceremony usually does not involve the presence of a large contingent such as the opening, so we (the state government) are looking for a venue that suits the current needs.

"For the opening ceremony, it can be said that 80 per cent of the results are in favour of the Sepang International Circuit (SIC) but it does not involve any circuit activities," he said. – Bernama **THE** number of teams participating in next Super League season will only be known after April 30.

Malaysian Football League (MFL) acting chief executive officer Mohd Shazli Shaik Mohd said the First Instance Body (FIB) would meet to decide the number of teams that would be eligible to receive a national license to play in the 2025-2026 Super League.

Mohd Shazli said his party is in touch with the teams involved, including clubs that are plagued by financial problems, to ensure that they could complete the necessary documents before uploading them into the club licensing system.

"I think we are still optimistic that any existing team can remain and can commit to club licensing.

"So far, through the meeting sessions, it appears very positive."I think, in over a month, the clubs have to work hard to ensure that matters involving licensing can be fulfilled

Solution RI PAHANG FC are capable of pulling off a surprise upset over defending champions Johor Darul Ta'zim (JDT) in the 2024-2025 Malaysia Cup final scheduled to be held at the National Stadium in Bukit Jalil on April 12. Former *Tok Gajah* squad coach, Datuk Zainal

Former *Tok Gajah* squad coach, Datuk Zainal Abidin Hassan said the performance of the team from the east coast was outstanding in this Malaysia Cup campaign, and he expects Fandi Ahmad's team to play without pressure against the domestic football giant.

"We certainly don't deny the strength that JDT have, but I think Pahang will give good and fierce competition in the final.

"The ball is round, we have seen many surprises happening, JDT certainly doesn't want what happened in the 2014 final to happen again and they will be more careful. For Sri Pahang, they will still be able to surprise and this is the chance for the players to shine in the final." he said.

He said this when met at a breaking of fast with the media organised by the Malaysia Football League (MFL) on Monday night.

The last time Sri Pahang lifted the Malaysia Cup was in 2014 when they were under Zainal Abidin's management by defeating JDT 5-3 in a penalty shootout after both teams were tied 2-2.

The four-time champions ended a wait of more than a decade to advance to the final stage of the prestigious local football competition by defeating Sabah FC 3-2 on aggregate while JDT easily dismissed the challenge of Terengganu FC 6-1 on aggregate.

Meanwhile, the national football legend hopes that speculations about Sri Pahang's absence from the Super League next season will not affect the players' focus ahead of the Malaysia Cup final this time.

He also said that the local football scene will experience a big loss if his old team does not play in the 2025-2026 Super League.

"For me, the players need to focus on the final, and let the management do their job in other agenda so let us pray because Pahang is an elite team and needs to be in the Malaysian football scene," he said.

Last week, the Regent of Johor Tunku Mahkota Ismail in a question and answer session with JDT supporters said that the Sri Pahang and Kedah Darul Aman FC teams will most likely not play in the Super League next season.

He explained that this problem is due to inefficient financial management when expenses exceed income. – Bernama

Running on empty

Liverpool's season sliding off the rails as Slot's players look fatigued

THE Carabao Cup had been lifted by Bruno Guimaraes and Kieran Trippier, Eddie Howe drenched in alcohol by Joelinton and the black-andwhite hordes were starting to disperse when a manager reflected on a historic first. Not the victorious one, though.

"It took us seven, eight, nine months to lose twice in a row," said Arne Slot.

It is perhaps not a statistic to echo through the ages like Newcastle's 70year wait for domestic silverware or the 56-year gap between claiming any major honour.

It was nevertheless a way of illustrating Liverpool's consistency this season.

Slot's pragmatic explanation underlined why trebles are rarities; within a week, Liverpool's disappeared, replaced by a solitary pursuit of the Premier League.

"You know if you go further into tournaments that the opposition get stronger and stronger and even Liverpool can lose games," he added. It was notable he referred to Paris

It was notable he referred to Paris Saint-Germain, their first conquerors last week, as the best team in Europe.

That tag was applied to Liverpool late last year. They haven't looked it in March. They were distinctly second best in the first leg against PSG, albeit while winning it, and again against Newcastle in the Carabao Cup final.

Perhaps the French champions softened Liverpool up for Newcastle, exhausting them by making them run for 120 minutes, further depressing them with Gianluigi D o n n a r u m m a's excellence in the penalty shootout.

Liverpool looked drained at Wembley, even if Slot disagreed.

disagreed. "Were we on Tuesday mentally or physically tired?" he asked. "No. This game had nothing to do with running, only to do with duels."

Newcastle's bruising physicality equipped them to win them. Liverpool looked overpowered in midfield.

That can be a consequence of facing Sandro Tonali, Bruno Guimaraes and Joelinton. But it also highlights Liverpool's workload. Alexis Mac Allister had one of his

games last season, just six the

previous year. His 41st start for Liverpool this season came at Wembley.

Gravenberch, who could have been confined to a bit-part role this season if summer target Martin Zubimendi had joined, has instead been their third most-used player

player. He was taken off at Wembley with 3,516 minutes to his name this season, behind only – inevitably – Virgil van Dijk and Mohamed Salah. Mac Allister, who may not be built for such a schedule, is next with 3,081.

Slot had called Dominik Szoboszlai a "machine" but the Hungarian looked like one whose battery was running down against Southampton the previous week.

Like Trent Alexander-Arnold and Andy Robertson, Szoboszlai has played over 2,800 minutes this season. Luis Diaz and Ibrahima Konate have passed 2,700.

Continuity has brought consistency and a commanding lead in the title race. Yet Slot's preference for working with a small core of around 14 or 15 risks them becoming fatigued at the same time. Salah's season has been sensational but his only goals in his last five games were penalties against lowly Southampton; his impact over 300 minutes against PSG and Newcastle in the last two weeks has been insufficient.

Yet in turn, that underlined how Liverpool have become overreliant on him. Diaz's recent return stands at one goal in 18 games, Diogo Jota's at none in 10.

The Portuguese, who was poor against PSG, is performing in such a way to suggest that centre-forward is a position where Liverpool are in most need of an upgrade.

most need of an upgrade. Liverpool have found much to cherish in their campaign but it seems, in very different circumstances, that they are hitting the wall at the same time as they did last year.

It may render it just as well that the context has changed. It could be just as well they have a 12-point lead: a side who were even lethargic in the first half against Southampton have fewer guarantees of victory but only need a maximum of 16 points.

It will give them just a second League title in 35 years; Newcastle do not have a monopoly on long waits.

But if Slot wants to win it twice in a row, some lessons from Wembley may be required if Liverpool are to look stronger at the business end of next season. – The Independent
