90-day US tariff pause only offers temporary relief: PM

Malaysia evaluating ripple effects, working with Asean partners to cushion blow, strengthen regional economic resilience and push for fair trade rules

PETALING JAYA: The 90-day pause on tariffs by the United States (US) on 75 countries, including Malaysia, provides only temporary relief, said Prime Minister Datuk Seri Anwar Ibrahim yesterday.

"Malaysia is involved, but this is shortterm," he said after attending an *Aidilfitri* open house hosted by the Energy Transition and Water Transformation Ministry.

Earlier, Investment, Trade and Industry Minister Datuk Seri Tengku Zafrul Abdul Aziz welcomed the decision to pause tariff hikes on many of US' trading partners, but noted that the move injects fresh uncertainty into Asean economies.

"This shifting landscape will be front and centre at the Asean Economic Ministers' Meeting I'm chairing this morning," he said in a post on social media yesterday. He added that with US President Donald

He added that with US President Donald Trump's tariff policy, "the only certainty is uncertainty".

Yesterday's special meeting was convened to forge a united Asean response to Trump's sweeping reciprocal tariffs.

"Malaysia is actively evaluating the ripple effects and remains firmly committed to working with Asean partners to cushion the blow, strengthen regional economic resilience and push for fair, predictable trade rules."

Tengku Zafrul said Asean unity and deeper regional integration are now more critical than ever.

He said Malaysia remains a reliable and transparent trading partner to all, including China and the US, committed to securing win-win outcomes.

He added that Malaysia is accelerating trade diversification, breaking into new and unfamiliar markets, and fast-tracking economic reforms to sharpen its competitive edge.

edge. "Our priority is to navigate this volatile terrain while securing Malaysia's economic future."

Trump said on Wednesday he had considered a 90-day delay to the planned tariff hikes "over the last few days", and credited the pause to active diplomatic engagement, reported Anadolu Ajansi. The announcement coincided with a

dramatic 125% tariff on Chinese imports. Trump said the pause follows appeals from affected nations seeking to "negotiate a solution" to trade disputes spanning tariffs, currency manipulation and non-monetary barriers.

He said these countries had not retaliated "in any way, shape or form against the US".

On Tuesday, Anwar had said Malaysia does not subscribe to megaphone diplomacy in dealing with Washington's tariff whiplash.

He said in line with its policy of quiet engagement, Malaysia would instead despatch officials to Washington to initiate dialogue.

Anwar acknowledged there may be limited scope to revisit the underlying intent but maintained there is room to adjust how the policy is implemented.

It was reported that Tengku Zafrul would lead Malaysia's delegation to Washington at the end of this month to engage on the reciprocal tariffs, Bernama reported.

He will be joined by Investment, Trade and Industry Ministry Deputy Secretary-General (Trade) Mastura Ahmad Mustafa, senior ministry officials as well the ministry's representatives from the Malaysian Embassy in Washington.

Asean's Indochina bloc bore the brunt of the tariff hike with Cambodia hit with 49%, Laos 48%, Vietnam 46%, and Myanmar 44%.

Thailand was slapped with 36%, Indonesia 32%, Brunei and Malaysia 24% each, the Philippines 17% and Singapore the baseline 10%.

'Asean steps up efforts to eliminate market distortions'

KUALA LUMPUR: Asean member states are stepping up efforts to eliminate trade distortions and enhance efficiency, creating more space for negotiations amid mounting concerns over tariff and non-tariff barriers, said Indonesian Finance Minister Sri Mulyani Indrawati.

Welcoming the United States' (US) decision to pause reciprocal tariffs, Sri Mulyani, a seasoned policymaker and economist, said many member states acknowledge there is still room to sharpen their trade and investment policies.

policies. "We hope this 90-day pause presents a valuable opportunity for the US and its partners to build a more positive-sum relationship. As the world's largest economy, the US should view the rest of the world through a lens of mutual gain," she said in an interview on the sidelines of the 12th Asean Finance Ministers' and Central Bank Governors' meeting here yesterday.

She said the 10-member bloc, both collectively and individually, has strong mechanisms in place to absorb economic shocks, backed by its experience in navigating past crises such as the Asian financial crisis, the global economic downturn and the Covid-19 pandemic.

Sri Mulyani emphasised the need for a focused approach to economic fundamentals.

"Macroeconomic policy, which must encompass fiscal, monetary and structural reforms, should be combined for Asean to strengthen its economic foundation."

Media reports suggest that Sri Mulyani would travel to Washington next week with other senior Indonesian economic officials to discuss the country's tariff situation.

On a different note, Sri Mulyani, who led a delegation to the meeting, praised Malaysia's leadership, noting that Asean's theme this year

 focusing on inclusivity and sustainability – is particularly relevant in today's global context.

She commended Prime Minister Datuk Seri Anwar Ibrahim's role in coordinating, communicating and assessing the issue of US tariffs, which has enabled Asean to act as a unified group.

"The Asean chairmanship under Malaysia is crucial in reinforcing this cooperation," she said, particularly as intra-Asean trade accounts for only 22% of total Asean trade.

Sri Mulyani, a former World Bank managing director, stressed that many complementarities between member states still need to be explored so that members view one another as collaborators rather than competitors.

She also highlighted how current US policies could shift trade dynamics, with increased trade diversion from the US, especially towards regions like Europe, India, Australia, New Zealand and other Asean+3 nations. – Bernama

Malaysia, China hold talks on boosting trade cooperation

BEIJING: China and Malaysia have held candid talks on boosting economic and trade cooperation as part of Malaysia's tenure as Asean chair.

China's Commerce Minister Wang Wentao and Malaysian Investment, Trade and Industry Minister Datuk Seri Tengku Zafrul Abdul Aziz had a video meeting yesterday, according to China's Commerce Ministry. Xinhua reported that both sides discussed

Xinhua reported that both sides discussed strengthening China-Malaysia and China-Asean trade relations and addressing the so-called "reciprocal tariffs" imposed by the US. Wang condemned the tariffs, arguing that they

Wang condemned the tariffs, arguing that they undermine years of multilateral trade negotiations and ignore the long-standing benefits the US has gained from global trade.

He labelled the US move as blatant unilateral bullying, damaging the legitimate rights of China and Asean members. Wang warned that this approach also harms US

Wang warned that this approach also harms US interests, disrupts global economic growth and destabilises industrial and supply chains, posing a serious threat to the multilateral trading system.

He reaffirmed China's firm opposition to such measures and vowed decisive counteractions, adding that China is prepared to stand firm if the US persists in its misguided path. Wang also expressed China's readiness to

Wang also expressed China's readiness to strengthen dialogue and coordination with trading partners, including Asean. Tengku Zafrul said the Investment, Trade and

Tengku Zafrul said the Investment, Trade and Industry Ministry had already issued a statement opposing the US policy, emphasising that it contradicts the principles of free and fair trade as outlined by the World Trade Organisation.

He also affirmed Malaysia's full respect for China's position and its commitment to supporting multilateralism and the advancement of global trade.

Tengku Zafrul added the country would consult with other Asean members to collectively address the so-called "reciprocal tariffs" and other measures proposed by the US. – Bernama-Xinhua

S'gor to get feedback from industries

SUBANG JAYA: The Selangor state government will conduct a survey this week through Invest Selangor Bhd to gather feedback from industry players on the impact of US tariffs on their businesses.

Selangor Investment, Trade and Mobility Committee chairman Ng Sze Han said the weeklong survey aims to assess the effects on industries, particularly property development and manufacturing.

"We need to understand the impact on these sectors and prepare to assist them," he said after the Brazil-Malaysia Bilateral Semiconductor Industry Development Programme yesterday. The Malaysia Semiconductor Integrated Circuit

The Malaysia Semiconductor Integrated Circuit Design Park, in collaboration with Brazil, ChipInventor and Amazon Web Services, aims to accelerate innovation, strengthen the semiconductor value chain, and nurture worldclass talent in chip design and manufacturing.

The park, the first of its kind in Southeast Asia, is designed to drive national growth in semiconductor innovation. It brings together companies, startups, research institutions and talent development programmes under one roof.

Ng said the partnership offers a stable, strategic alternative for companies seeking to mitigate risks and expand in Asia.

"Collaborations with Brazil show that we can rise above trade tensions through cooperation and shared values.

"Brazil's expertise in semiconductor design complements Malaysia's manufacturing ecosystem. Together, we are proving that emerging economies can lead the high-tech industry through shared innovation and mutual trust." – Bernama

Health Ministry refutes fatality claims, lodges police report

KUALA LUMPUR: The Health Ministry has lodged a police report over several social media comments falsely claiming that there were deaths in the recent gas pipeline fire in Putra Heights, Subang Jaya, Selangor.

In a statement issued yesterday, the ministry said the Malaysian Communications and Multimedia had Commission also been informed.

However, no report has been received from public or private health facilities regarding any fatalities linked to the incident.

"Irresponsible parties who spread false comments that cause public outrage will be dealt with strictly according to the law," the ministry warned.

The gas pipeline fire, which broke out at 8.10am on April 1, caused flames to rise over 30m high, with temperatures exceeding 1,000°C.

It took almost eight hours to fully extinguish the blaze. As of 12.30pm on Wednesday, 17

residents were receiving treatment at government hospitals, while 21 others were being treated at private facilities.

One patient remains in the intensive care unit, and is reportedly

responding well to treatment. A total of 150 individuals sought medical attention following the incident

Of these, 127 suffered direct injuries such as burns and other physical trauma.

Another 18 experienced indirect effects, including anxiety, panic attacks and hypertensive urgency, while the remaining five did not require further treatment.

The ministry confirmed that government healthcare facilities will continue to support all residents affected, especially those with burn injuries, at Kuala Lumpur Hospital and Putrajaya Hospital.

"This also includes mental health services, which are crucial in helping affected individuals and their families return to normal life as soon as possible."

The ministry also said eight of its staff who were involved in the incident will receive full support until they are fit to return to work. – Bernama

PETALING JAYA: The recent gas pipeline fire incident has rattled many Malaysians, particularly those considering property purchases in the affected or nearby areas.

What was once an overlooked consideration on the property checklist is now gaining serious attention – hidden underground risks such as fuel pipelines.

For many potential buyers, safety concerns have always played a part in the decision-making process, but the recent incident has brought these hidden threats to the forefront. "Honestly, such pipelines were

never a top consideration until this

recent incident," said Yaswinii Kannan, 28, a business analyst.

on hidden property risks

Her typical checklist includes evaluating nearby pollution sources, proximity to hazardous industrial premises, electrical hubs and other strong electromagnetic fields.

Other key considerations for Yaswinii include the crime rate in the area, security features such as gated communities and camera surveillance, and traffic risks.

She also looks at the environmental history of the land,

such as whether it was once a mine or a lake.

"It is also important to investigate the land stability and check for pests, termites or other harmful parasites," she added.

For Indira Magesan, 31, a former general practitioner, buying property revolves around three main pillars - location, safety and finance.

She emphasised the importance of being near basic amenities, evaluating future developments for investment potential and

ensuring affordability.

Although checking for industrial activity and construction is part of her process, pipelines had never "To be honest, we just make sure

that industrial areas are at least five to 10km away from our community.

"As a layperson, we don't have access to blueprints to check for pipelines underground.

"As for construction sites, as long as safety, noise levels and air quality are maintained, I'm okay because these factors can affect property

value in the long term," she said. Before the fire incident, Indira had been unaware of the risks posed by pipelines.

We assumed all developments go through strict evaluations to ensure safety," she said.

"But now, we realise freak incidents such as this can happen anywhere to anyone.

"It will definitely influence my decision in the future. Safety is crucial, but peace of mind is even more important."

Reflecting on the explosion, she expressed concern that despite numerous regulations for property construction, such an incident still happened.

Buyers need to do thorough research on the property and evaluate the developer's portfolio and risk management measures before making a decision. "I'm not sure if I'd consider

buying a house near the site of the incident or in areas known to have gas pipelines, at least not now." While Indira believes authorities

will take steps to improve safety in the area, she pointed out that human nature makes it difficult to let go of past trauma.

She also said full disclosure on such incidents should be mandatory for parties selling property. "Buyers must be made aware of

past accidents, the countermeasures taken, the placement of pipelines

and ongoing safety measures. "It's crucial that they have all the information to make informed decisions, free from the pressure of sales talk or promotions."



190 homes reoccupied after safety inspections

KUALA LUMPUR: A total of 190 homes affected by the gas pipeline fire in Putra Heights have been reoccupied after inspections confirmed it was safe for

residents to return to their units. Selangor police chief Datuk Hussein Omar Khan said as of Wednesday, 487 affected homes had been inspected by 12 technical agencies. These include Tenaga Nasional Berhad (TNB), Air

Selangor, the Department of Occupational Safety and Health, Public Works Department, Subang Jaya City Council and the police. "Of these, 328 homes were deemed

safe for occupancy, and 190 homes have already been reoccupied," he told Bernama when contacted.

Hussein added that TNB had restored electricity supply to

Fire underscores need for comprehensive home insurance

PETALING JAYA: Homeowners affected by the recent gas pipeline explosion in Putra Heights may still need to continue repaying their housing loans, even if their properties were destroyed, unless they are fully insured, said a property expert. Universiti Teknologi Malaysia

property economics and finance associate professor Dr Muhammad Najib Razali explained that borrowers are generally obligated to service their loans regardless of the condition

of the property. "In the event of property destruction, banks typically expect repayment to continue as agreed,"

he said.

However, in extraordinary cases such as natural disasters or industrial incidents, including the Putra Heights blast, affected borrowers may appeal

for financial relief. "In such cases, borrowers can request a loan moratorium or restructuring, potentially suspending repayments for up to six months to ease financial stress during recovery." He highlighted the importance of

comprehensive insurance coverage homeowners shield from to significant loss financial in unforeseen disasters.

Without adequate coverage, borrowers could be left repaying loans on uninhabitable homes.

Banks may also restructure loans by extending tenures or reducing

monthly payments to support

affected borrowers. According to Muhammad Najib, such flexibility is vital in times of crisis and can help ease the burden on those facing severe financial strain.

Homeowners impacted by the Putra Heights incident could reasonably expect similar support from their banks, but any relief depends on individual bank policies, the extent of the damage, insurance status and the borrower's financial standing.

Responsibility for rebuilding lies with the homeowners, especially in the absence of third-party liability. However, if a third party such as a

utility provider or contractor is found negligent, homeowners may pursue compensation or legal action

"In the case of Putra Heights, in which the fire may involve a gas pipeline, determining liability is critical," he said.

"Legal and insurance investigations will be necessary to establish if the pipeline operator or another party is responsible for the damage?

Affected homeowners may need to rely on their insurance or government aid for reconstruction.

Muhammad Najib also highlighted the importance of fire insurance, which protects against the financial impact of such events.

"Many Malaysian homeowners only carry basic mortgage-linked insurance, which usually covers just the outstanding loan, not rebuilding costs or personal losses," he added

adding that this leaves many vulnerable to severe financial strain in the event of a fire.

He said the Putra Heights incident serves as a reminder of the consequences of being underinsured or lacking comprehensive coverage.

"It's crucial for homeowners, especially those near industrial zones or infrastructure, to ensure their insurance policies cover both property rebuilding and contents."

Following the incident, the Association of Banks in Malaysia issued a statement urging affected borrowers to contact their banks promptly.

Borrowers are advised to reach out through official websites or customer service hotlines to explore available support

'Bullying, abuse cases in army will not be condoned'

No leniency in SOP implementation against military personnel involved in such acts, with stern action pursued: Deputy minister

KOTA BHARU: The Defence Ministry has stressed that there will be no leniency in the implementation of SOPs regarding cases of bullying and abuse among military personnel, and that relentless action will be pursued at the ministry level and in accordance with the law

Defence Deputy Minister Adly Zahari said the ministry will not compromise with any member of the Armed Forces who crosses the line by being involved in bullying.

line by being involved in bullying. "Emphasis is given to the SOP in addressing bullying cases. Although these cases may be considered isolated, action will still be taken.

"As stated by the army chief, there have been

some cases reported but we have a clear SOP with two approaches, action at the ministry level and internal measures," he said after attending a Madani Aidilfitri celebration event at the Chinese Chamber of Commerce hall yesterday.

Adly added that the ministry does not condone any form of bullying, although military training is conducted rigorously according to prescribed modules, Bernama reported. He said the ministry has an internal

He said the ministry has an internal mechanism, including a special committee, to differentiate between disciplinary training and bullying behaviour.

"We have made several decisions regarding bullying cases and have issued warnings that perpetrators will face legal action," he said.

He also said additional measures have been taken, including increasing the number of wardens at the Royal Military College, keeping junior and senior students separated, and installing closed-circuit cameras at strategic locations. "We also provide psychological

"We also provide psychological rehabilitation spaces, advisory services and

education to raise awareness among students and families," he said.

On Monday, it was disclosed that 41 army officers and personnel were dismissed from service due to bullying and abuse cases involving lower ranked personnel since 2019.

Army chief Tan Sri Jen Muhammad Hafizuddeain Jantan reportedly stated that the dismissed group comprised 12 officers and 29 other personnel.

In earlier media reports, Muhammad Muqriz, 21, from the 20th Battalion of the Royal Malay Regiment at Sri Miri Camp in Sarawak died on March 24 due to blunt force trauma to the chest.

Muhammad Hafizuddeain said the army does not take lightly any form of abuse or bullying in the military and views every lowerranked personnel as a brother or sister who ought to be protected.

"The army will not remain idle. We often remind our personnel regarding these matters (not to bully or abuse lower-ranked personnel). However, the incident is not a tradition within the army, but there are isolated incidents due to the actions of individuals," he said.

Child protection initiatives to continue at 300 schools

SEPANG: The Women, Family and Community Development Ministry, through the Social Welfare Department, will continue its "Kasih Kanak-kanak" child protection advocacy programme at 300 schools and 30 children activity centres nationwide this year.

Activity centres nationwide this year. Minister Datuk Seri Nancy Shukri said the programme, which would begin this month, is part of efforts to address sexual offences involving minors.

She added that the ministry would also promote the Talian Kasih helpline and mobilise the One-Stop Social Support Centre to participating schools throughout the programme.

"They (the children) have school counsellors, but many are reluctant to speak up, possibly due to embarrassment. So, during the advocacy sessions, we use tailored approaches to connect with them.

"For instance, we ask them to draw and explain their artwork. This gives us insights into their inner thoughts and emotions," she said after officiating at the Raikan Keceriaan Keluarga event at the KL International Airport (KLIA) Terminal 1 yesterday.

Nancy was commenting on recent media reports highlighting a rise in rape and incest cases in Kelantan, with 252 cases recorded last year compared with 206 in 2023.

On the Raikan Keceriaan Keluarga initiative by Malaysia Airports Holdings Bhd (MAHB), Nancy said the effort is commendable as it shows the corporate entity is taking family aspects into account in its development plans.

"I believe that public spaces such as airports

"The new uniforms are more than just a design update. They represent our professionalism, friendliness and commitment to excellent service while also offering comfort and easy identification.

"The Orangutan Kids Zone was created to make the airport more family-friendly. It provides a space for children to play while their parents take a short break (before their flights)," he said. – Bernama

Sabah records RM6.5 billion total investments

KOTA KINABALU: Sabah recorded total investments of RM6.5 billion last year, with 38.7% contributed by the manufacturing sector, said Yang di-Pertua Negeri Tun Musa Aman.

He said the figures clearly showed that the Sabah government efforts to develop the manufacturing sector were on the right track, and had succeeded in attracting more investors to the state.

Musa added that the manufacturing sector continued to play an important role in stimulating the state economy, including opening up opportunities for technology integration, strengthening infrastructure and creating job opportunities.

"To that end, focus will be given to developing more downstream activities in key industries, including biomass, oil palm, industrial tree plantations and oil and gas. "By encouraging the expansion of these

"By encouraging the expansion of these sectors, Sabah also has the potential to attract more investments, thus stimulating more sustainable economic growth for the state," he said in his state government policy speech in conjunction with the opening ceremony of the Fifth Term of the 16th Sabah State Legislative Assembly yesterday. Also present were Chief Minister Datuk

Also present were Chief Minister Datuk Seri Hajiji Noor and Sabah State Assembly Speaker Datuk Seri Kadzim M. Yahya. Musa said Sabah also managed to

Musa said Sabah also managed to maintain state revenue collection above the RM6 billion level, at RM6.842 billion last year.

The Sabah government has imposed state sales tax on three new products, namely silica sand, palm oil biomass brought out of Sabah, and gold and silver mined in the state, he added.

It is an effort to diversify revenue sources and reduce state dependence on oil and gas related resources. Meanwhile, Musa said the Sabah

Meanwhile, Musa said the Sabah government has drawn up a strategic direction for state development for a five-year period through the 13th Malaysia Plan (13MP), with a focus on priority areas that are pillars of state development.

"Therefore, I urge all ministries, departments and state agencies to take proactive steps to plan development in line with this set direction to ensure that the real needs of Sabah are given priority," he added.

Musa also said the Sabah government would focus on implementing programmes and projects oriented towards development spending as an effort to ensure the smooth implementation of the state's strategic development direction through 13MP.

The commitment was in line with efforts to improve state financial management and increase development expenditure compared with operating expenditure, he said.

he said. "With this effort, the achievement of state economic development goals will be accelerated.

"I am confident that with full cooperation from all parties, the process of preparing 13MP will be able to run smoothly and orderly by taking into account various perspectives and needs," he said. – Bernama

Stay vigilant amid unpredictable weather, public advised

BAGAN SERAI: The Natural Resources and Environmental Sustainability Ministry has advised the public to remain vigilant due to unpredictable weather conditions.

Minister Nik Nazmi Nik Ahmad said the country is expected to experience hot and dry weather as the northeast monsoon approaches its final phase, which is projected to end by mid-May.

He said changes in the weather could affect

body temperature regulation and lead to common illnesses such as fever, flu, cough and even hypothermia, especially among children.

"According to records in 2023 and the previous year, the country recorded numerous cases of heat-related illnesses with several fatalities due to heatstroke.

"In fact, we are still witnessing flood incidents caused by the unpredictable weather. While the current hot weather has not yet reached a critical level, we must always remain cautious," he said after opening Agrobank's first green branch in Bagan Serai yesterday. Agrobank president and CEO Datuk Tengku

Ahmad Badli Shah Raja Hussin was also present. Meanwhile, Nik Nazmi said the ministry encouraged more financial institutions to

encouraged more financial institutions to adopt green technology to enhance development while minimising environmental degradation. "The ministry supports green initiatives by Agrobank, such as installing roof structures and using solar energy at its Bagan Serai branch, which help reduce environmental impact and curb pollution.

"We hope that more parties, not just financial institutions, would participate in advancing more sustainable green initiatives, in line with the Malaysia Madani aspiration," he added. – Bernama

Statements recorded from 7 students over bullying case

NIBONG TEBAL: Police have recorded statements from two more Mara Junior Science College students here in relation to a bullying incident, the video of which was widely circulated recently on social media.

South Seberang Perai police deputy chief DSP Mohd Norazmi Abd Ghapar said this brings the total number of students whose statements have been recorded to seven.

"At this point, police believe that seven Form Three students are involved in the incident, including the victim and the person who recorded it.

"Police are completing the investigation paper before submitting it to the deputy public prosecutor's office for further action," he said.

Asked if police would record statements from other parties, Mohd Norazmi said the current focus is on the students suspected to be involved in the incident.

Previously, police detected a video, lasting one minute and 31 seconds, uploaded by Facebook account "Utara Kini", showing a scene believed to be in a hostel room where several individuals appeared to be bullying another person lying on a bed.

The incident occurred at a Mara Junior Science College in South Seberang Perai last year and the case is being investigated under Section 323 of the Penal Code.

On Tuesday, the disciplinary committee of the college recommended that the seven students involved in bullying a fellow student be expelled.

Mara chairman Datuk Dr Asyraf Wajdi Dusuki said in a post on his Facebook page that two of the students were found to have been involved in physical bullying.

"No matter whose children they are, whether the children of a Tan Sri, a Datuk or some influential individuals, if they are involved in bullying, firm and stern action will be taken against them. No need to find a way to talk me out of it. My office will never entertain such bullies." – Bernama

'RM177m seizure in ex-PM case largest in first quarter'

Solution Amount does not include funds frozen under Anti-Money Laundering, Anti-Terrorism Financing and Proceeds of Unlawful Activities Act 2001: MACC

KOTA KINABALU: A total of RM177 million in assets, consisting of cash and gold bars, has been seized by the Malaysian Anti-Corruption Commission (MACC) as part of the probe involving former prime minister Datuk Seri Ismail Sabri Yaakob.

MACC Chief Commissioner Tan Sri Azam Baki said the amount represents the largest seizure recorded by the commission in the first quarter of this year, out of a total of RM483.38 million in assets seized under the MACC Act 2009.

"This RM177 million refers specifically to seizures. Freezing actions under the Anti-Money Laundering, Anti-Terrorism Financing and Proceeds of Unlawful Activities Act 2001 (Amlatfa) are separate," he clarified at a media conference yesterday.

Guinata) are separate, in character at a media conference yesterday. He was speaking at the launch of Cakna Rasuah, an MACC programme with Sabah media, which was also attended by Sabah Journalists Association president Datuk Muguntan Vanar.

It was also reported that although the

MACC has advocated the use of deferred prosecution agreements, this approach would not apply to the corruption case involving Ismail Sabri.

The approach, which is being applied in other developed countries, defers the prosecution with the condition that there will be a settlement.

"As of now, no," Azam was reported as saying when asked whether deferred prosecution may apply to Ismail Sabri's case when the law comes into force.

He said the MACC has submitted the proposal and is currently awaiting approval from the attorney-general. The Bera MP is being investigated for

The Bera MP is being investigated for alleged corruption and money laundering involving the use of funds for the promotion and publicity of the Keluarga Malaysia programme during his tenure from Aug 2021 to Nov 2022.

The case is being investigated under the MACC Act 2009 and Amlatfa 2001.

Azam said during the same period, asset

freezes under Amlatfa alone amounted to RM548.97 million.

Forfeitures under the MACC Act 2009, Amlatfa 2001 and the Criminal Procedure Code amounted to RM603,363, while compound payments totalled RM412,000.

"During this period, we opened 319 investigation papers, made 401 arrests and charged 146 individuals. We will continue to resolve these cases, focusing not only on securing charges but also on recovering assets."

It was reported that Ismail Sabri is expected to resume providing his statement to the MACC by the end of this month.

This upcoming session will mark the second phase of the investigation, which will focus on the issue of asset declaration, according to his statement.

Azam previously said the first round of questioning, which centred on the discovery of RM170 million in cash and 16kg of gold bars at several "safe houses," had been completed.

Ismail Sabri spent seven days providing a statement to the MACC after being named a suspect in an ongoing investigation involving four of his former senior officers.

The most recent session, held on March 24, lasted five hours, bringing the total time spent on his testimony to over 30 hours.

It was reported that as part of the probe, a money changer was also arrested. - Bernama

Illegal immigrant fails in bid to dupe enforcement team

KUALA LUMPUR: A man's frantic attempt to disguise himself and blend in with media and enforcement officers in a bid to avoid detection was among the dramas during raids conducted by the Malaysian Immigration Department in Chow Kit and Sentul yesterday.

The man was arrested at a hotel in Chow Kit, a location suspected to be a hideout for illegal immigrants. In a state of panic, he kneeled and pleaded for his release, insisting he had valid documents to stay in the country. A woman also failed to escape from being

A woman also failed to escape from being arrested, as her friend refused to open the hotel room door despite her desperate cries for help from outside.

Both the man and woman were among 32 illegal immigrants detained for not having valid travel documents and overstaying in the country. Bernama reported.

country, Bernama reported. Kuala Lumpur Immigration Director Wan Mohammed Saupee Wan Yusoff said the raids were the culmination of two weeks of intelligence gathering, focusing on several known hotspots across the capital.

"In the first raid conducted at a hotel in Chow Kit, believed to be occupied by illegal immigrants, a total of 22 individuals were arrested. The group included two men and nine Indonesian women, four Pakistani men, five Bangladeshi men and two Thai women.

"In the second raid at four shophouses in Sentul, the authorities nabbed three Indonesian women, three Indian men, two Nepali men, one Myanmar national and one Pakistani."

Plan to promote libraries

PETALING JAYA: When thousands of Malaysians lined up outside BookXcess stores for a recent three-day book giveaway, some observers were left stunned.

Others saw it as confirmation of what they have always believed: Malaysians do read, but are books here too expensive and inaccessible?

Librarians Association of Malaysia president Dr Ghazali Mohamed Fadzil said the sight of people queueing from 8am for free books was not surprising. Instead, it underscored an ongoing reality. "Malaysians read, and many read

printed books more than digital copies. "In rural areas and small towns, it's also about connectivity.

"Even when people have smartphones, many are still not comfortable reading digital books."

He added that while students have increasingly turned to digital formats for academic purposes, the general public continues to gravitate toward physical books for leisure reading.

books for leisure reading. Ghazali also said the BookXcess giveaway showed that the reading habit is alive in Malaysia, but needs more support and visibility.

On public complaints about limited access to libraries, he pointed out that Malaysia has a vast library network. "There are around 13,000 libraries in

"There are around 13,000 libraries in the country. I do not think it's about limited access, but more about reading culture.

"One of the main roles of libraries is to ensure access to information and learning for all."

However, he acknowledged that some libraries, especially in smaller towns, may not be easily accessible.

"They are not hidden, just maybe not easy to reach due to distance. One way to mitigate this is to upgrade all libraries," he said.

He also addressed calls to have libraries in malls and allow them to stay open beyond normal working hours.

"We do have libraries in shopping malls and urban transformation centres in most states, including Kuala Lumpur, Penang, Johor, Sabah and Sarawak.

"We even have a library inside the Kota Kinabalu International Airport in Sabah and another at a petrol station in Perlis." Ghazali said while nighttime libraries may struggle to attract visitors, academic libraries with public access and 24-hour sections could provide a more sustainable model in the future.

In addition to physical expansion, he said librarians are working closely with communities and NGOs to promote reading in more informal ways.

"The association encourages and works with NGOs to organise reading activities such as Read in the Park and Taman Baca Sungai Bunus in Kuala Lumpur with the residents of various communities."

He also suggested that librarians and libraries be more active on social media platforms, saying: "We could be more active strategically."

In addition, the association is lobbying for policies to include libraries at all new housing and mall developments, such as People's Housing Programme areas in Kuala Lumpur and Selangor.

"The problem with reading and its solution lie within the home," he said, adding that libraries are community hubs that could help to address social issues.

Big demand for tiny house experience

KUALA LUMPUR: For retiree Mat Zin Ali, 64, nothing brings greater joy than celebrating Hari Raya with his large family of 12.

However, the house he built five years ago that has only four bedrooms and three bathrooms is unable to accommodate everyone comfortably. To ensure his children, in-laws and grandchildren

To ensure his children, in-laws and grandchildren could gather under one roof, he decided to build two tiny houses next to his main home in 2022.

He said the project was both affordable and practical, with a modern design that maximised space, adding that it cost about RM20,000.

"Which parent wouldn't be happy to have all the children, in-laws and grandchildren celebrating together? It's wonderful. But before the upgrade, I felt sad seeing them inconvenienced due to lack of space, sharing bedrooms and bathrooms, and lacking privacy, especially the women." Mat Zin, fondly known as Pok Suzin,

Mat Zin, fondly known as Pok Suzin, incorporated traditional Malay village house elements into his two compact units. One is slightly larger, accommodating three to four people while the other is designed for two adults.

"I also took the opportunity to use these tiny houses as a homestay for visitors looking for a unique lodging experience. This not only benefits guests searching for alternative accommodation but also provides me with a source of side income."

Apart from gaining popularity among those looking for cost-effective housing options or additional space for large family gatherings, the tiny houses have also become a favourite spot for taking OOTD (Outfit of the Day) photos during festive seasons, Bernama reported.

Cottage Homes PD owner Yuslan Ibrahim, 46, said demand for tiny houses usually spikes during festive seasons. His units in Port Dickson, Negri Sembilan have a modern cottage concept, blending English country home aesthetics with minimalism and natural beauty. "I have two tiny house units, and the idea to

"I have two tiny house units, and the idea to build them came from my fascination with small home designs on Pinterest, particularly the Nordic, cottage and cabin styles. I receive many bookings during festive seasons like Aidilfitri," he said.

Architect Kahar Ambok Lalek, 25, said the tiny house movement began in the early 2000s in the United States as a response to limited land availability, with homes often built on trailer frames. Over time, tiny houses have gained popularity among those seeking a minimalist dream home.

"In Malaysia, demand for tiny houses is mainly concentrated at orchards and farm areas, where they are used as vacation homes or guesthouses. Despite requiring only a small plot of land, these homes can feel surprisingly spacious inside," he said.

Top yakuza gang promises 'no more trouble'

Senior members submit written pledge to police

TOKYO: Japan's largest yakuza organised crime body submitted a written pledge to authorities to end its wars with splinter groups, police said yesterday.

The Yamaguchi-gumi has fought bloody wars with other yakuza gangs formed by its former members who broke away in 2015.

Senior members submitted a letter in person to police on Monday vowing to "end all infighting" and "not make any trouble", said a police official.

Authorities have had various yakuza gangs under close surveillance since 2020 over their intensifying violence, which has severely limited their activities, such as their ability to use offices in certain areas.

The Yamaguchi-gumi's pledge, submitted in Hyogo prefecture in western Japan, may be aimed at loosening the restrictions, local media said. The splinter gangs' plans remain unclear, said the Hyogo police official.

Investigators are monitoring the situation as the Yamaguchi-gumi's pledge might only be a one-sided declaration, he said.

Unlike the Italian mafia or Chinese triads, yakuza have long occupied a grey area in Japanese society.

Japanese society. They are not illegal, and each gang has its own headquarters in full view of police.

The yakuza grew from the chaos of post-war Japan into multi-billion-dollar criminal organisations.

They are involved in a variety of activities, from drugs and prostitution to protection rackets and white-collar crime.

They were long tolerated as a necessary evil for ensuring order on the streets and getting things done quickly – however dubious the means.

In recent decades, stiffer anti-gang regulations, waning social tolerance and a weak economy have resulted in steadily falling membership.

Membership of the nation's yakuza gangs hit a new low of 18,800 last year after years of decline, falling below the 20,000 mark for the first time, police data showed this month.

Still, they pose a threat to society as they continue to engage in criminal acts while keeping a lower profile, the National Police Agency said in a recent report.

Criminal activities by yakuza and others are becoming more complicated with the emergence of "tokuryu" groups, police said.

Unlike yakuza gangs with organised membership and established hierarchical structures, these are ad hoc gangs of individuals.

Many have no criminal background and are often recruited via social media under the promise of quick money.

These groups are seen working with established yakuza gangs, adding complexity to Japan's crime scenes, according to police. Tattoos are still often associated with yakuza

Tattoos are still often associated with yakuza and other "anti-social" elements, although attitudes are changing.

People with tattoos in Japan are often barred from facilities like swimming pools or "onsen" baths, and tourists with body art can sometimes fall foul of the rule. – AFP



Pressure builds on Afghans fearing arrest in Pakistan

KARACHI: Convoys of Afghans pressured to leave Pakistan are driving to the border, fearing the "humiliation" of arrest, as the government's crackdown on migrants sees widespread public support.

Islamabad wants to deport 800,000 Afghans after cancelling their residence permits – the second phase of a deportation programme which has already pushed out around 800,000 undocumented Afghans since 2023.

undocumented Afghans since 2023. According to the UN refugee agency, more than 24,665 Afghans have left Pakistan since April 1, 10,741 of whom were deported.

"People say the police will come and carry out raids. That is the fear. Everyone is worried about that," said Rahmat Ullah, an Afghan migrant in Karachi.

"For a man with a family, nothing is worse than seeing the police take his women from his home. Can anything be more humiliating than this? It would be better if they just killed us," added Nizam Gull, as he packed his belongings and prepared to return to Afghanistan.

Abdul Shah Bukhari, a community leader in one of the largest informal Afghan settlements

in the coastal city, has watched buses leave daily for the Afghan border, about 700km away.

The maze of makeshift homes has grown over decades with the arrival of families fleeing successive wars in Afghanistan. But now, he said "people are leaving voluntarily".

"What is the need to cause distress or harassment?" said Bukhari.

Ghulam Hazrat, a truck driver, said he reached the Chaman border crossing with Afghanistan after days of police harassment in Karachi.

"We had to leave behind our home. We were being harassed every day."

In Peshawar, the capital of Khyber Pakhtunkhwa, on the Afghan border, police climb mosque minarets to order Afghans to leave: "The stay of Afghan nationals in Pakistan has expired. They are requested to return to Afghanistan voluntarily."

Police warnings are not only aimed at Afghans, but also at Pakistani landlords.

"Two police officers came to my house on Sunday and told me that if there are any Afghan nationals they should be evicted," said Farhan Ahmad. Human Rights Watch has slammed "abusive tactics" used to pressure Afghans to return to their country, where they risk persecution.

In September 2023, hundreds of thousands of undocumented Afghans poured across the border into Afghanistan in the days leading up to a deadline to leave, after weeks of police raids and the demolition of homes.

After decades of hosting millions of Afghan refugees, there is widespread support among the Pakistani public for the deportations.

"They eat here, live here, but are against us. Terrorism is coming from there (Afghanistan), and they should leave, that is their country. We did a lot for them," said university lecturer Pervaiz Akhtar in Islamabad.

"Come with a valid visa, and then come and do business with us," said Muhammad Shafiq, a 55-year-old businessman.

His views echo the Pakistani government, which for months has blamed rising violence in the border regions on "Afghan-backed perpetrators" and argued that the country can no longer support such a large migrant population. – AFP

Thai court grants bail to detained academic

BANGKOK: A US academic charged with breaking Thailand's royal defamation laws will appeal against a decision to revoke his visa, his lawyers said yesterday, after he was released on bail of 300,000 baht (RM39,403). Paul Chambers, who has spent decades in

Thailand and is a lecturer in Southeast Asian politics at a provincial university, was arrested on Tuesday after reporting to police to answer a charge of *lese-majesty*. His case is a rare instance of a foreigner

His case is a rare instance of a foreigner falling foul of strict laws that shield King Maha Vajiralongkorn and his close family from any criticism.

Chambers was granted bail on the criminal case on Wednesday, but was kept in custody until late in the evening while his lawyers negotiated with immigration authorities on his visa status.

"His legal team plan to appeal the visa revocation," said the Thai Lawyers for Human Rights group, representing Chambers, in a post on X yesterday.

The Thai military filed a complaint against Chambers earlier this year over a blurb posted online for a podcast hosted by a thinktank website which focuses on Southeast Asian politics.

Chanatip Tatiyakaroonwong, a researcher at Amnesty International who campaigns for the release of political prisoners, said the visa revocation was meant to "intimidate".

"The visa revocation is meant to send a message to foreign journalists and academics working in Thailand, that speaking about the monarchy could lead to consequences," he said on Wednesday.

International watchdogs have expressed concern over the use of the laws, known as Article 112, against academics, activists and even students.

17 killed in Papua, two held hostage

JAKARTA: Rebels in Indonesia's Papua region said yesterday they have killed more than 17 people since the weekend, claiming that they were soldiers disguised as gold miners, and police said the insurgents were holding two hostages.

A low-level but increasingly deadly battle for independence has simmered between security forces and rebels in resource-rich Papua ever since it was controversially brought under Indonesian control in a vote overseen by the United Nations in 1969.

Sebby Sambom, a Papuan rebel spokesperson, said in a statement yesterday the rebels had killed more than 17 people since April 6, including five on Wednesday, and claimed they were soldiers disguised as gold miners.

"If the Indonesian government military wants to chase us, please come to Dekai town, we are in the town," Sebby said, referring to a town in Yahukimo district, where the incident took place.

Faizal Ramadhani, a senior police official who is the chief of the peace task force in Papua, confirmed the rebel attack yesterday. He said police have yet to confirm a death toll as officers are still on the way to the area.

Indonesia's military denied the people killed by rebels were their soldiers, adding it was a hoax, its spokesperson was quoted by state news agency Antara as saying.

Separately, police said in a statement yesterday that 35 people in the area were evacuated to another district, while two residents are allegedly still being held hostage by the rebels. – Reuters

South Korean opposition leader enters presidential race

SEOUL: South Korean opposition leader Lee Jae-myung, who is the front-runner in opinion polls to be the country's next leader, declared his bid for the presidency yesterday, promising to fix inequality and spur economic growth.

The presidential election will be held on June 3, after the impeachment of former president Yoon Suk Yeol for his December martial law declaration was upheld on April 4.

In a video released yesterday, Lee pledged to fix economic polarisation that he said was a key source of social conflict, highlighting how he felt this had exacerbated the recent political turmoil in the wake of Yoon's martial law order.

He vowed to drive large-scale investments at the government level in technology and talent development to resuscitate economic growth.

Lee, who has sought to brand himself as a pragmatist, said it did not matter who launched a policy but what was important was whether the policy was useful.

Conservative critics have warned that the opposition could undermine the alliance with the United States and threaten improved ties with Japan, but Lee proposed a pragmatic approach to diplomacy.

"Realistically speaking, the South Korea-US alliance is important, and South cooperation is Korea, US, Japan important. Within that, the consistent principle is the national interest of the . Republic of Korea is the top priority," Lee said.

A new South Korean leader will likely face the daunting task of negotiating with the US, the country's leading security ally, over tariffs that have cast a cloud over the export-reliant economy. Lee, 61, lost by the slimmest margin in

the country's history when he ran against Yoon in the 2022 presidential election.

But last year, he led his liberal Democratic Party to a landslide victory in a parliamentary election. - Reuters

Meta memoir author stars at US Senate hearing

Ex-staff claims company collaborated with Chinese govt

SAN FRANCISCO: The former Facebook employee behind a book about parent scathing company Meta on Wednesday alleged that the social networking giant collaborated with the Chinese government on artificial intelligence, censorship and more, then lied to Congress about what it was doing.

Former global policy director Sarah Wynn-Williams (*pic*), who worked at the company from 2011 to 2017, told members of a Senate committee that top Facebook executives met routinely with Chinese officials, schooling them on technology to compete with US companies and even building products to appease Beijing's government censors.

"The greatest trick under and CEO) (Meta founder and CEO) Mark Zuckerberg ever pulled was wrapping the American flag around himself and calling himself a patriot and saying he didn't offer services in China while he spent the last decade building an US\$18 billion (RM81 billion) business

there," Wynn-Williams said of the co-founder Meta and chief

executive. Wynn-Williams said she saw Meta work "hand in glove" with the Chinese Communist Party to build censorship tools tested on users in Taiwan and Hong Kong.

"When Beijing demanded that Facebook delete the account of a prominent Chinese dissident living on American soil, they did it and then lied to Congress when asked about the incident in a Senate hearing," Wynn-Williams said.

Wynn-Williams's book, Careless People: A Cautionary Tale of Power, Greed and Lost Idealism, was released on March 11 and became a bestseller despite Meta winning an arbitration court order barring the author from promoting the work or making derogatory statements about the company.

Her book recounts working at the tech titan and includes claims of sexual harassment by longtime company executive Joel Kaplan, a prominent Republican and ally of President Donald Trump who took over as head of Meta's global affairs team this year.

Meta took the matter to arbitration, contending the book violates a non-disparagement contract signed by Wynn-Williams when she worked with the company's global affairs team.

"The measure of how important these truths are is directly proportional to the ferocity of Meta's efforts to censor and intimidate me," Wynn-Williams told Senators. - AFP

Dominican Republic ends search for nightclub collapse survivors

SANTO DOMINGO: Rescue workers here on Wednesday ended the search for survivors of a nightclub roof collapse as the death toll neared 150 in the Caribbean nation's worst disaster in decades.

Emergency personnel said they had found 20 more bodies on Wednesday afternoon, a figure yet to be added to the official toll of 124.

An official statement said on Wednesday that "all reasonable possibilities of finding more survivors" had been exhausted, and the focus will turn to recovering bodies.

"Today we will complete the rescue effort," said Jose Luis Frometa Herasme, head of the fire service in Dominican capital Santo Domingo, where the tragedy ocurred at the Jet Set nightclub on Tuesday.

Relatives of missing people were still waiting desperately for news on Wednesday of their loved ones outside the ruined club, at hospitals and at the local morgue.

Over 300 rescue workers, aided by sniffer dogs, had spent two days combing through mounds of fallen bricks, steel bars and tin sheets, supported by firefighters from Puerto Rico and Israel.

Aerial images of the site showed a scene resembling the aftermath of an earthquake, with a gaping hole where the roof of the club, a fixture of Santo Domingo's nightlife for half a century, had been.

Over 500 people were also injured when the roof caved in while renowned merengue singer Rubby Perez was performing for a crowd of hundreds.

Perez and two former Major League Baseball players were among the dead.

Antonio Hernandez, whose son worked at the Jet Set nightclub, said



pieces".

A crew from the Gaza civil defence agency rushed to the scene, only to find several people trapped under the rubble, a rescuer said.

When asked by AFP about the strike, the Israeli military said it 'struck a senior Hamas official who was responsible for planning and executing attacks" from the area. It did not give the target's name. Hamas condemned the strike as

one of the "most heinous acts of genocide". - AFP

Three killed in US strikes on Yemen

SANAA: Houthi rebels said yesterday the United States killed three people in the rebel-held capital Sanaa.

Rebel-held areas of Yemen have seen near-daily strikes since Washington on March 15 intensified an air campaign against the Houthis to force them to stop threatening vessels.

"Three citizen's were killed in the American aggression on the Sabeen neighbourhood of the capital," Saba news agency said.

Houthi media also reported strikes on Yemen's Kamaran island in the Hodeida area, after the rebels earlier said a US air strike on Hodeida on Tuesday night killed 13 people, including women and children.

Since March 15, the Houthis have also resumed attacks targeting US military ships and Israel, saying they are acting in solidarity with Palestinians in the Gaza Strip.

The rebels began targeting ships transiting the Red Sea and Gulf of Aden, as well as Israeli territory, after the Gaza war began in October 2023, later pausing their attacks during a January ceasefire. The new US campaign followed

Houthi threats to resume attacks on vessels over Israel's Gaza blockade.

The Pentagon inspector general's office, a watchdog, said it would investigate Defence Secretary Pete Hegseth and other personnel after a leak of details about the March 15 US strikes.

The Atlantic Magazine published the transcript of messages accidentally shared with its editor in a chat group of senior US officials on Signal, a

messaging app. After the White House insisted no classified details were involved, the magazine then also published details of the attack plans which it initially withheld. – AFP

Bombers moved closer to Iran

PANAMA CITY: US Defence Secretary Pete Hegseth said it was up to Iran to decide whether the movement of B-2 bombers was a message to Tehran, as he voiced hope that negotiations over Tehran's nuclear programme could be

resolved peacefully. As many as six B-2 bombers relocated in March to a US-British military base on the Indian Ocean island of Diego Garcia, US officials have told Reuters, amid a bombing campaign in Yemen and mounting tensions with Iran.

There are only 20 B-2 bombers in the Air Force's inventory so they are usually used sparingly.

Experts say that puts the B-2s, which are equipped to carry the heaviest US bombs and nuclear weapons, in an ideal position to operate in the Middle East. Asked if the B-2s were meant to

send a message to Iran, Hegseth said:

"We'll let them decide." "It's a great asset. Trump's been clear ... Iran should not have a nuclear bomb. We very much hope - the president is focused on doing that peacefully," he said.

Trump on Monday made a surprise announcement that the United States and Iran were poised to begin direct talks on Tehran's nuclear programme, warning that Iran would be in "great danger" if the talks were unsuccessful. - Reuters

Israel seizing 'large areas' of Gaza

Security zone being expanded'

GAZA CITY: Israel said its troops were seizing "large areas" in Gaza and making the Palestinian territory "smaller and more isolated", as an air strike on a residential block killed at least 23

people on Wednesday. Defence Minister Israel Katz's comments come weeks into a renewed offensive by the military on the war-battered territory,

which has displaced hundreds of thousands, while an aid blockade has revived the spectre of famine for its 2.4 million people. Katz said that "large areas are

being seized and added to Israel's security zones, leaving Gaza smaller and more isolated", during a visit to the newly announced Morag Corridor between the southern cities of Rafah and Khan Younis.

Katz emphasised that Israel would keep increasing pressure on Gaza "until the hostages are freed and Hamas defeated". is

also Katz

said that Israel was encouraging plans for "voluntary emigration ... in accordance with the vision of the US president, which we are working to implement".

US President Donald Trump had earlier this year proposed a plan to develop Gaza into a "Riviera of the Middle East" while displacing its population. Gaza's civil defence agency said

an Israeli airstrike on a residential building in Gaza City killed at least 23 people, most of them children or women, while the military

said it targeted a "senior Hamas" official. The strike took

France could recognise Palestinian state in June

ISTANBUL: France could recognise the State of Palestine "in June" during an international conference co-chaired with Saudi Arabia, French President Emmanuel Macron

"We must move towards recognition, and we will do so in the coming months," Macron said in an interview broadcast on France 5. He said the conference, expected

to take place in New York, aims to advance the implementation of the

two-state solution and could mark a turning point in the Israeli-Palestinian conflict.

"Our goal is to chair this conference (on Palestine) with Saudi Arabia sometime in June, where we could finalise this movement of mutual recognition by several parties," he said.

Macron's remarks come amid mounting international calls for a political resolution to the conflict in Gaza, where Israel has killed more

than 50,000 people since October 2023, as well as the wider Israeli-Palestinian dispute.

In February 2024, Macron said that recognising a Palestinian state is "not a taboo for France", describing the move as both a moral and political necessity.

"We owe it to the Palestinians, whose aspirations have been trampled on for too long. We owe it to the Israelis who experienced the greatest anti-Semitic massacre of

our century. We owe it to a region that yearns to escape the promoters of chaos and the sowers of revenge,

of chaos and the sowers of revenge, he said at the time. At present, 147 of the 193 UN member states recognise Palestine. In May last year, Spain, Ireland, and Norway joined the list, bringing the number of EU countries extending recognition to 10.

Others include Bulgaria, Cyprus, Malta, Hungary, Poland, Sweden and Romania. – Bernama

Arabia was once lush and green, study reveals

LONDON: One of the world's largest deserts was once home to a vast lake and river system, an international team revealed in

research published on Wednesday. Recent research suggested the Empty Quarter, the vast desert of the Arabian Peninsula, had been in place for at least 11 million years, making it one of the largest biogeographic barriers on Earth.

Its presence limited the dispersal of early humans and animals between Africa and Eurasia.

But a new study published in *Nature* says the Empty Quarter was lush and green for 8 million years. At one point it featured a lake that reached a depth of 42m and an area of 1,100 sq km some 9,000 years

Favourable conditions in the area fostered grasslands and savannas and enabled human and animal migration until drought returned, according to the international team.

"Our work highlights the presence of an ancient lake, which reached its peak around 8,000 years ago, as well as rivers and a large valley shaped by water," said Abdallah Zaki, a postdoctoral fellow the Jackson School of at Geosciences, University of Texas.

Michael Petraglia, professor at Australia's Griffith University, said the "formation of lake and riverine landscapes, together with grasslands and savanna conditions,

would have led to the expansion of hunting and gathering groups and pastoral populations across what is now a dry and barren desert."

The authors say that fossil evidence from the late Miocene suggests the presence at times of "water-dependent animals (crocodiles, equids, hippopotamids and proboscideans), sustained by rivers and lakes that are largely absent from today's arid landscape. – Bernama

Anger can be restrained but it takes a deliberate and conscious effort - and it is worth the change.

Q: What should I do if I am starting to fear that my marriage was a

THE term "brain rot" was named Oxford's word of the year in 2024, which amplifies the influence of the internet and social media on language evolution and change.

The appeal of brain rot language stems from its engaging and atte grabbing characteristics. attention-

lt attracts younger individuals into online spaces where gaining visibility and recognition becomes highly desirable.

Their active involvement within these digital communities provides them with a sense of personal validation, social status and belonging.

Academically, this phenomenon can be understood through the intricate relationship between evolving cultural norms, linguistic shifts and advancements in communication technology.

Research on the influence of emojis, memes and internet slang on contemporary language and interpersonal communication have indicated that the younger generation are facing academic and professional communication challenges.

Formal communication settings, such as academic institutions and work environments, have always adhered to the conventional language rules for coherence and linguistic integrity.

However, these norms are nonexistent with internet slang, shaping communication in ways we had not anticipated. In addition, the short, bitesized content that are on social media platforms has the

potential to disrupt or diminish

deeper, reflective thinking. The recent Netflix series Adolescence delves deeply into new language norms and communication styles of teenagers, highlighting how emojis and slang were used in ways that carried hidden meanings. The series also explores

how teenagers use emojis to convey nuanced emotions or intentions and sheds light on the complexities of modern teenage communication and potential the for misinterpretation or harm such language when is weaponised.

We, hence, believe that it is crucial to examine the widespread brain rot language being used in communication among generation. our younger

While we accept that this phenomenon is a defining feature of Gen Z and Gen Alpha and is facilitating quick and engaging communication, we are wary of its impact in academic and professional contexts where clarity, structure and grammatical accuracy are essential.

Thus, we argue that there is need to include digital literacy into the curriculum.

Learning how and when to use the right language is key to equipping our future generations with the tools to engage, interact and integrate with the world around them.

Is there a secret clause in the Local Government Act that reads: "Use excessive force where dignity is detected"?

Or perhaps a footnote that says: "Extra punches if the suspect is poor, Malay and unphotogenic"?

If this is just doing their job, then we need to ask - what is the job? Keeping the peace or peacocking with unchecked power?

So, here is to the balloon man the villain we did not know we had – may your bruises fade faster than the public's memory. May your spirit inflate again, if not your balloons.

And to our fearless enforcers: sleep soundly. The streets are safe from smiles, from joy, from hope. Mission accomplished!

Xi's visit to M'sia set to trigger new investments into Asean

PETALING JAYA: Chinese President Xi Jinping's official visit to Malaysia next week will be pivotal in not only triggering new investments in Southeast Asia but also pave the way for further economic development and

prosperity in the region. In expressing confidence over the positive outcome from the visit, Malaysian Chamber of Commerce and Industry in China (MayCham) chairman Loh Wee Keng (*pic*) cited the enormous potential for the development of digital currency and cross-border digital payment systems between China and Asean in the financial

sector. "(Although) the trade volume between China and Asean in 2023 exceeded US\$900 billion (RM4 trillion), there is an urgent need for an efficient and costeffective cross-border transfer (payments) system for the region.

told Bernama recently. Loh said Malaysia was one of the earliest supporters of the Belt and Road Initiative (BRI) and, therefore, one can expect some of the BRI projects such as the highspeed train, Malacca port, green energy and Kuala Ketil power plant to feature prominently at high-level discussions between Malaysia and China.

MayCham China chairman expresses confidence over positive outcome from Chinese president's trip

"These mega infrastructure projects will have long-term implications for Malaysia's economic development," he said. Loh noted that the discussions could also look into issues

"For instance, Malaysia has huge reserves of rare earth, which are highly in demand by industries in China; but Malaysia does not allow rare earth exports while China's mining technology for rare earth is not allowed to be transferred to foreigners."

With this scenario, Loh said, the high-level meeting would be the perfect platform to discuss the trade in rare earth and achieve a win-win situation to help each other.

On conventional items such as palm oil and derivatives, rubber products, bird's nests and agricultural products, the MayCham chairman expressed hope that China would increase its imports from Malaysia.

He added that there is also room for increased investments between China and Malaysia as well as between China and Asean.

KUALA LUMPUR: Asean must remain neutral in the escalating global trade war over tariffs between superpowers the United States and China, former Bank Negara Malaysia assistant governor Tan Sri Andrew Sheng (pic) said

"It is not going to be healthy for anyone to be seen taking sides, more so with Asean economies inextricably linked in both trade and investment to Washington and Beijing," Sheng told Bernama at the Asean Finance Ministers' and Central Bank Governor's Meeting here on Wednesday.

He said Malaysia, as the Asean chair this year, has the influence to help shape the grouping's views toward neutrality as regional leaders converge for their 47th annual summit here on May 26-27.

"Asean's neutrality is critical right now," said Sheng, who is also chair-man of the George Town Institute of Open and Advanced Studies and distinguished fellow at the Institute for Capital Market Research.

Donald Trump an-nounced sweet tariffs against 168 countries on April 2, both countries have been engaged in a titfor-tat tariff retaliation. This has culminated in the US announcing a staggering 104% tariff on Chinese imports while the latter has hit back with a 84%

import levy on American goods entering its own market. The global backlash has escalated with Canada hot on the heels of China, imposing a 25% tariff on selected American vehicle imports.

The 27-member European Union , meanwhile, is also planning reta-liatory tariffs on America although it has expressed willingness to negotiate first.

(In the latest development yes-



inflation and an impending global recession.

Asked whether it could be time for Asean+3 (China, South Korea, and Japan) to unite against the US, Sheng said, "That is clearly a 'No' as America's biggest power is being the largest importer of all you produce." He likened the US-China trade

tension to a "war of the elephants" the Sang Kancil, or mousedeer, in reference to small countries, "must be very clear about how to stay nimble, fast and flexible".

Southeast Asian economies should reaffirm their diversities and economic strengths.

In doing business, Sheng said, they must hold onto an open trading approach, allowing for flexibility and discretion in choosing partners without necessarily revealing their identities.

To suggestions that Indochinese countries Cambodia and Laos are the hardest hit because of their dependence on China, Sheng said this is not true as both are heavily reliant on the US market.

That's why the US wants to remind Cambodia, "You're ultimately selling to me."

Sheng emphasised that trade and investment cooperation "is not something you can achieve overnight as every country is different (and) as long as everybody is nimble and fast on your feet, you will survive".

"This entails Asean countries being open to the idea that non-tariff barriers are not necessarily sacred cows that you cannot remove," he said.

Malaysia, as Asean chair, has the opportunity to introduce fresh ideas such as the Asean Business Entity, proposed by the Asean Business Advisory Council, which accords trade privileges to companies operating regionally.

Sheng pointed out that Trump's shocking tariffs have inevitably started an economic revolution for which economies must upgrade and achieve competitiveness or risk losing out to the vagaries of the inter-national marketplace.

"Tariffs have changed the competitive game," he said, adding that this is not a crisis but rather a massive shock for which the good news is that "you do something you don't want to do" such as reducing non-tariff barriers.



Asean Infrastructure Fund launches four-year action plan

KUALA LUMPUR: The Asean Infrastructure Fund (AIF), one of the region's largest infrastructure financing initiatives funded by member contributions, has launched the AIF Action Plan 2025-2028.

Endorsed at the 12th Asean Finance Ministers and Central Bank Governors Meeting here, the action plan charts a strategic and actionable guide for the fund's next four years of growth to spur sustainable infrastructure projects across the region.

Launched under Malaysia's chairmanship of the AIF, the Ministry of Finance said in a statement yesterday that the plan is a "living document" subject to ongoing guidance of its Board, comprising 10 Asean member states (AMS) and the Asian Development Bank (ADB).

Finance Minister II Datuk Seri Amir Hamzah Azizan said the endorsement will catapult Asean's role as the global standard in governance and sustainable development. The AIF Action Plan 2025-2028 serves to secure confidence among potential investors and co-financiers, which then produces tangible benefits to AMS in the form of sustainable and resilient infrastructure projects that will contribute to Asean's growth and development for years to come."

The action plan's immediate priorities are set out as to expand the fund's financial capacity by securing new capital, allowing greater lending to Asean member states; improve the price competitiveness of the AIF's loans through policy adjustments and periodic reviews; expand the AIF's range of financing solutions through new innovative facilities, including those for preparing regional connectivity projects, such as the Asean Power Grid and pilot loans in Islamic finance; and expand the Asean Catalytic Green Finance Facility's collaboration with other multilateral development banks and development finance institutions, and widen access to more public and private capital donors, channel more expertise, and grow the AIF's pipeline of projects. With the strong support of all Asean

member states and its funding partners, the AIF looks forward to a new phase of expanded scale and impact in support of Asean's efforts to finance more green and resilient infrastructure in the region. To date, the AIF has committed over US\$500 million (RM2.23 billion), and disbursed over US\$460 million, to support 15 projects in six Asean countries.

"Malaysia, as the AIF chair, remains resolute in advancing the AIF Action Plan," said Finance Ministry deputy secretary-general of the Treasury (policy) and AIF chair Datuk Zamzuri Abdul Aziz.

He added that the commitment ensures that Asean's infrastructure financing is not only innovative and impactful but also aligns with their collective vision for a more integrated, resilient and sustainable Southeast

Spanning 23,000 acres and involving an investment of €15 billion (RM72 billion), LuMIC encompasses an international-standard port, an eco-friendly industrial zone and a sustainable smart city.

Backed by the completed European Unionfunded feasibility study, the next steps will see the proposal and masterplan put in place to attract RM72 billion in investments over the next 25 years.

The bold plan is set to drive Perak's socioeconomic growth, generating over 50,000 new jobs and transforming the region into a vibrant industrial and maritime hub.

The feasibility study evaluating the state and country's potential in the competitive maritime and industrial sectors, also highlighted Lumut's captive industry, abundant resources, skilled workforce, and strong state support as key success factors.

The findings and masterplan were presented to key stakeholders, including ambassadors from Belgium, the European Union (EU), Croatia, Spain, the Netherlands, France and Poland, along with representatives from federal ministries, the Perak state government, and

industry leaders from maritime, port, logistics, and industrial sectors.

LuMIC is expected to have a positive impact on the services sector, such as tourism and retail, and has the potential to elevate the socioeconomic status of the local community. At the same time, it will strengthen Malaysia's position in the global industrial and maritime sectors.

Saarani said, "The close collaboration between PKNPk and PoABI reflects a strategic international synergy and enhances global confidence in the prospects of the LuMIC project's success. Since the partnership was established in 2022, efforts have been further intensified with the support of an EU grant worth RM9.5 million, which was announced in December 2023 for the implementation of the project's feasibility study.

"In May 2024, the first phase of the study was presented, covering six key focus areas developed through a combination of local expertise and the professional network of European port authorities.

"As a result of the signing of this strategic agreement, LuMIC Development Sdn Bhd (LuMIC DevCo) was established as the main driver of a new, more competitive, strategic and future-oriented economic growth?

Furthermore, Saarani said, the imple-mentation of the National Research, Development, Innovation, Commercialisation and Economy Roadmap is expected to increase the contribution of the marine and maritime sectors to national gross domestic product from 21.3% to 31.5% by 2030, equivalent to a value of RM1.4 trillion.

He said LuMIC is also positioned to address challenges through sustainable global approaches such as carbon reduction, the use of renewable energy, and the development of a resilient supply chain. At the same time, this project supports the National Energy Transition Roadmap, positioning Perak as one of the pioneers of maritime sustainability in Asean, . Saarani noted.

PKNPk chief executive Datuk Redza Rafiq Abdul Razak said the findings of this feasibility study mark an important milestone in the agency's collaboration with the PoABI, which is not only the second-largest industrial port in Europe but also one that has an established track record in this area.

'Together, we are preparing a comprehensive and actionable framework that will transform Lumut into a world-class maritime and industrial nerve centre," he said.

West River to acquire land, build factory and warehouse in Klang Valley

LUMPUR: ACE KUALA Market-bound mechanical and electrical (M&E) engineering services provider West River Bhd, which launched its initial public offering (IPO) prospectus yesterday, plans to expand its manufacturing capabilities with the manufacturing capabilities with the development of a new facility in the Klang Valley,

The IPO is expected to raise RM27.9 million, of which RM10 million (35.84%) has been earmarked for the acquisition of land and construction of a manufacturing facility and warehouse in the Klang Valley. Managing director Lim Yong Lai said the

proposed facility, with an estimated built-up area of 35,000 square feet (sq ft), will accommodate expanded production space for electrical panels and distribution boards, and 25,000 sq ft of dedicated storage for M&E project-related inventories including cables, wires and spare parts.

"The new facility will allow West River to triple our annual production capacity over the next three years, strengthen supply chain efficiency and enable bulk procurement directly from manufacturers, further reducing reliance on trading intermediaries and securing more competitive pricing.

"Our expansion into a larger facility is a strategic move to meet growing demand for our services while improving operational efficiency. This IPO marks a pivotal milestone as we scale our operations and unlock greater value across the M&E engineering sector," he said at the prospectus launch.

Of the remaining proceeds from the IPO, RM5.6 million (20.07%) will be used for the repayment of borrowings to strengthen the company's capital structure and improve gearing; RM7.8 million (27.96%) for general working capital, including workforce expansion and the purchase of materials for the manufacturing of electrical panels and distribution boards, and RM4.5 million (16.13%) to cover estimated listing expenses.

West River's IPO entails a public issue of 71.54 million new shares and an offer for sale of 35.77 million existing shares, priced at 39 sen per share. The IPO values the company at RM139.5 million, with a price-to-earnings ratio of 12.19 times based on its FY 2024 profit after tax of RM11.46 million.

According to independent market research by Providence Strategic Partners Sdn Bhd, Malaysia's M&E engineering industry is projected to grow from RM8.5 billion in 2024 to RM10.9 billion in 2026, underpinned by rising investments and increased construction activities across the residential, commercial, and industrial sectors.

Lim said the company is well-positioned to progress towards greater innovation, expansion and long-term success in the M&E engineering sector. "This year will be significant for West River as we embark on our IPO journey for the listing on the ACE Market of Bursa Malaysia Securities.

The application period of West River's IPO commenced yesterday and will close on April 17 at 5pm. The company is slated for listing on May M&A Securities Sdn Bhd is the principal adviser, sponsor, underwriter and placement agent for the IPO

Asean at critical juncture as global landscape shifts

> Political will and coordinated efforts are crucial, says Zeti

KUALA LUMPUR: As the global economic landscape shifts dramatically, Asean stands at a critical juncture, ready to navigate the challenges ahead, but the region's success hinges on the strength of its political will and coordinated efforts, said Tan Sri Dr Zeti Akhtar Aziz.

Unlike in the past, Asean is now positioned from a place of strength, said the former Bank Negara governor.

Two decades of concerted efforts have significantly strengthened the 10-member bloc through enhanced regional economic and financial integration, along with more robust networks, she said.

This solid foundation enables it to harness its collective comparative advantages to address challenges such as excess capacity, job losses, and supply chain disruptions resulting from global shocks, she said at the *Eminent Persons' Dialogue: Asean Financial Integration in a Multipolar World* here on Wednesday.

Greater reliance on new technologies and artificial intelligence (AI) will also be required,

coupled with the best minds that reside in Asean and the greater Asia, who must be mobilised to design such a coordinated transformation in the region.

"While this vision is entirely within reach, it will, however, require political will, institutional capacity, and continued public-private collaboration. It will require investment in digital infrastructure, harmonised regulatory frameworks, and mechanisms that support financial inclusion," she said. Vital, she added, will be the continued

Vital, she added, will be the continued commitment to regional solidarity toward building a stronger, more secure, and more prosperous region.

Asean, she said, must also shape, and not merely adapt to the evolving global financial architecture and environment.

architecture and environment. "The world today is characterised by multiple centres of economic influence, and Asean must navigate this shifting landscape with confidence and agility to adjust.

"While recognising these realities, the region should actively shape international financial

and trade norms to ensure Asean's perspectives and priorities are reflected in global decisionmaking," she added.

In her address, Zeti also cited the Chiang Mai Initiative Multilateralisation (CMIM) as a hallmark of regional cooperation – an assertion of regional solidarity and greater financial self-reliance – signalling that the region has the capacity and political will to stand together in times of stress. She said the CMIM has further fortified the

She said the CMIM has further fortified the region's financial safety net to provide crucial liquidity support during turbulent times and security during tranquil periods.

"This mechanism reinforces our collective ability to respond swiftly to external shocks and to safeguard our macroeconomic and financial stability."

The CMIM involves the 10 Asean member countries, as well as China, Japan, and South Korea, forming the Asean+3 regional financial safety net.

It was established in May 2000 as the Chiang Mai Initiative in response to the 1997/98 Asian Financial Crisis.

It was later multilateralised and became the CMIM in 2010, with the total funding size increased to US\$240 billion (RM1.07 trillion) from US\$120 billion previously. – Bernama

Petronas and PetroVietnam strengthen partnership

The KPA sets the framework for the continuation of the PSC and UGSA until Dec 31, 2047, ensuring production continuity across seven fields and unlocking further potential PM3 CAA.

The PM3 CAA PSC facilities are also positioned as a strategic hub to support tie-ins

from nearby discoveries – optimising asset utilisation and reinforcing energy security in both Malaysia and Vietnam.

The domestic market UGSA has been structured to maintain the economic viability of future gas field developments.

Key terms for a new UGSA will ensure continued supply to Malaysia via Kertih and to Vietnam via Ca Mau, supporting national energy demands of both countries.

The PM3 CAA is also expected to include plans for the reinjection of carbon dioxide (CO₂) produced from petroleum production activities – positioning the area as a potential hub for CO₂ sequestration.

This approach supports the net-zero aspirations of both countries' net-zero ambitions by 2050.

March palm oil exports up 0.9%, CPO output jumps 16.7% from previous month: Board

KUALA LUMPUR: Malaysia's palm oil exports rose 0.91% in March to one million tonnes from 996,460 tonnes in February, the Malaysian Palm Oil Board (MPOB) said.

In its March 2025 industry performance report, MPOB said crude palm oil (CPO) production climbed 16.76%, or 199,164 tonnes, to 1.38 million tonnes from 1.18 million tonnes in the previous month. Palm kernel output increased 18.23% to 336,918 tonnes in March from 284,959 tonnes in February.

Crude palm kernel oil production rose 15.20% to 149,923 tonnes from 130,146 tonnes, while palm kernel cake output advanced 20.74% to 172,655 tonnes from 142,997 tonnes.

CPO stocks fell 5.68% to 779,233 tonnes in March, compared with 826,145 tonnes a month earlier.

Processed palm oil stockpiles grew 14.63% to 783,353 tonnes from 683,380 tonnes in February, while total palm oil inventories increased 3.52% to 1.56 million tonnes from 1.50 million tonnes.

MPOB said palm kernel oil exports slipped 3.11% to 56,333 tonnes in March from 58,144 tonnes in February.

Palm kernel cake exports tumbled 36.90% to 122,977 tonnes from 194,894 tonnes, while

biodiesel exports dropped 64.46% to 14,947 tonnes from 42,052 tonnes.

Oleochemical exports, however, rose 5.74% to 209,610 tonnes from 198,238 tonnes a month earlier.

No CPO imports were recorded in March, while palm kernel oil imports edged down 0.17% to 12,678 tonnes from 12,699 tonnes in February. – Bernama

Stock markets soar as **Trump pauses painful tariffs**

But American president raises duties on Chinese imports to 125%

HONG KONG: Stocks rocketed yesterday as a relief rally spread through markets after Donald Trump paused crippling tariffs on US partners, with Chinese investors even brushing off his decision to ramp up duties on Beijing to 125%.

The across-the-board gains tracked a blistering performance on Wall Street as the US president said he would delay for 90 days measures announced last week that set off a firestorm on trading floors and sparked global recession fears.

Trump said he would keep in place a basic levy of 10% on dozens of countries but upped the ante in his brutal trade war with superpower rival China by hitting it even harder after it retaliated.

china's own 84% retaliatory measures kicked in at 0401 GMT (12.01pm in Malaysia) yesterday, later saying that the USs "goes against the whole world" with the measures and called on Washington to "meet halfway".

Trump made the decision to delay because investors were "jumping a little bit out of line",

he said, after markets collapsed and US Treasuries - considered the safest option in times of crisis - showed signs of cracking.

People "were getting yippy, a little bit afraid", he added, referring to a term in sports to describe a loss of nerves.

The extra tariffs on Beijing, however, were "based on the lack of respect that China has shown to the world's markets", Trump said.

The president denied he had made a U-turn, telling reporters that "you have to be flexible". And his top trade adviser Peter Navarro said:

"This will go down in American history as the greatest trade negotiating day we have ever had.

"We're in a beautiful position for the next 90 days, we've got over 75 countries that are going to come in and negotiate with us and what they're going to have to do, without fail, is they're going to have to lower their non-tariff barriers

Trump's announcement on his Truth Social network sparked a buying frenzy as Asian and European investors chased beaten-down stocks. "Asia markets are flipping the switch - from

fear to euphoria – as Trump throws a 90-day lifeline, pausing the reciprocal tariff barrage, said Stephen Innes at SPI Asset Management. "We just witnessed one of the all-time

bouncebacks – and now, we look for Asia investors, much like their North American counterparts, to step in and buy the 'yips."

Tokyo's Nikkei surged more than 9%, while Taipei's 9.3%t gain was its best rise on record -

after Monday's 9.7% drop represented its worst fall.

Hong Kong rallied more than 2% – a third day of gains after collapsing more than 13% on Monday in its worst day since 1997 during the Asian financial crisis.

Shanghai gained more than 1%.

The two markets have been given extra support by optimism that China will unveil fresh stimulus to support its economy.

Seoul, Singapore, Jakarta, Sydney, Saigon and Bangkok climbed between 4% and 6.6%. Manila and Wellington were also well in the

positive territory. In early trade, Paris and Frankfurt cruised more than 6% higher and London rallied more than 4%

Tech firms were the standout performers, with Sony, Sharp, Panasonic and SoftBank chalking up double-digit gains, while airlines, car makers and casinos also enjoyed strong buying.

Gold surged almost 3% around US\$3,120 -US\$50 short of its record touched last month thanks to the weaker dollar and as the uncertainty saw investors rush into the safe haven

Chihiro Ota, at SMBC Nikko Securities, said: "What happens now? If the US takes hardline stance (in negotiations), then the market would be disappointed. If it turns out that they can engage in talks, then it may create a room for (an upswing)." - AFP



NZ proposes CPTPP-EU alliance to defend free trade

WELLINGTON: New Zealand's prime minister proposed yesterday a new alliance to battle global export restrictions, enlisting members of a 12-nation trans-Pacific free trading agreement and the European Union.

The US tariffs had "shocked" financial markets, though Donald Trump's pause on the highest levies – excepting those on China – was "welcome", Christopher Luxon said.

The consequences of a world retreating from trade and uncertain about the economic future would be "more significant", however, he warned in a speech in Wellington.

Countries in the Comprehensive and

Agreement for Trans-Pacific Progressive Partnership (CPTPP) – accounting for about 15% of global economic activity - could help promote free trade, he said.

"One possibility is that members of the CPTPP and the European Union work together to champion rules-based trade and make specific commitments on how that support plays out in practice," the prime minister said.

"My vision is that includes action to prevent restrictions on exports and efforts to ensure any retaliation is consistent with existing rules.

Collective action by a large portion of the global economy would be a "significant step" towards preserving free trade and protecting supply chains.

The trans-Pacific CPTPP has a dozen members including Canada, Mexico, Chile, Peru, Malaysia, Japan, Brunei, Vietnam, Singapore, Australia, New Zealand, and most recently Britain.

Some commentators had declared an end to the era of free markets, free trade, free people and the rules-based international order, Luxon said.

"For my part, I am not ready to throw in the towel quite yet."

The prime minister said he would telephone world leaders to discuss how to strengthen the rules-based global trading system. - AFP

Vietnam to start trade talks with US

HANOI: Vietnam and the United States agreed to start negotiations on a reciprocal trade agreement, Hanoi said vesterday, hours after Washington delayed imposing an enormous tariff on the Southeast Asian manufacturing powerhouse.

The United States was Vietnam's biggest export market in the first three months of the year but President Donald Trump hit it with a 46% duty as part of a global trade blitz announced last week.

Trump paused the stiff new tariffs on Wednesday and Vietnam's Deputy Prime Minister Ho Duc Phoc suggested the two countries "should soon negotiate a bilateral trade agreement ... to promote stable and mutually beneficial economic and trade relations", according to a statement on the government news portal.

Ho has been appointed by top leader To Lam to negotiate with the US on tariffs. He met with US Trade Representative

Jamieson Greer on Wednesday.

'The US agreed that the two sides should initiate negotiations on a reciprocal trade agreement, which would include tariff agreements, and asked technical levels from both sides to begin discussions immediately," according to the government statement. Ho had meetings with senators and many

organisations and businesses while in the United States, it said. Budget airline Vietjet said yesterday it had

signed a US\$300 million (RM1.3 billion) agreement with AV AirFinance, a commercial aviation lending company, to boost its fleet.

It said the agreement, signed in the presence of Ho, was part of a broader series of aircraft financing deals totalling more than US\$4 billion that Vietjet had secured with leading US partners.

AV AirFinance said Vietjet would begin taking delivery of the first batch of Boeing 737 MAX aircraft this year as part of a US\$24 billion deal originally announced in 2019.

Experts said Trump's levy could seriously damage Vietnam's growth model, which relies heavily on exports to the United States. – AFP

EU chief welcomes 'important step' to stabilise world economy

BRUSSELS: EU chief Ursula von der Leyen yesterday welcomed US President Donald Trump's decision to pause planned tariff increases as an "important step towards stabilising the global economy". "Clear, predictable conditions are essential

for trade and supply chains to function," the European Commission president said in a statement.

'The European Union remains committed to constructive negotiations with the US," she said, reiterating the bloc's offer of a bilateral tariff exemption for cars and other industrial goods.

The EU was hit with a 20% rate as part of Trump's universal tariffs and the commission has been preparing its response, although Brussels has made it clear it would prefer to avoid retaliation.

Trump announced the punishing tariffs last week, throwing global markets into chaos until he announced on Wednesday that he was halting the measures for almost

all nations for 90 days. The 27-nation EU is among dozens of countries including Japan – but not China – that now face a baseline tariff rate of 10%.

The bloc also remains subject to previously enacted US tariffs on steel and aluminium, to which it retaliated on Wednesday, and on the auto sector.

Trump's aggressive trade moves and hostile rhetoric against the EU have focused minds in Brussels, with leaders now scrambling to establish closer trade ties with other nations including India. - AFP

White House backs off Nvidia H2O chip crackdown

SAN FRANCISCO: Donald Trump's administration has reversed course on plans to restrict exports of Nvidia's H20 AI chips to China after CEO Jensen Huang attended a Mar-a-Lago dinner last week, NPR reported on Wednesday.

The planned American export controls on the chips - the most advanced AI processor legally available in China under US export controls – had been in the works for months, NPR reported, citing two sources, and were ready to be implemented as soon as this week.

The change in plans came after Nvidia promised the Trump administration new US investments in AI data centres, the NPR report said.

The White House and Nvidia did not immediately respond to Reuters' requests for comment.

Trump's administration was considering tightening restrictions on the Al leader's sales of its H20 chips designed for the China market, Reuters had reported in January.

The idea to restrict shipments of those chips to China has been under consideration since Democratic former president Joe Biden's administration.

In February, Reuters exclusively reported a surge in orders for the H20, driven by booming demand for Chinese startup DeepSeek's low-cost AI models.

China firms, including ByteDance, Alibaba and Tencent, have placed at least US\$16 billion in orders for Nvidia's H20 server chips in the first three months of the year, The Information reported last week.

Two American lawmakers, Republican John Moolenaar and Democrat Raja Krishnamoorthi, called for more restrictions on exports of Nvidia's AI chips in January. – Reuters

Philippine central bank cuts policy rate by 25 bps

MANILA: The Philippine central bank resumed its easing cycle yesterday, as expected, cutting its key policy rate by 25 basis points (bps) to 5.5% to help the economy cope with global challenges, including US trade policy.

The quarter-point reduction in the benchmark interest rate , which was forecast by 20 out of 23 economists in a Reuters poll, came after data last week showed inflation eased to a near five-year low of 1.8% in March.

Bangko Sentral ng Pilipinas Governor Eli Remolona said a "more challenging external environment" was a risk for global and domestic growth.

"On balance, the more manageable inflation outlook and the risks to growth allow for a shift toward a more accommodative monetary policy stance. "Looking ahead, Bangko Sentral ng will

continue to take a measured approach in deciding on further monetary easing." Though less affected than some of its

neighbours, the Philippines has not been spared from the global trade wars, with the US threatening tariffs on its exports.

Manila is targeting growth of 6%-8% this year, up from last year's 5.7% expansion. Reuters

TSMC's Q1 revenue surges 42%, ahead of forecasts

TAIPEI: Taiwanese chipmaking giant TSMC reported yesterday a better-than-expected revenue for the first quarter on strong demand for AI technology, after tariffs slapped onto major economies by President Donald Trump caused global uncertainty.

Semiconductor Taiwan Manufacturing Company is the world's largest contract maker of chips that are used in everything from Apple's iPhones to Nvidia's cutting-edge artificial intelligence hardware. TSMC said revenue in the first

three months of 2025 rose nearly 42% to NT\$839.25 billion (RM114 billion) on-year, beating a forecast of around NT\$830.5 billion by analysts surveyed by Bloomberg News. The company is scheduled to

Contract chipmaker expects 2025 to be 'another strong growth year'

release full first quarter earnings in an online briefing next week.

TSMC chairman and chief executive C.C. Wei has said the firm expected "2025 to be another strong growth year" as AI-related demand continues to surge.

And its full year revenue was expected to increase "by close to mid-20s per cent in US dollar terms", Wei said at an earnings conference in January.

But in light of Trump's ongoing trade war with China – the world's second-largest economy - and his threats to slap tariffs on semiconductor imports, Taiwan's

own industry could experience reverberations across the global chip supply chain.

Taiwan had sought to avoid Trump's threatened levies by pledging increased investment in the United States, more purchases of US energy and greater defence

spending, Also last month, TSMC said it would invest US\$100 billion (RM447 billion) in the United States in what was hailed by Taiwan's President Lai Ching-te as a "historic moment" for Taiwan-US relations.

The planned investment followed Trump's accusations that

Taiwan stole the US chip industry and his threats to impose tariffs of up to 100%.

In the end, Trump imposed a hefty 32% on Taiwanese imports – excluding semiconductor chips though the mercurial Republican on Wednesday abruptly paused the implementation for almost all countries except China for 90

days. TSMC has long faced demands to move more of its production away from Taiwan, with fears that supplies of the critical technology could be disrupted in any conflict with Beijing. China has upped military

pressure on Taiwan in recent years to press its claim of sovereignty over the self-ruled island, where TSMC has its headquarters and the bulk of its fabrication plants. - AFP

Volkswagen earnings dragged down by EU carbon provision, US tariffs

BERLIN: Volkswagen's first-quarter earnings fell far short of market expectations, plunging about 40%, as Europe's biggest carmaker factored in costs for penalties of missing EU carbon emissions targets and for cars affected by US tariffs. Volkswagen's shares were up

8.2%, as relief swept through markets after the US administration's announcement of a 90-day pause on tariffs imposed less than 24 hours earlier on dozens of countries, but a 25% tariff on autos imports remains

in place and Volkswagen is heavily exposed.

After lobbying from the car sector, the European Commission, the EU executive, has proposed to loosen rules that most of the industry is likely to breach this year, leading to billions of euros in fines.

The proposal, which would give Volkswagen and the rest of the industry more time to boost sales of low emission electric vehicles, has yet to be approved by the European Parliament

As a result, Volkswagen included a €600 million (RM2.9 billion) provision for potential fines in its first-quarter result, as well as €200 million for restructuring at its software unit Cariad, which is in the midst of layoffs. That lowers its operating return on sales to around 3.6%, down from 6% last year.

A spokesperson declined to provide detail on the costs related to . US tariffs.

Those linked to the valuation of vehicles in transit to the US, where a

25% import tariff was imposed from

April 3, weighed on results. The bulk of the VW brand's US sales is from cars made in Mexico and its Audi and Porsche brands have no US manufacturing base.

The company confirmed its full-year outlook of up to 5% sales growth and operating return on sales of between 5.5% and 5.6% but said in its results statement these forecasts excluded the possible impact of tariffs since it was too early to assess their impact. - Reuters

Bursa rebounds sharply as US tariff pause brightens mood

BURSA Malaysia rebounded sharply to close higher yesterday, with the benchmark index rising 4.47%, amid improved market sentiment across the region following the US tariff pause announcement.

At 5pm, the FBM KLCI rose 62.54 points to 1,463.13 from Wednesday's close of 1,400.59.

The benchmark index opened 63.71 points higher to 1,464.30, then retreated a low of 1,453.13 after 15 minutes of trading before continuing to trend to a high of 1,473.36 at mid-morning and maintained its positive momentum towards closing.

Market breadth was positive, with gainers overwhelming decliners 1,075 to 183, while 261 counters were unchanged, 847 untraded, and 10 suspended.

UOB Kay Hian Wealth Advisors Sdn Bhd head of investment research Mohd Sedek Jantan said the FBM KLCI recovery was broad-based across all index components, reflecting improved investor sentiment following an overnight rally on Wall Street.

"The catalyst behind the renewed optimism was US President Donald Trump's decision to delay the implementation of higher reciprocal tariffs, which offered temporary relief to global markets. However, the existing 10% tariffs remain in effect and continue

to pose downside risks to market stability," he told Bernama.

Among heavyweights, Maybank jumped 49 sen to RM9.99, Public Bank rose 16 sen to RM4.25, Tenaga Nasional climbed 48 sen to RM13.30, CIMB bagged 56 sen to RM6.91, and IHH Healthcare gained nine sen to RM6.80.

For the actives, MYEG rose eight sen to 83.5 sen, Top Glove garnered nine sen to 91 sen, Inari Amertron jumped 27 sen to RM1.72, Supermax put on 4.5 sen to 85 sen, and SumiSaujana edged up one sen to 19 sen.

Agrobank to equip 18 branches with solar power by year-end

BAGAN SERAI: Bank Pertanian Malaysia Bhd (Agrobank) aims to use solar power at 18 branches by year-end.

Its president and CEO Datuk Tengku Ahmad Badli Shah Raja Hussin, said the bank also targeted an additional 50 branches nationwide to adopt green technology by 2025.

"We are committed to supporting the government's environmental efforts by planning to install solar energy at 138 more branches over the next five years.

'This initiative aligns with Agrobank's commitment to reduce the impact of climate change and achieve net-zero carbon emissions by 2050," he said at a press conference yesterday.

He made these remarks after attending the inauguration of Agrobank's first Green Branch in Bagan Serai, officiated by Natural Resources and Environmental Sustainability Minister Nik Nazmi Nik Ahmad.

Tengku Ahmad Badli Shah added that the Bagan Serai branch has been fitted with 40 solar panels at a cost of RM45,000, capable of generating 20 kWp of energy with an average of 2,400 kWh of electricity each month.

"In addition to being equipped with a solar system, this branch also features a 350-litre rainwater collection system for general use and landscaping, an energy-efficient cooling system, and LED lighting designed to reduce energy consumption.

"Through this initiative, we can reduce monthly electricity and water bills by 45%, with an estimated monthly savings of RM1,530.90 on electricity bills," he said.

He added that green technology is expected to help fight climate change and cut carbon dioxide emissions by 1.91 tonnes each month. – Bernama

Ringgit ends three-day losing streak against US dollar

THE ringgit ended firmer against the US dollar yesterday, snapping a three-day losing streak following US President Donald Trump's 90-day pause in reciprocal tariffs for all countries except China.

At 6pm, the ringgit strengthened to 4.4670/4730 against the US dollar, marking a 0.58% gain from Wednesday's close of 4.4935/4990.

Bank Muamalat Malaysia Bhd chief economist Dr Mohd Afzanizam Abdul Rashid said the pause lifted market sentiment and paves the way for countries to negotiate with the US government and, perhaps, achieve a more favourable outcome

"That has contributed to the rebound in risky assets in equities and currency markets," he told Bernama.

It was reported that during the 90-day pause, tariffs will revert to a baseline rate of 10% even as negotiations with the US progress.

Downplaying the risk of further escalation, Trump sharply raised tariffs on Chinese goods from 104% to 125%

Meanwhile, the ringgit was traded higher against major currencies yesterday.

It appreciated against the Japanese yen to 3.0594/0639 from 3.0921/0964, increased against the euro to 4.9401/9467 from 4.9640/9700 and rose against the British pound to 5.7566/7644 from 5.7629/7700 on Wednesday.

The local note traded mixed against Asean currencies. It slid versus the Thai baht to 13.0618/0866 from

12.9915/13.0153 and was weaker against the Singapore dollar at 3.3361/3411 from 3.3349/3395 previously.

Market Strategy Trump's tariffs rattle markets

THE chaotic start to US President Donald Trump's second coming has left equity markets reeling. Robust domestic growth and liquidity conditions are at risk from poorly communicated US policy revolving around on/off tariff threats and its impact on global macroeconomic, inflation and US monetary policy direction that has cratered investor sentiment.

RHB Economics has turned more cautious on the global macroeconomic outlook on the back of elevated protectionist risks, dwindling risk appetite and potential downside to global economic growth. A global economic recession is not the RHB base case scenario, but US stagflation risks are now more elevated and 2025 US GDP growth is cut to 1.5% (from 2%). Expect a weaker DXY, with three potential US Federal Funds Rate (FFR) cuts in 2025. China's GDP growth forecast is also slashed to 4.2% (from 4.8%) following the US tariff broadside and headwinds from a persistently weak property sector.

In light of rising external uncertainties and growing challenges to global economic growth, we have accordingly revised our GDP forecast for Malaysia downwards to 4.5% for 2025, from the earlier projection of 5%. While we acknowledge that Malaysia's strategic growth initiatives are expected to support and stimulate investment flows over the medium term, we maintain a cautious outlook given the potential negative spillover effects stemming from intensifying global trade tensions. - RHB Research, April 10

While the proposed acquisitions align with the REIT's long-term strategy to scale up its operations and grow its total assets under management (AUM) to RM2 billion within the next three years, we remain neutral due to near-term earnings dilution stemming from the enlarged unit base post-placement.


To partially fund the proposed acquisitions and planned AEIs at KIPMall Tampoi, KIP REIT intends to undertake a private placement to raise gross proceeds of up to RM132 million via a book-building exercise. Based on an illustrative issue price of 82.5 sen per unit, the placement will involve the issuance of up to 160 million new units, representing approximately 20% of the existing fund size of 798.6 million units. Upon completion, the enlarged fund size will increase to 958.6 million units.

The AEIs at KIPMall Tampoi are targeted at strengthening the mall's market position through improvements in infrastructure, enhancement of F&B offerings, incorporation of digital solutions, and sustainability-focused upgrades.

Both the acquisition and placement proposals are subject to the approval of non-interested unitholders at an extraordinary general meeting to be convened. Completion is expected by Q1'26 (or Q3'26).

DUOPHARMA has received and accepted a letter of offer from Pharmaniaga to supply additional 3 pharmaceutical and/or nonpharmaceutical products, with a total estimated value to RM16.6 million, to the offices and facilities operated and controlled by the government of Malaysia. The additional contracts will remain in effect until Dec 31, 2026, or until another date is specified by the government of Malaysia, in accordance with the terms outlined in the contracts previously awarded in April and October 2024.

With this additional contract win, Duopharma's Approved Products Purchase List (APPL) contract stood at 99 products, with a total estimated value of RM682.3 million until Dec 31, 2026

We are not surprised by Duopharma's latest APPL contract win, as we believe it is a natural outcome of the recent expansion in Pharmaniaga's concession agreement with the government, which increased the number of approved SKUs to approximately 1,200 from the previous 815. This will expand Duopharma's APPL to 99 SKUs (vs. 50 SKUs under the old APPL contact), which bodes well for the group. Additionally, Duopharma would benefit from stronger ringgit as the new APPL contract term is based on an exchange rate of RM4.70/USD (vs. RM4.20 in 2017).

All in all, we remain optimistic about the group's prospects. We expect earnings to increase by 41.2% to RM88.4 million, driven by: i) higher demand, ii) lower Active Pharmaceutical Ingredient (API) costs and iii) cost efficiencies.



Europe's must-visit spots for music fans

ANY European cities are hotspots for music lovers, with a variety of experiences to discover and enjoy. Whether it is huge concerts, vibrant festivals or exceptional nightlife, some destinations stand out when it comes to making music the star of the show.

To identify these must-visit cities, the travel booking platform Omio carried out a detailed examination of 50 major European cities according to their musical offerings, event prices and their festive vibrancy. Unsurprisingly, Paris remains a choice destination for attending concerts by the world's biggest stars, with an average ticket price of ϵ 122 (RM606).

But Nantes takes first place in France for the richness of its music scene. Between its quality operas, classical concerts and numerous festivals, the city on the Loire River shines with the diversity and accessibility of its musical events. Lyon also stands out with much more affordable prices, at around ϵ 63 per ticket for pop or rock concerts, making the city an economical alternative to Paris.

France is also one of the most attractive European destinations for musicals and operas without breaking the bank. For around ϵ 60, you can enjoy an internationally renowned show, well below the prices charged in London, where tickets for musicals in the famous West End cost an average of ϵ 130.

For night owls, Ibiza remains the undisputed capital of European clubbing. Every summer, the island welcomes the world's top DJs, such as David Guetta and Martin Garrix, rocking its legendary clubs Ushuaia and Hi. In Manchester, it is the underground and authentic atmosphere of clubs such as The Warehouse Project that attracts electronic music fans

electronic music fans. The Omio study also revealed some hidden gems, such as

Budapest, which is ideal for those who want to experience major musicals without breaking the bank (around \notin 33 per ticket). Naples, on the other hand, offers the most affordable concerts in Europe at only \notin 43 on average, a real bargain compared to Paris prices.

Finally, opera, often perceived as a luxury event, is becoming accessible in cities such as Marseille (€45) or even Lisbon and Aarhus, with performances costing less than \in 30.

In the face of the widespread increase in concert ticket prices (+74% since 2011 according to Pollstar), these destinations offer a great opportunity to enjoy musical experiences of all kinds, whether you are a fan of modern pop, classical music or electro nights. - ETX Studio

ONE lucky visitor will soon become the first ever to sleep overnight at Britain's National Gallery, after the 200-year-old museum launched a competition on Monday to mark the reopening of a wing housing celebrated European paintings. When the Sainsbury Wing reopens

When the Sainsbury Wing reopens after a two-year refurbishment on May 10, the overnight guest, to be picked at random from a list of newsletter subscribers, will wake up to breakfast in bed and the chance to explore the gallery before the crowds arrive.

The renovated wing will see some of earliest paintings in the collection rehoused, a chapel-like room for Piero della Francesca's 15th-century *Baptism of Christ* and a new frame for Jacopo di Cione's 14th-century *San Pier Maggiore Altarpiece*, while Paolo Uccello's *Battle Of San Romano* will be back after a three-year restoration process.

Night at museum

Western European paintings from the 13th to 20th centuries will be "completely redisplayed", the museum said, with dedicated rooms for works by artists including Claude Monet, Titian, Rembrandt and Thomas Gainsborough. The guest will spend the night in a

The guest will spend the night in a bed near the paintings and take a private late-night tour with a gallery curator before being allowed to roam about the following morning.

The gallery said the winner would be able to "see over 1,000 works of art, which trace the development of painting in the Western European tradition – from iconic masterpieces to paintings which have never previously been seen in the National Gallery".

"The carefully curated rehang will enable them to not only see their favourites returned to the walls, but also those paintings in the context of history," it said, calling the prize a chance to "experience the wonder of art".

The Sainsbury Wing opens to the public on May 10, and the gallery's competition is open until April 28.

Though the National Gallery said this would be its first official sleepover, it has hosted late-night events before. On Jan 17, it announced it was

On Jan 17, it announced it was opening through the night to give art lovers a final chance to see its blockbuster Vincent van Gogh exhibition, following a similar experiment in 2012 for a Leonardo da Vinci display.



Cruise to showcase last Mission: Impossible at Cannes

TOM CRUISE is set to return to the Cannes Film Festival to present the latest and last episode of his *Mission: Impossible* series, joining Robert De Niro and French actress Juliette Binoche among the confirmed A-list attendees.

Cruise's presence, three years after he lit up the French Riviera while promoting Top Gun: Maverick, marks a major coup for festival organisers.

Mission: Impossible – The Final Reckoning is one of the most hotly awaited blockbusters of the year and is set for release in cinemas worldwide from May 17.

"After nearly three decades of thrills, stunts and twists, Mission: Impossible - The Final Reckoning promises to deliver an unforgettable cinematic experience," the festival said in a statement.

On Monday, it announced De Niro, star of *Taxi Driver* and *Godfather Part II*, would be given an honorary Palme d'Or at the opening ceremony of the world's premier film festival on May 13.

Cannes president Iris Knobloch and long-time director Thierry Fremaux unveiled the selection of in-competition films and other major premieres at a press conference in Paris yesterday.

The industry is buzzing with speculation about who will attend one month before the red carpet rolls out on the seafront

Croisette in Cannes.

Cinemas are desperate for some stardust and sparkling new films after a series of expensive Hollywood flops this year.

These include Disney's live-action Snow White, superhero sequel Captain America: Brave New World and bizarre sci-fi movie Mickey 17.

The much-hyped A Minecraft Movie, released last week, was panned by critics but might help to lift the gloom after a record-breaking opening weekend in the US.

The head of the Cannes jury this year is French screen legend Juliette Binoche, who will hand out the famed Palme d'Or for best film.

Around 20 movies are set to compete in the top category, looking to emulate the success of last year's winner Anora by Sean Baker.

Terrence Malick, who won the Palme d'Or for *The Tree of Life* 14 years ago, has been tipped to return with a long-awaited project inspired by biblical stories.

Other festival veterans could also return, such as Jim Jarmusch (Broken Flowers, Dead Man), whose latest film Father, Mother, Sister, Brother, stars Cate Blanchett and Adam Driver.

Wes Anderson, 55, has also assembled

yet another star-studded cast for his latest , film *The Phoenician Scheme*, featuring Benicio Del Toro, Tom Hanks and Scarlett Johansson.

Johansson, 40, could bring a breath of fresh air to the festival by presenting her directorial debut *Eleanor the Great*.

Another actress-turned-director, Kristen Stewart, 34, has also recently completed her first feature film.

Experts have also suggested the new master of American horror 38-year-old Ari Aster, known for his chilling films *Hereditary* and *Midsommar*, could make his Cannes debut with a movie starring Joaquin Phoenix and Emma Stone.

Three French female directors, Julia Ducournau (2021 Palme d'Or winner for Titane), Rebecca Zlotowski (Other People's Children, An Easy Girl) and Alice Winocour, who has made a film about Paris Fashion Week starring Angelina Jolie, have also been named as contenders.

Exiled Russian filmmakers such as Kirill Serebrennikov, Andrey Zvyagintsev and rising talent Kantemir Balagov could also feature.

The festival has yet to announce its opening film on May 13 or the full composition of the jury.



No impact on Haas F1

THE US-owned Haas Formula One team said they were carrying on as normal despite owner Gene Haas's machine tools business reporting a 'dramatic decrease in demand' as a result of President Donald Trump's trade tariffs.

California-based Haas Automation said in a statement yesterday that it had reduced production, eliminated overtime and halted hiring while studying the impact of tariffs on its operations.

"While tariffs will have a significant impact on Haas Automation's business", it added, the company was optimistic that the Trump administration would come up with solutions to provide relief for US manufacturers.

The company employs 1,700 workers at its Oxnard plant and others at factory outlets across the United States.

It said the drop in demand was from both domestic and international customers.

A team spokesman said ahead of this weekend's Bahrain Grand Prix that the statement had no impact as far as Haas F1 were concerned.

"It's business as usual regarding the team and there is no change to our development plan, recruiting process and other projects," he added. "To clarify again, no impact to the team.

FORMER Wimbledon champion Elena Rybakina put Kazakhstan on course for the Billie Jean King Cup finals yesterday, helping her country take down Australia in a qualifying tie.

The world No. 10 battled past Kim Birrell 6-3, 7-6 (7-4) at Pat Rafter Arena in Brisbane, rallying from 3-1 down in the first set and 5-1 behind in the second.

gave Kazakhstan lt unsurmountable 2-0 lead after world No. 23 Yulia Putintseva outclassed teenager Maya Joint 6-2, 6-1 in just 74 minutes in the opening rubber.

"Such a difficult match and super happy to bring the win for the team, and Yulia did a great job in her match," said Rybakina, who has an 8-1 win singles record at the BJK Cup – previously known as the Fed Cup.

"I played pretty well in the first set, but it was difficult and I was just trying to fight in the second set when I was down."

Putintseva added: "It was definitely a good game for me and I love playing in Brisbane. I think today was just one of those days when everything was working."

Max out to silence

McLaren

ORMULA ONE leader Lando Norris has Max Verstappen breathing down his neck and only a point separating the pair ahead of a Bahrain Grand Prix that could trigger a change at the top on Sunday (1pm Malaysian time).

Verstappen dominated last year's race at Sakhir, the now-four-times world champion leading from pole to flag with fastest lap as Red Bull celebrated a one-two finish for the second season in a row.

A third successive win for Verstappen at the desert circuit, even if a one-two now looks highly unlikely, would be another big statement after a victory in Japan last weekend that ended McLaren's winning start.

"Bahrain (is a) completely different track, very tough on tyres... we still have work to do," said Verstappen after Suzuka. the start of a triple header that ends in Saudi Arabia next week. "But it (the Japanese GP) does

show that if we really nail everything,

we can be up there," added the 27year-old whose new teammate Yuki Tsunoda has yet to score after replacing New Zealander Liam Lawson.

McLaren will be chasing their third successive double podium, and third win in four rounds, at what is a home race for the team's Bahraini owners.

Norris has led since he won last month's opener in Australia, ending a Verstappen run at the top dating back to May 2022, and he and McLaren teammate Oscar Piastri remain hot favourites.

Either could become the season's first double winner - they and Verstappen each have a pole and win so far - but round four of 24 could also see Mercedes or Ferrari getting in on the act around a circuit all teams tested at in February.

"It doesn't take much of a mistake from us - or certainly from myself - to let the others in," said Piastri, who finished ninth in Melbourne after

running wide and letting a podium slip through his fingers.

Mercedes' George Russell, who made his Mercedes debut at Sakhir in 2020, was third in Australia and China while 18-year-old rookie teammate Andrea Kimi Antonelli became the youngest ever race leader and fastest lap setter last weekend.

Lewis Hamilton, now at Ferrari, has won a record five times at Sakhir – all with Mercedes – while teammate Charles Leclerc finished first in 2022.

Ferrari, stunned by a double disqualification in China, have yet to get on the podium this season although Hamilton did win the Shanghai sprint.

Friday's opening practice will feature a host of teams giving potential stars of the future a spin. Among them is Dino Beganovic, who holds dual Swedish and Bosnian nationality. The Ferrari academy Formula Two driver takes Leclerc's seat in 'FP1'. Reuters/AFP

Joker falls in Monte Carlo, Alcaraz wins

NOVAK DJOKOVIC rued a "horrible" performance as he crashed out of the Monte Carlo Masters in his opening match yesterday, while Carlos Alcaraz staged a fightback for his first win at the tournament.

The fifth-ranked Djokovic struggled to find his rhythm in a 6-3, 6-4 loss to Chilean Alejandro Tabilo in the second round, making an inauspicious start to his clay season.

Djokovic, 37, went into the tournament hampered by an eye infection that has been troubling him since the semifinals in Miami at the end of March and admitting that he did not have "very high" expectations for Monte Carlo.

As it transpired a sluggish performance meant that Tabilo, who also beat Djokovic on clay in last year's Italian Open in Rome, faced few difficulties in claiming a rare 2-0 head-to-head record against the 24-time Grand Slam winner.

"It was actually more like the worst day (at the office)," said Djokovic."I was hoping it was not going to happen,

but it was quite a high probability I'm going to play this way.

"Just horrible. Horrible feeling to play this way, and just sorry for all the people that have to witness this.


"I expected myself at least to have put a decent performance. Not like this. It was horrible," said Diokovic.

"I did not have high expectations, really. I knew I'm gonna have a tough opponent and I knew I'm gonna probably play pretty bad. But this bad, I didn't expect." Alcaraz, meanwhile, picked up his first ever

OPENER Sai Sudharsan struck his third halfcentury of this season to guide Gujarat Titans to the top of the IPL table with a 58-run thrashing of Rajasthan Royals yesterday.

The left-handed Sudharsan smashed 82 off 53 balls as Gujarat posted 217-6 after being invited to bat first at their home at the world's biggest cricket stadium in Ahmedabad.

Pace bowler Prasidh Krishna then stood out with figures of 3-24 to help bowl out Rajasthan for 159 in 19.2 overs after Shimron Hetmyer topscored with 52.

Gujarat registered their fourth successive victory in five matches to lead the 10-team table.

Inaugural champions Rajasthan slipped to their third defeat.

Gujarat had a disappointing start when Rajasthan's England import bowler Jofra Archer bowled skipper Shubman Gill with a 147kph delivery that rattled the off stump.

But Sudharsan after a cautious start put on key stands, including a 80-run second-wicket partnership with England's Jos Buttler, who hit 36, to lay the foundations for the mammoth total.

"I always try to see what I can do better, trying to improve my awareness and skill," Sudharsan said after being named player of the match.

"I feel I work a lot on basics that is helping me be a versatile batter."

Sudharsan has amassed 273 runs in five matches and is second behind leading batter Lucknow Super Giants' Nicholas Pooran, who has 288 runs.

Emery remains bullish

Aston Villa boss believes Villans can beat PSG in Champions League despite defeat in Paris

STON VILLA coach Unai Emery insisted he still believes his side can get the better of Paris Saint-Germain and reach the Champions League semifinals despite a 3-1 defeat in the first leg of their last-eight tie yesterday.

Villa took the lead in the first half in Paris through Morgan Rogers only for the hosts to turn the game on its head thanks to stunning strikes by Desire Doue and Khvicha Kvaratskhelia either side of the interval.

And a Nuno Mendes effort in stoppage time which gives PSG a two-goal cushion to take to Villa Park for the return appears to leave Emery's side with a huge task to turn the tie around.

"At 2-1 we were thinking about playing to win in the next match, and at 3-1 it is still the same," Emery said.

"But we are here and enjoying it, and I am very proud of the players. We competed fantastically and we were close to getting a good result.

"At the end, with this goal, it is still more or less the same. "Villa Park is our home, and

hopefully there we will be stronger. But of course they are still favourites. They showed their power and individual quality."

Villa came to the French capital on a streak of seven straight wins in all competitions which has boosted their chances of qualifying for the Champions League again next season and taken them to the FA Cup semifinals.

However, it will likely now require a special performance in Birmingham next Wednesday for them to carry on their current run in the Champions League.

"I am not happy but I am satisfied with the performance of the team. It is special for us to be in Paris and playing a Champions League quarterfinal," Emery added.

"The second leg will be just as difficult at 3-1 as it was at 2-1. We have to win." Meanwhile Emery's opposite number, Luis

Enrique, expressed delight with his team's performance as he emphasised that PSG would not sit back and "speculate" in the second leg next Wednesday.

"The game had a bit of everything but we controlled it," said the former Barcelona coach. "It is always difficult to attack a team who sit in a medium to low block
