Selangor Sultan warns against offering fake haj packages

SHAH ALAM: The Sultan of Selangor Sultan Sharafuddin Idris Shah has reminded Muslims not to exploit others by offering fake *haj* packages for personal gain

Sultan Sharafuddin said such acts are taken seriously by the government, and Islam strictly prohibits cheating, with those involved in such wrongdoing subject to divine punishment. His Royal Highness also advised the public to use services provided by Lembaga Tabung Haji (TH) instead of unverified travel agencies that could potentially scam pilgrims and jeopardise their pilgrimage.

"I hope there will be no more cases of *haj* pilgrims being deceived by unlicensed agents in the future," he said in his royal address at the Selangor-level Haj Premier Course

1446H yesterday.
Also present were Minister in the Prime Minister's Department (Religious Affairs) Datu Dr Mohd Na'im Mokhtar and Selangor Menteri Besar Datuk Seri Amirudin Shari.

Sultan Sharafuddin urged Selangor pilgrims to focus on their worship while in the Holy Land and avoid participating in any protests or demonstrations.

"I have been informed that Malaysian pilgrims, including those from Selangor, are among the most disciplined and compliant with the regulations set by the Saudi Arabian government.

"I hope all of you will continue to

uphold self-discipline and maintain the good name of Selangor and

Malaysia while in the Holy Land." He advised pilgrims to take care of

their health, as the haj requires physical endurance, and to seek medical attention if needed.

"Let me also remind all pilgrims to comply with the laws set by both the Malaysian and Saudi Arabian Malaysian and governments so that we may remain

safe and free from any issue."
Sultan Sharafuddin also presented haj essentials to representatives from each district in Selangor. – Bernama

Admissions to residential schools to be streamlined

LENGGONG: The system for Maktab Rendah Sains Mara (MRSM) and fully residential schools will be streamlined starting with the January intake to prevent overlapping offers, said Deputy Prime Minister Datuk Seri Dr Ahmad Zahid Hamidi.

He said students would still be able to apply to both institutions, but each applicant would only receive one offer.

"At present, applicants, especially those applying to both institutions, can end up receiving

"Usually, MRSM issues its offer letter first, but when a student later receives an offer from a residential school, he often switches his choice. To address this, I will propose a streamlined admission process."

Ahmad Zahid, who is also Rural and Regional Development minister, was speaking after attending the Wacana Aspirasi programme at MRSM here yesterday.

Also present was Mara chairman Datuk Dr Asyraf Wajdi

Ahmad Zahid said he has also been appointed as Science, Technology, Engineering and Mathematics (STEM) Committee that fully residential schools, including MRSM, prioritise STEM education.

"This is part of our efforts to nurture more professionals in science, technology, engineering and other professionl fields, in preparation for Malaysia's transition into a high-income and developed nation."

He added that there is zero tolerance for bullying in MRSM, and any student found guilty of such misconduct would be expelled. - Bernama

Govt shield against US tariffs for public health institutions

While rate increases likely to push up cost of essential medical imports, govt expected to absorb much of financial burden, says professor

PETALING JAYA: The ripple effects of United States (US) tariffs on Chinese goods may soon reach Malaysian public hospitals. But for now, patients, especially those from lower-income groups, are expected to be shielded from significant cost

Universiti Kebangsaan Malaysia public health medicine specialist Prof Dr Sharifa Ezat Wan Puteh said while the tariffs are likely to push up the cost of essential medical imports, the government is expected to absorb much of the financial

"It's possible purchase prices will rise. But as this is government-funded, the bulk of it will be subsidised by state funds," she told

She said while the public healthcare sector is partially insulated, patients may eventually have to bear part of the cost for certain treatments or medications.

Health Minister Datuk Seri Dr Dzulkefly Ahmad has said the cost of

imported drugs and medical devices would increase if tariffs impact the active pharmaceutical ingredients (API) or key components used in their production. He added

that pharmaceutical companies may face steeper costs as global competition for raw materials intensifies

Chinese president's visit places M'sia firmly on global stage: PM

PETALING JAYA: Prime Minister Datuk Seri Anwar Ibrahim has expressed Malaysia's appreciation to Chinese President Xi Jinping for placing the nation firmly on the global stage through his recent state visit. In a post on his Facebook page,

Anwar highlighted the significance of

Xi's visit amid rising global uncertainties, describing it as a concerted effort to forge stronger hilateral ties

"China is not here to exert pressure, but to deepen ties that have existed for centuries while exploring new opportunities to reinforce our friendship.

"Malaysia, for its part, will do all it advance this

commitment on behalf of the broader Asian and Asean family, in the pursuit of regional strength and stability."

President Xi arrived in Malaysia on April 15 at the invitation of His Majesty the King of Malaysia Sultan Ibrahim.

Xi's first official visit 12 years ago saw the elevation of Malaysia-China relations to Comprehensive Strategic Partnership level.

His meeting with Anwar at the Seri

Perdana Complex saw discussions on a wide range of topics, including bilateral ties, regional development

and international cooperation.
Thirty-one MoUs, agreements and notes between Malaysia and China were also exchanged, signalling renewed momentum and expanded collaboration across multiple sectors.

Since the establishment diplomatic relations on May 31, 1974, Malaysia and China have maintained a

resilient partnership. China has been Malaysia's largest trading partner since 2009. In 2024, bilateral trade reached RM484.12 billion, representing 16.8% Malaysia's total global trade.

Xi's visit to Southeast Asia has been viewed as part of Beijing's efforts to position itself as a reliable alternative to the US amid ongoing trade tensions.

"As for haj, we have 37 licensed haj supervisors accredited by Tabung Haji. The public must check these details to avoid being deceived," he said when met after the conclusion of the Selangor-level Premier Haj course here yesterday.

Earlier, the Sultan of Selangor Sultan Sharafuddin Idris Shah in his address at the ceremony, reminded Muslims not to exploit one another by offering fraudulent haj packages for profit. He also urged the government to take the matter seriously, Bernama reported.

'Workforce mental, physical resilience key to growth'

PUTRAJAYA: Malaysia's future growth depends on the physical and mental resilience of its workforce, said Human Resources Minister Steven Sim Chee Keong.

2025 event in Putrajaya, Sim
emphasised that national progress is
made possible by the unwavering
dedication of workers across all
sectors, including security, defence
and both public and private services.

"Nothing is stopping you from continuing to serve the nation, religion and homeland. What truly hinders Malaysia from becoming a great nation, especially in

today's volatile world, isn't the strength of global powers such as the United States or China. It's whether we, Malaysians, have the resilience to overcome challenges."

The event, attended by thousands, celebrated national unity and spirit.

Also present were Socso Board

chairman Datuk Seri Subahan Kamal and Socso CEO Datuk Seri Dr Mohammed Azman Aziz Mohammed.

Sim also voiced concern over the sharp increase in non-communicable diseases (NCDs) among Socso contributors. He revealed that in 2023,

an average of 80 individuals a day were diagnosed with NCDs.

Based on Socso's internal data, about 2.3 million Malaysian adults are affected by three major NCDs diabetes, high blood pressure and obesity – all of which are largely preventable through healthier lifestyle choices.

"The figures should serve as a wake-up call. If we want to build a strong and productive workforce, we must take health seriously."

He warned that NCDs pose a serious threat to workforce productivity and the nation's economic sustainability. Between 2022 and 2024 alone, the number of Socso contributors diagnosed with NCDs surged by 26.5%, Bernama reported.

Citing a Health Ministry report, Sim said Malaysia suffers annual economic losses of up to RM64.2 billion or 4.2% of its GDP due to NCDs, primarily through healthcare costs and reduced worker productivity.

To address this, Socso introduced the Health Screening Programme in 2013, which has since benefited over 900,000 individuals. Data from the programme in 2023 and 2024 revealed that among the 270,000 workers aged 40 and above, 19.4% were found to have diabetes, 19.6% had high blood pressure, 59.7% had excessive cholesterol levels and 59.3 per cent (around 160,100 people) were obese.

This year's Socso Run and Ride marked its eighth edition and made history with over 10,000 participants. The event also served as the curtain-raiser for the upcoming MYFutureJobs Career Carnival @ Labour Day 2025, to be held from April 28 to May 1 at Axiata Arena in Bukit Jalil.

Sex education should not be taboo topic: Minister

LUNDU: Malaysia must stop treating sex education as an afterthought and instead adopt a serious, all-round approach involving schools, parents and key government agencies, said Women, Family and Community Development Minister Datuk Seri Nancy Shukri.

She said it should no longer be a

She said it should no longer be a taboo topic but recognised as a tital tool in shaping values and protecting children, especially in today's digital age.

"It is in the school curriculum, but its content is limited and often not emphasised. This must be addressed immediately," she said after opening the Malaysia Madani statehood seminar yesterday.

the Sun had previously reported that sex education remains a sensitive and often overlooked issue, particularly when it involves children with disabilities.

Educators and activists have highlighted the need for inclusive, accessible programmes that empower such individuals. Among them was Johor Disabled Children Charitable and Cares Organisation president Mohd Yahya Haidrus, who stressed the urgency of tailored sex education for special needs children.

"A structured, accessible curriculum can help them recognise inappropriate behaviour, understand consent, practise hygiene and build safe, respectful relationships."

Bernama reported that while laws such as the Sexual Offences Against Children Act 2017, Child Act 2001 and Persons with Disabilities Act 2008 exist, enforcement remains a challenge.

Nancy said the matter had been raised at the highest levels, including during a meeting chaired by Prime Minister Datuk Seri Anwar Ibrahim with various ministries and agencies.

She also called for a collaborative

approach, especially involving parents, to teach children about values and personal safety.

"This is about the safety and wellbeing of our children, and we're actively seeking the most effective and comprehensive ways to tackle it."

Nancy added that parenting programmes would be updated to help parents speak openly and safely with their children.

Recently in Kelantan, a police officer who was checking his 14-year-old daughter's phone was shocked to find sexually suggestive messages exchanged with a teenage boy.

Concern over potential impact of regional quakes

Many of nation's 398 high-rise buildings over 150m tall may not be adequately designed to withstand tremors, says expert

PETALING JAYA: With 398 high-rise buildings over 150m tall in Malaysia, experts are raising concerns that many of these structures may not be adequately designed to withstand the increasing threat of regional earthquakes.

According to the Council on Tall Buildings and Urban Habitat, Malaysia, now in fourth place, trails China, the United States and the United Arab Emirates in the number of

Although the country has long been regarded as low-risk for seismic activity, structural engineers argue that this perception is outdated, especially as tremors from nearby countries such as Indonesia and Myanmar

grow more frequent and intense.
Universiti Teknologi Malaysia structural earthquake engineering expert Prof Dr Azlan Adnan said tremors in Sabah and along fault lines in Peninsular Malaysia indicate that the country now lies in a low to moderate seismic zone.

"With the growing number of high-rise buildings, particularly in urban areas like Kuala Lumpur and Penang, the potential

impact of even distant earthquakes becomes a real concern."

Azlan pointed out that newer public buildings in Malaysia, constructed after it adopted in 2017 Eurocode 8 (European standard for seismic-resistant design), are

generally better equipped.

However, many older and privately developed high-rises remain vulnerable to

developed figuri-rises remain vulnerable to significant seismic risks. "One of the key issues is inconsistent enforcement. Eurocode 8 offers a strong framework, but it's often overlooked unless

required by authorities or foreign consultants.

"Some developers still cut corners. Without strict enforcement, seismic safety becomes a matter of individual discretion."

He warned that buildings constructed on soft soil, common in parts of the Klang Valley, are particularly at risk, as tremors from major quakes in Indonesia or Myanmar can be amplified in such conditions.

The recent earthquake in Myanmar, which caused tremors as far away as Bangkok, has

reignited concerns about Malaysia's exposure to regional seismic activity. Azlan said retrofitting vulnerable buildings is not only possible but necessary, especially for hospitals, schools and densely occupied residential towers.

"It's technically feasible, but the cost and complexity often discourage building owners.

What we need is a nationwide assessment and retrofitting programme to identify and strengthen these at-risk structures.

Universiti Malaya senior lecturer Assoc Prof Dr Tan Chee Ghuan echoed similar concerns, particularly regarding high-rises built before seismic design became standard practice.

"There's no official definition of a high-rise

in our building codes, but once a building exceeds 10 storeys or around 35m, it starts to respond differently to forces

At those heights, wind and seismic loads become dominant, and with soft soil conditions in places like the Klang Valley, the shaking can be much worse," said Tan, who is also a structural earthquake engineering

He said seismic waves from distant earthquakes can travel over 1,000km and still cause significant shaking due to soil amplification.

"While landmark towers like KLCC Twin Towers, Merdeka 118 and The Exchange 106 were designed with seismic forces in mind, many typical residential towers were not. They may withstand wind, but earthquakes are a

Tan underscored the urgent need to retrofit older buildings, noting that many were constructed before seismic considerations

were included in the design process.

He added that while effective materials such as reinforced concrete jackets, steel bracing and fibre-reinforced polymer composites are available, their use in Malaysia remains limited to specialised or large-scale

"Cost is part of the challenge, but perception is another. Too many still believe Malaysia is immune to earthquakes. That mindset has to change.

Azlan added that true resilience goes beyond engineering.

"Earthquake preparedness isn't just about concrete and steel, it's about people, planning, and systems working together. Taking action now will not only reduce risks in the future but also build a safer, more resilient Malaysia."

Charcoal factory penalised for causing pollution

ALOR SETAR: An Equipment Operation Detention action has been taken against a factory producing charcoal using coconut shells in the Kubang Pasu district by the Kedah Environment Department, said its director Charles Alich Card Carbo. Sharifah Zakiah Syed Sahab.
She said the action was taken under Section

38 (1)(a) of the Environmental Quality Act (EKA) 1974 following a complaint received last Friday regarding air pollution caused by the factory.

'Our investigation found the complaint to be valid. The factory was penalised for operating without a chimney unit and air pollution control equipment during its coconut shell burning process," she said in a statement yesterday.

She added that the action could not be taken

immediately on the day of the inspection as the equipment was still hot, posing a risk to enforcement officers.

She said the factory has since been ordered to halt operations to allow immediate corrective measures and the installation of proper pollution control systems

"A notice under Sections 31 and 37 of the Environmental Quality Act 1974 has been issued to the factory, requiring immediate repair and maintenance work to be carried out. The factory will only be permitted to resume operations once the department is satisfied with the corrective actions taken."

She urged the public to call the department's toll-free line at 1-800-88-2727, email aduan_k@doe.gov.my, or lodge a report at eaduan.doe.gov.my.report about any activity being carried out that may harm the environment. – Bernama

PASIR MAS: Residents and traders in Rantau Panjang have expressed hope that the flood mitigation project in the area will be expedited, as the risk of recurring annual floods continues to disrupt local socio-economic

stability.

Mohd Aiman Muhamad Yusof, 22, from Kampung Cabang Bagus said the project should be a priority, especially in the context of climate resilience and disaster management.

"This area is affected almost every year during the monsoon season. A long-term solution is urgently needed to minimise damage

to public assets and private property."

He said coordination between federal and state agencies must be prioritised to avoid delays caused by policy differences or political

"Swift implementation will not only safeguard lives and property, but also reduce the government's dependency on post-disaster

"If this project is realised, government spending can be redirected to other sectors with wider development impact.

Darul Hisham Mat Noor, 52, from Kampung

Gual Mesa said the project must be guided by long-term risk projections and the area's development potential.

"We face high water levels three to four times a year. This must be addressed systematically."

He added that ongoing flood risks have eroded investor confidence and pose challenges to long-term development planning in the

Food trader Muhamad Kharimi Arif said floods directly affect business operations in Rantau Panjang town.

"This town is a vital economic hub in

Kelantan, especially in the wholesale and retail sectors. Without proper infrastructure like flood mitigation systems, we cannot maximise its economic potential."

He expressed hope that the project would not be delayed by technical or administrative issues as any postponement would continue to burden all stakeholders.

Renewed focus on piezoelectric option

Generating power from everyday motion such as footsteps viable, but only for small scale applications: Expert

PETALING JAYA: A video circulating online claims that Japan is using subway foot traffic to generate electricity through piezoelectric tiles, allegedly powering lights and other systems in high-traffic transit hubs such as Shibuya Station.

While the authenticity of the

video remains unverified, the concept it promotes – generating energy from human movement – is based on real and scientifically

proven technology.

Xiamen University Malaysia New Energy Science and Engineering head of programme Assoc Prof Dr Gan Wee Chen told theSun the concept, known as piezoelectric energy, is not new but is attracting renewed attention as countries, including Malaysia explore including Malaysia, explore sustainable energy solutions amid rapid urbanisation and growing climate concerns.

"Piezoelectricity phenomenon in which certain materials, such as quartz crystals, specific ceramics or polymers, generate an electric charge when they are mechanically stressed,"

"In simpler terms, when pressure, vibration or force is applied to these materials, they produce electricity. The effect also works in reverse, when these materials change shape

when exposed to electric fields."

He said this dual property has long been employed in devices such as microphones, sensors and ultrasound machines. More recently, researchers have started exploring how piezoelectric materials could harvest renewable energy from everyday actions such as footsteps.

Gan, who specialises in piezoelectric energy conversion, added that while the concept holds

promise, its practical use is likely limited to specific, small-scale applications.

"Piezoelectric energy harvesters are best suited for powering low-energy devices, especially in the field of the Internet of Things (IoT).

These include small sensors embedded in buildings, wearables or distributed networks that monitor environment or structural

integrity."
On whether Malaysia could On whether Malaysia could benefit from using piezoelectric tiles in busy places such as train stations, Gan said the energy generated from footsteps is very low and only enough to power tiny devices, not big systems such as lighting for the

However, he said it could be useful for small, battery-free sensors that power themselves, adding that the technology could be used in places with low energy needs, such as sensors on bridges, buildings or farms.

"These could be powered by "These could be powered by vibrations or pressure changes, offering sustainable energy for monitoring purposes without needing conventional electricity.
"In such cases, piezoelectric technology could help reduce maintenance costs and enable remote monitoring in hard-to-reach

Gan said there are still several challenges slowing down the wider use of piezoelectric systems in Malaysia, starting with cost.
"The materials

manufacturing processes needed to make efficient piezoelectric devices are still expensive, especially when compared with more developed renewable options such as solar.

"Solar panels can produce much more energy, and Malaysia's tropical climate offers steady sunlight,



Gan said the energy generated from footsteps is very low and only enough to power small devices, not big systems such as lighting for premises. – ADIB RAWI YAHYA/THESUN

making it a more practical choice for high-energy needs."

He said efficiency is another

concern, explaining that piezoelectric devices perform best in environments where consistent mechanical stress is present.

"Malaysia's unpredictable weather, high humidity and inconsistent foot traffic patterns may affect energy output.

"Retrofitting existing infrastructure to incorporate these systems would also be costly and complex."

Despite these hurdles, Gan said piezoelectric technology could complement other energy sources in specific applications, such as smart traffic systems.

smart highways. "On "On smart highways, piezoelectric energy could be used to power low-energy IoT devices such as traffic sensors or emergency alert systems, especially at night or during overcast weather when solar power

isn't available.

"In addition, it could also be used for foot traffic monitoring and understanding areas of high foot traffic for placement of advertising boards to increase consumer (visibility)," he said.

Gan also said piezoelectric systems may find a niche in smaller urban developments or remote rural areas where access to electricity is

While the technology is unlikely to replace solar or wind as Malaysia's primary sources of renewable energy, Gan said it could still play a valuable supporting role. "When applied strategically and

where appropriate, piezoelectric energy could contribute to Malaysia's shift towards a more sustainable future.

"As with any emerging technology, the key is to understand where it works best and where it doesn't."

Police to probe shooting case over parang incident

SHAH ALAM: Police are investigating an incident involving a security quard who allegedly fired a shot at wielding a *parang* at a restaurant in Banting on Saturday. Kuala Langat police chief Supt

Mohd Akmalrizal Radzi said police were informed of the incident at about 3.30pm by an individual who reported that a man was brandishing a parang at healthcare workers.

"Earlier at about 12pm, police had received a call from a separate individual to report that his younger sibling was behaving aggressively at their home in the Banting area.

"Following the report, the Kuala

Langat district police headquarters operations room deployed personnel and took the local man to the Banting Hospital for treatment before the parang incident occurred later in the afternoon," he said in a statement yesterday.

Earlier, a video on social media showed a man in a frenzy while brandishing a *parang* at several healthcare workers before a security guard at the scene discharged a shot from a shotgun. – Bernama

Woman driver in UiTM fatal crash claims trial

KUALA TERENGGANU: A woman driver has pleaded not guilty to a charge of attempting to murder a Dungun Universiti Teknologi Mara (UiTM) student in October last year.

Norizan Ismail, 50, made the plea before Judge Datuk Hassan Abdul Ghani after the charge was read out by an interpreter at the High Court here yesterday.

According to the charge, the mother of three children is alleged to have committed the act at 7.35pm on Oct 9, 2024 at Jalan Pantai opposite the university, under Section 307(1) of the Penal Code.

If convicted, the accused could be jailed for up to 10 years and fined, and if the act causes injury, then she could be jailed for a maximum of 20 years.

In the incident, Muhammad Ammar Danish Mohamad Ridhuan. who was 20 years old at the time, was injured after being hit from behind by the accused who was driving a sports utility vehicle while he was riding a motorcycle.

The incident caused the deaths of

three friends who were with him -Muhammad Akmal Md Tukirin, 25, Ku Adib Aizad Ku Azmi, 20, and Khairil Anwar Jamaludin, 20. The case was handled by DPP

Mohd Khairuddin Idris while the accused was represented by lawyer Mohd Shahir Mat Jusoh.

The court set May 20 for submission of trial documents.

On March 2. Norizan had pleaded not guilty to three charges under Section 302 of the same law for committing murder by causing the deaths of Muhammad Akmal, Ku

Adib Aizad and Khairil Anwar.

The case, which has received nationwide attention, will proceed after the court ruled that Norizan is fit to stand trial based on a psychiatric examination report obtained from the Permai Hospital in Johor. – Bernama

UUM student crushed while waiting to board bus

ALOR SETAR: A Universiti Utara Malaysia (UUM) female student died on Saturday after being crushed in an incident involving two buses in front

of a bus stop. Manarina Hasya Muhamad Karim, 22, was confirmed dead after being treated for almost 10 hours at the Sultanah Bahiyah Hospital, said Kubang Pasu district police chief

Supt Mohd Radzi Abdul Rahim. The student was queueing to board a bus that had stopped at the bus stop when it was hit from behind by another bus.

The impact caused the front bus to hit a metal railing that crushed the victim, who was walking in queue to board the bus.

'The victim, from Johor Bahru,

was sent to the hospital before being confirmed dead while being treated," he said in a statement, adding that the case was being investigated under Section 41(1) of the Road Transport Act 1987.

UUM deputy vice-chancellor (student affairs and alumni) Prof Dr Ahmad Martadha Mohamed posted a condolence message to the family

of the student on Facebook.

"Following the incident involving the campus shuttle bus, the university is waiting for a complete report from the UUM security department and has contacted police about the matter. Police are conducting a full investigation and a complete report will follow," he added. - Bernama

Man killed by falling tree

KOTA BHARU: A man was killed by a falling tree at Kampung Kuala Semerak in Pasir Puteh on Saturday. District police chief Supt Zaizul

Rizal Zakaria said a report was received from the Cherang Ruku police station at about 3pm.

Alarm bells in Indonesia over rising military role

Prabowo dismisses public outrage

JAKARTA: Greater military influence in government, reporters under threat and a stuttering economy – President Prabowo Subianto's first six months in power have triggered alarm bells for activists worried about a return to the country's authoritarian roots.

Indonesia's parliament amended a law last month allowing activeduty military personnel to work in 14 state institutions, up from 10, including the attorney general's office, which rights groups say could weaken legal checks on military

The decision has critics anxious that the world's third-largest democracy could hark back to the days of dictator Suharto.
"The government does not realise

that Indonesia has a collective authoritarian (Suharto's) New

government," said Hussein Ahmad, deputy director of rights group Imparsial.

After Prabowo appointed representatives to kickstart discussions of the law in parliament in February, former president Susilo Bambang Yudhoyono said it used to be "taboo" for military personnel to enter politics.

"It was one of the doctrines that we issued back then ... If you want to do politics, resign," he told a meeting.

Presidential spokesman Hasan Nasbi denied that the new law would push Indonesia back to Suharto's

era.
"This law limits the role to 14 sectors that need the skills and expertise relevant to (military) training," he said.

After his October inauguration,

Prabowo paraded his Cabinet in

Prabowo paraded his Cabinet in military fatigues at a retreat. In November, his defence minister, also a former general accused of abuses under Suharto, announced that 100 battalions would be set up to enforce the government's agenda.

And Prabowo has also faced backlash in recent months for slashing budgets, as Indonesia's flailing economy is further hit by a plummeting rupiah and see-sawing markets

Adding to worries is a regulation issued last month allowing police to monitor foreign journalists and researchers.

It gives the police the authority to provide a permission letter when reporting from "certain locations" though a spokesperson later said the letter was "not mandatory".

But the regulation could still spook reporters working on sensitive topics, said Human Rights Watch's Andreas Harsono.

"Journalism always goes hand-in-

hand with democracy," he said.
"If journalism is suppressed, the freedom of speech is suppressed,

democracy will be paralysed."

The country's press flourished after the fall of Suharto, but reporters have in recent weeks raised fears of

an environment of intimidation.
Journalist Francisca Christy
Rosana, who was doxxed in recent

weeks, said they got the message loud and clear.
"This terror was not just aimed at

intimidating but silencing and stopping our work."

Thousands across Indonesia last month protested against the new law, carrying posters that called for the military to "return to barracks".

Dismissing the public's outrage over the military's potential dual role in government as "nonsense", Prabowo said he respected the people's right to protest.

But if the demonstrations "create chaos and unrest, in my opinion this is against the national interest", he said earlier this month.

Andrie Yunus of KontraS, the commission for missing persons and victims of violence, said the demonstrations are "the tip of the iceberg".

"Civilians are fed up with the entry of militarism into civilian affairs," he said, warning that the path to a military regime "is open".

"We consider the passing of the (military law) to be an attempt to open Pandora's box." – AFP

Group of 200 Karen individuals flee to Thailand

BANGKOK: Around 200 Karen people fled fighting in Myanmar and crossed the border into Thailand, Thai border officials said on Saturday.

Fighting has been raging in Myanmar's eastern Karen state, which borders Thailand, with militias battling the military government that seized power in a 2021 coup.

Four years of conflict across Myanmar have spurred mass displacement, driving tens

thousands across the border into Thailand.

About 200 Karen people fled to the kingdom on Friday and Saturday due to bombing and civil unrest a few kilometres from the border on the Myanmar side, said Major General Maitree Chupreecha, commander of the Thai military's Naresuan Force border unit.

They were frightened by drone

bombing targeting military troops,

he said, leading some to cross the Moei border river to Tak province.

"Approximately 200 people started to arrive yesterd afternoon," he said. yesterday

Those who crossed are being held in a temporary shelter by the Ratchamanu Task Force, he said, which was confirmed by a post on the Thai Army unit's Facebook page.

Maitree said there could be more people crossing into Thailand and that authorities intended to repatriate them when security improves.

The government and opposition groups declared a ceasefire to ease relief efforts after a 7.7-magnitude quake hit central Myanmar on March 28, killing more than 3,700 people.

However, Myanmar residents said there has been fighting in towns on a highway leading to the Thai border town of Mae Sot. – AFP

JAPANESE WARSHIPS **DOCK IN CAMBODIA**

PHNOM PENH: Two Japanese warships made a port call at Cambodia's Chinese-renovated naval base on Saturday, the Japanese embassy said, the first vessels to dock at the site that has vessels to dock at the site that has raised concerns in Washington. Media access to the base was restricted on Saturday when the Bungo and Etajima from the Japanese Maritime Self Defence Force made a port call. "We are glad to witness the visit to the renovated Ream Naval Base. It is a historically significant event. We are aware that Cambodia has been willing to open the base to all countries," the embassy said in a statement. Cambodia has long been one of China's staunchest allies in Southeast Asia, and Beijing has extended its influence over has extended its influence over Phnom Penh in recent years. – AFP

SEOUL GROUNDS MOST **MILITARY AIRCRAFT**

SEOUL:The South Korean Air Force has grounded nearly all of its aircraft after a KA-1 light attack aircraft accidentally released two gun pods and empty fuel tanks last week. On Friday, the aircraft taking part in nighttime drills over Pyeongchang, about 125km east of Seoul, jettisoned the parts in a mountainous area. No casualties or property damage have been reported. In response, the air force has decided to impose flight restrictions on all of its aircraft, excluding those that conduct reconnaissance operations or are on emergency standby, until tomorrow. The move is expected to affect the Freedom Flag air exercise under way since Thursday.

11 killed in Delhi building collapse

NEW DELHI: At least 11 people, including three children, were killed in New Delhi on Saturday after a residential building collapsed on the outskirts of the Indian capital.

The incident happened in the early bours in the postbacture dictrict of

hours in the northeastern district of the city that mostly houses migrant workers, with rescue teams digging through the rubble throughout the

day.

Eleven people were pronounced though dead, NDTV channel reported, though 11 others were rescued and taken to hospital. Five were still undergoing treatment, the network said.

Prime Minister Narendra Modi said

he was "saddened by the loss of lives".
"Condolences to those who have lost their loved ones. May the injured recover soon," Modi said. President Droupadi Murmu said

"the deaths of many people including women and children is very sad".

The cause of the collapse was not

immediately known. Delhi Chief Minister Kapil Mishra blamed corruption in the municipal plamed corruption in the municipal government, run by a rival political party, for such building collapses, saying on X: "Construction of such illegal buildings is going on in full

swing.
"Survey of all these illegal buildings is necessary, strict action is required."

News reports said that the four-

storey building "came crashing down like a stack of cards".

Building collapses are frequent in India, and illegal structures, often home to migrant workers, are common in big cities. – AFP



Oldest active astronaut returns to Earth on birthday

WASHINGTON: Cake, gifts and a low-key family celebration may be how many senior citizens picture their 70th birthday.

But Nasa's oldest serving astronaut Don Pettit became a septuagenarian while hurtling towards the Earth in a spacecraft to wrap up a seven-month mission aboard the International Space Station (ISS).

A Soyuz capsule carrying the American and two Russian cosmonauts landed in Kazakhstan yesterday, the day of Pettit's milestone birthday.

"Today at 0420 Moscow time (9.20am in Malaysia), the Soyuz MS-26 landing craft with Alexei Ovchinin, Ivan Vagner and Donald (Don) Pettit aboard landed near the Kazakh town of Zhezkazgan," said Russia's space agency

Spending 220 days in space, Pettit and his

crewmates Ovchinin and Vagner orbited the Earth 3,520 times and completed a journey of 93.3 million miles over the course of their

It was the fourth spaceflight for Pettit, who has logged more than 18 months in orbit

throughout his 29-year career.

The trio touched down in a remote area southeast of Kazakhstan after undocking from

the space station just over three hours earlier. Nasa images of the landing showed the small capsule parachuting down to Earth with the sunrise as a backdrop.

The astronauts gave thumbs-up gestures as rescuers carried them from the spacecraft to an inflatable medical tent.

Despite looking a little worse for wear as he was pulled from the vessel, Pettit was "doing well

and in the range of what is expected for him following return to Earth," Nasa said.

He was then set to fly to the Kazakh city of Karaganda before boarding a Nasa plane to the agency's Johnson Space Center in Texas.

The astronauts spent their time on the ISS researching areas such as water sanitisation technology, plant growth and fire behaviour in microgravity, Nasa said.

The trio's seven-month trip was just short of the nine months that Nasa astronauts Butch Wilmore and Suni Williams unexpectedly spent stuck on the orbital lab after the spacecraft they were testing suffered technical issues.

Space is one of the final areas of US-Russia cooperation amid an almost complete breakdown in relations between Moscow and Washington over the Ukraine conflict. – AFP

Six drowning deaths as huge waves hit Australian coast

SYDNEY: A fisherman died after being swept off rocks near Sydney yesterday, stretching the Easter weekend death toll of drownings to six as huge waves battered Australia's east

Emergency services winched two people from the surf at Wattamolla Beach, but one of them couldn't be revived, New South Wales

The pair had been fishing when swept off

rocks on the outskirts of southern Sydney. The second person, a 14-year-old boy, was in a stable condition in hospital.

It continued a run of fatalities over the holiday weekend, with the search continuing for two other people still missing in the sur since Friday: one off Sydney and one off Melbourne.

Surf Life Saving Australia (SLSA) issued a warning on Thursday that strong swells would create hazardous surf conditions along the coasts of New South Wales and Victoria.

Three people drowned on Friday in New South Wales, while a woman died and a man went missing after they were swept into the sea near Melbourne.
On Saturday, when swells were as high as

3.5m in some places, a fisherman was swept to his death off rocks in southern New South

SLSA had released data before the weekend showing 630 people had died at beaches without an active lifesaving service

over the last 10 years.

Chief executive Adam Weir advised patrolled beaches should be prioritised for

"We know that Aussies and visitors to our country like to go off the beaten track to enjoy camping, fishing and other coastal activities," Weir said.
"But these coastal locations can present

dangers, some that you can see and some that you can't, which is why we have some simple advice: Stop, Look, Stay Alive." – AFP

Man with US\$2m cash held at airport

LUSAKA: Zambian customs officials said on Saturday they had arrested an Indian national who had attempted to smuggle more than US\$2 million (RM8.8 million) in cash and gold worth US\$500,000 through the country's

main airport.
The 27-year-old was on his way to Dubai in the United Arab Emirates when his attempt was thwarted by a multi-agency team at the Kenneth Kaunda International Airport, the

Drug Enforcement Commission (DEC) said. He was intercepted with US\$2,320,000 in cash and seven pieces of what they suspected to be gold valued at US\$500,000, the agency said in a statement.
Images shared by Zambian media showed

stacks of US\$100 bills held together with rubber bands. The money was packed into a black bag, which was then placed inside a larger polypropylene suitcase.

Those involved in transnational organised crimes that the long arm of the law will catch up with them soon," DEC said.

Tractors join Turkiye opposition protest

Disgruntled political parties call for early elections

ISTANBUL: Around 100 tractors blocked roads in central Turkiye on Saturday as their drivers joined the latest anti-government protest called

by the main opposition CHP.

The rally in the central town of Yozgat took place exactly a month after the arrest of Istanbul's popular opposition mayor, Ekrem Imamoglu, President Recep Tayyip Erdogan's

biggest political rival.

That detention sparked Turkiye's worst street protests in a decade and prompted a sharp crackdown by the authorities who detained

nearly 2,000 people.

Although the initial mass demonstrations tailed off, the government has failed to stamp out the unrest, with ongoing protests by university and high school students, and CHP leader Ozgur Ozel calling for weekly rallies. Wearing a flat cap, Ozel drove a tractor into

Yozgat on Saturday at the head of a long convoy where several thousand flag-waving protesters had rallied in this deeply conservative farming heartland that has long backed Erdogan's AKP and its nationalist allies.
"Government, resign!" they chanted in

footage posted online by several opposition news outlets.
"I warn the authorities who see the people of

Yozgat as ants and are trying to crush them: we will not let you crush these hard-working

"The 'despised farmers' and the villager who is ignored will demand an accounting, starting here in Yozgat! The nation's future will be saved by determination and resolve. It's not ... those who fear the ballot box who will win, but the

people!" he later wrote on X. The jailed mayor's wife Dilek Imamoglu said

people wanted change.

"We came here to support each other, we can't afford anything because of hunger and thirst ... Our government should stop being partisan and deal with people's hunger," he said.

At the rally, organisers read out a letter from

Imamoglu urging support for the opposition's call for early elections.

"If the government were to call early elections today, the economy would get back on track," he wrote in a direct appeal to those who voted for Erdogan's AKP. – AFP

Father of US hostage hopeful son still alive

NEW YORK: The father of a US-Israeli hostage held in Gaza said on Saturday he remains hopeful his 21-year-old son was still alive after Hamas said it could not account for his status.

Adi Alexander, whose son Edan was serving in the Israeli army when he was captured on Oct 7, 2023, called on the United States to engage in direct talks to free the remaining hostages.

"I think we should engage with them directly and see what can be done about my son, four American dead hostages and everybody else," the father said.

"It seems like the negotiations are

stalled, everything is stuck and we are kind of back to a year ago. It's really concerning."

Hamas had previously agreed to

release Edan Alexander, believed to be the last surviving American hostage held by the group, as well as the bodies of four other Americans.

other Americans.

The armed wing of Hamas said on Saturday it did not know the fate of Alexander, after noting that the guard holding him was killed.

Hamas abducted Edan Alexander

when he was 19. Edan, who holds dual nationality, grew

up in New Jersey. His father said his son was an "all-American kid, great athlete ..., such a loving, loving boy" who found himself in "the wrong place, wrong time".

He said if he could speak to his son now, he would tell him, "Just believe. You know, nobody forgot about you. Definitely not your parents, and everybody is fighting for your release on the highest level." – Reuters

TURKIYE SPY CHIEF MEETS HAMAS LEADERS

ISTANBUL: Turkish intelligence chief Ibrahim Kalin met Hamas leaders in Turkiye on Saturday for talks about how to deliver aid to Gaza. He reassured them of Gaza. He reassured them of support and said Ankara would oppose any effort to occupy or annex further Palestinian territory. Hamas said its leaders had stressed their willingness to "immediately reach a prisoner exchange agreement in return for a ceasefire", Israeli withdrawal, the start of reconstruction and the lifting of Israel's blockade. It also expressed a desire to see "the implementation of the Egyptian proposal to establish a special committee to govern the Gaza Strip, composed of independents and competent national figures". – AFP

MOSCOW: President Vladimir Putin and Moscow Mayor Sergei Sobyanin attended an Easter service led by the head of Russia's Orthodox Church, Patriarch Kirill. Hours after declaring a unilateral Easter ceasefire that Kyiv said was just words as fighting continued, Putin and Sobyanin stood in Moscow's main church, the Cathedral of Christ the Saviour, while Kirill led a procession. Holding a thin red candle and donning a dark suit, white shirt and a red tie as in years past, the Russian leader crossed himself several times. The traditionally sung service starts late on Saturday and lasts into the early hours of Sunday. Putin always attends services during major church holidays. – Reuters

Gaza talks pace frustrates chief negotiator

Qatar committed to negotiations

DOHA: Qatar's chief negotiator voiced frustration over talks for a truce in Gaza in an interview, month after Israel resumed its strikes on the Palestinian territory and another round of negotiations ended without a deal.

"We're definitely frustrated by

the slowness, sometimes, of the process in the negotiation. This is an urgent matter. There are lives at stake here if this military operation continues day by day," Mohammed Al-Khulaifi said on Friday.

Qatar, with the United States and Egypt, brokered a truce in Gaza

came into force on Jan 19 and largely halted over a year of war.

The initial phase of the truce ended in early March, with the two sides unable to agree on the next

steps. Hamas has insisted that negotiations be held for a second phase to the truce, leading to a permanent end to the war, as outlined in the January framework.

Israel, which had called for an Israel, which had called for an extension to the opening phase, resumed air and ground attacks across the Gaza Strip on March 18 after earlier halting the entry of aid.

Late on Thursday, Hamas signalled it would not accept Israel's newest proposal for a 45-day ceasefire. Israel had wanted the

Israel restricts access to key church

ISTANBUL: Israeli authorities on Saturday blocked Christian worshippers' access to the Church of the Holy Sepulchre in Jerusalem. Israeli police erected military

checkpoints on roads leading to the church in the Old City, checking IDs and denying entry to many young people, Wafa news agency reported.

Israeli authorities barred thousands of Christians from the occupied West Bank from entering Jerusalem, enforcing strict permit requirements for both Muslim and Christian Palestinians.

Church sources told Wafa that only 6,000 permits were issued to West Bank Christians this year, despite the community numbering around 50,000 across the Palestinian territories.

In a statement by the Higher Presidential Committee for Church Affairs in Palestine, chaired by PLO Executive Committee member Ramzi Khouri, the committee strongly condemned "the Israeli occupation authorities for imposing sweeping restrictions on Christian worshippers and foreign pilgrims in

occupied Jerusalem".

Most notably, Israeli authorities denied entry to the Apostolic Delegate and Vatican Ambassador to Palestine Archbishop Adolfo Tito Yllana, an act that diplomatic protocols violates protocols

international conventions.

The committee "cited reports from human rights organisations documenting physical assaults and arbitrary arrests of worshippers. including Christians". local Jerusalemite

Calling for urgent international

action, the committee appealed to the United Nations, global human rights bodies, churches and Christian institutions to intervene. "The international community

must not remain silent in the face of these discriminatory and repressive measures. Freedom of worship in Jerusalem must be upheld for Palestinian Christians and Muslims."

Al tools like MidJourney, DALL-E, Adobe Firefly, Runway ML, and Canva's AI-powered design features can now generate logos, website layouts, and 3D models in seconds.

This technology offers officiency.

This technology offers efficiency, handling repetitive tasks so that designers can focus on bigger ideas. However, it also shifts their role from creators to curators, raising fundamental questions about identity raising

Traditionally, creative professionals have taken pride in originality and craftsmanship. But when AI can produce near-instant results, some may ask: "Am I still the artist, or just someone refining what the machine generates?" This shift can be unsettling, especially in an industry where individuality has always been a

marker of success.

At the same time, digital collaboration tools like Figma, Miro, and Adobe Creative Cloud have changed how teams work together. Designers, developers, and clients can now collaborate in real time, making the creative process more dynamic While this improves efficiency, it also

blurs the boundaries of expertise.

Previously, designers led the creative process, blending aesthetics with functionality. Now, with multiple stakeholders weighing in, they must navigate competing opinions and justify their decisions more than ever. Some may feel their expertise is being diluted, reduced to executing rather than envisioning.

This shift affects how designers

perceive their own value. If an organisation prioritises collective decision-making over individual creativity, professionals may struggle to see their contributions as unique or essential. When work is defined by consensus rather than creative vision, does the designer still have authority, or are they simply another voice in the crowd?

How can creative professionals embrace these changes while preserving their sense of identity? The key lies in redefining their roles. For those working with AI, the focus

should shift from execution to creative strategy. AI may handle the technical aspects, but human designers provide vision, meaning, and refinement

Rather than competing with AI, professionals should guide its use, ensuring that technology enhances creativity rather than replacing it. Organisations must also recognise that true innovation is not just about speed, but about depth and originality.

In collaborative environments. designers need to establish themselves as creative integrators.


While teamwork is valuable, their expertise should remain central in experise should remain central in balancing aesthetics, functionality, and user needs. Companies can support this by giving designers a clear leadership role, ensuring their voice is

This flexibility not only reinforced their presence in projects but also ensured that their creative vision was upheld until completion. By broadening their contributions rather than retreating from change, they sustained their professional identity in a shifting landscape.

Likewise, creative professionals today must adopt a sustainable today must adopt a sustainable mindset, integrating AI and digital tools without compromising their artistic integrity. The ability to evolve without losing one's core values is what will distinguish those who thrive from those who struggle to adapt.

As we navigate the Gen AI era, it is worth reflecting on what truly defines us in our work. Is it what we do, the skills we master, or the outputs we deliver? In my research, I have observed a growing emphasis on performance-based identity, where success is measured by efficiency rather than creativity. But is this shift sustainable?

Perhaps the answer lies redefining creativity itself. Instead of seeing AI as a threat, we should harness it as a tool that amplifies human ingenuity. The future of creativity is not about choosing between humans and machines but about finding ways to let technology enhance humanity.

As AI continues to reshape industries, we must ask ourselves: How can we use these tools to enrich our work rather than diminish it? And how do we ensure that our professional identity remains a source of pride, purpose, and fulfilment in this new era?



Starting afresh with retirement

ETIREMENT is a milestone that looms for every worker, whether it arrives at 60, 70, or beyond.

It's a phase as inevitable as it is transformative, yet it often arrives with a mix of anticipation and unease.

A former colleague of mine worked tirelessly until nearly 80, his mind sharp and his passion for challenges undimmed.

He saw every obstacle as a chance to grow. But when a family tragedy struck, followed swiftly by an incurable diagnosis, his vast earnings could not buy back time.

"I'll drop dead the day I stop working," he used to say, and though he faces his illness with no regrets, his story shook me. It prompted a deep reflection on what retirement truly means – not an end, but an invitation to reinvente life. to reimagine life.
Retirement is not a curtain falling;

it's a stage awaiting a new act. The secret to a vibrant post-career life lies not in chasing bucket lists, often little more than scripts to answer curious onlookers, but in releasing habits that

In letting go, we uncover a rhythm that hums with vitality and purpose.

Meet Wahid, whose journey after

retirement offers a roadmap for this transformation, which some of us can associate with.

Wahid's first lesson was his body's quiet rebellion. After decades of early alarms and crowded commutes, he sank into his armchair, believing endless rest was his reward. But inactivity was a thief. Muscles weakened, joints creaked, balance faltered. The couch was no sanctuary, it was a trap. So, Wahid began to move, not with

the vigour of youth but with gentle intention. Mornings became walks through his neighbourhood, sunlight filtering through trees, birdsong filling the air.

He tried *tai chi*, chuckling through wobbly poses with newfound friends. Even lifting spice jars in his kitchen became a small act of defiance against time. His body, he realised, was not a relic to mourn but a partner to cherish.

Retirement severed the daily threads of connection - office banter, shared lunches, the hum of human presence. Days stretched silent, and loneliness settled like a heavy fog, as

harmful as any vice.

But Wahid discovered that connection didn't require grandeur. It bloomed in small moments: weekly teas with an old colleague, their laughter warming the café; a Quran study group where debates sparked joy; and volunteering at the mosque, where sorting donations wove him back into the community. Loneliness wasn't his fate, it was a call to reach

Sleep, too, demanded care. For years, Wahid had treated it as a luxury, stolen by late-night worries or early meetings. In retirement, he saw its sacred role mending his body, sharpening his mind, steadying his heart. Yet erratic bedtimes and glowing screens disrupted his rest.

So, he crafted a ritual with rosehip a, a darkened room, a consistent bedtime like a lighthouse guiding him to shore. Sleep wasn't an afterthought but was his foundation.

Wahid's kitchen became a reason for endless transformation. Decades of rushed meals, greasy takeaways, skipped lunches had dulled his palate

morning markets, marvelling at fresh green *kangkung* and bright red chillies.

He roasted vegetables, drizzled them with sesame oil, savoured almonds and dark chocolate. Eating well wasn't a chore but was a love letter to the life he still craved.

Wahid stopped dodging the doctor. Annual check-ups, once dismissed as formalities, became his shield. A routine blood test caught a whisper of trouble, addressed before

Cholesterol and blood sugar weren't just numbers, they were signposts for a longer journey. Ignoring them was reckless while embracing them was empowerment.

Old grudges like a friend's betrayal and a family slight clung like damp leaves, stealing Wahid's peace. He learned to let go, not with grand gestures but in quiet moments, imagining each hurt dissolving like mist. Forgiveness wasn't for other. It was his liberation, a lightness that let him smile freely.

Money required care, too. Retirement savings weren't infinite, and small indulgences like the daily teh tarik and unused subscriptions nibbled at his security.

Budgeting wasn't about scarcity; it

was about stretching resources to match his dreams. Tracking spending and finding joy in simple pleasures ensured his future stayed bright.

Technology, once an adversary, ecame a bridge. Smartphones became a bridge. Smartphones baffled Wahid, apps tested his patience, but he refused to be left behind. A community centre tech class opened doors which enabled him to do video calls with distant grandchildren, and to online lectures

grandchildren, and to online lectures that sparked curiosity. Learning wasn't just for the young, it was his lifeline to the world.

Above all, Wahid rejected the notion that his purpose had faded. Retirement wasn't a retreat but an empty slate. He mentored young entrepreneurs at his old cooperative, their ambition rekindling his own their ambition rekindling his own.
He wrote stories of his *kampung*

childhood, pages that might outlive him. He planted a garden, each seed a promise to the future. Purpose wasn't a job; it was the spark of showing up.

As spring bloomed in his garden, As spring broomed in ins garden, Wahid stood taller, his hibiscus thriving, his tea warm in his hands. "I didn't retire from life," he said, eyes bright. "I retired to it."

EcoNiLi Battery New Energy invests RM80m in third facility

CEO says future looks bright, company ramps up expansion plans amid growing EV adoption in Malaysia

PETALING JAYA: Malaysia-based EcoNiLi Battery New Energy Sdn Bhd, the largest lithium-ion battery recycler in Asean, is investing RM80 million in a third facility focused on remanufacturing and repurposing

CEO Datuk Jayden Goh (pic) said t is ramping up expansion plans this year amid growing electric vehicle (EV) adoption in Malaysia.

"We are seeing an increase in the

number of EVs on Malaysian roads, and the government is actively pushing for greater adoption. As a result, we will soon have a large volume of batteries waiting to be recycled," he told *SunBiz* in an exclusive interview.

Furthermore, Goh said, battery recycling demand is expected to surge in five to seven years as lithium-ion batteries from EVs and production scrap accumulate.

"Currently, there are three battery makers in Malaysia operating near full capacity, and we expect even more lithium-ion batteries to enter the recycling pipeline soon. The future looks bright, it's just a matter of time," he added

As part of its expansion, Goh said, EcoNiLi is developing a "circular economy valley" to recover precious metals from used batteries.

"Malaysia lacks local mineral resources, so we must source them through secondary applications. In the future, having a large supply of these materials will support our goal of establishing domestic battery production."

Despite short-term challenges, including a slowdown in EV demand and fluctuating battery metal prices, Goh remains optimistic about long-term growth particularly in battery

recycling volumes.

"At the moment, battery value and metal prices are unstable due to the drop in global EV demand, which indirectly affects battery material prices. The entire battery ecosystem has faced challenges over the past two years, and this year will be no different. But as an entrepreneur, you have to stay optimistic and keep

scaling the business," he said.

Goh said the company has already

of profitability, so scaling up is a priority.

"We are currently in the process of com-pleting our Series A fundraise and will continue to seek funding from both local and international in-

In addition to that, he said EcoNiLi plans to list on Nasdaq within three years to global investors and talent.

"We will raise more funding in the capital market. Whether it's for overseas or Malaysia. To scale our next project because we have a few expansion plan. We have our upcoming phase two, which we are already securing land from Perak itself 43-acre industrial land."

Goh said EcoNiLi is targeting at least 20% profit growth this year, but with a successful fundraising, the company could even achieve 30% to 40% growth. Scaling a business of this size requires significant working capital."

EcoNiLi serves global clients such as LG, Tesla and Honda, as well as battery recyclers worldwide that lack refinery capabilities.

"Setting up a refinery is highly complex, requiring significant expertise and investment. We source

"The initiative, backed by an initial investment of RM25 million, will take

place at Stellantis' established manu-facturing facility in Gurun, Kedah," he

recycling materials from global battery collection companies and battery recyclers to process them further," Goh said.

However, he highlighted that Malaysia lags behind China, India, and South Korea in battery recycling policies.
"Malaysia is still in

its early stages, with unclear policies, on-going R&D and trial-and-error efforts."

He said EcoNiLi is willing to work alongside the government to advocate for clear policies that support the industry's growth.

"This is a new industry with no clear guidelines or regulatory framework. We are adapting to the evolving landscape while positioning ourselves as a key player in the sector. Over time, this will allow us to influence industry standards."

Goh believes Malaysia still has time to become a major industry player, leveraging its cost advantages over countries such as South Korea, Singapore and Japan.
"Our costs are significantly lower

than those in developed countries. Capital expenditure (capex) is also lower, making us a cost-effective

alternative."

Comparing Malaysia with India,

Goh noted that the Indian government has introduced incentives and a policy framework that accelerated industry growth. "Today, India has over 50 companies in battery recycling and related industries. They recognised its importance early on and acted swiftly."

Goh pointed out that China's battery recycling sector has also grown exponentially.

"In 2014, China had 500 battery

recycling companies. Today, there are 120,000, with over 200 listed companies. This shows the industry's rapid growth potential."

"Korea already has four listed

battery recycling companies. If we work closely with the government, we can fast-track our own listing and expand much faster," he added.

Goh stressed that battery recycling is a crucial industry, and discarded batteries should never end up in

"People now understand the value of used batteries. The battery ecosystem can generate national benefits, creating jobs, attracting investment, and positioning Malaysia as a global supplier of recycled materials."

He pointed out that recycled

battery materials can be sold worldwide, not just to China, but also

the US and Europe.
"This is a critical raw material needed for future battery production. Without recycling, we would be overly reliant on mining," Goh said.

PETALING JAYA: An initial investment of €5 million (RM25 million) has set the stage for European carmaker Stellantis and joint venture partner Leapmotor of China to begin electric vehicle (EV) assembly in Malaysia.

Stellantis Asean managing director Isaac Yeo said this marks a significant milestone in the region's push for electrification.

"The local production, which will take place at Stellantis' existing manufacturing facility in Gurun, Kedah, represents Leapmotor's first step into Malaysian localisation and strengthens

said at a press conference on assembly of Leapmotor vehicles in Malaysia on Friday.

The strategic move not only signals Leapmotor's entry into production in Malaysia, but also positions the country at the forefront of the electric mobility revolution in the Asean region, Yeo said.

"By leveraging Stellantis' global manufactions scale and Leapmotor's

manufacturing scale and Leapmotor's innovative new energy vehicle (NEV) technologies, the two companies are jointly advancing a vision for accessible, high-quality EVs tailored

for Southeast Asia.
"With demand for EVs rising rapidly across Asean, the local assembly project in Malaysia represents both a commercial opportunity and a statement of intent to lead in sustainable mobility," he noted.

Stellantis India and Asia-Pacific chief operating officer Ashwani Muppasani said the milestone marks

more than the start of local assembly it marks the next chapter in Stellantis' electrification journey across Asean.

innovation and success with Stellantis' regional expertise and global scale, we are laying the foundation for an accessible, sustainable future of mobility right here in Malaysia and across Southeast Asia," he remarked.

Ashwani said the Gurun plant, which has been a core manufacturing base for Stellantis in the region, was selected for its strategic location and well-established automotive infrastructure.

"The plant has undergone enhancements to accommodate EV production, starting with the Leapmotor C10 model. Local assembly of this model is expected to begin by the end of 2025, with plans for further expansion aligned with regional market demand," he added.

Ashwani highlighted the plant's evolving role in the company's

regional strategy.

"The Gurun plant has become a cornerstone of Stellantis' manufacturing presence in the region. We have proactively enhanced its capabilities to support EV assembly, and we are

proud that Leapmotor will be the first locally assembled electric vehicle to emerge from this plant," he said.

Beyond manufacturing, he added, the collaboration is expected to generate broader economic benefits including industrial growth, tech-nology transfer, and enhanced cooperation between Malaysia and

Leapmotor founder, chairman and CEO Zhu Jiangming said the initiative supports Malaysia's broader economic objectives during its 2025 Asean chairmanship, positioning the country as a regional leader in clean energy development and sustainable

He described the project as a key milestone in the company's global expansion.

"The localised assembly project in Malaysia will accelerate Leapmotor's global strategic expansion. Tripartite deal to build industrial park in Negeri

EcoWorld.SD Guthrie and NS Corp form special purpose vehicle for RM2.95b project in Malaysia Vision Valley 2.0

PETALING JAYA: A tripartite agreement has been signed to transform 1,195 acres of prime land in Bukit Pelandok, Negeri Sembilan, into an integrated industrial park.

The alliance sets the wheels into motion for the development of Parcel C within Malaysia Vision Valley 2.0 (MVV 2.0), the primary economic corridor on the west of Peninsular Malaysia. Eco World Development Group

Bhd (EcoWorld), SD Guthrie Bhd and NS Corporation (NS Corp) are partners in the collaboration through Eco Business Park 7 Sdn Bhd (EBP 7), a special purpose vehicle set up for the development. EcoWorld will hold 55% of EBP

while SD Guthrie Land Ventures Sdn Bhd, a wholly owned subsidiary of SD Guthrie, will hold a 30% stake. The remaining 15%

a 30% stake. The remaining 15% will be held by NS Corp, a state agency of Negeri Sembilan.. EBP 7 will leverage the synergies of the three entities - SD Guthrie's strategically located land within MVV 2.0, EcoWorld's expertise and experience in successful industrial park developments and NS Corp's role as the state-appointed coordinator and custodian of the MVV 2.0 master plan.

The new industrial park has an estimated gross development value (GDV) of RM2.95 billion and forms part of a larger initiative to advance

Malaysia's trade resilient, March exports rise to RM137.3b

Imports slip, balance in surplus for 59th consecutive month amount of RM24.7b

PETALING IAYA: Malaysia's trade performance in March 2025 reflected resilience with a steady increase in exports, while a decline in imports highlighted challenges amid broader economic uncertainties.

Total trade experienced a year-on-

year (y-o-y) growth of 2.2% to RM249.9 billion, attributable to a steady growth in exports (+6.8% or RM8.7 billion) to RM137.3 billion. However, imports experienced a decrease by 2.8% or RM3.3 billion to RM112.6 billion.


The trade balance demonstrated stronger performance, with the surplus rising by 94.4% to RM24.7 billion in March, the Department of Statistics Malaysia said in its monthly external trade statistics report. It marked the 59th consecutive month of surplus since May 2020.

Chief Statistician Malaysia Datuk Seri Dr Mohd Uzir Mahidin said Malaysia's export growth in March was driven by increases in both domestic exports and re-exports. Domestic exports, which accounted for 80% of total exports, rose by 5.6% to RM109.9 billion, while re-exports, making up 20% of total exports, expanded by 12.1% to RM27.4 billion compared to March 2024.

Month-on-month, March 2025 demonstrated growth over February 2025, with exports, imports, total trade up by 16.1%, 6.6%, 11.6%, respectively, and the trade balance surged 96%.

In terms of commodity group, 113 out of 257 export groups showed an increase while 137 out of 260 import groups showed a decrease compared to the same month of the previous year.

Mohd Uzir said higher exports were attributable mainly to the United States (+RM7.6 billion), Singapore (+RM1.9 billion), Singapore (+RM1.9 billion), Singapore (+RM1.9 billion), Taiwan (+RM1.6 billion), the European Union (+RM1 billion), the



Philippines (+RM498.7 million) and

Philippines (+RM498.7 million) and South Africa (+RM439 million).

Nevertheless, sluggish imports were mainly contributed by shipments from Taiwan (-RM1.7 billion), followed by India (-RM1.5 billion), the United Arab Emirates (-RM1.3 billion), Singapore (-RM1.2 billion), Australia (-RM799.9 million), Andraliand (-RM715.2 million) and Thailand (-RM715.2 million) and Qatar (-RM544.9 million).

Commenting further on exports, Mohd Uzir said the increase was reflecting the rise in electrical &

electronic products (+RM12.5 billion): (+RM785.3 million); condensates & parts other petroleum oil (+RM619.1 million); processed food (+RM542.7 million); other manufactures (+RM524.1 million); and palm oil-based manufactured

products (+RM512 million).

Meanwhile, the drop in imports was mainly attributed to petroleum products (-RM6.6 billion); crude petroleum (-RM1.7 billion); manufactures of metal (-RM1 billion); other mining (-RM1 billion); iron & steel products (-RM846.3 million): and liquefied natural gas (-RM592.8 million).

As for performance for the first quarter of 2025, total trade, exports, imports and trade surplus increased compared to the same period last year. The encouraging economic performance led to a 3.6% rise in total trade, aligning with the increase in exports (+4.4%) and imports (+2.8%).

The trade surplus amounted to RM41 billion, an increase of 20.1% compared to the same period in 2024.

Call for stronger collaboration to unlock oil palm biomass utilisation

KUALA LUMPUR: stakeholders have urged stronger collaboration and more coherent policy direction to accelerate the use of oil palm biomass in supporting Malaysia's low-carbon

goals.

The call was made during the 5th International Oil Palm Biomass Conference 2025, held on April 14-The conference brought together researchers, policymakers and industry players to discuss pathways for sustainable biomass utilisation.

Chemical engineer Hong Wai Onn from the Research Institute for Sustainable Excellence and Leader-ship, who was one of the panellists at the conference, highlighted the underutilisation of oil palm biomass and stressed the need for better coordination among stakeholders.

"The oil palm industry produces over 100 million tonnes of dry biomass annually – including trunks, fronds, empty fruit bunches and palm kernel shells – which are often treated as waste but hold significant untapped potential," he

Hong proposed a collaborative ecosystem with four key players: government agencies, sustainability standard owners, technology pro-viders, and biomass producers and

"To truly transform the industry we need synergy across these four pillars, with governments providing clear policy direction and funding support, standard owners en-couraging carbon footprint reductions, technology providers offering cost-effective solutions, and producers and valorisers committing to sustainability standards and ensuring stable supply and demand," he explained.

The panel also tackled policy gaps and regulatory bottlenecks that hinder effective biomass utilisation.

Hong recommended the establishment of an interministerial biomass task force to align priorities across key sectors such as agriculture, energy, environment, industry, and science and technology. He also proposed joint funding mechanisms and shared key performance indicators to improve cross-agency cooperation. – Bernama

Robust trading in issues over Hang Seng Index, YTL Power and Genting

WARRANTS WATCH

TRADING activity on the local warrants market in the third week of April remained robust with overall turnover increasing by 22.3% week-on-week (w-o-w) to RM641.1 million.

The increase was primarily driven by a further uptick in turnover for warrants over the Hang Seng Index (HSI), which rose 34.6% to RM562.2 million, despite the holiday-shortened trading week in Hong Kong due to the Good Friday holiday.

HSI futures kicked off the week in

positive territory, surging 2.7%, following some tariff rollbacks over imports of Chinese electronics. However, the futures drifted lower on

Wednesday for the first time in six days on the back of US-China trade war despite economy growing by 5.4% in the first quarter, exceeding Bloomberg's estimates. On the last trading day of the week, the futures rebounded 0.9% amid hopes of stimulus measures from China, ending the week 2.1% higher. The moves led to active trading in

mostly the call warrants with HSI-CWC4, HSI-CWEP and HSI-CWEI topping the leaderboard with up to 888.6 million, 502.6 million and 379.3 million units changing hands. Meanwhile, the put warrants HSI-PWD2 and HSI-PWFK were the most actively traded put warrants by volumé traded for the week at 607.6 million and 522.5 million units

Furthermore, warrants over the Hang Seng Tech Index (HSTECH) saw a significant increase in trading activity, surging 160.7%, logging a total turnover of RM10.8 million. HSTECH-C24 and HSTECH-C22 were the most actively traded HSTECH warrants, recording 24.5 million and 11.6 million units changing hands. The HSTECH futures closed 0.3% lower for the week.

As for local issues, trading in warrants over YTL Power International (YTLPOWR) remained robust, registering a total turnover of RM5.4 million and contributing 10.4% of the total turnover for warrants over Malaysian shares as its share price surged 6.7% w-o-w to close at RM3.20; top traded YTLPOWR warrants include YTLPOWR-C76 and YTLPOWR-C77.



Boeing jet returns to Seattle from China, victim of Trump's tariff war

by a Chinese airline landed back at the planemaker's American production hub vesterday, a victim of the tit-for-tat bilateral tariffs launched by President Donald Trump in his global trade

The 737 MAX, which was meant for China's Xiamen Airlines, landed at Seattle's Boeing Field at 6.11pm (9.11am in Malaysia), according to a Reuters witness.

It was painted with Xiamen livery.

The jet, which made refueling stops in Guam and Hawaii on its 8.000km return journey, was one of several 737 MAX jets waiting at Boeing's Zhoushan completion centre for final work and delivery to a Chinese carrier.

Trump this month raised baseline tariffs on Chinese imports to 145%.

In retaliation, China has imposed a 125% tariff on US goods.

A Chinese airline taking delivery of Boeing jet could be crippled by the tariffs, given that a new 737 MAX has a market value of around US\$55 million (RM243 million), according to IBA, an aviation consultancy.

It is not clear which party made the

Boeing did not immediately respond to request for comment while

The return of the 737 MAX, Boeing's best-selling model, is the latest sign of disruption to new aircraft deliveries from a breakdown in the aerospace industry's decades-old duty-free status.

The tariff war and apparent U-turn over deliveries comes as Boeing has been recovering from an almost five-year import freeze on 737 MAX jets and a previous round of trade

Confusion over changing tariffs

could leave many aircraft deliveries in limbo, with some airline CEOs saying they would defer delivery of planes rather than pay duties, analysts say.

Japan seeks 'fairness' in currency talks with US

Tokyo mulls relaxing auto safety rules for imports: Report

TOKYO: Japan will emphasise "fairness" in any discussions with the US on exchange rates, Prime Minister Shigeru Ishiba said yesterday, as bilateral trade talks grab global attention in President Donald Trump's tariff offensive.
Ishiba, in a talk show on public broadcaster

NHK, indicated Tokyo could buy more US energy and suggested flexibility on American accusations of non-tariff barriers to the Japanese automobile market.

Trump - who unexpectedly joined the first round of US-Japan talks on Wednesday and touted "big progress" - has indicated he wants the negotiations to include his accusations that Tokyo intentionally weakens its currency

to give its exporters an unfair advantage.

Ishiba said specific discussions on currency policy will be made between Finance Minister Katsunobu Kato and Treasury Secretary Scott

"We'll have to deal with this issue from the standpoint of fairness," Ishiba said, when asked how Japan would respond if the US asked for cooperation in boosting the yen.

He did not elaborate

Japan, which denies manipulating the venhas over the years typically fought to keep a strong ven from hurting its export-reliant economy, but it last intervened in the foreign-exchange market last year to boost its currency.

Kato plans to visit Washington this week for a meeting of the Group of 20 finance chiefs on the sidelines of the spring meeting of the International Monetary Fund.

He is widely expected to meet Bessent for bilateral trade talks.

Some analysts say Japan could use its huge US Treasury holdings - the largest in the world at over US\$1 trillion (RM4.4 trillion) - as trade leverage, but Kato this month ruled out using them as a bargaining tool

"This is something that's based on trust between the two sides, global economic stability, as well the two countries' economic stability Ishiba said when asked whether Japan would refer to its US debt holdings during the talks. Trump has hit Japan with 24% tariffs on its

exports to the US although, like most of

Trump's levies, they have been paused until

early July.

A 10% universal rate remains in place, as does a 25% duty on cars, a mainstay of Japan's export-reliant economy.

Nikkei Asia reported yesterday that Japan is

considering relaxing auto safety rules for imports as part of its tariff negotiations with

Washington has long complained that Japanese safety rules are a non-tariff barrier, while Japan and many experts say Detroit automakers do not make cars suited to Japan's roads and drivers.

Asked about such accusations, Ishiba said there were differences in US and Japanese traffic and safety rules that must be taken into

"But we also need to ensure we're not told

our (safety) rules are unfair."

He signalled a readiness to pledge bigger Japanese investment in the US, particularly in

the area of energy.

"As for liquefied natural gas, Australia is the biggest exporter to Japan. I believe the US is in fourth place. It's possible we could have this increase. The question is whether the US can deliver (energy) stably." – Reuters

Foreign investors increase Chinese bond holdings by 270 billion yuan

SHANGHAI: Foreign institutions have increased holdings in China's onshore bonds by more than 270 billion yuan (RM163 billion) so far this year, highlighting the appeal of the world's second-biggest bond market, the official

Kinhua news agency reported on Saturday.

Foreign institutional holdings in Chinese bonds totalled 4.5 trillion yuan as of April 15, Xinhua reported, citing central bank data.

But foreigners account for just around 2.4% of China's bond market, suggesting a big potential to grow, according to the article.

People's Bank of China unswervingly promote bond market opening, and attract more foreign investors, as ties deepen between regions such as the Middle East, Latin America, Europe and Africa, Xinhua

China's efforts to lure foreign investment comes as US President Donald Trump's global tariffs threaten to dent investor confidence in American assets

Prices of US Treasuries and the dollar index are down sharply in recent weeks, driven by concerns about recession and growing grievance against Trump's tariff and diplomatic policies. – Reuters

India central banker warns of dwindling money market liquidity

MUMBAI: India's call money market faces risks of dwindling liquidity, posing challenges for monetary policy transmission, its central bank chief said.

Reserve Bank of India Governor Sanjay Malhotra expressed concern about "asymmetries which arise on occasions between different money market rates – the rate at which RBI provides liquidity, the call money rate, the market repo rate and TREPS (tri-party repo dealing system) rate".

Banks – the entities with sole access to

the RBI's liquidity facilities, the call money market and the repo markets – must be proactive to ensure that the central bank's liquidity measures are "promptly and seamlessly" transmitted to the broader market, Malhotra said in a speech at a conference in India on Friday that was uploaded to the RBI website on Saturday.
The call money rate is an overnight

interest rate at which banks and other financial institutions lend and borrow from each other.

When the RBI cuts interest rates or injects liquidity, it can push down the call money rate, transmitting the central bank's policy move to the system.

Surplus liquidity in India's has averaged 1.7 trillion rupees (RM88 billion) a day this month, reversing a four-month deficit, as the RBI stepped up its liquidity infusions to support growth.

The governor also called for deepening

of India's government securities market and improving liquidity and pricing by increasing participation from various stakeholders.

He said there is also a need for more proactive management of risks by different stakeholders in the derivatives market, enhancing market depth, increasing the diversity of views and fostering greater competition and efficiency. - Reuters

'US chip curbs on China could backfire

Analysts say restrictions fuelling innovation at Chinese firms

SAN FRANCISCO: As Donald Trump's administration attempts to choke off exports of strategically important computer chips to China, experts say the effort might well backfire, fueling innovation at Chinese firms that could help them seize the world semiconductor market.

"What's actually happening is that the US government right now is handing China a big win as it tries to get their own chip business going," said Jack Gold, principal analyst at J.Gold associates.

"Once they're competitive, they'll start selling around the world and people will buy their chips." When that happens, he added, it

will be difficult for US chip makers to reclaim lost market share.

Silicon Valley semiconductor star Nvidia and its US rival Advanced Micro Devices (AMD) expect big financial hits from new US licencing requirements for semiconductors exported to China, they notified

regulators this week.

Nvidia expects the new rules to cost it US\$5.5 billion (RM24 billion), while AMD forecast it could sap as much as US\$800 million from the company's bottom line, according to filings with the US Securities and Exchange Commission (SEC).

Administration officials told Nvidia it must obtain licences to export its H20 chips to China because of concerns they may be used in supercomputers there, the company said.

The United States had already restricted exports to China, the world's biggest buyer of chips, of Nvidia's most sophisticated graphics processing units (GPUs), designed to power top-end artificial intelligence models.

Nvidia essentially developed the H20 chip for the Chinese market, aiming to maximise performance while meeting previous US export rules, but the new licencing requirements pose a roadblock, according to Gold.

For AMD, the new US export

For AMD, the new US export control measure applies to its MI308 GPUs, which are designed for high-performance applications like gaming and artificial intelligence, it said in a filing. It noted that there is no guarantee licences for sales to China will be

granted.

Independent tech analyst Rob Enderle predicted Chinese chip makers - likely led by the huge Huawei corporation - will ramp up efforts to snatch the lead in the

"It's going to be a godsend for China as they spin up their own microprocessor business," Enderle said of the tightened US export rules.

"This will be a really quick way to hand over US leadership in microprocessors and GPUs."

The Chinese government has

ample resources and motivation to bolster its chip industry, according to

He said while Trump might think he can "bully people" to achieve his objectives, "the worldwide economy is not like that".

Instead, Trump's tariffs have alienated allies, increasing their incentive to turn to China for chips, the analyst said.

"Across the board, this is going to create real problems for American companies competitively," Enderle

"Companies located overseas are suddenly going to be in much better shape to compete."

Nvidia chief executive Jensen Huang has said publicly that the AI chip powerhouse can comply with the new US requirements without sacrificing technological progress, adding that nothing will stop the global advancement of artificial intelligence.

"Nvidia is one of the most important pieces in this (US) chess game with China," Wedbush global head of technology research Dan Ives said in a note to investors.

"The Trump administration knows there is one chip and company fuelling the AI Revolution and it's Nvidia," he said, and so it placed "a Do Not Enter' sign in front of China" to slow its progress.

Ives warned, however, that the chip wars are not over.

He expects "more punches to be thrown by both sides". – AFP



Ford 'adjusts' some exports due to tariffs

NEW YORK: Citing the US-China trade conflict, Ford said last week it has "adjusted" its exports to the country, where the American auto giant operates manufacturing jointly with local partners.
"We have adjusted exports from the

US to China in light of the current tariffs," Ford told AFP without specifying

the models affected.

The American auto giant halted
Michigan-made shipments of the
F-150 Raptor, Mustang and Bronco sport utility vehicles, according to a Wall Street Journal report.
Also affected was the Lincoln

Navigator, which is built in the

southern US state of Kentucky, the newspaper said.

Over the last decade, Ford has sold

around 240,000 vehicles in China exported from the United States.

But volumes fell sharply in 2024 to around 5,500.

Despite pulling back on many other tariffs, President Donald Trump has stuck firm to US duties on Chinese goods and raised them to 145%.

In turn. China has increased tariffs on US exports, including cars, to 125%. Overall, Ford sold 442,000 vehicles

- made in the United States and elsewhere - in China in 2024, comprising 1.6% of the market,

according to the carmaker's latest

The US company operates a number of manufacturing joint ventures in China with Chinese companies, producing vehicles under both the Ford and Lincoln brands.

Some of Ford's production in China is exported to other markets. One of these vehicles, the Lincoln Nautilus, is now subject to hefty US tariffs, according to the *Wall Street Journal*.

Ford's Chinese ventures resulted in 2024 operating profits of around US\$900 million, Ford vice-chairman John Lawler said last week at a financial conference. – AFP

Beijing envoy to Washington calls for end to trade war

WASHINGTON: China's ambassador to the United States, Xie Feng, has urged Washington to seek common ground with Beijing and pursue peaceful coexistence while warning that China stood ready to retaliate in

the escalating trade war.

Speaking at a public event in Washington on Saturday, details of which were posted on the Chinese embassy's website, Xie said tariffs would devastate the global economy and drew a parallel between the Great Depression and

tariffs imposed by the US in 1930. Referring to concepts in traditional Chinese medicine like the need to balance the opposing forces of yin and yang, Xie said harmony should guide relations between the world's two largest

economies.

"A good traditional Chinese medicine recipe usually combines many different ingredients which reinforce one another and creates the best medical effect.

"Likewise, the earth is big enough to accommodate both China and the US," he said.

"We should pursue peaceful coexistence rather than collide

head-on, and help each other succeed rather than get caught in a lose-lose scenario."

The trade war has all but frozen the mammoth trade between the world's two largest economies with tariffs over 100% in each direction and a suite of trade, investment

and a suite of trade, investment and cultural restrictions. China's top shipbuilding association on Saturday attacked a US plan to apply port fees on China-linked ships. While Japan, Taiwan and others

are already in talks or preparing to negotiate with Washington over President Donald Trump's "Liberation Day" tariffs, there is currently no high-level dialogue planned with China.

Trump said on Friday the US is

having good conversations privately with China amid the two countries' trade war

"By the way, we have nice conversations going with China, he told reporters.

"It's, like, really very good." He did not offer additional details. China has said the US should show respect before any talks can take place. – Reuters

Taiwan short-selling curbs extended again

TAIPEI: Taiwan's top financial regulator said on Saturday it would extend temporary curbs on the short-selling of shares to help ensure stock market stability, and did not give an end date for when the restrictions might be lifted.

The curbs were first imposed on April 6 after the United States imposed sweeping import tariffs, prompting global market turmoil. Intially imposed for one week, they were then extended for a further week.

In a statement, Taiwan's Financial Supervisory Commission said the curbs would continue, without saying when they might end.

US tariff policy and the outcome of negotiations with other countries are still highly uncertain, and there will continue to be "fluctuations" on global stock markets, it added.

If there are significant changes

on the market, the regulator said it would "adjust the relevant measures accordingly to maintain market stability and investors' interests".

It did not elaborate.

Short sellers borrow shares they expect to fall, aiming to repay the loan for less later to pocket the difference. - Reuters



DHL to suspend global shipments of over US\$800 to Americans

BEUING: DHL Express, a division of Germany's Deutsche Post, said it would suspend global business-to-consumer shipments worth over US\$800 (RM3,527) to individuals in the United States from April 21, as US customs regulatory changes have lengthened clearance.

The notice on the company website was not dated, but its metadata showed it was compiled on Saturday.

DHL blamed the halt on new US

customs rules which require formal entry processing on all shipments worth over US\$800. The minimum had been US\$2,500 until a change on April 5.

DHL said business-to-business shipments would not be suspended

but could face delays. Shipments under US\$800 to either businesses or consumers were not affected by the changes.

The move is a temporary measure. the company said in its statement.

DHL said last week in response to Reuters questions that it would continue to process shipments from Hong Kong to the United States "in accordance with the applicable customs rules and regulations" and would "work with our customers to help them understand and adapt to the changes that are planned for May 2". – Reuters

S. Korea officials to hold trade talks in Washington this week

SEOUL: South Korea and the United States will hold trade consultations this week in Washington at the suggestion of the United States, Seoul's Trade Ministry said yesterday.

Finance Minister Choi Sang-mok and Trade Minister Ahn Duk-geun will meet with Trade Representative Jamieson Greer and Treasury Secretary Scott Bessent on the sidelines of the spring meetings of the International Monetary Fund and World Bank, the ministry said in a statement.

South Korea hopes to lower the 25% "reciprocal" tariff that President Donald Trump has announced for the country, which he has since paused along with high tariffs slapped on a string of countries.

Ahn will leave on Wednesday, the

statement said.

It did not specify the agenda or give other details. – Reuters

Global plans to tax super rich and tech giants stall

Trump pulls US out of international deal, threatens tariffs over digital levies

PARIS: Global tax plans targeting billionaires and multinational companies are running aground, with the United States torpedoing reforms under President Donald

The billionaire real estate tycoon has pulled the United States out of an international deal on taxing multinationals and threatened tariffs on countries that target US tech giants

Amazon, Microsoft, Google owner Alphabet and Facebook's parent company Meta of sidestepping

Trump issued a warning on Feb 21 to countries that would hit big tech and other US companies with fines or taxes that are fines or taxes that are "discriminatory, disproportionate" or designed to transfer funds to local companies.

"My administration will act. imposing tariffs and taking such other responsive actions necessary to mitigate the harm to the United States," he said in the memo.

Washington and its allies over taxing digital services.

During his first term, Trump threatened to slap tariffs on US imports of champagne and French cheese after France rolled out a digital services tax in 2019.

Seven other countries have followed France's lead since then.

The tax generated €780 million (RM3.9 billion) for the French government last year. Now the European Union is

threatening to impose a tax on digital services if negotiations fail over Trump's plans to impose 20 percent tariffs on EU goods.
Britain, which is hoping to strike

a trade deal with the United States, may reconsider its own digital levy, which currently brings in £800 million annually.

British Trade Secretary Ionathan

Reynolds has said the digital tax is not "something that can never change or we can never have a conversation about".

Nearly 140 countries struck a deal in 2021 to tax multinational

agreement negotiated under the auspices of the Organisation for Economic Co-operation

The OECD agreement has two

The first provides for the taxation of companies in countries where they make their profits, a move aimed at limiting tax evasion. It

primarily targets tech giants.
Pillar two, which sets a minimum
global rate of 15%, has been adopted by around 60 economies, including Brazil, Britain, Canada, the EU,

Switzerland and Japan.
Daniel Bunn, head of the Tax Foundation, a US non-profit think-tank, said negotiations on implementation of the first pillar "have been stalled for some even under Joe Biden's presidency.

Franco-American economist Gabriel Zucman told AFP that the EU's reaction in the coming weeks "will be crucial".

"If the EU and other countries give up and allow American multinationals to themselves, it will unfortunately spell the end of this very important agreement." Efforts to tax the world's ultra-wealthy are also stalling.

Brazil used its time as chair of the G20 to push for a plan to impose a 2% minimum tax on the net worth of individuals with more than US\$1 billion in assets, a project estimated to raise as much as US\$250 billion

per year. The Biden administration baulked at the plan and it is unlikely to get any traction with Trump - a billionaire himself and proponent of tax cuts – at the White House.

Almost a third of the world's billionaires are from the United States – more than China, India and Germany combined, according to Forbes magazine.

At a recent conference in Paris, French economist Thomas Piketty said the world cannot wait for the G20 to all agree.

"We need individual countries to act as soon as they can," he said.

"History suggests that once you have a couple of countries who adopt a certain kind of reform, in particular powerful countries, becomes sort of a new standard."

Volkswagen floats making Audis in America

BERLIN: Volkswagen could relocate some production of its high-end Audi line to dodge American tariffs on automobiles ordered by President Donald Trump, the German carmaker's CEO said in an interview released last

Europe's largest auto manufacturer, which is especially vulnerable to the increase in US tariffs, was in "constructive discussions" with the Trump administration on the told Oliver Blume

Frankfurter Allgemeine Zeitung newspaper.

Volkswagen, which earlier in April

said Trump's slew of planned tariffs had dragged down its first-quarter operating profit, wanted to do "as much as possible to remain an investor and reliable partner for the United States", Blume added.

"For Audi, production in the United States would be in line with our development strategy," he said.

However he ruled out any

American manufacturing for Porsche, despite the US market being the luxury sports car brand's largest.

At only around 70,000 vehicles a year the volumes were too small to

consider the idea, he said.

Trump last month announced a 25% tariff on autos imported to the United States, which is the number one destination for German car

exports.

The Republican has claimed that imposing tariffs would make foreign companies relocate part of their production to the United States. Volkswagen – a 10-brand group

which also includes Audi, Porsche, Seat and Skoda – sold just over one million vehicles in North America last year, 12% of its sales by volume.

With Volkswagen sales in reverse in China in the face of stiff competition from domestic carmakers, particularly on electric vehicles, the US market has become even more important for the German manufacturer

Despite the presence Volkswagen production plant in Tennessee, 65% of its flagship VW brand's American sales come from vehicles shipped into the United

States from Europe or Mexico.
The figure rises to 100% for its high-end Audi and Porsche brands.

Blume would not comment on the tariffs' financial impact on Volkswagen, nor on whether it would raise its prices in the United States in response. – AFP

FBM KLCI set to continue testing 1,500-point level

THE FTSE Bursa Malaysia Kuala Lumpur Composite Index (FBM KLCI) is expected to continue testing the 1,500-point psychological level this week, with a sustained breakout likely to Boost investor confidence and attract foreign inflows.

Rakuten Trade Sdn Bhd equity research vice-president Thong

Pak Leng said he remained optimistic about the local bourse's near-term prospects, noting that sentiment remains buoyant,

underpinned by a stronger ringgit, attractive equity valuations, and improving market conditions.

"From a technical standpoint, the FBM KLCI is likely to continue testing the key psychological resistance at the 1,500 level this week. We anticipate the benchmark index to trend within a range of 1,490 to 1,510, with 1,490 serving as the immediate support and 1,510 as the resistance," he told Bernama.

Thong said should the key index maintain its position above this level for a longer period, it would form a solid base for further rallies.

UOB Kay Hian Wealth Advisors Sdn Bhd head of investment research Mohd Sedek Jantan said the key focal point for this week will be the Malaysian delegation's visit to Washington, led by Investment, Trade and Industry Minister Tengku Datuk Seri Zafrul

Abdul Aziz, for discussions on tariff-related issues.


"Markets are cautiously optimistic, anticipating a pragmatic outcome given Tengku Zafrul's proven track record in trade diplomacy. The establishment of a clear framework to address." lingering Donald Trump-era tariffs could lift investor sentiment further, particularly for export-oriented counters," he said.

However, he added, any signs of policy ambiguity or lack of progress may trigger short-term volatility.

Last week, on a Friday-to-Friday basis, the key index gained

44.64 points to 1,499.40 from 1,454.76 a week earlier.



WE expect SAMAIDEN's upcoming 3QFY25 (FYE June) earnings due next month to reflect further traction in execution of Corporate Green Power Programme (CGPP) EPCC projects and still strong contribution from the rooftop solar segment. To recap, the group secured three CGPP EPCC contracts with a commissioning deadline by end-CY25 as per requirements set by the Energy Commission. At least two of the three CGPP projects are targeted to be completed by Aug and Sep 2025 with most of the earnings likely to be captured within 2HFY25. Overall, we estimate 3QFY25 earnings to come in at between RM5-6mn, representing a 22-46%

We gather that 59% of SAMAIDEN's outstanding orderbook comprise of utility scale solar contracts with the majority consisting of CGPP projects. Another 22% of orderbook comprise of rooftop solar PV projects (both C&I and residential) while other RE projects such as mini hydro and bioenergy as well as O&M contracts make up the remaining. Total orderbook of RM515.7mn as at end-Dec 2024 is still close to a record high, representing 2.3x FY24 revenue. The group is likely to have run down part of this orderbook by end-3QFY25, but replenishment prospects are solid given an aggregate 4GW capacity under LSS5 and LSS5+ entailing EPCC prospect of RM12-14bn - utility-scale solar projects account for up to 80% of the group's RM1.8bn tenderbook.

We continue to like SAMAIDEN as one of the prime beneficiaries of an upcycle in RE plant-up underpinned by a solid

orderbook, strong net cash position and secured pipeline of RE assets to boost recurring income.

Economist expects ringgit to trade flat this week

THE ringgit is expected to trade flat this week, potentially trading at around RM4.41 to RM4.42, said Bank Muamalat Malaysia Bhd chief

economist Dr Mohd Afzanizam Abdul Rashid. He said that US President Donald Trump indicated a reluctance to keep raising the tariff against China as it might impact the trade between the two nations.

Additionally, several US Federal Reserve officials, including Christopher Waller and Austan Goolsbee, are scheduled to share their thoughts on the current state of the economy this week.

Meanwhile, SPI Asset Management managing director Stephen Innes expects market volatility to remain muted this week as diminishing returns on the US-China tariff front have been reached. He anticipates the ringgit to trade within a slightly broader range

of RM4.39 to RM4.43, reflecting the ongoing negotiation dynamics. Innes said that at this stage, markets expect some level of give-and-


take to materialise out of necessity to avoid further economic drag.
"An easing of US-China tensions might provide some support for

the ringgit, though as always, there's no certainty as the market closely monitors the news flow. Therefore, the local note will likely hover around RM4.41. Overall, Asian currencies and the ringgit are expected to strengthen, driven by progress in trade talks over the coming month or two," he said.

The local currency ended at 4.4100/4175 against the greenback last week, up from 4.4200/4265 the previous week. Year to date, the ringgit has risen by 1.32%.

It gained against the euro to 5.0133/0218 from 5.0207/0281 last week, but eased versus the Japanese yen to 3.0971/1028 from 3.0952/1000 and weakened vis-a-vis the British pound to 5.8516/8616 from 5.7849/7934. – Bernama

SUNSURIA Bhd announced that it has signed a strategic partnership with Kwasa Land Sdn Bhd, a wholly-owned subsidiary of EPF and the master developer of Kwasa Damansara for a new residential development in the township. The deal involves acquisition of a land measuring 9.464 acres for RM89m, which is envisaged to have estimated Gross Development Value (GDV) of RM492m. As such, land cost appears fair at about 18% to the indicated GDV. The project will be delivered in phases, with the first phase expected to launch in the third quarter of 2026.

We understand that the group is planning to feature 520 residential units with an estimated GDV of RM492m on the newly acquired 9.464-acre land at Kwasa Dmanasara. The project would entail the construction of landed homes as well as a condominium, which designed for individuals and smaller families seeking an urban lifestyle. Additionally, the project will incorporate modern amenities and sustainable features to promote a balanced and connected living environment. The project will be delivered in phases, with the first phase expected to be launched in the third quarter of 2026.

Sunsuria currently has 2,052 acres of undeveloped landbank with potential gross development value (GDV) of RM8bn which we estimate could take at least 8-10 years to develop. About RM6bn GDV is mainly from Sunsuria City @ Salak Tinggi which has already completed projects with combined GDV of RM1.4bn to-date. Ongoing residential development projects, among others, include Tower A, D and E of Bangsar Hill Park, Seni Residences and multifacility serviced apartment Tangerine Suites at Sunsuria City township and integrated mixed development Forum 2 at Setia Alam



RON95 subsidy rationalisation is imminent, but could be delayed as the full criteria for the eligibility – originally slated for announcement in 1Q25 – has yet to see the light of day. We understand the MyKad will be used in conjunction with a 2-tier pricing system. Furthermore, the T15 classification, ie those not be eligible for the subsidy, is still being reviewed, which could delay the rollout to beyond mid-2025 in our view. While details remain unclear, we believe policy will raise car ownership costs – it could also drive EV adoption and prompt some buyers to down-trade, given the limited availability of affordable EVs.

Additionally, an unresolved policy issue remains on the revision of open market value (OMV) for excise duty calculations on CKD cars. Originally based on manufacturing costs, the revised OMV may include selling-related expenses, potentially increasing car prices by 10-30% if implemented in Jan 2026. This could lead to a surge in car sales before the new excise duty takes effect. Nonetheless, strong opposition from Malaysian carmakers may

influence the final decision on this policy change.

We remain cautious in our outlook due to ongoing price competition in the non-national segment and softening order backlogs. Perodua's backlog has reduced to 68k units (or 2-3 months of sales) currently from 90k units in Nov 2024, while Toyota's has maintained at 16k units (2-3 months of sales).

Keep neutral, given our expectations for a cyclical sector slowdown premised on a lack of catalysts to drive sales and earnings to new highs. We like SIME – it is well positioned for the RON95 rationalisation, given its broad EV line-up, while Perodua provides earnings protection amidst intensifying competition amongst non-national marques. - RHB Research, April 18



N a quiet corner of Mercu Maybank's 32nd-floor office in i-City, 75-year-old I-Bhd chairman Tan Sri Lim Kim Hong swipes through a live dashboard monitoring i-City's traffic flows, monitoring i-Citys traine flows, energy use and even crowd densities at its theme park – all powered by artificial intelligence (AI).

It is a far cry from his first job as a

12-year-old apprentice in a Muar furniture shop, supporting a family of 10 after his father passed away. His mother earned just RM2 a day as a rubber worker. Lim never completed secondary school - failing Bahasa Malaysia in Standard 6 despite topping his class in Mathematics – but he would go on to become one of Malaysia's most understated tycoons.

"I did not have a real education, but Malaysia gave me the opportunity I just never gave up," Lim said.

Mattress king
Lim first rose to prominence in the 1970s as the man who revolutionised Malaysia's bedding industry. His company Dreamland Holdings Bhd introduced spring mattresses to the local market and was listed on the local market and was listed on the Kuala Lumpur Stock Exchange in 1987.

In 1991, Dreamland diversified into steel production and was rebranded as Kanzen Bhd. Just two years later, Lim divested his interest in Kanzen to reorganise his business portfolio and focus on three core areas: manufacturing, property development and financial services. This transition would eventually lead to the acquisition of Sanyo Industries Malaysia Bhd. later renamed I-Bhd the company that would go on to build i-City.

In 1993, after selling his stake in Dreamland for RM300 million, Lim turned his focus toward a bigger ambition: building a future-ready city.

Smart infrastructure blueprint

In the late 1990s, Lim acquired a 72-acre plot in Shah Alam. Where others saw agriculture, he envisioned a data-driven city of the future. Today, that site is digital city i-City – a RM9.5 billion urban development and Malaysia's first privately-funded Multimedia Super Corridor project.

As the master developer, I-Bhd transformed i-City into a technology-led township that

- Malaysia's Tier III-certified data centres.
- First Malaysian development to provide fibre-to-unit broadband and to include it as a core utility alongside water and electricity
- Built on 5G-ready infrastructure, primed for AI and Internet of Things integration.

Now a recognised flagship of smart city planning in Malaysia, i-City draws over 30 million visitors annually, with a mix of residential, commercial, tourism and meetings, incentives. conferences exhibitions components.

"We are not just landlords. We have built highways for data. Now we are exploring collaborations with Chinese AI firms to offer what Shenzhen did in 2005 – space to experiment," Lim said.

Next frontier: AI and robotics

With its infrastructure backbone in place, i-City is entering its next evolution – the integration of AI and robotics into community life.

"In keeping with the evolution of what a smart city should be, we are now embedding AI and robotics into i-City's digital fabric," Lim explained.

This includes real-time energy optimisation, AI-led mobility solutions and autonomous systems in facilities and services. AI-led

With China's AI champions such as DeepSeek and Baidu rolling out cutting-edge large language models, Lim sees an opportunity to leverage his long-standing relationships and bring these next-generation technologies into i-City.

He is actively engaging with Chinese AI powerhouses – not as traditional tenants, but as collaborative partners seeking to extend AI into daily urban functions.

Just as global firms such as Cisco and Intel used i-City to pilot urban technologies in the early 2000s, today he is offering Chinese AI firms a living testbed to explore how their platforms can integrate into real-time environments – from traffic systems to healthcare and retail.

"We have always used cutting-edge tech in i-City. Now we want to take AI beyond search bars and chatbots and into improving the quality of life," he said.

Investing in next generation

Lim's belief in technology as a social equaliser dates back decades. In 1995, he invested RM10 million to host a Russian space exhibition in Malaysia – complete with a full-size MIR Space Station – to inspire students. In the early 2000s, he collaborated with Asus to launch i-Asus notebooks, helping to bridge the digital divide in underserved communities.

Today, i-Bhd, the listed company behind i-City, hosts around 400 interns annually, nurturing young Malaysian talent and exposing them



to real-world applications in smart city development and AI.

"I tell my friends I am doing this for

Then my mends I am doing this for the young. Some think I am crazy. But I never had those chances. So I build what I did not have - opportunities."

With its financial and tourism districts already in place, i-City's next frontier is focused on robotics, autonomous systems and community-integrated AI. The vision is to build a self-aware urban ecosystem that adapts to residents in real-time – and to make Malaysia a model for regional smart living.

"This is where the future is

heading - from infrastructure to intelligence."



Google ups storage requirements for Android

GOOGLE has just set new storage space minimums for installing the latest versions of Android. From now on, a minimum of

32GB of free space is recommended to be able to install the future Android 16, which automatically excludes the lowest-end models on the market.

Android According Authority, Google its minimum doubling requirements storage requi Android devices.

From now on, any smartphone (or tablet) wishing to obtain official certification for Android 15 will need to have at least 32GB of internal storage, as opposed to 16GB previously. The minimum RAM

requirement is 4GB to install Android 15 and later versions. This requirement applies to all device manufacturers wishing to integrate Google services, such as the Play Store into

their products.

This decision aims to improve the user experience on entry-level devices, which often have limited space available after installing the system and pre-installed applications.

This means that several smartphone and tablet models, mainly in the entry-level tier, will not be authorised to install either Android 15 or Android 16.

Generally speaking, however, these announcements are not going to be a game changer, as the most recent versions of Android are usually reserved for the latest models released on

the market. Moreover, in 2025, it is rare to find smartphones on the market with such little storage space, as most of them, even in the low and mid-range, have at least 64GB.

Dengue presents greater threat to women

Physiological, social, economic factors play huge role

major public health concern in Malaysia, with thousands of cases reported annually. The country's tropical climate and rapid urbanisation create ideal breeding conditions for mosquitoes, contributing to dengue's persistence and placing individuals

at constant risk of infection.
While dengue affects both men and women, emerging insights reveal that women may bear a disproportionate burden of the disease - not just physically, but also socially and economically.

Impact of dengue on women

Dengue may not discriminate, but its effects on women can be particularly severe due to physiological, social and economic

Women are more likely to women are more likely to develop severe dengue and dengue haemorrhagic fever due to physiological factors - women's immune system tends to mount a stronger response to the virus, leading to higher viral loads and increased inflammation. Women have lower blood volume, which makes them more susceptible to hypovolemic shock, a dangerous complication of severe dengue.

Capillary leakage As women's blood vessels naturally

allow more fluid to pass through their walls, they are more prone to bruising and internal bleeding. This is especially concerning for women who contract severe dengue while menstruating, as they are at risk of excessive bleeding, alongside other symptoms such as abdominal pain, persistent vomiting, mucosal

bleeding such as gum and nose

bleeds, as well as plasma leakage.

These factors significantly increase the risk of severe complications, requiring close medical monitoring, especially in women with low platelet counts or anemia, conditions that are more anaemia - conditions that are more common in women than in men.

Pregnant women face an even greater risk from dengue infection, which can have serious consequences for both mother and child. Dengue during pregnancy can lead to low birth weight, premature birth, stillbirth and an increased risk of maternal death. The virus can be transmitted to the baby in the womb, potentially causing severe dengue with haemorrhagic symptoms in

Social, emotional toll on women

Beyond the physiological risks, women often carry a heavier social and emotional burden when it comes to dengue. As primary caregivers in many households, women are responsible for looking

after children, elderly parents and sick family members. However, when women fall ill, they may have limited support or feel compelled to downplay their symptoms to continue their caregiving responsibilities. Delaying care can come at a high personal cost as dengue progresses rapidly, and without timely intervention, complications can become life-threatening.

The situation can become even more challenging if access to healthcare services is limited by financial constraints, lack of childcare options and other socioeconomic factors. This may cause women to delay medical cause women to delay medical attention, choosing instead to prioritise their families over their own health. These interconnected factors create a cycle where women are more vulnerable to severe dengue outcomes simply because struggle to prioritise their health.

Fight against dengue

There is a need to equip women

with the knowledge and resources to protect themselves and their families. If you have persistent fever, severe body aches, bleeding symptoms or prolonged fatigue, seek medical attention immediately. Equally important is ensuring

that women have the support they need to access healthcare. need to access healthcare. Supporting those affected by dengue are collective responsibilities that can be achieved through cooperation between neighbours and other community members. Whether it is financial assistance, childcare support or workplace flexibility, removing barriers to medical care can significantly improve outcomes for women affected by dengue.

While women often take the lead in dengue prevention at home, maintaining health is a shared responsibility.

Community-driven remain essential, such as keeping neighbourhoods clean and neighbourhoods clean and eliminating mosquito breeding sites, alongside personal measures such as covering exposed skin and the use of repellents to prevent mosquito bites.

Increasing vaccination uptake can help reduce severe dengue cases and hospitalisations, lessening the strain on both families and the healthcare system. Vaccination can reduce the system. Vaccination can reduce the burden of dengue, particularly for high-risk groups. Those living in or travelling to areas with high rates of dengue infections would also benefit from protecting themselves through vaccination.

By adopting integrated preventive measures, from vector integrated control to vaccination, we can move towards a future where dengue no longer weighs so heavily on women and other vulnerable communities.

DRASTIC RISE IN PENANG HFMD CASES

PENANG registered an alarming increase in hand, foot and mouth disease (HFMD) cases after 579 cases were recorded during the cases were recorded during the 15th epidemiological week between April 6 and 12. State Youth, Sports and Health Committee chairman Daniel Gooi Zi Sen said this was an increase of 353 cases or 156.2% compared to the previous week, with four new clusters also reported during the period. "This increase is believed to have occurred following the last Aidilfitri holidays, however, all the reported cases showed mild symptoms with outpatient treatment and none of the cases experienced complications or required intensive treatment," he said in a statement last Friday. – Bernama

Why are autism rates increasing?

AUTISM is a neurological and developmental condition marked by disruptions in brain-signalling that cause people to behave, communicate, interact and learn in atypical ways. Autism diagnoses have increased significantly since 2000, intensifying public concern over what might contribute to its prevalence.

How is autism diagnosed?

There are no objective tools for diagnosing autism spectrum disorder (ASD), the medical name for autism, such as blood tests or brain scans. Instead, diagnoses are made based on observations and interviews. The term spectrum reflects the wide range of possible manifestations. Some people with ASD may have good conversation skills while others may be nonverbal. Some may be acutely sensitive to sounds, touch or other triggers. Some may have restricted or repetitive

behaviours or interests. Some may need help with daily living, while others require little or no support.

What causes autism?

The causes of autism are unclear There is widespread speculation among scientists that its neurological characteristics may develop in utero, when the fetal brain is being wired. Studies have linked autism to maternal factors in pregnancy and some research suggests a link to birth complications and timing.

Genetic factors account for about 80% of the risk for developing autism, research suggests. A growing area of investigation focuses on epigenetics – the interactions between genetic and environmental factors. One theory suggests that a woman's exposure to air pollution or harmful contaminants before or during pregnancy may trigger a genetic mutation leading to autism in her child

Gene variations in some people with autism strengthen the evidence for a genetic component. Among the genetic disorders linked with higher risks for autism are Fragile syndrome, tuberous berous sclerosis Phelan-McDermid complex. syndrome and Prader-Willi syndrome.

Other potential risk factors may include very low birth weight, jaundice as a newborn, complications in utero or during birth, having an unhealthy assortment of organisms living in the intestines, immune system disorders, having a sibling

with autism and parental factors such as age, obesity and diabetes. No rigorous studies have found links between autism and vaccines or medications, or their components such as thimerosal or formaldehyde. Vaccination rates have declined as autism rates have climbed.

Why are autism rates rising?

Researchers largely attribute the rise in autism diagnoses to more widespread screening and the inclusion of a wider range of behaviours to describe the condition. Historically, the definition of autism included moderate to severe intellectual disabilities. Today, doctors recognise that the most severe forms account for only about 25% of cases.

In 2013, mental health experts combined what had been three separate diagnoses – autistic disorder, Asperger's disorder and pervasive developmental disorder - under the of autism spectrum

disorder.

An October 2024 study of US insurance claims data found the largest increases in diagnoses were in groups with low screening rates in the past, including young adults, females and children from some racial or ethnic minority groups.

Researchers have also noted that certain risk factors have become more common, such as having been born

prematurely or to older parents.

Diagnoses of more severe forms of the disorder, known as profound autism, have not risen as dramatically as rates of non-profound autism.

Are there treatment?

There are no treatments or cures for autism, nor can it be reversed However, experts agree that early diagnosis is crucial. Intervention with supportive measures – ideally before age three – is critical for improving cognitive, social and communication skills. Such measures can include speech therapy, occupational therapy, social skills training, sensory integration therapy, visual aids, structured routines individualised education plans, family therapy and providing a calm and predictable environment. - Reuters



Meanwhile, in the men's events, national backup bowler Ethan Damien Goh created an upset when he defeated compatriot and defending champion, Hafiz Zainuddin.

The 15-year-old bowler recorded a total pinfall of 220 to beat Hafiz's 180.

Earlier Hafiz advanced to the stepladder final after defeating Australia's Luke Doyle 218– 182 in the semifinal today while Ethan secured his spot in the final after finishing top in the qualifying round.

"This win is unexpected, but it was a fine run for me. I could not have done it without my family, coaches and the people who have supported me," he said.

The victory saw Ethan take home RM50,000 in cash, while Li Jane walked away with RM30,000. – Bernama



'No dedicated spot for Azizulhasni'

NATIONAL track cycling ace Datuk Mohd Azizulhasni Awang has to double down if he wants to be part of the Malaysian team for the 2025 Track Cycling World Championships in Santigo, Chile this October, said national cycling programme technical director John Beasley said Mohd Azizulhasni has to

prove he has what it takes as there will not be a dedicated spot for him on the squad for the team sprint event. Furthermore,

Beasley said Mohd Azizulhasni will not be competing in the individual events.

"We need Mohd Azizulhasni He realizes that he gonna need to push foward as hard as he can and he realizes he need to qualify to get a spot. There is no automatic spot (for Mohd Azizulhasni)," he told reporters during the Malaysian National Cycling Federation (MNCF) Hari Raya Open House yesterday.

For the team event, Mohd Azizulhasni will

have to compete with his juniors like Muhammad Fadhil Mohd Zonis, Umar Hasbullah, Mohamad Akmal Nazimi Jusena as well as seasoned campaigners Muhammad Shah Firdaus Sahrom and Muhamad Ridwan Sahrom.

Yesterday, Mohd Azizulhasni announced that he would continue his career as a track cyclist but as a professional.

He said the decision was made after discussing with the National Sports Council and Youth and Sports Minister Hannah Yeoh to ensure that all allocations could be focused on other riders.

According to him, one of the reasons he made the decision was to "heal the wounds" of failing to bring home a gold medal from the 2024 Paris Olympics.

Hannah also announced an individual rant allocation of RM200,000 for Mohd Azizulhasni to move professionally for the year 2025-2026. – Bernama

STON VILLA could bounce from the Champions League straight back into the Champions League. Four days after being knocked out, they scored four goals to take a giant stride towards a swift return.
